23	set by the county that is not less than 90 days after the replacement permit is issued.".
24	On <u>page 3</u> , delete lines 18 through 45.
25	On <u>page 4</u> , delete lines 1 through 31 and insert:

12 "(2) For replacement of a lawfully established dwelling under this section:

- "(a) The dwelling to be replaced must be removed, demolished or converted to an allowable
 nonresidential use[:]
- "[(A)] within [one year] three months after the date the replacement dwelling is certified for
 occupancy pursuant to ORS 455.055[; or].
- 17 "[(B) If the dwelling to be replaced is, in the discretion of the county, in such a state of disrepair 18 that the structure is unsafe for occupancy or constitutes an attractive nuisance, on or before a date set 19 by the county that is not less than 90 days after the replacement permit is issued.]
- 20 "(b) The replacement dwelling:

21 "(A) May be sited on any part of the same lot or parcel.

- "(B) Must comply with applicable siting standards. However, the standards may not be appliedin a manner that prohibits the siting of the replacement dwelling.
- 24 "(c) As a condition of approval, if the dwelling to be replaced is located on a portion of the lot 25or parcel that is not zoned for exclusive farm use, the applicant shall execute and cause to be re-26 corded in the deed records of the county in which the property is located a deed restriction pro-27hibiting the siting of another dwelling on that portion of the lot or parcel. The restriction imposed is irrevocable unless the county planning director, or the director's designee, places a statement of 28 29 release in the deed records of the county to the effect that the provisions of this section and either ORS 215.213 or 215.283 regarding replacement dwellings have changed to allow the lawful siting of 30 another dwelling. 31
- 32 "[(3) Notwithstanding subsection (2)(b)(A) of this section, a replacement dwelling under this section 33 must be sited on the same lot or parcel:]
- 34 "[(a) Using all or part of the footprint of the replaced dwelling or near a road, ditch, river, prop-35 erty line, forest boundary or another natural boundary of the lot or parcel; and]
- 36 "[(b) If possible, for the purpose of minimizing the adverse impacts on resource use of land in the 37 area, within a concentration or cluster of structures or within 500 yards of another structure.]
- 38 "[(4)] (3) The county planning director, or the director's designee, shall maintain a record of the 39 lots and parcels that do not qualify for the siting of a new dwelling under subsection (2) of this 40 section, including a copy of the deed restrictions filed under subsection (2)(c) of this section.
- 41 "[(5)] (4) If an applicant is granted a deferred replacement permit under this section:
- 42 "(a) The deferred replacement permit:
- 43 "(A) Does not expire but[, notwithstanding subsection (2)(a)(A) of this section,] the permit becomes
 44 void unless the dwelling to be replaced is removed or demolished within three months after the de45 ferred replacement permit is issued; and

1 "(B) May not be transferred, by sale or otherwise, except by the applicant to the spouse or a 2 child of the applicant.

"(b) The replacement dwelling must comply with applicable building codes, plumbing codes, sanitation codes and other requirements relating to health and safety or to siting at the time of construction. However, the standards may not be applied in a manner that prohibits the siting of the replacement dwelling.".
