House Bill 3203

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Requires each county to identify 10 most common languages spoken by residents of county. Requires Secretary of State and county to ensure state voters' pamphlet and county voters' pamphlet are translated into each of 10 identified languages and to make translated voters' pamphlets available on county website. Requires voters' pamphlets to include, in each of 10 identified languages, website address for translated voters' pamphlet.

Applies to voters' pamphlets distributed on or after January 1, 2021. Takes effect on 91st day following adjournment sine die.

(1) The Secretary of State shall prepare and have printed in the voters' pamphlet for the state primary election, the general election and any special election described in ORS 251.022 18 a statement containing, if applicable: 19 20 (a) Requirements for a citizen to qualify as an elector. 21(b) When an elector is required to register or update a registration. 22(c) In the voters' pamphlet for the primary election, a statement of the duties and responsibilities of a precinct committeeperson to be elected at the primary election. 23 (d) Any other information the Secretary of State considers relevant to the conduct of the 24 25 election. (2) The Secretary of State, in cooperation with the county clerks, shall include: 26 (a) A statement on the cover of the voters' pamphlet that the pamphlet may be used to assist 2728 electors in voting[.]; and
