## House Bill 3207

Sponsored by Representatives ZIKA, RESCHKE; Representative WILLIAMS

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Creates income tax subtraction for qualifying sales of single-family or multifamily housing. Applies to tax years beginning on or after January 1, 2020, and before January 1, 2026. Takes effect on 91st day following adjournment sine die.

5	SECTION 1. Section 2 of this 2019 Act is added to and made a part of ORS chapter 316.
6	SECTION 2. (1) As used in this section:
7	(a) "Multifamily housing" has the meaning given that term in ORS 456.515.
8	(b) "Qualifying sale" means:
9	(A) The sale of a new single-family dwelling at or below 140 percent of the area median
10	home price; or
11	(B) The sale of a single-family dwelling or multifamily housing to a purchaser that enters
12	into a recorded affordability restriction agreement governing the use of the property that:
13	(i) Has a duration of at least 10 years; and
14	(ii) Requires rental rates for the housing to be affordable, under federal rental
15	affordability standards, to households earning at or below 140 percent of the area median
16	income.
17	(c) "Urban reserve" has the meaning given that term in ORS 195.137.
18	(2) In computing Oregon taxable income for the purposes of this chapter, there shall be
19	subtracted from federal taxable income the gain realized by a taxpayer from the qualifying
20	sale of property during the tax year if the property:
21	(a) Is sited on no more than acres within an urban growth boundary or an urban
22	reserve;
23	(b) Is a new single-family residence or new multifamily housing; and
24	(c) Did not contain a structure suitable for housing or commercial purposes at the time
25	it was acquired by the seller.
26	(3) The taxpayer shall provide proof of eligibility for the subtraction allowed under this
27	section in a form prescribed by the Department of Revenue.
