**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

*[Directs State Court Administrator to study issues relating to courts.]*

**Increases certain filing fees, motion fees, settlement conference fees, trial fees, fees for writs of garnishment, marriage solemnization fees and prevailing party fees.**  
**Declares emergency, effective on passage.**

8 **FILING FEES**

9  
10 **SECTION 1.** ORS 21.135 is amended to read:

11 21.135. (1) Unless a specific fee is provided by subsection (3) of this section or other law for a  
12 proceeding, a circuit court shall collect a filing fee of [~~\$265~~] **\$281** when a complaint or other docu-  
13 ment is filed for the purpose of commencing an action or other civil proceeding and when an answer  
14 or other first appearance is filed in the proceeding.

15 (2) The filing fee established by subsection (1) of this section applies to:

16 (a) Proceedings in which only equitable remedies are sought.

17 (b) Appeals from a conviction of a violation in justice or municipal courts as provided in ORS  
18 21.285.

19 (c) Interpleader actions.

20 (d) Actions relating to a trust.

21 (e) Proceedings for judicial review of an agency order.

22 (f) Declaratory judgment actions.

23 (g) Any other action or proceeding that is statutorily made subject to the fee established by this  
24 section and any other civil proceeding for which a specific filing fee is not provided.

25 (3)(a) The circuit court shall collect a filing fee of [~~\$255~~] **\$263** in adoption cases under ORS  
26 chapter 109, excluding readoptions under ORS 109.385, when a petition is filed for the purpose of  
27 commencing an adoption proceeding or when any other document or other first appearance is filed

19 (1) Proceedings for dissolution of marriage, annulment of marriage or separation.

20 (2) Filiation proceedings under ORS 109.124 to 109.230.

21 (3) Proceedings under ORS 108.110, 109.100 and 109.103.

22 **SECTION 4.** ORS 21.160 is amended to read:

23 21.160. (1) A circuit court shall collect the following filing fees when a complaint or other doc-  
24 ument is filed for the purpose of commencing an action or other civil proceeding based on a tort  
25 or contract and when an answer or other first appearance is filed in the proceeding:

26 (a) If the amount claimed is \$10,000 or less, the court shall collect a filing fee of [~~\$165~~] **\$170**.

27 (b) If the amount claimed is more than \$10,000 and less than \$50,000, the court shall collect a

2 must pay [*the filing fee established under ORS 21.135*] a **filing fee of \$190**. The clerk shall treat the  
3 foreign judgment in the same manner as a judgment of the circuit court.

4 (2) A certified copy of any foreign judgment authenticated in accordance with the Act of Con-  
5 gress or the statutes of this state shall be recorded in the County Clerk Lien Record of any county  
6 other than the county in which the judgment is originally filed, in order to become a lien upon the  
7 real property of the judgment debtor in that county as provided in ORS 18.152.

8 (3) A judgment so filed has the same effect and is subject to the same procedures, defenses and

18 stay enforcement of the foreign judgment until the appeal is concluded, the time for appeal expires,  
19 or the stay of execution expires or is vacated, upon proof that the judgment debtor has furnished  
20 the security for the satisfaction of the judgment required by the state in which it was rendered.

21 (2) If the judgment debtor shows the court of any county any ground upon which enforcement  
22 of a judgment of any court of any county of this state would be stayed, the court shall stay  
23 enforcement of the foreign judgment for an appropriate period, upon requiring the same security for  
24 satisfaction of the judgment which is required in this state.

25 (3) Any person making an appearance in proceedings related to foreign judgments filed under

30 46.570. The small claims department of a circuit court shall collect the following filing fees from  
31 the plaintiff when a claim is filed in the court, and from the defendant when the defendant demands  
32 a hearing:

33 (1) [~~\$55~~] **\$57**, when the amount claimed is \$2,500 or less; and

34 (2) [~~\$99~~] **\$102**, when the amount is more than \$2,500.

35 **SECTION 10.** ORS 105.130 is amended to read:

36 105.130. (1) Except as provided in this section and ORS 105.135, 105.137 and 105.140 to 105.161,  
37 an action pursuant to ORS 105.110 shall be conducted in all respects as other actions in courts of  
38 this state.

39 (2) Upon filing a complaint in the case of a dwelling unit to which ORS chapter 90 applies, the  
40 clerk shall:

41 (a) Collect a filing fee of [~~\$83~~] **\$88**;

42 (b) Collect any other fee authorized by law or ordinance; and

43 (c) With the assistance of the plaintiff or an agent of the plaintiff, complete the applicable

44 **SECTION 12.** ORS 21.200 is amended to read:

45 21.200. (1) In any action or other proceeding subject to a fee under ORS 21.135, 21.145 or 21.160,

1 a [~~\$105~~] **\$111** fee must be paid by the party filing one of the following motions and by the party re-  
2 sponding to the motion:

- 3 (a) A motion for summary judgment under ORCP 47.
- 4 (b) A motion for judgment notwithstanding the verdict under ORCP 63.
- 5 (c) A motion for new trial under ORCP 64.
- 6 (d) A motion for relief from judgment under ORCP 71.
- 7 (e) A motion for preliminary injunction under ORCP 79.
- 8 (f) A motion seeking remedies for contempt of court.

9 (2) The fees provided for in this section may not be collected from the state, a county, a city  
10 or a school district.

11 (3) The fees provided for in this section may not be collected for motions made to an arbitrator  
12 or mediator in an arbitration or mediation required or offered by a court, or to any motion relating  
13 to an arbitration or mediation required or offered by a court.

14 (4) The clerk shall file a motion or response that is subject to a fee under this section only if  
15 the fee required by this section is paid when the motion or response is submitted for filing.

16 **SECTION 13.** ORS 21.205 is amended to read:

17 21.205. (1) In any action or other proceeding subject to a fee under ORS 21.155, a [~~\$158~~] **\$167**  
18 fee must be paid by the party filing a motion that seeks entry of a supplemental judgment and by  
19 a party responding to the motion.

20 (2) The fee provided for in subsection (1) of this section does not apply to any motion under  
21 ORCP 68, 69 or 71.

22 (3) In any action or other proceeding subject to a fee under ORS 21.155, a [~~\$53~~] **\$56** fee must  
23 be paid by the party filing one of the following motions and by a party responding to the motion:

- 24 (a) A motion filed under ORS 107.434; and
- 25 (b) A motion seeking remedies for contempt of court.

26 (4) Only the fees specified by subsection (1) of this section may be collected if a party concur-  
27 rently files a motion that seeks entry of a supplemental judgment and a motion seeking remedies for  
28 contempt of court.

29 **SECTION 14.** The amendments to ORS 21.200 and 21.205 by sections 12 and 13 of this 2019

32 **SETTLEMENT CONFERENCE FEES**

34 **SECTION 15.** ORS 21.215 is amended to read:

35 21.215. (1) In any civil proceeding subject to a fee under ORS 21.155 in which the parties request  
36 a settlement conference before a judge, or in which a settlement conference before a judge is re-  
37 quired by law or by the court, each party participating in the conference shall pay a [~~\$105~~] **\$111** fee  
38 to the court for each day or partial day during which the conference is conducted.

39 (2) Notwithstanding ORS 3.428 (3), the fee required under subsection (1) of this section must be  
40 paid when parties request a settlement conference through a family law facilitation program.

41 (3) In civil proceedings other than those described in subsection (1) of this section, if the parties  
42 request a settlement conference before a judge, or a settlement conference before a judge is required  
43 by law or by the court, each party participating in the conference shall pay a [~~\$210~~] **\$223** fee to the  
44 court for each day or partial day during which the conference is conducted.

45 (4) The fees required by this section shall be collected in advance, and are due and payable on

1 the first day of the settlement conference.

2 **SECTION 16. The amendments to ORS 21.215 by section 15 of this 2019 Act apply to**  
3 **settlement conferences conducted on or after October 1, 2019.**

5 **TRIAL FEES**

6  
7 **SECTION 17.** ORS 21.225 is amended to read:

8 21.225. (1) In any civil action, suit or proceeding in the circuit court, other than a protective  
9 proceeding under ORS chapter 125 or a probate, adoption or change of name proceeding, trial fees  
10 shall be collected as provided in this section.

11 (2) The clerk of the circuit court shall collect from the plaintiff, appellant or moving party, for  
12 a trial on the merits without a jury, a trial fee of [~~\$131~~] **\$139** for each full or partial day of the trial.  
13 The amount of the fee for the first day of trial shall be collected in advance and is due and payable  
14 when the action, suit or proceeding is set for trial. The amount of the fee for subsequent days of  
15 trial shall be collected on the day the trial concludes.

16 (3)(a) The clerk shall collect from the plaintiff or appellant, for a trial by a jury of more than  
17 six persons, a jury trial fee of [~~\$236~~] **\$250** for each full or partial day of the trial. The clerk shall  
18 collect from the plaintiff or appellant, for a trial by a jury of six persons, a jury trial fee of [~~\$158~~]  
19 **\$167** for each full or partial day of the trial. The amount of the fee for the first day of trial shall  
20 be collected in advance and is due and payable when the action, suit or proceeding is set for trial  
21 by jury. The amount of the fee for subsequent days of trial shall be collected on the day the trial  
22 concludes.

23 (b) If the plaintiff or appellant waives a trial by jury, and the defendant or respondent desires  
24 a trial by jury, the clerk shall collect the jury trial fee from the defendant or respondent, and not  
25 from the plaintiff or appellant.

26 (c) A case in which the jury trial fee for the first day of trial has not been paid shall be tried  
27 by the court without a jury, unless the court otherwise orders. If a case in which the jury trial fee  
28 for the first day of trial has not been paid is tried by a jury, the clerk shall tax against the losing  
29 party the total amount of the jury trial fee. The jury trial fee constitutes a monetary obligation  
30 payable to the court, and may be made part of the judgment in the case by the clerk without further  
31 notice to the debtor or further order of the court.

32 (4) If a counterclaim, cross-claim or third party claim is tried on any day other than a day on  
33 which the claim of the plaintiff is tried, the clerk shall collect from the party asserting the  
34 counterclaim, cross-claim or third party claim the trial fee or jury trial fee, whichever is applicable,  
35 for that day, and shall not collect the applicable fee for that day from the plaintiff. If the party as-  
36 serting a counterclaim, cross-claim or third party claim waives a trial by jury on the claim, and the  
37 party defending against the claim desires a trial by jury on the claim, the clerk shall collect the jury  
38 trial fee from the defending party and not from the asserting party.

39 (5) The fees provided for in this section include any reporting of the trial proceedings, but not  
40 the preparation of transcripts of a report.

41 (6) Except as otherwise provided in subsection (3)(c) of this section, the fees provided for in this  
42 section that are paid by a party shall be considered costs and disbursements and may be taxed and  
43 collected as other costs and disbursements by the prevailing party.

44 (7) A court shall order that a trial fee paid under the provisions of this section be refunded to  
45 the party that paid the fee if all claims in the action or proceeding are decided without the com-

1 mencement of a trial and the party that paid the fee files a motion and affidavit requesting refund  
2 of the fee not more than 15 days after entry of judgment disposing of the action or proceeding.

6 **DOCUMENT FEES**  
7

8 **SECTION 19.** ORS 18.999, as amended by section 10, chapter 98, Oregon Laws 2018, is amended  
9 to read:

10 18.999. This section establishes the right of a plaintiff to recover [*certain moneys the plaintiff has*  
11 *expended*] **amounts related to a plaintiff's attempts** to recover a debt under ORS 18.854 or to  
12 enforce a judgment and establishes procedures for that recovery. The following apply to this section:

13 (1) When a plaintiff receives moneys under a garnishment, attachment or payment, the plaintiff  
14 may proceed as follows:

15 (a) Before crediting the total amount of moneys received against the judgment or debt, the  
16 plaintiff may recover and keep from the total amount received under the garnishment, attachment  
17 or payment any moneys allowed to be recovered under this section.

18 (b) After recovering moneys as allowed under paragraph (a) of this subsection, the plaintiff shall  
19 credit the remainder of the moneys received against the judgment or debt as provided by law.

20 (2) Moneys recovered under subsection (1)(a) of this section shall not be considered moneys paid  
21 on and to be credited against the original judgment or debt sought to be enforced. No additional  
22 judgment is necessary to recover moneys in the manner provided in subsection (1)(a) of this section.

23 (3) The only moneys a plaintiff may recover under subsection (1)(a) of this section are those  
24 described in subsection (4) of this section that [*the plaintiff has paid to enforce*] **arise out of the**  
25 **enforcement of** the existing specific judgment or debt that the specific garnishment or attachment  
26 was issued to enforce or upon which the payment was received. Moneys recoverable under sub-  
27 section (1)(a) of this section remain recoverable and, except as provided under subsection (8) of this  
28 section, may be recovered from moneys received by the plaintiff under subsequent garnishments,  
29 attachments or payments on the same specific judgment or debt.

30 (4) This section allows the recovery only of the following:

31 (a) Statutorily established moneys that meet the requirements under subsection (3) of this sec-

34

35 **SECTION 22.** ORS 106.120 is amended to read:

36 106.120. (1) As used in this section:

37 (a) "Judicial officer" means:

38 (A) A judicial officer of this state as that term is defined in ORS 1.210 and includes but is not  
39 limited to a judge of a municipal court and a justice of the peace.

40 (B) An active judge of a federal court.

41 (C) An active United States magistrate judge.

42 (b) "Secular organization" means an organization that occupies a place in the lives of the  
43 organization's members parallel to that filled by a church or particular religious authority.

44 (2) Marriages may be solemnized by:

45 (a) A judicial officer;

1 (b) A county clerk;

2 (c) Religious congregations or organizations as indicated in ORS 106.150 (2);

3 (d) A clergyperson of any religious congregation or organization who is authorized by the reli-  
4 gious congregation or organization to solemnize marriages;

5 (e) Secular organizations as indicated in ORS 106.150 (2); or

6 (f) A celebrant or officiant of any secular organization described in paragraph (e) of this sub-  
7 section who is authorized by the secular organization to solemnize marriages.

8 (3) A person authorized to solemnize marriages under subsection (2) of this section may  
9 solemnize a marriage anywhere in this state.

10 (4)(a) When a marriage is solemnized by a tax, appellate or circuit judge of this state, the clerk  
11 of the court or the county clerk shall collect a fee of [~~\$110~~] **\$117** and deposit the fee in the Judicial  
12 Department Operating Account established in ORS 1.009.

13 (b) When a marriage is solemnized by a county clerk, the county clerk shall collect a fee of  
14 [~~\$110~~] **\$117**, as provided in ORS 205.320.

15 (c) The fee described in this subsection may be collected only if:

16 (A) The marriage is solemnized during normal working hours, excluding holidays;

17 (B) The marriage is solemnized in court facilities or a county clerk's office; or

20 (d) The Chief Justice of the Supreme Court or the county clerk may establish a written proce-  
21 dure for waiver of the fee required under this subsection in exigent circumstances, including but not

24 state and a county clerk may charge and accept an agreed upon personal payment not to exceed  
25 \$100 plus actual costs for the solemnization of a marriage if that solemnization is performed:

26 (a) At a place other than the courthouse where the judicial officer or county clerk serves; or

27 (b) Outside of the judicial officer's or county clerk's normal working hours.

28 (6) The charging and accepting of a personal payment by a judicial officer of this state or a  
29 county clerk under subsection (5) of this section does not constitute a violation of any of the pro-  
30 visions of ORS chapter 244.

31 (7) The amount of actual costs charged by a judicial officer of this state or a county clerk under  
32 subsection (5) of this section may not exceed:

33 (a) Actual expenses for food and lodging as verified by receipts.

34 (b) If travel is made by personal vehicle, the actual number of round-trip miles from the judicial  
35 officer's or county clerk's home or office, whichever is greater, compensated at the rate of re-  
36 imbursement then provided by the State of Oregon to its employees or, if travel is made by a com-  
37 mercial carrier, reimbursement shall be made of the actual costs thereof, verified by receipts.

16       (e) For taking an affidavit for and making and issuing a marriage license and registering the  
17 return of the license, or for taking an affidavit for and registering a Declaration of Domestic Part-  
18 nership, \$25.

19       (f) For solemnizing a marriage under ORS 106.120, [~~\$110~~] **\$117**. This paragraph does not require  
20 that the county clerk charge a fee for solemnizing a marriage after normal working hours or on  
21 Saturdays or legal holidays. This paragraph does not prohibit a county clerk from charging and ac-  
22 cepting a personal payment for solemnizing a marriage if otherwise authorized by ORS 106.120.

23       (g) For taking and certifying acknowledgment or proof of execution of any instrument, the fee  
24 established in the schedule adopted by the Secretary of State under ORS 194.400.

25       (h) For issuing any license required by law, other than a marriage or liquor license, and for  
26 which no fee is otherwise provided by law, \$5.

27       (i) For any service the clerk may be required or authorized to perform and for which no fee is  
28 provided by law, such fees as may favorably compare with those established by this section for  
29 similar services and as may be established by order or rule of the county court or board of county  
30 commissioners.

31       (j) For recording any instrument under ORS 205.130 (2), as required by ordinance pursuant to  
32 ORS 203.148.

33       (k) In addition to and not in lieu of the fees charged under paragraph (d) of this subsection, for  
34 each additional municipal assessment lien recorded under ORS 93.643, \$5.

35       (L) In addition to and not in lieu of the fees charged under paragraph (d) of this subsection, for  
36 each additional assignment, release or satisfaction of any recorded instrument, \$5.

37       (m) In addition to and not in lieu of the fees charged under paragraph (d) of this subsection, for  
38 each additional transaction described under ORS 205.236, \$5.

39       (n) In addition to and not in lieu of the fees charged under paragraph (d) of this subsection, for  
40 each additional lien recorded under ORS 311.675, \$5.

41       (o) For preparing and recording the certificate under ORS 517.280, \$20 or such other fee that  
42 is established by the county governing body.

43       (p) In addition to and not in lieu of the fees charged under paragraph (d) of this subsection, for  
44 each additional claim listed on an affidavit of annual compliance under ORS 517.210, \$5.

45       (q) In addition to and not in lieu of the fees charged under paragraph (d) of this subsection, for

1 each additional name listed on a cooperative contract under ORS 62.360 (2) or for recording the  
2 termination of a cooperative contract under ORS 62.360 (4), \$5.

3 (2) Notwithstanding any other law, five percent of any fee or tax that is not collected for the  
4 benefit of the county clerk shall be deducted from the fee or tax. The moneys deducted shall be  
5 expended for acquiring storage and retrieval systems, payment of expenses incurred in collecting the  
6 fee or tax and maintaining and restoring records as authorized by the county clerk. Moneys col-

18 **APPEAL OF ARBITRATION DECISION AND AWARD**

19  
20 **SECTION 25.** ORS 36.425 is amended to read:

21 36.425. (1) At the conclusion of arbitration under ORS 36.400 to 36.425 of a civil action, the  
22 arbitrator shall file the decision and award with the clerk of the court that referred the action to  
23 arbitration, together with proof of service of a copy of the decision and award upon each party. If  
24 the decision and award require the payment of money, including payment of costs or attorney fees,  
25 the decision and award must be substantially in the form prescribed by ORS 18.042.

26 (2)(a) Within 20 days after the filing of a decision and award with the clerk of the court under  
27 subsection (1) of this section, a party against whom relief is granted by the decision and award or  
28 a party whose claim for relief was greater than the relief granted to the party by the decision and  
29 award, but no other party, may file with the clerk a written notice of appeal and request for a trial  
30 de novo of the action in the court on all issues of law and fact. A copy of the notice of appeal and  
31 request for a trial de novo must be served on all other parties to the proceeding. After the filing  
32 of the written notice a trial de novo of the action shall be held. If the action is triable by right to  
33 a jury and a jury is demanded by a party having the right of trial by jury, the trial de novo shall  
34 include a jury.

35 (b) If a party files a written notice under paragraph (a) of this subsection, a trial fee or jury trial  
36 fee, as applicable, shall be collected as provided in ORS 21.225.

37 (c) A party filing a written notice under paragraph (a) of this subsection shall deposit with the  
38 clerk of the court the sum of [~~\$150~~] **\$159**. If the position under the arbitration decision and award  
39 of the party filing the written notice is not improved as a result of a judgment in the action on the  
40 trial de novo, the clerk shall dispose of the sum deposited in the same manner as a fee collected by  
41 the clerk. If the position of the party is improved as a result of a judgment, the clerk shall return  
42 the sum deposited to the party. If the court finds that the party filing the written notice is then  
43 unable to pay all or any part of the sum to be deposited, the court may waive in whole or in part,  
44 defer in whole or in part, or both, the sum. If the sum or any part thereof is so deferred and the  
45 position of the party is not improved as a result of a judgment, the deferred amount shall be paid

1 by the party according to the terms of the deferral.

2 (3) If a written notice is not filed under subsection (2)(a) of this section within the 20 days pre-  
3 scribed, the court shall cause to be prepared and entered a judgment based on the arbitration de-  
4 cision and award. A judgment entered under this subsection may not be appealed.

5 (4) Notwithstanding any other provision of law or the Oregon Rules of Civil Procedure:

6 (a) If a party requests a trial de novo under the provisions of this section, the action is subject  
7 to arbitration under the provisions of ORS 36.405 (1)(a), the party is entitled to attorney fees by law  
8 or contract, and the position of the party is not improved after judgment on the trial de novo, the  
9 party shall not be entitled to an award of attorney fees or costs and disbursements incurred by the  
10 party before the filing of the decision and award of the arbitrator, and shall be taxed the reasonable  
11 attorney fees and costs and disbursements incurred by the other parties to the action on the trial  
12 de novo after the filing of the decision and award of the arbitrator.

13 (b) If a party requests a trial de novo under the provisions of this section, the action is subject  
14 to arbitration under ORS 36.405 (1)(a), the party is not entitled to attorney fees by law or contract,  
15 and the position of the party is not improved after judgment on the trial de novo, pursuant to sub-  
16 section (5) of this section the party shall be taxed the reasonable attorney fees and costs and dis-  
17 bursements of the other parties to the action on the trial de novo incurred by the other parties after  
18 the filing of the decision and award of the arbitrator.

19 (c) If a party requests a trial de novo under the provisions of this section, the action is subject  
20 to arbitration under ORS 36.405 (1)(b), and the position of the party is not improved after judgment  
21 on the trial de novo, the party shall not be entitled to an award of attorney fees or costs and dis-  
22 bursements and shall be taxed the costs and disbursements incurred by the other parties after the  
23 filing of the decision and award of the arbitrator.

24 (5) If a party is entitled to an award of attorney fees under subsection (4) of this section, but  
25 is also entitled to an award of attorney fees under contract or another provision of law, the court  
26 shall award reasonable attorney fees pursuant to the contract or other provision of law. If a party  
27 is entitled to an award of attorney fees solely by reason of subsection (4) of this section, the court  
28 shall award reasonable attorney fees not to exceed the following amounts:

29 (a) Twenty percent of the judgment, if the defendant requests the trial de novo but the position  
30 of the defendant is not improved after the trial de novo; or

31 (b) Ten percent of the amount claimed in the complaint, if the plaintiff requests the trial de novo  
32 but the position of the plaintiff is not improved after the trial de novo.

33 (6) Within seven days after the filing of a decision and award under subsection (1) of this sec-  
34 tion, a party may file with the court and serve on the other parties to the arbitration written ex-  
35 ceptions directed solely to the award or denial of attorney fees or costs. Exceptions under this  
36 subsection may be directed to the legal grounds for an award or denial of attorney fees or costs,  
37 or to the amount of the award. Any party opposing the exceptions must file a written response with  
38 the court and serve a copy of the response on the party filing the exceptions. Filing and service  
39 of the response must be made within seven days after the service of the exceptions on the re-  
40 sponding party. A judge of the court shall decide the issue and enter a decision on the award of  
41 attorney fees and costs. If the judge fails to enter a decision on the award within 20 days after the  
42 filing of the exceptions, the award of attorney fees and costs shall be considered affirmed. The filing  
43 of exceptions under this subsection does not constitute an appeal under subsection (2) of this section  
44 and does not affect the finality of the award in any way other than as specifically provided in this  
45 subsection.

1 (7) For the purpose of determining whether the position of a party has improved after a trial  
2 de novo under the provisions of this section, the court shall not consider any money award or other  
3 relief granted on claims asserted by amendments to the pleadings made after the filing of the deci-  
4 sion and award of the arbitrator.

10 **SECTION 27.** ORS 20.190 is amended to read:

11 20.190. (1) Except as provided in subsections (2) to (5) of this section, a prevailing party in a  
12 civil action or proceeding who has a right to recover costs and disbursements in the following cases  
13 also has a right to recover, as a part of the costs and disbursements, the following additional  
14 amounts:

15 (a) In the Supreme Court or Court of Appeals, on an appeal, \$100.

16 (b) In a circuit court:

17 (A) When judgment is given without trial of an issue of law or fact or on an appeal, \$85; or

18 (B) When judgment is given after trial of an issue of law or fact, \$105.

19 (c) In a small claims department, a county court or justice court:

20 (A) When judgment is given without trial of an issue of law or fact or on an appeal, \$50; or

21 (B) When judgment is given after trial of an issue of law or fact, \$60.

22 (2) In lieu of the prevailing party fee provided for in subsection (1) of this section, in any civil  
23 action or proceeding in which recovery of money or damages is sought, a prevailing party who has  
24 a right to recover costs and disbursements also has a right to recover, as a part of the costs and  
25 disbursements, the following additional amounts:

26 (a) In a circuit court:

27 (A) When judgment is given without trial of an issue of law or fact, [~~\$325~~] **\$345**; or

28 (B) When judgment is given after trial of an issue of law or fact, [~~\$600~~] **\$640**.

29 (b) In a small claims department, a county court or justice court:

30 (A) When judgment is given without trial of an issue of law or fact, [~~\$110~~] **\$117**; or

31 (B) When judgment is given after trial of an issue of law or fact, [~~\$125~~] **\$135**.

32 (3) In addition to the amounts provided for in subsection (2) of this section, in any civil action  
33 or proceeding in a circuit court in which recovery of money or damages is sought, the court may  
34 award to the prevailing party up to an additional \$5,000 as a prevailing party fee. The court shall  
35 consider the following factors in making an award under the provisions of this subsection:

36 (a) The conduct of the parties in the transactions or occurrences that gave rise to the litigation,  
37 including any conduct of a party that was reckless, willful, malicious, in bad faith or illegal.

38 (b) The objective reasonableness of the claims and defenses asserted by the parties.

39 (c) The extent to which an award of a larger prevailing party fee in the case would deter others  
40 from asserting good faith claims or defenses in similar cases.

41 (d) The extent to which an award of a larger prevailing party fee in the case would deter others  
42 from asserting meritless claims and defenses.

43 (e) The objective reasonableness of the parties and the diligence of the parties and their attor-  
44 neys during the proceedings.

45 (f) The objective reasonableness of the parties and the diligence of the parties in pursuing

1 settlement of the dispute.

2 (g) Any award of attorney fees made to the prevailing party as part of the judgment.

3 (h) Such other factors as the court may consider appropriate under the circumstances of the  
4 case.

5 (4) Nonprevailing parties are jointly liable for the prevailing party fees provided for in this  
6 section. A court may not award more than one prevailing party fee to a prevailing party under this  
7 section, or more than one prevailing party fee against a nonprevailing party regardless of the num-  
8 ber of parties in the action, and, upon being paid the amount of the award, the prevailing party may  
9 not seek recovery of any additional amounts under the provisions of this section from any other  
10 nonprevailing party.

11 (5) In any appeal from the award or denial of a prevailing party fee under subsection (2) of this  
12 section, the court reviewing the award may not modify the decision of the court in making or de-  
13 nying an award, or the decision of the court as to the amount of the award, except upon a finding  
14 of an abuse of discretion.

15 (6) The prevailing party fees provided for in this section may not be awarded in the following  
16 proceedings:

17 (a) A class action proceeding under ORCP 32.

18 (b) A condemnation proceeding.

19 (c) Proceedings under the provisions of ORS chapters 25, 107, 108, 109 and 110.

20 (7) Mandatory arbitration under ORS 36.400 to 36.425 does not constitute a trial of an issue of  
21 law or fact for the purposes of this section.

22 **SECTION 28. The amendments to ORS 20.190 by section 27 of this 2019 Act apply to**  
23 **actions commenced on or after October 1, 2019.**

33 **SECTION 30. This 2019 Act being necessary for the immediate preservation of the public**  
34 **peace, health and safety, an emergency is declared to exist, and this 2019 Act takes effect**  
35 **on its passage.**
