## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Authorizes school nurse associated with school-based health center to engage in practice of telehealth. Directs State Board of Education to adopt rules related to telehealth.]

Directs Oregon Health Authority to award grant moneys to eligible school-based health center pilot projects to expand access to health care services and improve health and education outcomes for students through telehealth. Defines "telehealth." Establishes eligibility criteria for pilot projects.

Directs authority to report to interim committee of Legislative Assembly on effectiveness and success of pilot projects not later than December 31, 2023.

Sunsets January 2, 2024.

Takes effect on 91st day following adjournment sine die.

## A BILL FOR AN ACT

2 Relating to school nurses; and prescribing an effective date.

**3 Be It Enacted by the People of the State of Oregon:** 

4 **<u>SECTION 1.</u>** (1) As used in this section:

5 (a) "Distant site" means the site where a physician licensed under ORS chapter 677, or

6 other licensed health care practitioner, who provides health care services through telehealth

7 is located at the time the physician or licensed health care practitioner provides the health

8 care service through telehealth.

9 (b) "Originating site" means the site where the patient is located at the time the patient 10 receives health care services provided through telehealth.

- 11 (c) "School-based health center" has the meaning given that term in ORS 413.225.
- 12 (d) "School nurse" means:

13 (A) A school nurse as defined in ORS 342.455; or

(B) A registered nurse who is an employee or contractor of a school district and who
 practices nursing in a school setting.

(e) "Telehealth" means the use of electronic and telecommunication technologies to de liver health care services to a patient.

18 (2)(a) The Oregon Health Authority shall award grant moneys to an eligible school-based

(5) The authority shall establish a process to evaluate at least the following information 28regarding a pilot project established under this section: 2930 (a) Billing practices and reimbursements; 31 (b) Access to health care services; 32(c) Impact on student absence from schools; and (d) Workflow practices. 33 34 (6) Not later than December 31, 2023, the authority shall submit a report, in the manner 35 provided in ORS 192.245, to an interim committee of the Legislative Assembly related to health care, on the effectiveness and success of pilot projects established under this section. 36 37 The authority may include in the report submitted under this subsection recommendations 38 for legislation. SECTION 2. There is appropriated to the Oregon Health Authority, for the biennium be-39 ginning July 1, 2019, out of the General Fund, the amount of \$950,000 for the purpose of 40 carrying out the provisions of section 1 of this 2019 Act. 41 SECTION 3. Section 1 of this 2019 Act is repealed on January 2, 2024. 42 SECTION 4. (1) Section 1 of this 2019 Act becomes operative on January 1, 2020. 43 (2) The Oregon Health Authority may take any action before the operative date specified 44 in subsection (1) of this section that is necessary to enable the authority to exercise, on and 45
