SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires investigations of all reports involving suspected abuse or suspected sexual conduct by school employees, contractors, agents and volunteers.

Establishes requirements for law enforcement agencies and Department of Human Services to conduct investigations related to reports of abuse that involve child and person who is school employee, contractor, agent or volunteer. Establishes requirements for Teacher Standards and Practices Commission to conduct investigations related to reports of suspected sexual conduct that may have been committed by school employee, contractor, agent or volunteer who is licensed by commission. Establishes requirements for Department of Education to conduct investigations related to reports of suspected sexual conduct that may have been committed by school employee, contractor, agent or volunteer who is not licensed by commission. Allows education provider to use findings of agencies when making employment determinations. Prescribes timelines for completing investigations and making employment determinations.

Revises definitions of terms of "education provider," "sexual conduct" and "student" for purposes of certain laws related to abuse and sexual conduct by school employees, contractors, agents and volunteers.

Prohibits individual who is school employee, contractor or agent from assisting other school employee, contractor or agent in obtaining new job if individual knows or has probable cause to believe school employee, contractor or agent engaged in abuse or sexual contact with student. Provides exceptions. Allows commission to discipline individual for any violations of prohibition.

Prohibits certain agreements or contracts that have effect of terminating or impairing ongoing investigations or of suppressing information relating to substantiated report of abuse or sexual conduct.

Directs Department of Human Services and law enforcement agencies that receive report of child abuse to notify Department of Education if alleged child abuse occurred in school or was related to school-sponsored activity.

Declares emergency, effective July 1, 2019.

A BILL FOR AN ACT

Be It Enacted by the People of the State of Oregon:

REQUIREMENTS FOR SCHOOL DISTRICTS

SECTION 1. ORS 339.370 is amended to read:

339.370. As used in ORS 339.370 to 339.400:

(1) "Abuse" has the meaning given that term in ORS 419B.005.

(2) "Agent" means a person acting as an agent for an education provider in a manner that requires the person to have direct, unsupervised contact with students.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

1 **(3) “Contractor” means a person providing services to an education provider under a**
2 **contract in a manner that requires the person to have direct, unsupervised contact with**
3 **students.**

4 [(2) “Disciplinary records” means the records related to a personnel discipline action or materials
5 or documents supporting that action.]

6 [(3)] **(4)(a) “Education provider” means:**

7 [(a)] **(A)** A school district, as defined in ORS 332.002.

8 [(b)] **(B)** The Oregon School for the Deaf.

9 [(c)] **(C)** An educational program under the Youth Corrections Education Program.

10 [(d)] **(D)** A public charter school, as defined in ORS 338.005.

11 [(e)] **(E)** An education service district, as defined in ORS 334.003.

12 [(f)] **(F)** Any state-operated program that provides educational services to [*kindergarten through*
13 *grade 12*] students.

14 [(g)] **(G)** A private school.

15 **(b) “Education provider” does not include:**

16 **(A) The Oregon Youth Authority;**

17 **(B) The Department of Corrections; or**

18 **(C) The Department of Education, except when functioning as an education provider on**
19 **behalf of:**

20 **(i) The Oregon School for the Deaf;**

21 **(ii) An educational program under the Youth Corrections Education Program; or**

22 **(iii) A public charter school, as defined in ORS 338.005, that is sponsored by the Depart-**
23 **ment of Education.**

24 [(4)] **(5) “Investigation” means a detailed inquiry into the factual allegations of a report of sus-**
25 **pected abuse or suspected sexual conduct that:**

26 (a) Is based on interviews with the [*complainant*] **person who initiated the report, the person**
27 **who may have been subjected to abuse or sexual conduct**, witnesses and the [*school employee*
28 *or student*] **person** who is the subject of the report; and

29 [(b) *If the subject of the report is a school employee, meets any negotiated standards of an em-*
30 *ployment contract or agreement.*]

31 **(b) Results in a finding that the report:**

32 **(A) Is a substantiated report;**

33 **(B) Cannot be substantiated; or**

34 **(C) Is not a report of abuse or sexual conduct.**

35 [(5)] **(6) “Law enforcement agency” has the meaning given that term in ORS 419B.005.**

36 **(7) “License” includes a license, registration or certificate issued by the Teacher Stan-**
37 **dards and Practices Commission.**

38 [(6)] **(8) “Private school” means a school that provides to [*kindergarten through grade 12*] stu-**
39 **dents instructional programs that are not limited solely to dancing, drama, music, religious or ath-**
40 **letic instruction.**

41 [(7) “School board” means the governing board or governing body of an education provider.]

42 **(9) “School board” means the entity charged with adopting policies for an education**
43 **provider.**

44 [(8)] **(10) “School employee” means an employee of an education provider.**

45 [(9)(a) “Sexual conduct” means any verbal or physical conduct by a school employee that:]

1 [(A) *Is sexual in nature;*]

2 [(B) *Is directed toward a kindergarten through grade 12 student;*]

3 [(C) *Has the effect of unreasonably interfering with a student's educational performance; and*]

4 [(D) *Creates an intimidating, hostile or offensive educational environment.*]

5 [(b) "Sexual conduct" does not include abuse.]

6 [(10) "Substantiated report" means a report of abuse or sexual conduct that:]

7 [(a) *An education provider has reasonable cause to believe is founded based on the available evi-*
8 *dence after conducting an investigation; and*]

9 [(b) *Involves conduct that the education provider determines is sufficiently serious to be documented*
10 *in the school employee's personnel file or the student's education record.*]

11 **(11)(a) "Sexual conduct" means verbal or physical conduct or verbal, written or elec-**
12 **tronic communications by a school employee, a contractor, an agent or a volunteer that in-**
13 **volve a student and that are:**

14 **(A) Sexual advances or requests for sexual favors directed toward the student; or**

15 **(B) Of a sexual nature that are directed toward the student or that have the effect of**
16 **unreasonably interfering with the student's educational performance, or of creating an in-**
17 **timidating, hostile or offensive educational environment.**

18 **(b) "Sexual conduct" does not include touching:**

19 **(A) That is necessitated by the nature of the school employee's job duties or by the ser-**
20 **vices required to be provided by the contractor, agent or volunteer; and**

21 **(B) For which there is no sexual intent.**

22 **(12) "Student" means any person:**

23 **(a) Who is:**

24 **(A) In any grade from prekindergarten through grade 12; or**

25 **(B) Twenty-one years of age or younger and receiving educational or related services**
26 **from an education provider that is not a post-secondary institution of education; or**

27 **(b) Who was previously known as a student by the person engaging in sexual conduct and**
28 **who left school or graduated from high school within 90 days prior to the sexual conduct.**

29 **(13) "Substantiated report" means a report of abuse or sexual conduct that a law**
30 **enforcement agency, the Department of Human Services, the Teacher Standards and Prac-**
31 **tices Commission, the Department of Education or an education provider has reasonable**
32 **cause to believe, based on the available evidence after conducting an investigation, is**
33 **founded.**

34 **(14) "Volunteer" means a person acting as a volunteer for an education provider in a**
35 **manner that requires the person to have direct, unsupervised contact with students.**

36 **SECTION 2. The amendments to ORS 339.370 by section 1 of this 2019 Act apply to con-**
37 **duct that occurs before, on or after the effective date of this 2019 Act for purposes of:**

38 **(1) Reports of suspected abuse or suspected sexual conduct that are made on or after the**
39 **effective date of this 2019 Act.**

40 **(2) Investigations of suspected abuse or suspected sexual conduct that are initiated on**
41 **or after the effective date of this 2019 Act.**

42 **(3) A collective bargaining agreement, an employment contract, an agreement for resig-**
43 **nation or termination, a severance agreement or any similar contract or agreement entered**
44 **into on or after the effective date of this 2019 Act.**

45 **SECTION 3. ORS 339.372 is amended to read:**

1 339.372. Each school board shall adopt policies on the reporting of **suspected** abuse and **sus-**
2 **pected** sexual conduct by school employees, **contractors, agents and volunteers** and the reporting
3 of **suspected** abuse by students. The policies shall:

4 (1) Specify that abuse and sexual conduct by school employees, **contractors, agents and vol-**
5 **unteers** and abuse by students are not tolerated[;].

6 (2) Specify that all school employees, **contractors, agents, volunteers** and students are subject
7 to the policies[;].

8 (3) Require all school employees who have reasonable cause to believe that another school em-
9 ployee **or a contractor, an agent or a volunteer** has engaged in abuse or sexual conduct or that
10 a student has engaged in abuse to **report**:

11 *[(a) Report suspected abuse to a law enforcement agency, the Department of Human Services or a*
12 *designee of the department as required by ORS 419B.010 and 419B.015; and]*

13 *[(b)] (a) [Report suspected abuse or sexual conduct to the person] To the licensed administrator*
14 *designated as provided by subsection (4) of this section all incidents of suspected abuse or sus-*
15 *pected sexual conduct; and*

16 **(b) To a law enforcement agency, the Department of Human Services or a designee of the**
17 **department as required by ORS 419B.010 and 419B.015 all incidents of suspected abuse, in**
18 **addition to any report made as required under paragraph (a) of this subsection.**

19 (4) Designate a *[person]* **licensed administrator**, and an alternate **licensed administrator** in
20 the event the designated *[person]* **licensed administrator** is the suspected abuser, to:

21 **(a) Receive reports of suspected abuse or suspected sexual conduct by school employees, con-**
22 **tractors, agents or volunteers** or suspected abuse by students and specify the procedures to be
23 followed by *[that person]* **the licensed administrator** upon receipt of a report; **and**

24 **(b) In the manner required by ORS 339.388 (2), inform the Teacher Standards and Prac-**
25 **tices Commission or the Department of Education of reports of suspected sexual conduct**
26 **received under paragraph (a) of this subsection.**

27 **(5) Specify the procedures to be followed after a report of suspected abuse or suspected**
28 **sexual conduct is received, including notification that:**

29 **(a) All suspected abuse or suspected sexual conduct by school employees, contractors,**
30 **agents or volunteers will be reported to a law enforcement agency or to a state agency, as**
31 **appropriate, for investigation;**

32 **(b) A law enforcement agency or a state agency will complete an investigation regardless**
33 **of any changes in the relationship or duties of the person about whom the report was made;**
34 **and**

35 **(c) An education provider will take necessary actions as provided by ORS 339.388 to en-**
36 **sure the student's safety after a report is received, including placing a school employee on**
37 **paid administrative leave pending an investigation or prohibiting a contractor, an agent or**
38 **a volunteer from providing services to the education provider.**

39 *[(5)] (6) Require the posting in each school building of:*

40 **(a) The name and contact information for the *[person]* licensed administrator and alternate**
41 **licensed administrator** designated for the school building to receive reports of suspected abuse or
42 **suspected sexual conduct by school employees, contractors, agents and volunteers** or suspected
43 abuse by students and the procedures the *[person]* **licensed administrator** will follow upon receipt
44 of a report; **and**

45 **(b) The contact information for making a report of suspected abuse to a law enforcement**

1 **agency, the Department of Human Services or a designee of the department as required by**
2 **ORS 419B.010 and 419B.015 and a statement that the duty to report abuse is in addition to**
3 **any requirement to make a report to a licensed administrator.**

4 [(6)] (7) Specify that the initiation of a report in good faith about suspected abuse or **suspected**
5 sexual conduct may not adversely affect any terms or conditions of employment or the work envi-
6 ronment of the [*complainant;*] **person who initiated the report or who may have been subjected**
7 **to abuse or sexual conduct.**

8 [(7)] (8) Specify that the [*school board*] **education provider** or any school employee, **contractor,**
9 **agent or volunteer** will not discipline a student for the initiation of a report in good faith about
10 suspected abuse or **suspected** sexual conduct by a school employee, **a contractor, an agent or a**
11 **volunteer** or suspected abuse by a student[;].

12 [(8)] (9) Require notification, **as allowed by state and federal law**, by the education provider
13 to the person who [*initiated the report*] **was subjected to the suspected abuse or suspected sexual**
14 **conduct** about **any** actions taken by the education provider based on the report[; *and*].

15 [(9)] (10) Require the education provider to furnish to a school employee at the time of hire,
16 **or to a contractor, an agent or a volunteer at the time of beginning service for the education**
17 **provider**, the following:

18 (a) A description of conduct that may constitute abuse or sexual conduct; [*and*]

19 (b) A description of the **investigatory process and possible consequences** [*information and*
20 *records that will be disclosed as provided by ORS 339.378 or 339.388 (8)*] if a report of suspected
21 abuse or **suspected** sexual conduct is substantiated[.]; **and**

22 (c) **A description of the prohibitions imposed on school employees, contractors and agents**
23 **when another school employee, contractor or agent attempts to obtain a new job, as provided**
24 **by ORS 339.378 (2).**

25 (11) **Specify and make available to students, school employees, contractors, agents and**
26 **volunteers a policy of appropriate electronic communications with students.**

27 **SECTION 4.** ORS 339.374 is amended to read:

28 339.374. (1) Except as provided in ORS 339.384, before an education provider may hire an ap-
29 plicant for a position with the education provider **as a school employee**, the education provider
30 shall:

31 [(1)] (a) Require the applicant to provide:

32 [(a)] (A) A list of the applicant's current and former employers who are education providers.

33 [(b)] (B) A written authorization that authorizes [*the applicant's current and former employers*
34 *that are*] education providers **identified in subparagraph (A) of this paragraph** to disclose the
35 information requested under [*subsection (2) of this section*] **paragraph (b) of this subsection.**

36 [(c)] (C) A written statement of whether the applicant:

37 [(A)] (i) Has been the subject of a substantiated report of abuse or sexual conduct; or

38 [(B)] (ii) Is the subject of an ongoing investigation related to a report of suspected abuse or
39 **suspected** sexual conduct.

40 [(2)] (b) Conduct a review of the employment history of the applicant **with education providers**
41 by contacting the three most recent [*employers of the applicant who are*] education providers **iden-**
42 **tified in paragraph (a)(A) of this subsection** and requesting **from each education provider:**

43 [(a) *The following information:*]

44 (A) The dates of employment of the applicant by the education provider[;].

45 (B) Whether the **education provider conducted an investigation and determined that the**

1 applicant was the subject of any substantiated reports of abuse or sexual conduct related to the
2 applicant's employment with the education provider[;] **and, if so, the following additional infor-**
3 **mation:**

4 [(C)] (i) The dates of any substantiated reports;

5 [(D)] (ii) The definitions of "abuse" and "sexual conduct" used by the education provider when
6 the education provider determined that any reports were substantiated; and

7 [(E)] (iii) The standards used by the education provider to determine whether any reports were
8 substantiated.

9 [(b) Any disciplinary records required to be released as provided by ORS 339.388 (8).]

10 [(3)] (c) For an applicant who is licensed[, *registered or certified*] with the Teacher Standards and
11 Practices Commission, [*access online information provided by*] **request** the commission to verify:

12 [(a)] (A) That the applicant is licensed[, *registered or certified*] by the commission; and

13 [(b)] (B) Whether the commission has [*provided any information*] **an ongoing investigation or**
14 **has a substantiated report** relating to conduct by the applicant that may constitute [*abuse or*]
15 sexual conduct.

16 (d) **For an applicant who is not licensed with the Teacher Standards and Practices Com-**
17 **mission, request the Department of Education to verify whether the department has an on-**
18 **going investigation or has a substantiated report relating to conduct by the applicant that**
19 **may constitute sexual conduct.**

20 [(4)] (e) Conduct a nationwide criminal records check if required by ORS 326.603.

21 (2) **Before an education provider may accept the services of a contractor, agent or vol-**
22 **unteer, the education provider shall:**

23 (a) **For a person who is licensed with the Teacher Standards and Practices Commission,**
24 **request the commission to verify whether the commission has an ongoing investigation or**
25 **has a substantiated report relating to conduct by the person that may constitute sexual**
26 **conduct.**

27 (b) **For a person who is not licensed with the Teacher Standards and Practices Commis-**
28 **sion, request the Department of Education to verify whether the department has an ongoing**
29 **investigation or has a substantiated report relating to conduct by the person that may con-**
30 **stitute sexual conduct.**

31 (c) **Conduct any background checks required under ORS 326.603, 326.604 or 326.607.**

32 **SECTION 5.** ORS 339.378 is amended to read:

33 339.378. (1)(a) Not later than 20 days after receiving a request under ORS 339.374 (1)(b), an
34 education provider that has or has had an employment relationship with the applicant shall disclose
35 the information requested [*and any disciplinary records that must be disclosed as provided by ORS*
36 *339.388 (8)*].

37 [(2)] (b) An education provider may disclose the information on a standardized form and is not
38 required to provide any additional information related to a substantiated report of abuse or sexual
39 conduct other than the information that is required by ORS 339.374 [(2)] (1)(b).

40 [(3)] (c) Information received under this section is confidential and is not a public record as
41 defined in ORS 192.311. An education provider may use the information only for the purpose of
42 evaluating an applicant's eligibility to be hired.

43 (2)(a) **Except as provided by paragraphs (b) and (c) of this subsection, an individual who**
44 **is a school employee, a contractor or an agent may not assist another school employee,**
45 **contractor or agent in obtaining any new job if the individual knows, or has reasonable cause**

1 to believe, that the school employee, contractor or agent engaged in abuse or sexual conduct.

2 (b) Nothing in paragraph (a) of this subsection prevents an education provider from:

3 (A) Disclosing the information described in subsection (1) of this section; or

4 (B) Providing the routine transmission of administrative and personnel files.

5 (c) The prohibition prescribed by paragraph (a) of this subsection does not apply if the
6 school employee, contractor or agent knows, or has reasonable cause to believe:

7 (A) That the suspected abuse or suspected sexual conduct was reported to a law
8 enforcement agency, the Department of Human Services, the Teacher Standards and Prac-
9 tices Commission or the Department of Education; and

10 (B) Any of the following are true:

11 (i) The report could be neither substantiated nor found to be unsubstantiated following
12 an investigation;

13 (ii) The report was found to be unsubstantiated;

14 (iii) The report was found to be a substantiated report; or

15 (iv) The investigation into the report remains ongoing after four years.

16 (3)(a) The commission may take disciplinary action against a licensed school employee for
17 failure to disclose information as required by subsection (1)(a) of this section. In determining
18 whether to take disciplinary action, the commission may take into consideration any evi-
19 dence presented by the school employee that a longer period of time was necessary for good
20 cause.

21 (b) Any violation of the provisions of subsection (2) of this section shall be considered
22 gross neglect of duty under ORS 342.175.

23 **SECTION 6.** ORS 339.384 is amended to read:

24 339.384. (1) An education provider may not hire an applicant [*who*] to be a school employee
25 if the applicant does not comply with the requirements of ORS 339.374 (1)(a). A refusal by the
26 education provider to hire an applicant under this subsection removes the applicant from any ed-
27 ucation provider policies, any collective bargaining provisions regarding dismissal procedures and
28 appeals and any provisions of ORS 342.805 to 342.937.

29 (2) An education provider may hire an applicant to be a school employee on a conditional basis
30 pending the education provider's review of information [*and records*] received under ORS 339.378
31 (1).

32 (3) An education provider may not deny an applicant employment solely because:

33 (a) [*A current or former employer of an applicant*] An education provider identified by the
34 applicant under ORS 339.374 (1)(a)(A) fails or refuses to comply with the requirements of ORS
35 339.378 (1); or

36 (b) [*The applicant has or had an out-of-state employer*] One or more education providers iden-
37 tified by the applicant under ORS 339.374 (1)(a)(A) are located in another state and the laws
38 or rules of that state prevent the release of information [*or records*] requested under ORS 339.378
39 (1).

40 **SECTION 7.** ORS 339.388 is amended to read:

41 339.388. [(1)(a) A school employee having reasonable cause to believe that a child with whom the
42 employee comes in contact has suffered abuse by another school employee or by a student, or that an-
43 other school employee or a student with whom the employee comes in contact has abused a child, shall
44 immediately report the information to:]

45 [(A) The person designated in the policy adopted under ORS 339.372; and]

1 *[(B) A law enforcement agency, the Department of Human Services or a designee of the department*
2 *as required by ORS 419B.010 and 419B.015.]*

3 *[(b) A school employee having reasonable cause to believe that a student with whom the employee*
4 *comes in contact has been subjected to sexual conduct by another school employee, or that another*
5 *school employee with whom the employee comes in contact has engaged in sexual conduct, shall im-*
6 *mediately report the information to the person designated in the policy adopted under ORS 339.372.]*

7 **(1)(a) A school employee shall immediately submit a report as provided by paragraph (b)**
8 **of this subsection if the school employee has reasonable cause to believe that:**

9 **(A) A student has been subjected to abuse by another school employee or by a contrac-**
10 **tor, an agent, a volunteer or a student;**

11 **(B) A student has been subjected to sexual conduct by another school employee or by a**
12 **contractor, an agent or a volunteer; or**

13 **(C) Another school employee or a contractor, an agent or a volunteer has engaged in**
14 **sexual conduct.**

15 **(b) The report required under paragraph (a) of this subsection shall be made to:**

16 **(A) The licensed administrator designated in the policies adopted under ORS 339.372, for**
17 **all reports of suspected abuse or suspected sexual conduct; and**

18 **(B) A law enforcement agency, the Department of Human Services or a designee of the**
19 **department as required by ORS 419B.010 and 419B.015, for all reports of suspected abuse.**

20 **(2) [A person] The licensed administrator** who receives a report under subsection (1) of this
21 section shall follow the procedures required by the *[policy]* **policies** adopted by the school board
22 under ORS 339.372, **including:**

24 **reports of suspected sexual conduct that may have been committed by a person who is li-**

35 *[(B) In the case of suspected sexual conduct, may place the school employee on paid administrative*

38 **(B) Take necessary actions to ensure the student's safety.**

40 **of this subsection shall remain on administrative leave until:**

41 *[(A) The Department of Human Services or a law enforcement agency determines that the report*
42 *cannot be substantiated or that the report will not be pursued; or]*

43 *[(B) The Department of Human Services or a law enforcement agency determines that the report*
44 *is substantiated and the education provider takes the appropriate disciplinary action against the school*
45 *employee.]*

1 (A) For a report of suspected abuse, a law enforcement agency or the Department of
2 Human Services determines that the report:

3 (i) Is substantiated and the education provider takes the appropriate employment action
4 against the school employee; or

5 (ii) Cannot be substantiated or is not a report of abuse and the education provider:

6 (I) Determines that an employment policy has been violated and takes appropriate em-
7 ployment action against the school employee; or

8 (II) Determines that an employment policy has not been violated and employment action
9 against the school employee is not required.

10 (B) For a report of suspected sexual conduct, the Teacher Standards and Practices
11 Commission or the Department of Education determines that the report:

12 (i) Is substantiated and the education provider takes the appropriate employment action
13 against the school employee; or

14 (ii) Cannot be substantiated or is not a report of sexual conduct and the education pro-
15 vider:

16 (I) Determines that an employment policy has been violated and takes appropriate em-
17 ployment action against the school employee; or

18 (II) Determines that an employment policy has not been violated and that employment
19 action against the school employee is not required.

20 *[(4) An education provider may reinstate a school employee placed on paid administrative leave for
21 suspected abuse as provided under subsection (3) of this section or may take the appropriate discipli-
22 nary action against the employee if the Department of Human Services or a law enforcement agency is
23 unable to determine, based on a report of suspected abuse, whether abuse occurred.]*

24 (c) When a school employee is placed on paid administrative leave under paragraph (a)
25 of this subsection, the education provider may not require the school employee to use any
26 accrued leave during the paid administrative leave.

27 (4)(a) Except as provided in paragraph (c) of this subsection, when a licensed adminis-
28 trator receives a report of suspected abuse or suspected sexual conduct by a contractor, an
29 agent or a volunteer, the education provider:

30 (A) May immediately prohibit the contractor, agent or volunteer from providing services
31 to the education provider.

32 (B) Shall prohibit the contractor, agent or volunteer from providing services to the edu-
33 cation provider if the education provider determines that there is reasonable cause to sup-

4 (ii) Cannot be substantiated or is not a report of sexual conduct and the education pro-
5 vider:

6 (I) Takes the appropriate actions to protect students; or

7 (II) Determines that no other actions are required to protect students.

8 (c) If a contract under which a contractor provides services to an education provider or
9 an agreement under which an agent provides services to an education provider sets forth any
10 negotiated standards for the relationship between the contractor or agent and the education
11 provider, the education provider shall comply with those standards but may not in any in-
12 stance grant the contractor or agent more rights than granted to a school employee under
13 subsection (3) of this section.

14 (d) Nothing in this subsection:

15 (A) Establishes an employment relationship between an education provider and a con-
16 tractor or an agent; or

17 (B) Confers onto a contractor or an agent any rights of employment.

18 (5)(a) When a report of suspected abuse or suspected sexual conduct is investigated by
19 a law enforcement agency, the Department of Human Services, the Teacher Standards and
20 Practices Commission or the Department of Education, an education provider may use the
21 findings of the entity that conducted the investigation for the purpose of subsection (3) or
22 (4) of this section and for making any determinations described in subsection (6) of this

24 (b) Nothing in this subsection prohibits an education provider from:

25 (A) Conducting an investigation related to a report of suspected abuse or suspected sex-

41 (A) An employment policy of the education provider was violated; and

42 (B) The education provider will take any employment actions, including disciplinary
43 action against the school employee or changes to the employment relationship or duties of
44 the school employee.

45 (b) Determinations made under paragraph (a) of this subsection must be based on the

1 findings of an investigation conducted by:

2 (A) A law enforcement agency, the Department of Human Services, the Teacher Stan-
3 dards and Practices Commission or the Department of Education; or

4 (B) The education provider, if the education provider conducts an investigation.

5 (c) A final determination by a law enforcement agency, the Department of Human Ser-
6 vices, the Teacher Standards and Practices Commission or the Department of Education that
7 a report of suspected abuse or suspected sexual conduct cannot be substantiated or is not a
8 report of abuse or sexual conduct does not:

9 (A) Relieve an education provider of the requirement to make determinations under
10 paragraph (a) of this subsection; or

11 (B) Prohibit an education provider from taking any employment actions against a school
12 employee.

13 (d) Except as provided by paragraph (e) of this subsection, determinations made under
14 paragraph (a) of this subsection must be made:

15 (A) Within 60 calendar days from the date the education provider received from a law
16 enforcement agency, the Department of Human Services, the Teacher Standards and Prac-
17 tices Commission or the Department of Education a final determination that a report of
18 suspected abuse or suspected sexual conduct involving a school employee is a substantiated
19 report; or

20 (B) Within 90 calendar days from the date the education provider:

21 (i) Received from a law enforcement agency, the Department of Human Services, the
22 Teacher Standards and Practices Commission or the Department of Education a final deter-
23 mination that a report of suspected abuse or suspected sexual conduct involving a school
24 employee cannot be substantiated or is not a report of abuse or sexual conduct; or

25 (ii) Received a report of suspected abuse or suspected sexual conduct if the education
26 provider conducts an investigation.

27 (e) The timelines prescribed by paragraph (d) of this subsection may be extended if, for

44 **SECTION 13. Section 14 of this 2019 Act is added to and made a part of ORS 419B.005 to**
45 **419B.050.**

SECTION 14. (1) As used in this section:

(a) "Agent" means a person who:

(A) Acts as an agent for an education provider in a manner that requires the person to have direct, unsupervised contact with children; and

(B) Interacts with a child because of the person's status as an agent for an education provider.

(b) "Contractor" means a person who:

(A) Provides services to an education provider under a contract in a manner that requires the person to have direct, unsupervised contact with children; and

(B) Interacts with a child because of the person's status as a contractor for an education provider.

(c) "Education provider" has the meaning given that term in ORS 339.370.

(d) "School employee" means a person who:

(A) Is an employee of an education provider; and

(B) Interacts with a child because of the person's status as an employee of an education provider.

(e) "Volunteer" means a person who:

(A) Acts as a volunteer for an education provider in a manner that requires the person to have direct, unsupervised contact with children; and

(B) Interacts with a child because of the person's status as a volunteer of an education provider.

(2) A law enforcement agency or the Department of Human Services must conduct an investigation as provided by ORS 419B.020 if the law enforcement agency or department receives a report of abuse that involves a child and a person who is a school employee, contractor, agent or volunteer.

(3) A law enforcement agency shall notify the department as provided by ORS 419B.015 if the law enforcement agency receives a report described in subsection (2) of this section. The department shall notify a law enforcement agency as provided by ORS 419B.015 if the department receives a report described in subsection (2) of this section. The department shall ensure that an investigation related to the report is conducted if the report is not investigated by a law enforcement agency.

(4)(a) Within three business days of receiving a report or notification of a report described in subsection (2) of this section, the department shall notify:

(A) The Teacher Standards and Practices Commission, if the department believes the school employee, contractor, agent or volunteer is licensed or registered by the commission; or

(B) The Department of Education, if the Department of Human Services believes the report of suspected abuse:

(i) Occurred in a school or was related to a school-sponsored activity; or

(ii) Involves a child and a person who is a school employee, contractor, agent or volunteer.

(b) For the purpose of notification made under this subsection, the Department of Human Services may not disclose the name and address of, and other identifying information about, the person who made the report, but the department shall make available any information necessary to ensure the safety of the child, including the name of the school and the name

1 **of the person who may have conducted the suspected abuse. Any person or entity to whom**
2 **notification is made under this subsection may not release any information not authorized**
3 **by this subsection.**

4 **(c) When the Department of Education receives notification under this subsection, the**
5 **department shall immediately notify the appropriate education providers to ensure the safety**

17 of the child's mental or psychological ability to function caused by cruelty to the child, with due
18 regard to the culture of the child.

19 (C) Rape of a child, which includes but is not limited to rape, sodomy, unlawful sexual pene-
20 tration and incest, as those acts are described in ORS chapter 163.

21 (D) Sexual abuse, as described in ORS chapter 163.

22 (E) Sexual exploitation, including but not limited to:

23 (i) Contributing to the sexual delinquency of a minor, as defined in ORS chapter 163, and any
24 other conduct which allows, employs, authorizes, permits, induces or encourages a child to engage
25 in the performing for people to observe or the photographing, filming, tape recording or other ex-
26 hibition which, in whole or in part, depicts sexual conduct or contact, as defined in ORS 167.002 or
27 described in ORS 163.665 and 163.670, sexual abuse involving a child or rape of a child, but not in-

37 to the child's health or welfare.

38 (H) Buying or selling a person under 18 years of age as described in ORS 163.537.

41 (J) Unlawful exposure to a controlled substance, as defined in ORS 475.005, or to the unlawful

4 **SECTION 22.** Section 23 of this 2019 Act is added to and made a part of ORS 339.370 to

6 **SECTION 23.** (1)(a) When the Teacher Standards and Practices Commission receives a
7 report of suspected sexual conduct that may have been committed by a licensed school em-
8 ployee, contractor, agent or volunteer, the commission shall immediately initiate an investi-
9 gation.

10 (b) An investigation and final determination related to a report received under paragraph
11 (a) of this subsection must be completed and notification of the final determination must be
12 made to the education provider within 90 calendar days following the date on which the re-

2 **(7)(a) Except as provided in paragraph (b) of this subsection, the documents and materi-**

4 **investigation, are confidential and not subject to public inspection unless the commission**
5 **makes a final determination to suspend or revoke a license, discipline a person holding a li-**
6 **cence or revoke the right to apply for a license, as provided under ORS 342.175.**

7 **(b) To the extent allowed by state and federal law, the commission shall make available**
8 **any documents, materials and reports to:**

9 **(A) A law enforcement agency or the Department of Human Services for the purpose of**
10 **conducting an investigation under ORS 419B.005 to 419B.050;**

11 **(B) The Department of Education for the purpose of conducting an investigation under**
12 **section 32 of this 2019 Act; or**

13 **(C) An education provider for the purpose of taking any disciplinary actions or making**
14 **changes in the employment relationship or duties of the school employee, contractor, agent**

16 **(c) The commission shall retain documents and materials related to any report received**

3 sexual conduct that may have been committed by a school employee, contractor, agent or
4 volunteer that is not licensed with the Teacher Standards and Practices Commission, the
