<u>SECTION 21c.</u> Notwithstanding any other law limiting expenditures, the limitation on
expenditures established by section 3 (1), chapter ____, Oregon Laws 2019 (Enrolled House Bill
5026), for the biennium beginning July 1, 2019, as the maximum limit for payment of expenses
from federal funds, excluding federal funds described in section 2, chapter ____, Oregon Laws
2019 (Enrolled House Bill 5026), collected or received by the Department of Human Services,
for central services and state assessments and enterprise-wide costs, is increased by \$392,329
for the purpose of complying with the requirements of this 2019 Act.".

²⁸ "<u>SECTION 30.</u> Notwithstanding any other law limiting expenditures, the limitation on ²⁹ expenditures established by section 1, chapter ____, Oregon Laws 2019 (Enrolled Senate Bill ³⁰ 5537), for the biennium beginning July 1, 2019, as the maximum limit for payment of expenses ³¹ from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery ³² funds and federal funds, collected or received by the Teacher Standards and Practices Com-³³ mission, is increased by \$525,000 for the purpose of complying with the requirements of sec-³⁴ tion 23 of this 2019 Act.".
