“REQUIREMENTS FOR SCHOOL DISTRICTS

8 “**SECTION 1.** ORS 339.370 is amended to read:

9 “339.370. As used in ORS 339.370 to 339.400:

10 “(1) ‘Abuse’ has the meaning given that term in ORS 419B.005.

11 “(2) ‘Agent’ means a person acting as an agent for an education provider in a manner
12 that requires the person to have direct, unsupervised contact with students.

13 “(3) ‘Contractor’ means a person providing services to an education provider under a
14 contract in a manner that requires the person to have direct, unsupervised contact with
15 students.

16 “[2] *‘Disciplinary records’ means the records related to a personnel discipline action or materials*
17 *or documents supporting that action.*]

18 “[3] (4)(a) ‘Education provider’ means:

19 “[a] (A) A school district, as defined in ORS 332.002.

20 “[b] (B) The Oregon School for the Deaf.

21 “[c] (C) An educational program under the Youth Corrections Education Program.

22 “[d] (D) A public charter school, as defined in ORS 338.005.

23 “[e] (E) An education service district, as defined in ORS 334.003.

24 “[f] (F) Any state-operated program that provides educational services to [*kindergarten through*
25 *grade 12*] students.

26 “[g] (G) A private school.

27 “(b) ‘Education provider’ does not include:

28 “(A) The Oregon Youth Authority;

29 “(B) The Department of Corrections; or

30 “(C) The Department of Education, except when functioning as an education provider on
31 behalf of:

32 “(i) The Oregon School for the Deaf;

33 “(ii) An educational program under the Youth Corrections Education Program; or

34 “(iii) A public charter school, as defined in ORS 338.005, that is sponsored by the De-
35 partment of Education.

1 “[(4)] (5) ‘Investigation’ means a detailed inquiry into the factual allegations of a report of sus-
2 pected abuse or **suspected** sexual conduct that:

3 “(a) Is based on interviews with the [*complainant*] **person who initiated the report, the person**
4 **who may have been subjected to abuse or sexual conduct**, witnesses and the [*school employee*
5 *or student*] **person** who is the subject of the report; and

6 “[*(b) If the subject of the report is a school employee, meets any negotiated standards of an em-*
7 *ployment contract or agreement.*]

8 “(b) **Results in a finding that the report:**

9 “(A) **Is a substantiated report;**

10 “(B) **Cannot be substantiated; or**

11 “(C) **Is not a report of abuse or sexual conduct.**

12 “[*(5)*] (6) ‘Law enforcement agency’ has the meaning given that term in ORS 419B.005.

13 “(7) **‘License’ includes a license, registration or certificate issued by the Teacher Stan-**
14 **dards and Practices Commission.**

15 “[*(6)*] (8) ‘Private school’ means a school that provides to [*kindergarten through grade 12*] stu-
16 dents instructional programs that are not limited solely to dancing, drama, music, religious or ath-
17 letic instruction.

18 “[*(7)*] ‘School board’ means the governing board or governing body of an education provider.]

19 “(9) **‘School board’ means the entity charged with adopting policies for an education**
20 **provider.**

21 “[*(8)*] (10) ‘School employee’ means an employee of an education provider.

22 “[*(9)(a)*] ‘Sexual conduct’ means any verbal or physical conduct by a school employee that:]

23 “[*(A)*] *Is sexual in nature;*]

24 “[*(B)*] *Is directed toward a kindergarten through grade 12 student;*]

25 “[*(C)*] *Has the effect of unreasonably interfering with a student’s educational performance; and]*

26 “[*(D)*] *Creates an intimidating, hostile or offensive educational environment.*]

27 “[*(b)*] ‘Sexual conduct’ does not include abuse.]

28 “[*(10)*] ‘Substantiated report’ means a report of abuse or sexual conduct that:]

29 “[*(a)*] *An education provider has reasonable cause to believe is founded based on the available ev-*
30 *idence after conducting an investigation; and]*

31 “[*(b)*] *Involves conduct that the education provider determines is sufficiently serious to be docu-*
32 *mented in the school employee’s personnel file or the student’s education record.*]

33 “(11)(a) **‘Sexual conduct’ means verbal or physical conduct or verbal, written or elec-**
34 **tronic communications by a school employee, a contractor, an agent or a volunteer that in-**
35 **volve a student and that are:**

36 “(A) **Sexual advances or requests for sexual favors directed toward the student; or**

37 “(B) **Of a sexual nature that are directed toward the student or that have the effect of**
38 **unreasonably interfering with the student’s educational performance, or of creating an in-**
39 **timidating, hostile or offensive educational environment.**

40 “(b) **‘Sexual conduct’ does not include touching:**

41 “(A) **That is necessitated by the nature of the school employee’s job duties or by the**
42 **services required to be provided by the contractor, agent or volunteer; and**

43 “(B) **For which there is no sexual intent.**

44 “(12) **‘Student’ means any person:**

45 “(a) **Who is:**

1 “(A) In any grade from prekindergarten through grade 12; or
2 “(B) Twenty-one years of age or younger and receiving educational or related services
3 from an education provider that is not a post-secondary institution of education; or
4 “(b) Who was previously known as a student by the person engaging in sexual conduct
5 and who left school or graduated from high school within 90 days prior to the sexual conduct.
6 “(13) ‘Substantiated report’ means a report of abuse or sexual conduct that a law
7 enforcement agency, the Department of Human Services, the Teacher Standards and Prac-
8 tices Commission, the Department of Education or an education provider has reasonable
9 cause to believe, based on the available evidence after conducting an investigation, is
10 founded.
11 “(14) ‘Volunteer’ means a person acting as a volunteer for an education provider in a
12 manner that requires the person to have direct, unsupervised contact with students.
13 “**SECTION 2.** The amendments to ORS 339.370 by section 1 of this 2019 Act apply to
14 conduct that occurs before, on or after the effective date of this 2019 Act for purposes of:
15 “(1) Reports of suspected abuse or suspected sexual conduct that are made on or after
16 the effective date of this 2019 Act.
17 “(2) Investigations of suspected abuse or suspected sexual conduct that are initiated on
18 or after the effective date of this 2019 Act.
19 “(3) A collective bargaining agreement, an employment contract, an agreement for res-
20 ignation or termination, a severance agreement or any similar contract or agreement en-
21 tered into on or after the effective date of this 2019 Act.
22 “**SECTION 3.** ORS 339.372 is amended to read:
23 “339.372. Each school board shall adopt policies on the reporting of **suspected** abuse and **sus-**
24 **pected** sexual conduct by school employees, **contractors, agents and volunteers** and the reporting
25 of **suspected** abuse by students. The policies shall:
26 “(1) Specify that abuse and sexual conduct by school employees, **contractors, agents and vol-**
27 **unteers** and abuse by students are not tolerated[;].
28 “(2) Specify that all school employees, **contractors, agents, volunteers** and students are sub-
29 ject to the policies[;].
30 “(3) Require all school employees who have reasonable cause to believe that another school
31 employee **or a contractor, an agent or a volunteer** has engaged in abuse or sexual conduct or
32 that a student has engaged in abuse to **report**:
33 “[(a) Report suspected abuse to a law enforcement agency, the Department of Human Services or
34 a designee of the department as required by ORS 419B.010 and 419B.015; and]
35 “[(b)] (a) [Report suspected abuse or sexual [conduct to the person] **To the licensed administrator**
36 designated as provided by subsection (4) of this section **all incidents of suspected abuse or sus-**
37 **pected sexual conduct; and**
38 “(b) **To a law enforcement agency, the Department of Human Services or a designee of**
39 **the department as required by ORS 419B.010 and 419B.015 all incidents of suspected abuse,**
40 **in addition to any report made as required under paragraph (a) of this subsection.**
41 “(4) Designate a [person] **licensed administrator**, and an alternate **licensed administrator** in
42 the event the designated [person] **licensed administrator** is the suspected abuser, to:
43 “(a) Receive reports of suspected abuse or **suspected** sexual conduct by school employees,
44 **contractors, agents or volunteers** or suspected abuse by students and specify the procedures to
45 be followed by [that person] **the licensed administrator** upon receipt of a report; **and**

1 “(b) In the manner required by ORS 339.388 (2), inform the Teacher Standards and
2 Practices Commission or the Department of Education of reports of suspected sexual con-
3 duct received under paragraph (a) of this subsection.

4 “(5) Specify the procedures to be followed after a report of suspected abuse or suspected
5 sexual conduct is received, including notification that:

6 “(a) All suspected abuse or suspected sexual conduct by school employees, contractors,
7 agents or volunteers will be reported to a law enforcement agency or to a state agency, as
8 appropriate, for investigation;

9 “(b) A law enforcement agency or a state agency will complete an investigation regard-
10 less of any changes in the relationship or duties of the person about whom the report was
11 made; and

12 “(c) An education provider will take necessary actions as provided by ORS 339.388 to en-
13 sure the student’s safety after a report is received, including placing a school employee on
14 paid administrative leave pending an investigation or prohibiting a contractor, an agent or
15 a volunteer from providing services to the education provider.

16 “[(5)] (6) Require the posting in each school building of:

17 “(a) The name and contact information for the [*person*] **licensed administrator and alternate**
18 **licensed administrator** designated for the school building to receive reports of suspected abuse or
19 **suspected** sexual conduct by school employees, **contractors, agents and volunteers** or suspected
20 abuse by students and the procedures the [*person*] **licensed administrator** will follow upon receipt
21 of a report; **and**

22 “(b) **The contact information for making a report of suspected abuse to a law enforce-**
23 **ment agency, the Department of Human Services or a designee of the department as re-**
24 **quired by ORS 419B.010 and 419B.015 and a statement that the duty to report abuse is in**
25 **addition to any requirement to make a report to a licensed administrator.**

26 “[(6)] (7) Specify that the initiation of a report in good faith about suspected abuse or **suspected**
27 sexual conduct may not adversely affect any terms or conditions of employment or the work envi-
28 ronment of the [*complainant*]; **person who initiated the report or who may have been subjected**
29 **to abuse or sexual conduct.**

30 “[(7)] (8) Specify that the [*school board*] **education provider** or any school employee, **contrac-**
31 **tor, agent or volunteer** will not discipline a student for the initiation of a report in good faith
32 about suspected abuse or **suspected** sexual conduct by a school employee, **a contractor, an agent**
33 **or a volunteer** or suspected abuse by a student[;].

34 “[(8)] (9) Require notification, **as allowed by state and federal law**, by the education provider
35 to the person who [*initiated the report*] **was subjected to the suspected abuse or suspected sexual**
36 **conduct about any actions taken by the education provider based on the report[; and].**

37 “[(9)] (10) Require the education provider to furnish to a school employee at the time of hire,
38 **or to a contractor, an agent or a volunteer at the time of beginning service for the education**
39 **provider**, the following:

40 “(a) A description of conduct that may constitute abuse or sexual conduct; [*and*]

41 “(b) A description of the **investigatory process and possible consequences** [*information and*
42 *records that will be disclosed as provided by ORS 339.378 or 339.388 (8)*] if a report of suspected
43 abuse or **suspected** sexual conduct is substantiated[.]; **and**

44 “(c) **A description of the prohibitions imposed on school employees, contractors and**
45 **agents when another school employee, contractor or agent attempts to obtain a new job, as**

1 provided by ORS 339.378 (2).

2 **“(11) Specify and make available to students, school employees, contractors, agents and**
3 **volunteers a policy of appropriate electronic communications with students.**

4 **“SECTION 4.** ORS 339.374 is amended to read:

5 **“339.374. (1)** Except as provided in ORS 339.384, before an education provider may hire an ap-
6 plicant for a position with the education provider **as a school employee**, the education provider
7 shall:

8 **“[(1)] (a)** Require the applicant to provide:

9 **“[(a)] (A)** A list of the applicant’s current and former employers who are education providers.

10 **“[(b)] (B)** A written authorization that authorizes [*the applicant’s current and former employers*
11 *that are*] education providers **identified in subparagraph (A) of this paragraph** to disclose the
12 information requested under [*subsection (2) of this section*] **paragraph (b) of this subsection.**

13 **“[(c)] (C)** A written statement of whether the applicant:

14 **“[(A)] (i)** Has been the subject of a substantiated report of abuse or sexual conduct; or

15 **“[(B)] (ii)** Is the subject of an ongoing investigation related to a report of suspected abuse or
16 **suspected** sexual conduct.

17 **“[(2)] (b)** Conduct a review of the employment history of the applicant **with education provid-**
18 **ers** by contacting the three most recent [*employers of the applicant who are*] education providers
19 **identified in paragraph (a)(A) of this subsection** and requesting **from each education**
20 **provider:**

21 **“[(a)]** *The following information:*

22 **“(A)** The dates of employment of the applicant by the education provider[;].

23 **“(B)** Whether the **education provider conducted an investigation and determined that the**
24 applicant was the subject of any substantiated reports of abuse or sexual conduct related to the
25 applicant’s employment with the education provider[;] **and, if so, the following additional infor-**
26 **mation:**

27 **“[(C)] (i)** The dates of any substantiated reports;

28 **“[(D)] (ii)** The definitions of ‘abuse’ and ‘sexual conduct’ used by the education provider when
29 the education provider determined that any reports were substantiated; and

30 **“[(E)] (iii)** The standards used by the education provider to determine whether any reports were
31 substantiated.

32 **“[(b)]** *Any disciplinary records required to be released as provided by ORS 339.388 (8).*

33 **“[(3)] (c)** For an applicant who is licensed[, *registered or certified*] with the Teacher Standards
34 and Practices Commission, [*access online information provided by*] **request** the commission to verify:

35 **“[(a)] (A)** That the applicant is licensed[, *registered or certified*] by the commission; and

36 **“[(b)] (B)** Whether the commission has [*provided any information*] **an ongoing investigation or**
37 **has a substantiated report** relating to conduct by the applicant that may constitute [*abuse or*]
38 sexual conduct.

39 **“(d) For an applicant who is not licensed with the Teacher Standards and Practices**
40 **Commission, request the Department of Education to verify whether the department has an**
41 **ongoing investigation or has a substantiated report relating to conduct by the applicant that**
42 **may constitute sexual conduct.**

43 **“[(4)] (e)** Conduct a nationwide criminal records check if required by ORS 326.603.

44 **“(2) Before an education provider may accept the services of a contractor, agent or vol-**
45 **unteer, the education provider shall:**

1 “(a) For a person who is licensed with the Teacher Standards and Practices Commission,
2 request the commission to verify whether the commission has an ongoing investigation or
3 has a substantiated report relating to conduct by the person that may constitute sexual
4 conduct.

5 “(b) For a person who is not licensed with the Teacher Standards and Practices Com-
6 mission, request the Department of Education to verify whether the department has an on-
7 going investigation or has a substantiated report relating to conduct by the person that may
8 constitute sexual conduct.

9 “(c) Conduct any background checks required under ORS 326.603, 326.604 or 326.607.

10 “**SECTION 5.** ORS 339.378 is amended to read:

11 “339.378. (1)(a) Not later than 20 days after receiving a request under ORS 339.374 (1)(b), an
12 education provider that has or has had an employment relationship with the applicant shall disclose
13 the information requested [*and any disciplinary records that must be disclosed as provided by ORS*
14 *339.388 (8)*].

15 “[(2)] (b) An education provider may disclose the information on a standardized form and is not
16 required to provide any additional information related to a substantiated report of abuse or sexual
17 conduct other than the information that is required by ORS 339.374 [(2)] (1)(b).

18 “[(3)] (c) Information received under this section is confidential and is not a public record as
19 defined in ORS 192.311. An education provider may use the information only for the purpose of
20 evaluating an applicant’s eligibility to be hired.

21 “(2)(a) Except as provided by paragraphs (b) and (c) of this subsection, an individual who
22 is a school employee, a contractor or an agent may not assist another school employee,
23 contractor or agent in obtaining any new job if the individual knows, or has reasonable cause
24 to believe, that the school employee, contractor or agent engaged in abuse or sexual conduct.

25 “(b) Nothing in paragraph (a) of this subsection prevents an education provider from:

26 “(A) Disclosing the information described in subsection (1) of this section; or

27 “(B) Providing the routine transmission of administrative and personnel files.

28 “(c) The prohibition prescribed by paragraph (a) of this subsection does not apply if the
29 school employee, contractor or agent knows, or has reasonable cause to believe:

30 “(A) That the suspected abuse or suspected sexual conduct was reported to a law
31 enforcement agency, the Department of Human Services, the Teacher Standards and Prac-
32 tices Commission or the Department of Education; and

33 “(B) Any of the following are true:

34 “(i) The report could be neither substantiated nor found to be unsubstantiated following
35 an investigation;

36 “(ii) The report was found to be unsubstantiated;

37 “(iii) The report was found to be a substantiated report; or

38 “(iv) The investigation into the report remains ongoing after four years.

39 “(3)(a) The commission may take disciplinary action against a licensed school employee
40 for failure to disclose information as required by subsection (1)(a) of this section. In deter-
41 mining whether to take disciplinary action, the commission may take into consideration any
42 evidence presented by the school employee that a longer period of time was necessary for
43 good cause.

44 “(b) Any violation of the provisions of subsection (2) of this section shall be considered
45 gross neglect of duty under ORS 342.175.

1 “**SECTION 6.** ORS 339.384 is amended to read:

2 “339.384. (1) An education provider may not hire an applicant [*who*] **to be a school employee**
3 **if the applicant** does not comply with the requirements of ORS 339.374 (1)(a). A refusal **by the**
4 **education provider** to hire an applicant under this subsection removes the applicant from any ed-
5 ucation provider policies, any collective bargaining provisions regarding dismissal procedures and
6 appeals and any provisions of ORS 342.805 to 342.937.

7 “(2) An education provider may hire an applicant **to be a school employee** on a conditional
8 basis pending the education provider’s review of information [*and records*] received under ORS
9 339.378 (1).

10 “(3) An education provider may not deny an applicant employment solely because:

11 “(a) [*A current or former employer of an applicant*] **An education provider identified by the**
12 **applicant under ORS 339.374 (1)(a)(A)** fails or refuses to comply with the requirements of ORS
13 339.378 (1); or

14 “(b) [*The applicant has or had an out-of-state employer*] **One or more education providers**
15 **identified by the applicant under ORS 339.374 (1)(a)(A) are located in another state** and the
16 laws or rules of that state prevent the release of information [*or records*] requested under ORS
17 339.378 (1).

18 “**SECTION 7.** ORS 339.388 is amended to read:

19 “339.388. [(1)(a) *A school employee having reasonable cause to believe that a child with whom the*
20 *employee comes in contact has suffered abuse by another school employee or by a student, or that an-*
21 *other school employee or a student with whom the employee comes in contact has abused a child, shall*
22 *immediately report the information to:*]

23 “[(A) *The person designated in the policy adopted under ORS 339.372; and*]

24 “[(B) *A law enforcement agency, the Department of Human Services or a designee of the depart-*
25 *ment as required by ORS 419B.010 and 419B.015.*]

26 “[(b) *A school employee having reasonable cause to believe that a student with whom the employee*
27 *comes in contact has been subjected to sexual conduct by another school employee, or that another*
28 *school employee with whom the employee comes in contact has engaged in sexual conduct, shall im-*
29 *mediately report the information to the person designated in the policy adopted under ORS 339.372.*]

30 “(1)(a) **A school employee shall immediately submit a report as provided by paragraph (b)**
31 **of this subsection if the school employee has reasonable cause to believe that:**

32 “(A) **A student has been subjected to abuse by another school employee or by a con-**
33 **tractor, an agent, a volunteer or a student;**

34 “(B) **A student has been subjected to sexual conduct by another school employee or by**
35 **a contractor, an agent or a volunteer; or**

36 “(C) **Another school employee or a contractor, an agent or a volunteer has engaged in**
37 **sexual conduct.**

38 “(b) **The report required under paragraph (a) of this subsection shall be made to:**

39 “(A) **The licensed administrator designated in the policies adopted under ORS 339.372, for**
40 **all reports of suspected abuse or suspected sexual conduct; and**

41 “(B) **A law enforcement agency, the Department of Human Services or a designee of the**
42 **department as required by ORS 419B.010 and 419B.015, for all reports of suspected abuse.**

43 “(2) [*A person*] **The licensed administrator** who receives a report under subsection (1) of this
44 section shall follow the procedures required by the [*policy*] **policies** adopted by the school board
45 under ORS 339.372, **including:**

1 “(a) Notifying the Teacher Standards and Practices Commission as soon as possible of
2 any reports of suspected sexual conduct that may have been committed by a person who is
3 licensed by the commission; and

4 “(b) Notifying the Department of Education as soon as possible of any reports of sus-
5 pected sexual conduct that may have been committed by a person who is not licensed by the
6 commission.

7 “(3)(a) [Except as provided in subsection (4) of this section, when an education provider] **When a**
8 **licensed administrator** receives a report of suspected abuse or **suspected** sexual conduct by [one
9 of its employees,] **a school employee** and [the education provider’s designee determines that] there is
10 reasonable cause to support the report, the education provider **shall**:

11 “[(A) In the case of suspected abuse, shall place the school employee on paid administrative leave;
12 or]

13 “[(B) In the case of suspected sexual conduct, may place the school employee on paid administrative
14 leave or in a position that does not involve direct, unsupervised contact with children.]

15 “(A) **Place the school employee on paid administrative leave; and**

16 “(B) **Take necessary actions to ensure the student’s safety.**

17 “(b) A school employee who is placed on paid administrative leave under paragraph [(a)(A)] (a)
18 of this subsection shall remain on administrative leave until:

19 “[(A) The Department of Human Services or a law enforcement agency determines that the report
20 cannot be substantiated or that the report will not be pursued; or]

21 “[(B) The Department of Human Services or a law enforcement agency determines that the report
22 is substantiated and the education provider takes the appropriate disciplinary action against the school
23 employee.]

24 “(A) **For a report of suspected abuse, a law enforcement agency or the Department of**
25 **Human Services determines that the report:**

26 “(i) **Is substantiated and the education provider takes the appropriate employment action**
27 **against the school employee; or**

28 “(ii) **Cannot be substantiated or is not a report of abuse and the education provider:**

29 “(I) **Determines that an employment policy has been violated and takes appropriate em-**
30 **ployment action against the school employee; or**

31 “(II) **Determines that an employment policy has not been violated and employment action**
32 **against the school employee is not required.**

33 “(B) **For a report of suspected sexual conduct, the Teacher Standards and Practices**
34 **Commission or the Department of Education determines that the report:**

35 “(i) **Is substantiated and the education provider takes the appropriate employment action**
36 **against the school employee; or**

37 “(ii) **Cannot be substantiated or is not a report of sexual conduct and the education**
38 **provider:**

39 “(I) **Determines that an employment policy has been violated and takes appropriate em-**
40 **ployment action against the school employee; or**

41 “(II) **Determines that an employment policy has not been violated and that employment**
42 **action against the school employee is not required.**

43 “[(4) An education provider may reinstate a school employee placed on paid administrative leave
44 for suspected abuse as provided under subsection (3) of this section or may take the appropriate disci-
45 plinary action against the employee if the Department of Human Services or a law enforcement agency

1 *is unable to determine, based on a report of suspected abuse, whether abuse occurred.]*

2 **“(c) When a school employee is placed on paid administrative leave under paragraph (a)**
3 **of this subsection, the education provider may not require the school employee to use any**
4 **accrued leave during the paid administrative leave.**

5 **“(4)(a) Except as provided in paragraph (c) of this subsection, when a licensed adminis-**
6 **trator receives a report of suspected abuse or suspected sexual conduct by a contractor, an**
7 **agent or a volunteer, the education provider:**

8 **“(A) May immediately prohibit the contractor, agent or volunteer from providing services**
9 **to the education provider.**

10 **“(B) Shall prohibit the contractor, agent or volunteer from providing services to the ed-**
11 **ucation provider if the education provider determines that there is reasonable cause to sup-**
12 **port a report of abuse or sexual conduct.**

13 **“(b) Except as provided in paragraph (c) of this subsection, an education provider is not**
14 **required to reinstate a contractor, an agent or a volunteer. Any reinstatement of a con-**
15 **tractor, an agent or a volunteer that does occur may not occur until:**

16 **“(A) For a report of suspected abuse, a law enforcement agency or the Department of**
17 **Human Services determines that the report:**

18 **“(i) Is substantiated and the education provider takes the appropriate actions to protect**

23 **“(B) For a report of suspected sexual conduct, the Teacher Standards and Practices**
24 **Commission or the Department of Education determines that the report:**

25 **“(i) Is substantiated and the education provider takes the appropriate actions to protect**
26 **students; or**

27 **“(ii) Cannot be substantiated or is not a report of sexual conduct and the education**
28 **provider:**

29 **“(I) Takes the appropriate actions to protect students; or**

30 **“(II) Determines that no other actions are required to protect students.**

31 **“(c) If a contract under which a contractor provides services to an education provider**
32 **or an agreement under which an agent provides services to an education provider sets forth**
33 **any negotiated standards for the relationship between the contractor or agent and the edu-**
34 **cation provider, the education provider shall comply with those standards but may not in any**
35 **instance grant the contractor or agent more rights than granted to a school employee under**
36 **subsection (3) of this section.**

19 “(A) An employment policy of the education provider was violated; and

20 “(B) The education provider will take any employment actions, including disciplinary
21 action against the school employee or changes to the employment relationship or duties of
22 the school employee.

23 “(b) Determinations made under paragraph (a) of this subsection must be based on the
24 findings of an investigation conducted by:

25 “(A) A law enforcement agency, the Department of Human Services, the Teacher Stan-
26 dards and Practices Commission or the Department of Education; or

27 “(B) The education provider, if the education provider conducts an investigation.

27 “(b) *[Notify]* **Make the following notifications:**

28 “**(A) To** the Office of Child Care if the alleged child abuse occurred in a child care facility as

11 court under ORS 419B.100 and 419C.005. Citizen review boards may make such records available to
12 participants in case reviews;

13 “(e) A court appointed special advocate in any juvenile court proceeding in which it is alleged

25 “(k) With respect to a report of abuse occurring at a school or in an educational setting that
26 involves a child with a disability, Disability Rights Oregon[.];

27 **“(L) The Department of Education for purposes of investigations conducted under section**
28 **32 of this 2019 Act; and**

29 **“(m) An education provider for the purpose of making determinations under ORS 339.388.**

30 “(2)(a) When disclosing reports and records pursuant to subsection (1)(i) of this section, the
31 Department of Human Services may exempt from disclosure the names, addresses and other identi-
32 fying information about other children, witnesses, victims or other persons named in the report or
33 record if the department determines, in written findings, that the safety or well-being of a person
34 named in the report or record may be jeopardized by disclosure of the names, addresses or other
35 identifying information, and if that concern outweighs the public’s interest in the disclosure of that
36 information.

37 “(b) If the Department of Human Services does not have a report or record of abuse regarding
38 a child who, as the result of abuse, died or suffered serious physical injury as defined in ORS

13 “SECTION 22. Section 23 of this 2019 Act is added to and made a part of ORS 339.370 to
14 339.400.

15 “SECTION 23. (1)(a) When the Teacher Standards and Practices Commission receives a
16 report of suspected sexual conduct that may have been committed by a licensed school em-
17 ployee, contractor, agent or volunteer, the commission shall immediately initiate an investi-
18 gation.

19 “(b) An investigation and final determination related to a report received under para-
20 graph (a) of this subsection must be completed and notification of the final determination
21 must be made to the education provider within 90 calendar days following the date on which
22 the report was filed with the commission.

23 “(c) Notwithstanding paragraph (b) of this subsection, the prescribed timeline for an in-
24 vestigation and final determination may be extended if, for good cause, a longer period of

17 any documents, materials and reports to:

20 “(B) The Department of Education for the purpose of conducting an investigation under
21 section 32 of this 2019 Act; or

22 “(C) An education provider for the purpose of taking any disciplinary actions or making

36 or revoke the right of any person to apply for a license or registration, if the licensee, registrant
37 or applicant has held a license or registration at any time within five years prior to issuance of the
38 notice of charges under ORS 342.176 or section 23 of this 2019 Act based on the following:

39 “(a) Conviction of a crime not listed in ORS 342.143 (3);

40 “(b) Gross neglect of duty;

41 “(c) Any gross unfitness;

42 “(d) Conviction of a crime for violating any law of this state or any state or of the United States
43 involving the illegal use, sale or possession of controlled substances;

44 “(e) Conviction of a crime described in ORS 475B.010 to 475B.545;

45 “(f) Any false statement knowingly made in an application for issuance, renewal or rein-

1 statement of a license or registration; or

2 “(g) Failure to comply with any condition of reinstatement under subsection (4) of this section
3 or any condition of probation under ORS 342.177 (3)(b).

4 “(2) If a person is enrolled in an approved educator preparation program under ORS 342.147, the
5 commission may issue a public reprimand or may suspend or revoke the right to apply for a license
6 or registration based on the following:

7 “(a) Conviction of a crime listed in ORS 342.143 (3) or a crime described by the commission by
8 rule;

9 “(b) Conviction of a crime for violating any law of this state or any state or of the United States
10 involving the illegal use, sale or possession of controlled substances; or

11 “(c) Any conduct that may cause the commission to issue a public reprimand for a teacher or
12 to suspend or revoke the license or registration of a teacher.

13 “(3) The commission shall revoke any license or registration and shall revoke the right of any
14 person to apply for a license or registration if the person has been convicted of any crime listed in
15 ORS 342.143 (3).

16 “(4)(a) Except for convictions for crimes listed in ORS 342.143 (3) and subject to subsection (5)
17 of this section, any person whose license or registration has been revoked, or whose right to apply
18 for a license or registration has been revoked, may apply to the commission for reinstatement of the
19 license or registration after one year from the date of the revocation.

20 “(b) Any person whose license or registration has been suspended, or whose right to apply for
21 a license or registration has been suspended, may apply to the commission for reinstatement of the
22 license or registration.

23 “(c) The commission may require an applicant for reinstatement to furnish evidence satisfactory
24 to the commission of good moral character, mental and physical health and such other evidence as
25 the commission may consider necessary to establish the applicant’s fitness. The commission may
26 impose a probationary period and such conditions as the commission considers necessary upon ap-
27 proving an application for reinstatement.

28 “(5) The commission shall reconsider immediately a license or registration suspension or revo-
29 cation or the situation of a person whose right to apply for a license or registration has been re-
30 voked, upon application therefor, when the license or registration suspension or revocation or the
31 right revocation is based on a criminal conviction that is reversed on appeal.

32 “(6) Violation of rules adopted by the commission relating to competent and ethical performance
33 of professional duties shall be admissible as evidence of gross neglect of duty or gross unfitness.

34 “(7) A copy of the record of conviction, certified to by the clerk of the court entering the con-
35 viction, shall be conclusive evidence of a conviction described in this section.

36 “**SECTION 25.** ORS 342.176 is amended to read:

37 “342.176. (1)(a) A person may file a complaint with the Teacher Standards and Practices Com-
38 mission regarding a person licensed by the commission. **If a complaint concerns an allegation of**
39 **sexual conduct that may have been committed by a licensed school employee, contractor,**
40 **agent or volunteer, the complaint process provided by this section does not apply and the**
41 **commission shall investigate the complaint as provided by section 23 of this 2019 Act.**

42 “(b) Prior to beginning an investigation based on a complaint filed under paragraph (a) of this
43 subsection, the commission may require verification that attempts were made to resolve the com-
44 plaint through the complaint process of the school district that employs the person against whom
45 the complaint was filed.

1 “(c) After receiving sufficient verification as provided by paragraph (b) of this subsection, the
2 [Teacher Standards and Practices] commission shall promptly undertake an investigation upon re-
3 ceipt of a complaint or information that may constitute grounds for:

4 “(A) Refusal to issue a license or registration, as provided under ORS 342.143;

5 “(B) Suspension or revocation of a license or registration, discipline of a person holding a li-
6 cense or registration, or suspension or revocation of the right to apply for a license or registration,
7 as provided under ORS 342.175; or

8 “(C) Discipline for failure to provide appropriate notice prior to resignation, as provided under
9 ORS 342.553.

10 “(2) The commission may appoint an investigator and shall furnish the investigator with appro-
11 priate professional and other special assistance reasonably required to conduct the investigation,
12 and the investigator is empowered to issue subpoenas to require the attendance of witnesses or the
13 production of documents over the signature of the executive director of the **Teacher Standards and**
14 **Practices** Commission, subpoena witnesses over the signature of the executive director, swear wit-
15 nesses and compel obedience in the same manner as provided under ORS 183.440 (2).

16 “(3) Following completion of the investigation, the executive director or the executive director’s
17 designee shall report in writing any findings and recommendations to:

18 “(a) The commission, meeting in executive session, at its next regular meeting following com-
19 pletion of the investigation; and

20 “(b) The person against whom the charge is made, following consideration by the commission.

21 “(4)(a) Except as provided in paragraph (b) of this subsection, the documents and materials used
22 in the investigation undertaken as provided by this section and the report related to the investi-
23 gation are confidential and not subject to public inspection unless the commission makes a final
24 determination to:

25 “(A) Refuse to issue a license or registration, as provided under ORS 342.143;

26 “(B) Suspend or revoke a license or registration, discipline a person holding a license or regis-
27 tration, or suspend or revoke the right to apply for a license or registration, as provided under ORS
28 342.175; or

29 “(C) Discipline a person for failure to provide appropriate notice prior to resignation, as pro-
30 vided under ORS 342.553.

31 “(b) Records made available to the commission under ORS 419B.035 (1)(h) shall be kept confi-
32 dential.

33 “(5) If the commission finds from the report that there is sufficient cause to justify holding a
34 hearing under ORS 342.177, the commission shall notify in writing:

35 “(a) The person charged, enclosing a statement of the charges and a notice of opportunity for
36 hearing;

37 “(b) The complainant; and

38 “(c) The employing district or public charter school, if any.

39 “(6) If the commission finds from the report that there is not sufficient cause to justify holding
40 a hearing under ORS 342.177, the commission shall notify in writing:

41 “(a) The person charged;

42 “(b) The complainant; and

43 “(c) The employing district or public charter school, if any.

44 “(7) Notwithstanding ORS 192.660 (6), the commission may make its findings under this section
45 in executive session. However, the provisions of ORS 192.660 (4) apply to the sessions.

1 “**SECTION 26.** ORS 342.177 is amended to read:

2 “342.177. (1)(a) Hearings under ORS 342.176 **and section 23 of this 2019 Act** shall be conducted
3 by an administrative law judge assigned from the Office of Administrative Hearings established un-
4 der ORS 183.605.

5 “(b) Any hearing conducted under this section shall be private unless the person against whom
6 the charge is made requests a public hearing. Students attending school in the employing district
7 may not attend any hearing except as witnesses duly subpoenaed to testify with respect to the
8 charges made. Students attending a public charter school that employs the person may not attend
9 any hearing except as witnesses duly subpoenaed to testify with respect to the charges made. The
10 person charged shall have the right to be represented by counsel and to present evidence and ar-
11 gument. The evidence must be confined to the charges.

34 “**SECTION 27.** ORS 342.183 is amended to read:

35 “342.183. (1) The Teacher Standards and Practices Commission may issue a letter of informal
36 reproof to a person licensed, registered or certified by the commission if:

37 “(a) Following the completion of an investigation, the commission determines that the person
38 has engaged in conduct that affects the person’s ability to be professionally effective, based on
39 standards adopted by the commission by rule; and

40 “(b) Subject to subsection (5) of this section, the commission agrees not to pursue disciplinary
41 action against the person under ORS 342.175 and the person agrees to the terms of the letter of
42 informal reproof, including a monitoring period.

43 “(2) A letter of informal reproof issued as provided by subsection (1) of this section shall es-
44 tablish the terms of a monitoring period for the person to whom the letter is issued.

45 “(3) Upon the issuance of a letter of informal reproof, the commission shall notify the employer

1 of the person to whom the letter is issued, including any terms of the letter that the employer may
2 need to know to assist the person in complying with the terms of the letter.

4 “(a) Is confidential; and

5 “(b) Except when a disciplinary action is taken as provided in subsection (5) of this section, may
6 not be posted on an interstate clearinghouse related to educator license sanctions.

7 “(5) If a person fails to comply with the terms of a letter of informal reproof, the commission
8 may take disciplinary action against the person based on one or both of the following:

9 “(a) The conduct underlying the letter of informal reproof; or

10 “(b) The failure to comply with the terms of the letter of informal reproof.

11 “(6) If the executive director of the **Teacher Standards and Practices** Commission determines
12 that a person failed to meet the terms of a letter of informal reproof, the executive director shall
13 report the failure to the commission for the commission to make a final determination pursuant to
14 ORS 342.176 or **section 23 of this 2019 Act**.

15 “(7) The documents and materials used in an investigation for the purposes of this section are
16 confidential and are not subject to public inspection unless the commission makes a final determi-
17 nation to discipline the person pursuant to ORS 342.175.

18 “**SECTION 28.** ORS 342.390 is amended to read:

19 “342.390. (1) The Teacher Standards and Practices Commission shall meet at least once every
20 six months at a place, day and hour determined by the commission. The commission shall also meet
21 at such other times and places as are specified by the call of the chairperson or of a majority of the
22 members of the commission **or as required by the executive director of the Teacher Standards
23 and Practices Commission for the purposes of section 23 of this 2019 Act**.

24 “(2) A member of the commission who is employed at a public school or by a private educator
25 preparation provider or by a public university listed in ORS 352.002:

34 342.177, 342.183 and 342.390 by sections 24 to 28 of this 2019 Act become operative on January
35 1, 2020.**

36 “(2) **Section 23 of this 2019 Act and the amendments to ORS 342.175, 342.176, 342.177,
37 342.183 and 342.390 by sections 24 to 28 of this 2019 Act apply to reports of suspected sexual
38 conduct received on or after January 1, 2020.**

39 “(3) **Notwithstanding the operative date set forth in subsection (1) of this section, the
40 Teacher Standards and Practices Commission may take any action before the operative date
41 set forth in subsection (1) of this section that is necessary to enable the commission to ex-
42 ercise, on and after the operative date set forth in subsection (1) of this section, all of the
43 duties, functions and powers conferred on the commission by section 23 of this 2019 Act.**

44 “**SECTION 30.** **In addition to and not in lieu of any other appropriation, there is appro-
45 priated to the Teacher Standards and Practices Commission, for the biennium beginning July**

1 1, 2019, out of the General Fund, the amount of \$_____, which shall be used by the com-
2 mission to employ the necessary personnel to comply with the requirements of section 23
3 of this 2019 Act.

5 **“REQUIREMENTS FOR THE DEPARTMENT OF EDUCATION**

6
7 **“SECTION 31.** Section 32 of this 2019 Act is added to and made a part of ORS 339.370 to
8 339.400.

9 **“SECTION 32.** (1)(a) When the Department of Education receives a report of suspected
10 sexual conduct that may have been committed by a school employee, contractor, agent or
11 volunteer that is not licensed with the Teacher Standards and Practices Commission, the
12 department shall immediately initiate an investigation.

13 **“(b)** An investigation and final determination related to the report received under para-
14 graph (a) of this subsection must be completed and notification of the final determination
15 must be made to the education provider within 90 calendar days following the date on which
16 the report was filed with the department.

17 **“(c)** Notwithstanding paragraph (b) of this subsection, the prescribed timeline for an in-
18 vestigation and final determination may be extended if the department determines that, for
19 good cause, a longer period of time is necessary.

20 **“(2)** The department shall appoint an investigator and shall furnish the investigator with
21 appropriate professional and other special assistance reasonably required to conduct an in-
22 vestigation. An investigator appointed under this subsection is empowered to:

23 **“(a)** Issue subpoenas to require the attendance of witnesses or the production of docu-
24 ments;

25 **“(b)** Subpoena witnesses; and

26 **“(c)** Swear witnesses and compel obedience in the same manner as provided under ORS
27 183.440 (2).

28 **“(3)(a)** Following the completion of an investigation, the Department of Education shall

31 **“(B)** The student and, if applicable, the student’s parents;

32 **“(C)** The education provider;

33 **“(D)** The person who provided the report of suspected sexual conduct; and

34 **“(E)** Any regulatory board that is not the Teacher Standards and Practices Commission
35 and that licenses, registers, certifies or otherwise authorizes the school employee, contrac-
36 tor, agent or volunteer to practice a profession or to provide professional services.

37 **“(b)** The notification required under paragraph (a) of this subsection shall include the
38 following information as allowed by state and federal law:

39 **“(A)** The statutory authority of the department to conduct the investigation;

40 **“(B)** The procedural background for the investigation;

41 **“(C)** The legal standards and arguments used for the investigation;

42 **“(D)** The department’s findings of fact from the investigation;

43 **“(E)** The department’s final determination based on the investigation; and

44 **“(F)** The right to an appeal, as provided by subsection (5) of this section.

45 **“(4)(a)** Except as provided in paragraph (b) of this subsection, the documents and mate-

1 rials used in the investigation undertaken under this section, and the report related to the
2 investigation, are confidential and not subject to public inspection.

3 “(b) To the extent allowed by state and federal law, the department shall make available
4 any documents, materials and reports to:

5 “(A) A law enforcement agency or the Department of Human Services if necessary to
6 conduct an investigation under ORS 419B.005 to 419B.050;

7 “(B) The Teacher Standards and Practices Commission if necessary for the commission
8 to conduct an investigation under section 23 of this 2019 Act; and

9 “(C) An education provider if necessary for the education provider to take any discipli-
10 nary action or changes in the employment relationship or duties of the school employee,
11 contractor, agent or volunteer.

12 “(c) The Department of Education shall retain documents and materials related to any
13 report received under this section, regardless of whether the department found sufficient
14 cause to justify holding a hearing under this section.

15 “(5) A person may appeal the final determination made by the department under this
16 section as a contested case under ORS chapter 183.

17 “(6) The State Board of Education shall adopt any rules necessary for the administration
18 of this section.

19 “SECTION 33. (1) Section 32 of this 2019 Act becomes operative on July 1, 2020.

20 “(2) Section 32 of this 2019 Act applies to reports of suspected sexual conduct received
21 on or after July 1, 2020.

22 “(3)(a) For the purposes of ORS 339.372 (4)(b) and 339.388 (2)(b), a licensed administrator
23 is not required to inform the Department of Education of reports of suspected sexual con-
24 duct involving a person who is not licensed by the Teacher Standards and Practices Com-
25 mission if the report is received before July 1, 2020.

26 “(b) For the purpose of ORS 339.374 (1)(d), an education provider is not required to verify
27 with the Department of Education whether the department has an ongoing investigation or
28 has a substantiated report relating to conduct by an applicant who is not licensed with the
29 Teacher Standards and Practices Commission if the applicant is considered for employment
30 before July 1, 2020.

31 “(c) For the purpose of ORS 339.374 (2)(b), an education provider is not required to verify
32 with the Department of Education whether the department has an ongoing investigation or
33 has a substantiated report relating to conduct by a person who is not licensed with the
34 Teacher Standards and Practices Commission if the person begins providing services to the
35 education provider before July 1, 2020.

36 “(d) Notwithstanding ORS 339.388, an education provider must conduct an investigation
37 related to a report of suspected sexual conduct by a person who is not licensed by the
38 Teacher Standards and Practices Commission if the report is received before July 1, 2020.
39 An investigation conducted under this paragraph must be completed as provided by ORS
40 339.388 (6)(d)(B)(ii).

41 “(e) The Department of Education is not required to take any action on information re-
42 ceived under section 14 of this 2019 Act or ORS 419B.020 if the department receives the in-
43 formation before July 1, 2020.

44 “(4) Notwithstanding the operative date set forth in subsection (1) of this section, the
45 Department of Education and the State Board of Education may take any action before the

1 operative date set forth in subsection (1) of this section that is necessary to enable the de-
2 partment to exercise, on and after the operative date set forth in subsection (1) of this sec-
3 tion, all of the duties, functions and powers conferred on the department by section 32 of this
4 2019 Act.

5 “SECTION 34. In addition to and not in lieu of any other appropriation, there is appro-
6 priated to the Department of Education, for the biennium beginning July 1, 2019, out of the
7 General Fund, the amount of \$_____, which shall be used by the department to employ the
8 necessary personnel to comply with the requirements of section 32 of this 2019 Act.
