9 “**SECTION 1.** ORS 446.003 is amended to read:

10 “446.003. As used in ORS 446.003 to 446.200 and 446.225 to 446.285, and for the purposes of ORS
11 chapters 195, 196, 197, 215 and 227, the following definitions apply, unless the context requires oth-
12 erwise, or unless administration and enforcement by the State of Oregon under the existing or re-
13 vised National Manufactured Housing Construction and Safety Standards Act would be adversely
14 affected, and except as provided in ORS 446.265 **or section 26 of this 2019 Act:**

15 “(1) ‘Accessory building or structure’ means any portable, demountable or permanent structure
16 established for use of the occupant of the manufactured [*structure*] **dwelling** and as further defined
17 by rule by the Director of the Department of Consumer and Business Services.

18 “(2)(a) ‘Alteration’ means any change, addition, repair, conversion, replacement, modification or
19 removal of any equipment or installation that may affect the operation, construction or occupancy
20 of a manufactured [*structure*] **dwelling**.

21 “(b) ‘Alteration’ does not include:

22 “(A) Minor repairs with approved component parts;

23 “(B) Conversion of listed fuel-burning appliances in accordance with the terms of their listing;

24 “(C) Adjustment and maintenance of equipment; or

25 “(D) Replacement of equipment or accessories in kind.

26 “(3) ‘Approved’ means approved, licensed or certified by the Department of Consumer and
27 Business Services or its designee.

28 “(4) ‘Board’ means the Residential and Manufactured Structures Board.

29 “(5) ‘Cabana’ means a stationary, lightweight structure that may be prefabricated, or demount-
30 able, with two or more walls, used adjacent to and in conjunction with a manufactured [*structure*]
31 **dwelling** to provide additional living space.

32 “(6) ‘Certification’ means an evaluation process by which the department verifies a
33 manufacturer’s ability to produce manufactured [*structures*] **dwelling**s to the department rules and
34 to the department approved quality control manual.

35 “[*(7) ‘Conversion’ or ‘to convert’ means the process of changing a manufactured structure in whole*”

1 *or in part from one type of vehicle or structure to another.]*

2 “[(8)] (7) ‘Dealer’ means any person engaged in the business of selling, leasing or distributing
3 manufactured [*structures*] **dwelling**s or equipment, or both, primarily to persons who in good faith
4 purchase or lease manufactured [*structures*] **dwelling**s or equipment, or both, for purposes other than
5 resale.

6 “[(9)] (8) ‘Department’ means the Department of Consumer and Business Services.

7 “[(10)] (9) ‘Director’ means the Director of the Department of Consumer and Business Services.

8 “[(11)] (10) ‘Distributor’ means any person engaged in selling and distributing manufactured
9 [*structures*] **dwelling**s or equipment for resale.

10 “[(12)] (11) ‘Equipment’ means materials, appliances, subassembly, devices, fixtures, fittings and
11 apparatuses used in the construction, plumbing, mechanical and electrical systems of a manufactured
12 [*structure*] **dwelling**.

13 “[(13)] (12) ‘Federal manufactured housing construction and safety standard’ means a standard
14 for construction, design and performance of a manufactured dwelling promulgated by the Secretary
15 of Housing and Urban Development pursuant to the federal National Manufactured Housing Con-
16 struction and Safety Standards Act of 1974 (Public Law 93-383).

17 “[(14)] (13) ‘Fire Marshal’ means the State Fire Marshal.

18 “[(15)] (14) ‘Imminent safety hazard’ means an imminent and unreasonable risk of death or se-
19 vere personal injury.

20 “[(16) ‘Insignia of compliance’ means:]

21 “[(a) For a manufactured dwelling built to HUD standards for such dwellings, the HUD label;
22 or]

23 “[(b) For all other manufactured structures, the insignia issued by this state indicating compliance
24 with state law.]

25 “(15) **‘Insignia of compliance’ means the HUD label for a manufactured dwelling.**

26 “[(17)] (16) ‘Inspecting authority’ or ‘inspector’ means the Director of the Department of Con-
27 sumer and Business Services or representatives as appointed or authorized to administer and enforce
28 provisions of ORS 446.111, 446.160, 446.176, 446.225 to 446.285, 446.310 to 446.350, 446.990 and this
29 section.

30 “[(18)] (17) ‘Installation’ in relation to:

31 “(a) Construction means the arrangements and methods of construction, fire and life safety,
32 electrical, plumbing and mechanical equipment and systems within a manufactured [*structure*]
33 **dwelling**.

34 “(b) Siting means the manufactured [*structure*] **dwelling** and cabana foundation support and
35 tiedown, the structural, fire and life safety, electrical, plumbing and mechanical equipment and ma-
36 terial connections and the installation of skirting and temporary steps.

37 “[(19)] (18) ‘Installer’ means any individual licensed by the director to install, set up, connect,
38 hook up, block, tie down, secure, support, install temporary steps for, install skirting for or make
39 electrical, plumbing or mechanical connections to manufactured dwellings or cabanas or who pro-
40 vides consultation or supervision for any of these activities, except architects registered under ORS
41 671.010 to 671.220 or engineers registered under ORS 672.002 to 672.325.

42 “[(20)] (19) ‘Listed’ means equipment or materials included in a list, published by an organization
43 concerned with product evaluation acceptable to the department that maintains periodic inspection
44 of production of listed equipment or materials, and whose listing states either that the equipment
45 or materials meets appropriate standards or has been tested and found suitable in a specified man-

1 ner.

2 “[~~(21)~~] **(20)** ‘Lot’ means any space, area or tract of land, or portion of a manufactured dwelling
3 park, mobile home park or recreation park that is designated or used for occupancy by one manu-
4 factured [~~structure~~] **dwelling**.

5 “[~~(22)(a)~~] **(21)(a)** ‘Manufactured dwelling’ means a residential trailer, mobile home or manufac-
6 tured home.

7 “(b) ‘Manufactured dwelling’ does not include any building or structure constructed to conform
8 to the State of Oregon Structural Specialty Code or the Low-Rise Residential Dwelling Code adopted
9 pursuant to ORS 455.100 to 455.450 and 455.610 to 455.630 [~~or any unit identified as a recreational~~
10 ~~vehicle by the manufacturer~~].

11 “[~~(23)~~] **(22)** ‘Manufactured dwelling park’ means any place where four or more manufactured
12 dwellings are located within 500 feet of one another on a lot, tract or parcel of land under the same
13 ownership, the primary purpose of which is to rent or lease space or keep space for rent or lease
14 to any person for a charge or fee paid or to be paid for the rental or lease or use of facilities or to
15 offer space free in connection with securing the trade or patronage of such person. ‘Manufactured
16 dwelling park’ does not include a lot or lots located within a subdivision being rented or leased for
17 occupancy by no more than one manufactured dwelling per lot if the subdivision was approved by
18 the local government unit having jurisdiction under an ordinance adopted pursuant to ORS 92.010
19 to 92.192.

20 “[~~(24)(a)~~] **(23)(a)** ‘Manufactured home,’ except as provided in paragraph (b) of this subsection,
21 means a structure constructed for movement on the public highways that has sleeping, cooking and
22 plumbing facilities, that is intended for human occupancy, that is being used for residential purposes
23 and that was constructed in accordance with federal manufactured housing construction and safety
24 standards and regulations in effect at the time of construction.

25 “(b) For purposes of implementing any contract pertaining to manufactured homes between the
26 department and the federal government, ‘manufactured home’ has the meaning given the term in the
27 contract.

28 “[~~(25)(a)~~] *‘Manufactured structure’ means a recreational vehicle, manufactured dwelling or recre-*
29 *ational structure.*]

30 “[~~(b)~~] *‘Manufactured structure’ does not include any building or structure regulated under the State*
31 *of Oregon Structural Specialty Code or the Low-Rise Residential Dwelling Code.*]

32 “[~~(26)~~] **(24)** ‘Manufacturer’ means any person engaged in manufacturing, building, rebuilding, al-
33 tering, converting or assembling manufactured [~~structures~~] **dwellings** or equipment.

34 “[~~(27)~~] **(25)** ‘Manufacturing’ means the building, rebuilding, altering or converting of manufac-
35 tured [~~structures~~] **dwellings** that bear or are required to bear an Oregon insignia of compliance.

36 “[~~(28)~~] **(26)** ‘Minimum safety standards’ means the plumbing, mechanical, electrical, thermal, fire
37 and life safety, structural and transportation standards prescribed by rules adopted by the director.

38 “[~~(29)~~] **(27)** ‘Mobile home’ means a structure constructed for movement on the public highways
39 that has sleeping, cooking and plumbing facilities, that is intended for human occupancy, that is
40 being used for residential purposes and that was constructed between January 1, 1962, and June 15,
41 1976, and met the construction requirements of Oregon mobile home law in effect at the time of
42 construction.

43 “[~~(30)~~] **(28)** ‘Mobile home park’:

44 “**(a)** Means any place where four or more manufactured [~~structures~~] **dwellings** are located within
45 500 feet of one another on a lot, tract or parcel of land under the same ownership, the primary

1 purpose of which is to rent space or keep space for rent to any person for a charge or fee paid or
2 to be paid for the rental or use of facilities or to offer space free in connection with securing the
3 trade or patronage of such person.

4 “(b) [*Mobile home park;*] Does not include a lot or lots located within a subdivision being
5 rented or leased for occupancy by no more than one manufactured dwelling per lot if the subdivision
6 was approved by the municipality unit having jurisdiction under an ordinance adopted pursuant to
7 ORS 92.010 to 92.192.

8 “[31] (29) ‘Municipality’ means a city, county or other unit of local government otherwise au-
9 thORIZED by law to enact codes.

10 “[32] ‘Recreational structure’ means a campground structure with or without plumbing, heating
11 or cooking facilities intended to be used by any particular occupant on a limited-time basis for recre-
12 ational, seasonal, emergency or transitional housing purposes and may include yurts, cabins, fabric
13 structures or similar structures as further defined, by rule, by the director.]

14 “[33] ‘Recreational vehicle’ means a vehicle with or without motive power, that is designed for
15 human occupancy and to be used temporarily for recreational, seasonal or emergency purposes and as
16 further defined, by rule, by the director.]

17 “[34] (30) ‘Residential trailer’ means a structure constructed for movement on the public
18 highways that has sleeping, cooking and plumbing facilities, that is intended for human occupancy,
19 that is being used for residential purposes and that was constructed before January 1, 1962.

20 “[35] (31) ‘Sale’ means rent, lease, sale or exchange.

21 “[36] (32) ‘Skirting’ means a weather resistant material used to enclose the space below [*the*]
22 a manufactured [*structure*] **dwelling**.

23 “[37] (33) ‘Tiedown’ means any device designed to anchor a manufactured [*structure*] **dwelling**
24 securely to the ground.

25 “[38] (34) ‘Transitional housing accommodations’ means accommodations described under ORS
26 446.265.

27 “[39] (35) ‘Utilities’ means the water, sewer, gas or electric services provided on a lot for a
28 manufactured [*structure*] **dwelling**.

29 “**SECTION 2.** ORS 446.155 is amended to read:

30 “446.155. (1) A person may not sell or offer for sale within this state a manufactured dwelling
31 manufactured after January 1, 1962, that contains:

32 “(a) Plumbing equipment, unless such equipment meets the requirements of the Department of
33 Consumer and Business Services;

34 “(b) Heating equipment, unless such equipment meets the requirements of the State Fire Mar-
35 shal; or

36 “(c) Electrical equipment, unless such equipment meets the requirements of the department.

37 “(2) A person may not rent, lease, sell or offer for rent, lease or sale within this state a manu-
38 factured [*structure*] **dwelling** manufactured after September 1, 1969, unless the manufactured [*struc-*
39 *ture*] **dwelling** bears an insignia of compliance and contains:

40 “(a) Plumbing, mechanical and electrical equipment or installations that meet the minimum
41 safety standards of the department;

42 “(b) Thermal, fire and life safety equipment, material and installations that meet the minimum
43 safety standards of the department; or

44 “(c) Structural and transportation equipment, materials, installations and construction that meet
45 the minimum safety standards of the department.

1 “(3) A person may not rent, lease, sell or offer for rent, lease or sale within this state a recre-
2 ational vehicle unless the recreational vehicle:]

3 “(a) Bears an insignia of compliance;]

4 “(b) Has previously been lawfully registered and titled within the United States;]

5 “(c) Has previously been issued an ownership document under ORS 446.571 or recorded under
6 ORS 446.626; or]

7 “(d) Is exempt from registration, title or ownership document requirements because of United
8 States government ownership.]

9 “(4) (3) Persons manufacturing, remanufacturing, converting, altering or repairing manufac-
10 tured [structures] **dwelling**s or equipment within the state or for use within the state shall comply
11 with all applicable construction and safety rules of the department and the following:

12 “(a) Alterations performed on a manufactured dwelling by the manufacturer or dealer before or
13 at the time of sale to the first consumer shall be performed in conformance with the National
14 Manufactured Housing Construction and Safety Standards Act.

15 “(b) After the initial sale to a consumer by a manufacturer or dealer, all alterations to a man-
16 ufactured dwelling, except as identified by the Director of the Department of Consumer and Business
17 Services by rule, shall be in conformance with the specialty codes as described in ORS 455.010 to
18 455.740 and 479.855.

19 “(c) Solid fuel burning appliances shall be in conformance with the National Manufactured
20 Housing Construction and Safety Standards Act and standards adopted by the department.

21 “(d) Notwithstanding subsections (1) and (2) of this section, a previously owned manufactured
22 dwelling may be sold ‘as is’ provided that the seller discloses in the bill of sale that the manufac-
23 tured dwelling is being sold on an ‘as is’ or ‘with all faults’ basis, and that the entire risk as to the
24 quality and performance of the manufactured dwelling is with the buyer. If the manufactured
25 dwelling is found to be defective after purchase, the buyer shall assume the entire cost of all ser-
26 vicing and repair. The seller, manufacturer, distributor or retailer is not responsible for any cost
27 for servicing and repair.

28 “(5) (4) Installations of manufactured [structures shall] **dwelling**s **must** be in conformance with
29 the standards adopted by the department for site preparation, foundation support, anchoring, struc-
30 tural and utility connections, electrical and plumbing tests, underfloor enclosures, ventilation, vapor
31 barriers and steps used for access and egress.

32 “**SECTION 3.** ORS 446.160 is amended to read:

33 “446.160. (1) The Department of Consumer and Business Services may cause such inspections to
34 be made, approve plans and specifications, provide technical services, issue insignia of compliance,
35 collect fees provided by ORS 446.176 and, in compliance with ORS chapter 183, promulgate and en-
36 force such rules and regulations as are reasonably necessary to carry out its duties and insure
37 compliance with those parts of ORS 446.003 to 446.200, 446.225 to 446.285, 446.310 to 446.350 and
38 446.395 to 446.440 within the jurisdiction of the department.

39 “(2) The Director of the Department of Consumer and Business Services shall adopt rules pur-
40 suant to ORS chapter 183 to insure that manufacturers, distributors and dealers comply with the
41 reporting requirements of the Department of Consumer and Business Services of this state and the
42 Secretary of Housing and Urban Development as required by the National Manufactured Housing
43 Construction and Safety Standards Act of 1974 (Public Law 93-383).

44 “(3) The director is authorized to conduct such inspections and investigations as may be neces-
45 sary to administer and enforce any federal manufactured dwelling construction and safety standards

1 adopted under ORS 446.155 or the National Manufactured Housing Construction and Safety Stan-
2 dards Act of 1974 (Public Law 93-383). The director shall furnish to the Secretary of Housing and
3 Urban Development or a designee any information obtained indicating noncompliance with such
4 standards for appropriate action.

5 “(4) The director or a designee is authorized to enter, at reasonable times and without advance
6 notice, any factory, warehouse or establishment in which a manufactured [structure] **dwelling** or
7 equipment is manufactured, stored or held for sale; and to inspect at reasonable times within rea-
8 sonable limits in a reasonable manner, any such factory, warehouse or establishment, and to inspect
9 such products, books, papers, records and documents [which] **that** are relevant to the manufacture
10 of a manufactured [structure] **dwelling** or equipment and the manufacturer’s, distributor’s or dealer’s
11 compliance with ORS 446.155 and the National Manufactured Housing Construction and Safety
12 Standards Act of 1974 (Public Law 93-383).

13 “**SECTION 4.** ORS 446.170 is amended to read:

14 “446.170. (1) **An insignia of compliance shall be affixed to** manufactured [structures] **dwelling**
15 **that are** subject to the provisions of ORS 446.155 to 446.200[,] and **to** manufactured [structures]
16 **dwelling**s upon which additions, conversions or alterations of installations of equipment or material
17 are made [shall have affixed to the manufactured structures insignia of compliance].

18 “(2) A person may not place an insignia of compliance on a manufactured [structure] **dwelling**
19 except as provided by ORS 446.155 to 446.200 and the rules adopted under ORS 446.155 to 446.200.

20 “(3) Insignia of compliance may be issued in bulk only to manufacturers, remanufacturers or
21 converters certified and registered with the Department of Consumer and Business Services.

22 “(4) Insignia of compliance are not transferable, and the department may not make a refund
23 representing any unused insignia.

24 “[5] *Subsection (1) of this section does not apply to a recreational vehicle described in ORS*
25 *446.155 (3)(b) to (d).*]

26 “**SECTION 5.** ORS 446.180 is amended to read:

27 “446.180. (1) If the Director of the Department of Consumer and Business Services determines
28 that standards for construction, equipment and material installed in manufactured [structures]
29 **dwelling**s provided by the statutes or rules and regulations of other states are at least equal to the
30 minimum safety standards prescribed under ORS 446.155 to 446.200, and that such statutes, rules and
31 regulations are being enforced, the director may provide by rule that manufactured [structures]
32 **dwelling**s approved by such other state shall be considered approved by the director.

33 “(2) Mobile homes built between September 1, 1969, and June 15, 1976, to the American National
34 Standards Institute Mobile Home Standards A119.1 and which also bear an insignia of compliance
35 from the State of California, Idaho, Nevada or Washington shall be considered to comply with ORS
36 446.155 (2) provided no alterations have been made to the original structure.

37 “**SECTION 6.** ORS 446.185 is amended to read:

38 “446.185. (1) In compliance with ORS chapter 183, rules establishing minimum safety standards
39 and requirements shall be adopted and enforced by the Director of the Department of Consumer and
40 Business Services for manufactured [structures] **dwelling**s and [manufactured structure] installations
41 as prescribed in ORS 446.155.

42 “(2) Minimum safety standards prescribed in ORS 446.155 to 446.200 shall be reasonably con-
43 sistent with nationally recognized standards for construction of manufactured [structures, and the]
44 **dwelling**s. Manufactured [structures shall] **dwelling**s **must** be designed to protect the health and
45 safety of the people of this state from dangers inherent in the use of substandard and unsafe

1 equipment, material and installations.

2 “**SECTION 7.** ORS 446.200 is amended to read:

3 “446.200. [(1) Any manufactured structure that meets the requirements prescribed under ORS
4 446.003, 446.155 to 446.200 and 446.225 to 446.285:]

5 “[*(a)* Is not required to comply with any ordinances of a city or county prescribing requirements
6 for plumbing, heating, illuminating, mechanical, structural, transportation, thermal, fire and life safety,
7 cooking or electrical equipment and material installed in manufactured structures.]

8 “[*(b)* Is required to comply with this chapter and the administrative rules adopted thereunder reg-
9 ulating plumbing, heating, illuminating, mechanical, structural, transportation, thermal, fire and life
10 safety, cooking and electrical equipment and material installed in manufactured structures.]

11 “[*(2)*] A manufactured dwelling that is constructed in conformity with the minimum safety stan-
12 dards provided by ORS 446.185 and [*which*] **that** bears an insignia of compliance is not required to
13 comply with any additional regulations if [*it*] **the dwelling** is thereafter placed upon a permanent
14 foundation and affixed to real property.

15 “**SECTION 8.** ORS 446.245 is amended to read:

16 “446.245. (1) Manufactured dwellings shall be used as single-family dwellings.

17 “(2) Manufactured dwellings shall not be used for commercial purposes.

18 “(3) Exceptions to subsections (1) and (2) of this section are:

19 “(a) Manufactured dwellings may be used for purposes other than as a single-family dwelling
20 when specifically approved for a change in occupancy in accordance with the provisions of the
21 Oregon specialty codes by the authority having jurisdiction. When a manufactured dwelling changes
22 in occupancy it shall lose its identity as a manufactured dwelling and have the insignia removed and
23 returned to the Department of Consumer and Business Services.

24 “(b) Manufactured dwellings may be used by dealers or distributors [*of manufactured*
25 *structures*] as temporary sales offices [*when*] **if**:

26 “**(A)** No alterations to the design, construction, transportation, fire and life safety, plumbing,
27 mechanical or electrical systems are made to accommodate the office use; and

28 “**(B)** [*when*] The dealer or distributor continues to offer the manufactured dwelling for sale
29 during the office use.

30 “(c) A portion of a manufactured dwelling may be used for an in-house business when the re-
31 mainder of the [*structure*] **dwelling** is used as a single-family dwelling by the same person. **Approval**
32 **for** the type and location of an in-home business [*shall be approved by*] **must be obtained from** the
33 authority having jurisdiction and the local planning commission prior to the use.

34 “**SECTION 9.** ORS 446.250 is amended to read:

35 “446.250. The Director of the Department of Consumer and Business Services shall cause in-
36 spections to be made, approve plans and specifications, provide technical services and issue permits
37 for alteration of manufactured dwellings [*and*], **for** installation of manufactured dwellings [*and*
38 *manufactured structure*] **or** accessory buildings [*and*] **or** structures on a lot **and for alterations of**
39 **plumbing, heating, illuminating, cooking or electrical equipment installations.** The director
40 shall appoint or contract with municipalities that request such appointment or contract for in-
41 spection and issuance of permits for [*alteration of manufactured dwellings and installation of manu-*
42 *factured dwellings and manufactured structure accessory buildings and structures*] **manufactured**
43 **dwelling alterations, for installations of manufactured dwellings or accessory buildings or**
44 **structures** and **for** alterations of [*installations of*] plumbing, heating, illuminating, cooking or elec-
45 trical equipment **installations**, [*provided*] **if** the municipality employs as local inspectors qualified

1 persons who have been certified by the director for inspection and issuance of permits for [*alteration*
2 *of manufactured dwellings and installation of manufactured dwellings and manufactured structure ac-*
3 *cessory buildings and structures, pursuant to*] **manufactured dwelling alterations, for installations**
4 **of manufactured dwellings or accessory buildings or structures and for alterations of**
5 **plumbing, heating, illuminating, cooking or electrical equipment installations under** ORS
6 446.003, 446.111, 446.155, 446.160, 446.176, 446.225 to 446.285 and 446.990. [*However, the*] Certification
7 standards under this section shall relate to the inspections to be performed and shall not be more
8 stringent for municipal inspectors than those applying to state inspectors.

9 “**SECTION 10.** ORS 446.252 is amended to read:

10 “446.252. A person may not install a manufactured dwelling or [*manufactured structure*] **an** ac-
11 cessory building or structure without first obtaining from the Department of Consumer and Business
12 Services or a municipality as provided under ORS 446.250 all permits necessary for installing the
13 manufactured dwelling or [*manufactured structure*] **the** accessory building or structure on a lot.

14 “**SECTION 11.** ORS 446.253 is amended to read:

15 “446.253. (1) The authority of the Director of the Department of Consumer and Business Services
16 under ORS 446.250 [*shall be*] **is** in addition to the provisions of ORS chapter 455. Where the pro-
17 visions of ORS 446.252 and this section conflict with the provisions under ORS chapter 455, the
18 provisions of ORS 446.252 and this section shall control.

19 “(2) Except as otherwise provided by this subsection, any municipality that establishes a pro-
20 gram under ORS [*446.252 and*] **455.148 or** 455.150 [*and this section*] to administer and enforce in-
21 stallations of manufactured dwellings and [*manufactured structure*] accessory buildings [*and*] **or**

29 “(a) Creating building inspection program application and amendment requirements and proce-
30 dures;

31 “(b) Granting or denying applications for building inspection program authority and amend-
32 ments;

33 “(c) Reviewing procedures and program operations of municipalities;

34 “(d) Creating standards for efficient, effective, timely and acceptable building inspection pro-
35 grams;

36 “(e) Creating standards for justifying increases in building inspection program fees adopted by
37 a municipality;

38 “(f) Creating standards for determining whether a county or department building inspection
39 program is economically impaired in its ability to reasonably continue providing the program or part
40 of the program throughout a county, if another municipality is allowed to provide a building in-
41 spection program or part of a program within the same county; and

42 “(g) Enforcing the requirements of this section.

43 “(12) The department may assume administration and enforcement of a building inspection pro-
44 gram:

45 “(a) During the pendency of activities under ORS 455.770;

1 “(b) If a municipality abandons any part of the building inspection program or is no longer able
2 to administer the building inspection program; and

3 “(c) If a municipality fails to substantially comply with any provision of this section or of ORS
4 455.465, 455.467 and 455.469.

5 “(13) If the department assumes the administration and enforcement of a building inspection
6 program under this section, in addition to any other power granted to the director, the director may:

7 “(a) Enter into agreements with local governments under ORS 455.185 regarding the adminis-
8 tration and enforcement of the assumed building inspection program;

9 “(b) Take action as described in ORS 455.192 to ensure that sufficient staff and other resources
10 are available for the administration and enforcement of the assumed building inspection program;
11 and

12 “(c) Charge fees described in ORS 455.195 for department services provided in administering and
13 enforcing the assumed building inspection program.

14 “(14) If a municipality abandons or otherwise ceases to administer all or part of a building in-
15 spection program described in this section, the municipality may not resume the administration and
16 enforcement of the abandoned program or part of a program for at least two years. The municipality
17 may resume the administration and enforcement of the abandoned program or part of a program only
18 on July 1 of an odd-numbered year. To resume the administration and enforcement of the abandoned
19 program or part of a program, the municipality must comply with ORS 455.148, including the re-
20 quirement that the municipality administer and enforce all aspects of the building inspection pro-
21 gram. Thereafter, the municipality is subject to ORS 455.148 and ceases to be subject to this
22 section.

23 “(15) A municipality that administers and enforces a building inspection program under this
24 section shall include in the program the inspection of boilers and pressure vessels described in
25 subsection (1)(a)(H) of this section.

26 “**SECTION 20.** ORS 455.312 is amended to read:

27 “455.312. (1) *[For a residential prefabricated]* **Except as provided in subsection (2) of this**
28 **section, if the manufacturer intends a** structure manufactured in this state *[and intended]* **to be**
29 **for delivery in another state, the Director of the Department of Consumer and Business Services**
30 **may not require that:**

31 “(a) The *[prefabricated]* structure conform to the state building code.

32 “(b) An inspector provide plan approvals and inspections pursuant to ORS 455.715 to 455.740.

33 “(c) A person licensed under ORS 479.630, 693.060 or 693.103 perform electrical or plumbing in-
34 stallations in the *[prefabricated]* structure.

35 “[*(2) Nothing in subsection (1) of this section exempts a person that is renting, leasing, selling,*
36 *exchanging, installing or offering for rent, lease, sale, exchange or installation a residential prefabri-*
37 *cated structure from meeting the insignia of compliance or certification stamp requirements prescribed*
38 *under ORS 455.705 if the prefabricated structure is delivered in or relocated to this state.]*

39 “**(2) If a structure described in subsection (1) of this section is delivered in or relocated**
40 **to this state, the structure shall cease to qualify for the exemption described in subsection**
41 **(1) of this section. A person renting, leasing, selling, exchanging or installing the structure,**
42 **or offering the structure for rent, lease, sale, exchange or installation, shall:**

43 “(a) **Ensure that the structure is in conformance with the state building code;**

44 “(b) **Ensure compliance with plan review and inspection requirements for the structure**
45 **as determined by the building official; and**

1 “(c) **Ensure that the structure is in compliance with applicable licensing laws.**

2 “(3) **Subsection (1) of this section does not apply to a manufactured dwelling that is**
3 **subject to ORS 446.155 to 446.200, or upon which additions, conversions or alterations of in-**
4 **stallations of equipment or material are made.**

5 “**SECTION 21.** ORS 455.705 is amended to read:

6 “455.705. (1) A manufacturer of prefabricated structures or manufacturer of prefabricated
7 structure components may not contract with a municipality or a person to perform prefabricated
8 structure plan approvals or inspections unless the person providing the plan approvals or in-
9 spections is certified or approved under subsection (2) of this section or is providing plan approvals
10 or inspections for a [*residential*] prefabricated structure that is [*intended for delivery in another*
11 *state*] **exempt under ORS 455.312 (1).**

12 “(2)(a) A person may not engage in [*prefabricated structure*] plan approvals or inspections **for a**
13 **structure** without being certified under ORS 455.715 to 455.740 or 479.810 unless the person is
14 providing plan approvals or inspections for a [*residential prefabricated structure that is intended for*
15 *delivery in another state*] **structure that is exempt under ORS 455.312 (1).**

16 “(b) **Except as provided in this paragraph,** a person may not engage in the business of pro-
17 viding [*prefabricated structure*] plan approvals or inspections **for a structure** without an approval
18 issued by the Department of Consumer and Business Services. **This paragraph does not apply to**
19 **plan approval or inspection of a structure that is exempt under ORS 455.312 (1).**

20 “(3) In accordance with any applicable provisions of ORS chapter 183, the Director of the De-
21 partment of Consumer and Business Services shall establish by rule a system for approval and reg-
22 ulation of businesses and persons who perform prefabricated structure plan approvals or inspections.
23 **This subsection does not authorize the director to require or regulate plan approval or in-**
24 **spection of a prefabricated structure that is exempt under ORS 455.312 (1).** The system shall
25 include but not be limited to the following provisions:

26 “(a) Prescribing the form and content of and the times and procedures for submitting an appli-
27 cation for the issuance or renewal of an approval.

28 “(b) Prescribing the term of the approval and the fee for the original issue and renewal in an
29 amount that does not exceed the cost of administering the approval system. The charge for review
30 and approval of a third party inspection service shall not exceed, for the original issue, \$400 and for
31 the renewal, \$200.

32 “(c) Prescribing the conditions for initial issuance, renewal and maintenance of the approval for
33 a person certified under ORS 455.715 to 455.740 or 479.810, including but not limited to the following
34 provisions:

35 “(A) Procedures and reports for plan approvals and inspections;

36 “(B) Ethical practices and prohibitions of conflicts of interests with manufacturers of prefabri-
37 cated structures and manufacturers and suppliers of parts and services;

38 “(C) Insurance compliance requirements;

39 “(D) Procedures for use and application of insignia of compliance; and

40 “(E) Fees for and procedures for use and application of certification stamps.

41 “(d) Prescribing other actions or circumstances that constitute failure to achieve or maintain
42 approval competency or that otherwise constitute a danger to the public health or safety and for
43 which the director may refuse to issue or renew or may suspend or revoke a certification, permit
44 or certificate.

45 “(e) Prescribing the authority of the department to perform oversight monitoring including but

1 not limited to:

2 “(A) Right of entry and access to third party records and information;

3 “(B) Frequency, type and extent of the oversight monitoring and inspection of third party
4 agencies and manufacturing facilities; and

5 “(C) Frequency and description of information to be submitted as part of the monitoring process.

6 “(f) Prescribing fees for monitoring conducted by the department at the manufacturing plant site
7 or at third party inspection service locations, which fees shall not exceed \$60 per hour.

8 “(4)(a) The department shall establish by rule a manufacturer compliance program to allow for
9 plan approvals or inspections of prefabricated structures or prefabricated structure components at
10 the facility at which the prefabrication takes place, including but not limited to the following pro-
11 visions:

12 “(A) Quality assurance programs;

13 “(B) Procedures for use and application of insignia of compliance; and

14 “(C) Fees for and procedures for use and application of certification stamps.

15 “(b) A manufacturer of prefabricated structures shall provide the department with written notice
16 at least 60 days before a manufacturer may provide for plan approval or inspection service as al-
17 lowed under subsection (2) of this section.

18 “(c) The department is not required to provide plan approval for or inspection of any prefabri-
19 cated structure or prefabricated structure components unless the department has been notified in
20 writing by the manufacturer of the prefabricated structure 180 days in advance of the proposed as-
21 sumption of department inspections.

22 “(5) A person may not rent, lease, sell, exchange, install or offer for rent, lease, sale, exchange
23 or installation within this state a prefabricated structure constructed on or after July 1, 1991, unless
24 it bears an insignia of compliance or certification stamp issued by the department or a third party
25 indicating compliance with this state’s building regulations and standards for prefabricated struc-
26 tures. The prohibition in this subsection does not apply to a [*residential*] prefabricated structure
27 [*intended for delivery in another state unless the residential prefabricated structure is installed or of-*
28 *fered for installation in this state*] **described in ORS 455.312 (1) or (2)**. A prefabricated structure
29 with an insignia of compliance or certification stamp shall be acceptable to municipalities as meet-
30 ing the state building code regulations. Prefabricated structures constructed prior to July 1, 1991,
31 are subject to the building code regulations in effect at the time of original construction.

32 “(6) The provisions of this section do not apply to employees of the Department of Consumer
33 and Business Services and testing laboratories approved under ORS chapters 447 and 479.

34 “(7) For purposes of this section, ‘insignia of compliance’ means the plate affixed to a structure
35 by the Department of Consumer and Business Services or a third party to signify compliance with
36 all state building code requirements for which the structure was inspected.

37 “(8) Prefabricated structures or components found by the department or a third party to repre-
38 sent a danger to public health or safety shall be brought into compliance with building code regu-
39 lations or removed from the state.

40 “(9) All plan approvals and inspections of prefabricated structures and prefabricated components
41 constructed at manufacturing plants outside of Oregon but intended for delivery into Oregon shall
42 be performed by the department or conducted under ORS 455.430.

43 “**SECTION 22.** ORS 455.895 is amended to read:

44 “455.895. (1)(a) The State Plumbing Board may impose a civil penalty against a person as pro-
45 vided under ORS 447.992 and 693.992. Amounts recovered under this paragraph are subject to ORS

1 693.165.

2 “(b) The Electrical and Elevator Board may impose a civil penalty against a person as provided
3 under ORS 479.995. Amounts recovered under this paragraph are subject to ORS 479.850.

4 “(c) The Board of Boiler Rules may impose a civil penalty against a person as provided under
5 ORS 480.670. Amounts recovered under this paragraph are subject to ORS 480.670.

6 “(2) The Department of Consumer and Business Services, or an appropriate advisory board, if
7 any, may at its discretion impose a civil penalty against any person who violates the state building
8 code or ORS 446.003 to 446.200, 446.225 to 446.285, 446.395 to 446.420, 446.566 to 446.646, 446.666 to
9 446.746, 479.510 to 479.945, 479.950 or 480.510 to 480.670, or this chapter or ORS chapter 447, 460
10 or 693, or any rule adopted or order issued for the administration and enforcement of those statutes.
11 Except as provided in subsections (3), (4) and (9) of this section or ORS 446.995, a civil penalty im-
12 posed under this section must be in an amount determined by the appropriate advisory board or the
13 department of not more than \$5,000 for each offense or, in the case of a continuing offense, not more
14 than \$1,000 for each day of the offense.

15 “(3) Each violation of ORS 446.003 to 446.200 or 446.225 to 446.285, or any rule or order issued
16 under ORS 446.003 to 446.200 or 446.225 to 446.285, constitutes a separate violation with respect to
17 each manufactured [*structure*] **dwelling** or with respect to each failure or refusal to allow or perform
18 an act required [*thereby*] **under ORS 446.003 to 446.200 or 446.225 to 446.285**, except that the
19 maximum civil penalty may not exceed \$1 million for any related series of violations occurring
20 within one year from the date of the first violation.

21 “(4) The department may impose a civil penalty of not more than \$25,000 against a public body
22 responsible for administering and enforcing a building inspection program. As used in this sub-
23 section, ‘public body’ has the meaning given that term in ORS 174.109.

24 “(5) The maximum penalty established by this section for a violation may be imposed only upon
25 a finding that the person has engaged in a pattern of violations. The department, by rule, shall de-
26 fine what constitutes a pattern of violations. Except as provided in subsections (1) and (10) of this
27 section, moneys received from any civil penalty under this section are appropriated continuously for
28 and shall be used by the department for enforcement and administration of provisions and rules de-
29 scribed in subsection (2) of this section.

30 “(6) Civil penalties under this section shall be imposed as provided in ORS 183.745.

31 “(7) A civil penalty imposed under this section may be remitted or reduced upon such terms and
32 conditions as the department or the appropriate advisory board considers proper and consistent with
33 the public health and safety. In any judicial review of a civil penalty imposed under this section, the
34 court may, in its discretion, reduce the penalty.

35 “(8) Any officer, director, shareholder or agent of a corporation, or member or agent of a part-
36 nership or association, who personally participates in or is an accessory to any violation by the
37 partnership, association or corporation of a provision or rule described in subsection (2) of this
38 section is subject to the penalties prescribed in this section.

39 “(9) In addition to the civil penalty set forth in subsection (1) or (2) of this section, any person
40 who violates a provision or rule described in subsection (2) of this section may be required by the
41 department or the appropriate advisory board to forfeit and pay to the General Fund of the State
42 Treasury a civil penalty in an amount determined by the department or advisory board that does
43 not exceed five times the amount by which such person profited in any transaction that violates a
44 provision or rule described in subsection (2) of this section.

45 “(10) If a civil penalty is imposed for a violation of a provision of ORS 446.566 to 446.646 and

1 the violation relates to a filing or failure to file with a county assessor functioning as agent of the
2 department, the department, after deducting an amount equal to the department's procedural, col-
3 lection and other related costs and expenses, shall forward one-half of the remaining civil penalty
4 amount to the county in which the manufactured structure is located at the time of the violation.

5 **“SECTION 23.** ORS 479.540 is amended to read:

6 “479.540. (1) Except as otherwise provided in this subsection, a person is not required to obtain
7 a license to make an electrical installation on residential or farm property that is owned by the
8 person or a member of the person's immediate family if the property is not intended for sale, ex-
9 change, lease or rent. The following apply to the exemption established in this subsection:

10 “(a) The exemption established for a person under this subsection does not exempt the work
11 performed by the person from having to comply with the requirements for such work under ORS
12 chapter 455 or this chapter and rules adopted thereunder.

13 “(b) If the property is a building used as a residence and is for rent, lease, sale or exchange, this
14 subsection establishes an exemption for work on, alterations to or replacement of parts of electrical
15 installations as necessary for maintenance of the existing electrical installations on that property,
16 but does not exempt new electrical installations or substantial alterations to existing electrical in-
17 stallations on that property. As used in this paragraph, ‘new electrical installations or substantial
18 alterations’ does not include the replacement of an existing garbage disposal, dishwasher or electric
19 hot water heater with a similar appliance of 30 amps or less, single phase, by a landlord, landlord's
20 agent or the employee of the landlord or landlord's agent.

21 “(2) An electrical contractor license is not required in connection with an electrical installation:

22 “(a) Of meters and similar devices for measuring electricity by a person principally engaged in
23 the business of generating or selling electricity in connection with the construction or maintenance
24 of electrical lines, wires or equipment.

25 “(b) Of ignition or lighting systems for motor vehicles.

26 “(c) To be made by a person on the person's property in connection with the person's business.

27 “(d) To be made by a public utility, consumer-owned utility as defined in ORS 757.270, telecom-
28 munications carrier as defined in ORS 133.721, competitive telecommunications provider as defined
29 in ORS 759.005 or municipality for generation, transmission or distribution of electricity on property
30 that the utility, carrier, provider or municipality owns or manages.

31 “(3) A person whose sole business is generating or selling electricity in connection with the
32 construction or maintenance of electrical lines, wires or equipment, is not required to obtain a li-
33 cense to transform, transmit or distribute electricity from its source to the service head of the
34 premises to be supplied thereby.

35 “(4)(a) A person is not required to obtain a license for the repair or replacement of light fix-
36 tures, light switches, lighting ballast, electrical outlets or smoke alarms in a building used for
37 housing purposes that is owned, leased, managed or operated by a housing authority and the person
38 doing the repair or replacement is a member of the housing authority's regular maintenance staff.

39 “(b) A license is not required for:

40 “(A) Temporary demonstrations;

41 “(B) A street lighting system located on a public street or in a right of way if the system is
42 similar to a system provided by a public utility and the installation or maintenance, or both, is
43 performed by a qualified employee of a licensed electrical contractor principally engaged in the
44 business of installing and maintaining such systems; or

45 “(C) An outdoor transmission or distribution system, whether overhead or underground, if the

1 system is similar to a system provided by a public utility and the installation or maintenance, or
2 both, is performed by a qualified employee of a licensed electrical contractor principally engaged in
3 the business of installing and maintaining such systems.

4 “(c) For the purposes of this subsection, ‘qualified employee’ means an employee who has regis-
5 tered with or graduated from a State of Oregon or federally approved apprenticeship course de-
6 signed for the work being performed. The supervising electrician signature required under ORS
7 479.560 (1)(b) does not apply to contractors working under this subsection.

8 “(5) The provisions of ORS 479.510 to 479.945 and 479.995 do not apply:

9 “(a) To electrical products owned by, supplied to or to be supplied to a public utility as defined
10 in ORS 757.005, consumer-owned utility as defined in ORS 757.270, telecommunications carrier as
11 defined in ORS 133.721 or competitive telecommunications provider as defined in ORS 759.005;

12 “(b) To electrical installations made by or for a public utility, consumer-owned utility, telecom-
13 munications carrier or competitive telecommunications provider if the electrical installations are
14 an integral part of the equipment or electrical products of the utility, carrier or provider; or

15 “(c) To any electrical generation plant owned or operated by a municipality to the same extent
16 that a utility, telecommunications carrier or competitive telecommunications provider is exempted
17 under paragraphs (a) and (b) of this subsection.

18 “(6) A permit is not required:

19 “(a) For the repair or replacement of light fixtures, light switches, lighting ballast, electrical
20 outlets or smoke alarms in a building used for housing purposes that is owned, leased, managed or
21 operated by a housing authority; or

22 “(b) For the repair, alteration or replacement of existing electrical products or electrical in-
23 stallations authorized by ORS 479.560 (3) at an industrial plant, a commercial office building, a
24 building that is owned, leased, managed or operated by the state or a local government entity or
25 other facilities designated by the Electrical and Elevator Board when the owner, operating manager
26 or electrical contractor of the facility meets the provisions of ORS 479.630 (1) and (2) and:

27 “(A) Obtains a master permit for inspection under ORS 479.560 (3); or

28 “(B) Obtains a master individual inspection permit under ORS 479.565.

29 “(7) In cases of emergency in industrial plants, a permit is not required in advance for electrical
30 installation made by a person licensed as a general supervising electrician, a general journeyman
31 electrician or an electrical apprentice under ORS 479.630 if an application accompanied by appro-
32 priate fee for a permit is submitted to the Department of Consumer and Business Services within
33 five days after the commencement of such electrical work.

34 “(8)(a) A license or permit is not required for the installation or assembly of industrial electrical
35 equipment by the duly authorized agents of the factory, vendor or owner.

36 “(b) The license and permit exemptions of this subsection do not apply to activity in an area
37 where industrial electrical equipment is installed in or enters a hazardous location or penetrates
38 or enters a fire rated assembly or plenum rated assembly.

39 “(c) As used in this subsection:

40 “(A) ‘Duly authorized agents’ means individuals trained by the factory or a vendor or by expe-
41 rience and who are knowledgeable in the operation, maintenance, repair and installation of indus-
42 trial electrical equipment.

43 “(B) ‘Installation or assembly’ means the reassembly at a job site of equipment that is wired and
44 assembled at the factory and then disassembled for shipping purposes or of existing equipment that
45 is relocated. ‘Installation or assembly’ does not include work involving field fabricated assemblies

1 or any other electrical product that is not an original part of the industrial electrical equipment.
2 'Installation or assembly' does not include the connection of industrial electrical equipment to a
3 power source.

4 "(9) The provisions of ORS 479.510 to 479.945 and 479.995 do not apply to:

5 "(a) Electrical installations and repairs involving communication and signal systems of railroad
6 companies.

7 "(b) Electrical installations and repairs involving remote and permanent broadcast systems of
8 radio and television stations licensed by the Federal Communications Commission if the systems are
9 not part of the building's permanent wiring.

10 "(c) The installing, maintaining, repairing or replacement of telecommunications systems on the
11 provider side of the demarcation point by a telecommunications service provider.

12 "(d) The maintaining, repairing or replacement of telecommunications equipment on the cus-
13 tomer side of the demarcation point by a telecommunications service provider.

14 "(e) Installations, by a telecommunications service provider or an appropriately licensed elec-
15 trical contractor, of telecommunications systems on the customer side of the demarcation point ex-
16 cept:

17 "(A) Installations involving more than 10 telecommunications outlets; and

18 "(B) Installations of any size that penetrate fire-resistive construction or air handling systems
19 or that pass through hazardous locations.

20 "(f) Notwithstanding paragraph (e) of this subsection, installation of telecommunications systems
21 on the customer side of the demarcation point in:

22 "(A) One and two family dwellings; and

23 "(B) Multifamily dwellings having not more than four dwelling units if the installation is by a
24 telecommunications service provider.

25 "(g) Notwithstanding paragraph (e) of this subsection, installation or replacement of cord or plug
26 connected telecommunications equipment on the customer side of the demarcation point.

27 "(h) Notwithstanding paragraph (e) of this subsection, installation of patch cord and jumper
28 cross-connected equipment on the customer side of the demarcation point.

29 "(10)(a) The board may grant partial or complete exemptions by rule for any electrical product
30 from any of the provisions of ORS 455.610 to 455.630 or 479.510 to 479.945 and 479.995 if the board
31 determines that the electrical product does not present a danger to the health and safety of the
32 people of this state.

33 "(b) If the board grants an exemption pursuant to subsection (1) of this section, the board may
34 determine that the product may be installed by a person not licensed under ORS 479.510 to 479.945.

35 "(11) ORS 479.760 does not apply to products described in this subsection that comply with the
36 electrical product safety standards established by concurrence of the board and the Director of the
37 Department of Consumer and Business Services as described under ORS 479.730. This subsection
38 does not exempt any products used in locations determined to be hazardous in the electrical code
39 of this state. The following apply to this subsection:

40 "(a) Except as provided in paragraph (b) of this subsection, the exemption under this subsection
41 applies to:

42 "(A) The rotating equipment portion of power generation equipment.

43 "(B) Testing equipment used in a laboratory or hospital.

44 "(C) Commercial electrical air conditioning equipment.

45 "(D) Prefabricated work performed by an electrical contractor with licensed electrical personnel

1 in the contractor's place of business for assembly on the job site if the work is composed of parts
2 that meet the electrical product safety standards established by concurrence of the board and the
3 director.

4 "(b) Notwithstanding paragraph (a) of this subsection, the board may require any of the products
5 described in paragraph (a) of this subsection to be subject to the certification requirements under
6 ORS 479.760 if the board determines that the product or class of products has presented a fire or
7 life safety hazard in use. A determination under this paragraph shall be effective as to any such
8 product or class of products installed after the date of the determination becomes final. The board
9 may reinstate any exemption removed under this paragraph if the board determines that the reasons
10 for the removal of the exemption have been corrected.

11 "(12)(a) ORS 479.610 does not apply to installations of industrial electrical equipment unless the
12 board determines that the product or class of products may present a fire or life safety hazard.

13 "(b) The board may reinstate an exemption removed under this subsection if the product quali-
14 fies for reinstatement under:

15 "(A) An equipment safety program approved by the board;

16 "(B) Equipment minimum safety standards established by concurrence of the board and the di-
17 rector;

18 "(C) An evaluation by an approved field evaluation firm;

19 "(D) A listing from a nationally recognized testing laboratory;

20 "(E) An evaluation of a first model of a product by the board; or

21 "(F) Any other method approved by the board.

22 "(13) ORS 479.760 does not apply to electrical equipment that has been installed and in use for
23 one year or more.

24 "(14) A person who holds a limited maintenance specialty contractor license or a limited pump
25 installation specialty contractor license issued under ORS 479.510 to 479.945 or a person who is the
26 employee of such license holder and who is listed with the board as an employee is not required to
27 have a journeyman license or supervising electrician's license to perform work authorized under the
28 person's license.

29 "(15) A person is not required to obtain a permit for work on, alterations to or replacement of
30 parts of electrical installations as necessary for maintenance of existing electrical installations on
31 residential property owned by the person or by a member of the person's immediate family. This
32 subsection does not establish an exemption for new electrical installations or substantial alterations
33 to existing electrical installations.

6 “**SECTION 24.** ORS 693.020 is amended to read:

7 “693.020. (1) Except as provided in subsection (2) of this section, this chapter does not apply to:

8 “(a) A person working on a building or premises owned by the person, regardless of whether the
9 person holds a license under this chapter, if the person complies with all the rules adopted under
10 this chapter and ORS 447.010 to 447.156 and ORS chapter 455.

11 “(b) A person testing, repairing, servicing, maintaining, installing or replacing new or existing
12 potable water pump equipment not exceeding seven and one-half horsepower on residential property
13 and piping between the pumps and storage tanks for the pumps, regardless of whether the person
14 holds any license under this chapter.

15 “(c) A person installing exterior storm drains that are not connected to a sanitary sewer or
16 combination sanitary storm sewer.

17 “(d) An employee or contractor of a utility, energy service provider or water supplier who is
18 installing an approved low-flow showerhead or faucet aerator in existing plumbing fixtures. The de-
19 vices installed under this paragraph are exempt from the certification, permit and inspection re-
20 quirements of this chapter and ORS 447.010 to 447.156.

21 “(e) A person who owns, leases or operates residential property and who repairs, or uses regular

31 *is designed for residential use and intended for delivery in another state]* **that is exempt under ORS**
32 **455.312 (1).**

34 as defined *[by the State Plumbing Board by rule]* **in section 25 of this 2019 Act.**

25 “(b) An individual who offers or negotiates terms of a residential mortgage loan with or on be-
26 half of the individual’s spouse, child, sibling, parent, grandparent, grandchild or a relative in a sim-
27 ilar relationship with the individual that is created by law, marriage or adoption;

28 “(c) An individual who offers or negotiates terms of a residential mortgage loan that is secured
29 by a dwelling that served as the individual’s residence;

30 “(d) An individual who, as a seller during any 12-month period, offers or negotiates terms for
31 not more than three residential mortgage loans that are secured by a dwelling unit that the indi-
32 vidual owns, or that a limited liability company of which the individual is a member owns, and that
33 did not serve as the individual’s residence, if:

34 “(A) Membership in the limited liability company that owns the dwelling unit consists only of

2 that for the purposes of determining whether the attorney is exempt under this paragraph, the at-
3 torney does not receive compensation from a mortgage loan originator or lender if the attorney re-
4 ceives compensation from a client that would otherwise meet the definition of a mortgage loan
5 originator or lender but is exempt under paragraph (c), (d) or (f) of this subsection;

6 “(f) An individual who is licensed as a manufactured structure dealer under ORS 446.691 and
7 who:

8 “(A) Offers or negotiates terms of a residential mortgage loan related to a sale for occupancy
9 of a previously owned manufactured dwelling in a manufactured dwelling park three or fewer times
10 in any 12-month period; and

11 “(B) Uses a written sale agreement form with the purchaser that complies with the requirements
12 of ORS 646A.050, 646A.052 and 646A.054, with any rules adopted under ORS 646A.050, 646A.052 and
13 646A.054 and with any other applicable requirements for residential mortgages for manufactured
14 dwellings; or

15 “(g) An individual who is licensed as a limited manufactured structure dealer under ORS 446.706
16 and who:

17 “(A) Has an ownership interest in a manufactured dwelling park;

18 “(B) Offers or negotiates terms of a residential mortgage loan related to a sale for occupancy
19 of a previously owned manufactured dwelling in any manufactured dwelling park in which the indi-
20 vidual has an ownership interest, five or fewer times in any 12-month period; and

21 “(C) Uses a written sale agreement form with the purchaser that complies with the requirements
22 of ORS 646A.050, 646A.052 and 646A.054, with any rules adopted under ORS 646A.050, 646A.052 and
23 646A.054 and with any other applicable requirements for residential mortgages for manufactured
24 dwellings.

25 “(3) An individual who offers or negotiates terms for a residential mortgage loan, and who
26 claims an exemption under subsection (2)(c), (d) or (f) of this section from the requirements set forth
27 in subsection (1) of this section, may not at any time hold more than eight residential mortgage
28 loans without meeting the requirements set forth in subsection (1) of this section. For the purposes
29 of a determination under this subsection as to whether an individual who claims an exemption under
30 subsection (2)(d) of this section holds more or fewer than eight residential mortgage loans, the in-
31 dividual shall disclose to the Director of the Department of Consumer and Business Services all
32 loans that all limited liability companies of which the individual is a member hold in the aggregate.

33 “(4) An individual who offers or negotiates terms for a residential mortgage loan, and who
34 claims an exemption under subsection (2)(g) of this section from the requirements set forth in sub-
35 section (1) of this section, may not at any time hold more than 12 residential mortgage loans without

4 “(B) Receives in connection with a sale or other transaction related to a manufactured struc-
5 ture, as defined in [ORS 446.003] **section 25 of this 2019 Act**, only a salary or commission that is
6 customary among dealers and employees of dealers.

7 “(b) An employee of a dealer is subject to the provisions of ORS 86A.200 to 86A.239 if the United
8 States Consumer Financial Protection Bureau determines, in a guideline, rule, regulation or inter-
9 pretive letter, that the exemption granted in paragraph (a) of this subsection is inconsistent with
10 requirements set forth in 12 U.S.C. 5101 et seq.

11 “**SECTION 28.** ORS 90.100 is amended to read:

12 “90.100. As used in this chapter, unless the context otherwise requires:

13 “(1) ‘Accessory building or structure’ means any portable, demountable or permanent structure,
14 including but not limited to cabanas, ramadas, storage sheds, garages, awnings, carports, decks,
15 steps, ramps, piers and pilings, that is:

16 “(a) Owned and used solely by a tenant of a manufactured dwelling or floating home; or

17 “(b) Provided pursuant to a written rental agreement for the sole use of and maintenance by a
18 tenant of a manufactured dwelling or floating home.

19 “(2) ‘Action’ includes recoupment, counterclaim, setoff, suit in equity and any other proceeding
20 in which rights are determined, including an action for possession.

21 “(3) ‘Applicant screening charge’ means any payment of money required by a landlord of an
22 applicant prior to entering into a rental agreement with that applicant for a residential dwelling
23 unit, the purpose of which is to pay the cost of processing an application for a rental agreement for
24 a residential dwelling unit.

25 “(4) ‘Building and housing codes’ includes any law, ordinance or governmental regulation con-
26 cerning fitness for habitation, or the construction, maintenance, operation, occupancy, use or ap-
27 pearance of any premises or dwelling unit.

28 “(5) ‘Carbon monoxide alarm’ has the meaning given that term in ORS 105.836.

29 “(6) ‘Carbon monoxide source’ has the meaning given that term in ORS 105.836.

30 “(7) ‘Conduct’ means the commission of an act or the failure to act.

31 “(8) ‘DBH’ means the diameter at breast height, which is measured as the width of a standing
32 tree at four and one-half feet above the ground on the uphill side.

33 “(9) ‘Dealer’ means any person in the business of selling, leasing or distributing new or used
34 manufactured dwellings or floating homes to persons who purchase or lease a manufactured dwelling
35 or floating home for use as a residence.

36 “(10) ‘Domestic violence’ means:

37 “(a) Abuse between family or household members, as those terms are defined in ORS 107.705;
38 or

39 “(b) Abuse, as defined in ORS 107.705, between partners in a dating relationship.

40 “(11) ‘Drug and alcohol free housing’ means a dwelling unit described in ORS 90.243.

41 “(12) ‘Dwelling unit’ means a structure or the part of a structure that is used as a home, resi-
42 dence or sleeping place by one person who maintains a household or by two or more persons who
43 maintain a common household. ‘Dwelling unit’ regarding a person who rents a space for a manu-
44 factured dwelling or recreational vehicle or regarding a person who rents moorage space for a
45 floating home as defined in ORS 830.700, but does not rent the home, means the space rented and

1 not the manufactured dwelling, recreational vehicle or floating home itself.

2 “(13) ‘Essential service’ means:

3 “(a) For a tenancy not consisting of rental space for a manufactured dwelling, floating home or
4 recreational vehicle owned by the tenant and not otherwise subject to ORS 90.505 to 90.850:

5 “(A) Heat, plumbing, hot and cold running water, gas, electricity, light fixtures, locks for exte-
6 rior doors, latches for windows and any cooking appliance or refrigerator supplied or required to
7 be supplied by the landlord; and

8 “(B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.320,
9 the lack or violation of which creates a serious threat to the tenant’s health, safety or property or
10 makes the dwelling unit unfit for occupancy.

11 “(b) For a tenancy consisting of rental space for a manufactured dwelling, floating home or
12 recreational vehicle owned by the tenant or that is otherwise subject to ORS 90.505 to 90.850:

13 “(A) Sewage disposal, water supply, electrical supply and, if required by applicable law, any
14 drainage system; and

15 “(B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.730,
16 the lack or violation of which creates a serious threat to the tenant’s health, safety or property or
17 makes the rented space unfit for occupancy.

18 “(14) ‘Facility’ means a manufactured dwelling park or a marina.

19 “(15) ‘Fee’ means a nonrefundable payment of money.

20 “(16) ‘First class mail’ does not include certified or registered mail, or any other form of mail
21 that may delay or hinder actual delivery of mail to the recipient.

22 “(17) ‘Fixed term tenancy’ means a tenancy that has a fixed term of existence, continuing to a
23 specific ending date and terminating on that date without requiring further notice to effect the ter-
24 mination.

25 “(18) ‘Floating home’ has the meaning given that term in ORS 830.700. ‘Floating home’ includes
26 an accessory building or structure.

27 “(19) ‘Good faith’ means honesty in fact in the conduct of the transaction concerned.

28 “(20) ‘Hazard tree’ means a tree that:

29 “(a) Is located on a rented space in a manufactured dwelling park;

30 “(b) Measures at least eight inches DBH; and

31 “(c) Is considered, by an arborist licensed as a landscape construction professional pursuant to
32 ORS 671.560 and certified by the International Society of Arboriculture, to pose an unreasonable
33 risk of causing serious physical harm or damage to individuals or property in the near future.

34 “(21) ‘Hotel or motel’ means ‘hotel’ as that term is defined in ORS 699.005.

35 “(22) ‘Informal dispute resolution’ means, but is not limited to, consultation between the landlord
36 or landlord’s agent and one or more tenants, or mediation utilizing the services of a third party.

37 “(23) ‘Landlord’ means the owner, lessor or sublessor of the dwelling unit or the building or
38 premises of which it is a part. ‘Landlord’ includes a person who is authorized by the owner, lessor
39 or sublessor to manage the premises or to enter into a rental agreement.

40 “(24) ‘Landlord’s agent’ means a person who has oral or written authority, either express or
41 implied, to act for or on behalf of a landlord.

42 “(25) ‘Last month’s rent deposit’ means a type of security deposit, however designated, the pri-
43 mary function of which is to secure the payment of rent for the last month of the tenancy.

44 “(26) ‘Manufactured dwelling’ means a residential trailer, a mobile home or a manufactured
45 home as those terms are defined in ORS 446.003. ‘Manufactured dwelling’ includes an accessory

1 building or structure. [*Manufactured dwelling* does not include a recreational vehicle.]

2 “(27) ‘Manufactured dwelling park’ means a place where four or more manufactured dwellings
3 are located, the primary purpose of which is to rent space or keep space for rent to any person for
4 a charge or fee.

5 “(28) ‘Marina’ means a moorage of contiguous dwelling units that may be legally transferred as
6 a single unit and are owned by one person where four or more floating homes are secured, the pri-
7 mary purpose of which is to rent space or keep space for rent to any person for a charge or fee.

8 “(29) ‘Marina purchase association’ means a group of three or more tenants who reside in a
9 marina and have organized for the purpose of eventual purchase of the marina.

10 “(30) ‘Month-to-month tenancy’ means a tenancy that automatically renews and continues for
11 successive monthly periods on the same terms and conditions originally agreed to, or as revised by
12 the parties, until terminated by one or both of the parties.

13 “(31) ‘Organization’ includes a corporation, government, governmental subdivision or agency,
14 business trust, estate, trust, partnership or association, two or more persons having a joint or com-
15 mon interest, and any other legal or commercial entity.

16 “(32) ‘Owner’ includes a mortgagee in possession and means one or more persons, jointly or se-
17 verally, in whom is vested:

18 “(a) All or part of the legal title to property; or

19 “(b) All or part of the beneficial ownership and a right to present use and enjoyment of the
20 premises.

21 “(33) ‘Person’ includes an individual or organization.

22 “(34) ‘Premises’ means:

23 “(a) A dwelling unit and the structure of which it is a part and facilities and appurtenances
24 therein;

25 “(b) Grounds, areas and facilities held out for the use of tenants generally or the use of which
26 is promised to the tenant; and

27 “(c) A facility for manufactured dwellings or floating homes.

28 “(35) ‘Prepaid rent’ means any payment of money to the landlord for a rent obligation not yet
29 due. In addition, ‘prepaid rent’ means rent paid for a period extending beyond a termination date.

30 “(36) ‘Recreational vehicle’ has the meaning given that term in [ORS 446.003] **section 25 of this**
31 **2019 Act.**

32 “(37) ‘Rent’ means any payment to be made to the landlord under the rental agreement, periodic
33 or otherwise, in exchange for the right of a tenant and any permitted pet to occupy a dwelling unit
34 to the exclusion of others and to use the premises. ‘Rent’ does not include security deposits, fees
35 or utility or service charges as described in ORS 90.315 (4) and 90.532.

36 “(38) ‘Rental agreement’ means all agreements, written or oral, and valid rules and regulations
37 adopted under ORS 90.262 or 90.510 (6) embodying the terms and conditions concerning the use and
38 occupancy of a dwelling unit and premises. ‘Rental agreement’ includes a lease. A rental agreement
39 shall be either a week-to-week tenancy, month-to-month tenancy or fixed term tenancy.

40 “(39) ‘Roomer’ means a person occupying a dwelling unit that does not include a toilet and ei-
41 ther a bathtub or a shower and a refrigerator, stove and kitchen, all provided by the landlord, and
42 where one or more of these facilities are used in common by occupants in the structure.

43 “(40) ‘Screening or admission criteria’ means a written statement of any factors a landlord
44 considers in deciding whether to accept or reject an applicant and any qualifications required for
45 acceptance. ‘Screening or admission criteria’ includes, but is not limited to, the rental history,

1 character references, public records, criminal records, credit reports, credit references and incomes
2 or resources of the applicant.

3 “(41) ‘Security deposit’ means a refundable payment or deposit of money, however designated,
4 the primary function of which is to secure the performance of a rental agreement or any part of a
5 rental agreement. ‘Security deposit’ does not include a fee.

6 “(42) ‘Sexual assault’ has the meaning given that term in ORS 147.450.

7 “(43) ‘Squatter’ means a person occupying a dwelling unit who is not so entitled under a rental
8 agreement or who is not authorized by the tenant to occupy that dwelling unit. ‘Squatter’ does not
9 include a tenant who holds over as described in ORS 90.427 (7).

10 “(44) ‘Stalking’ means the behavior described in ORS 163.732.

11 “(45) ‘Statement of policy’ means the summary explanation of information and facility policies
12 to be provided to prospective and existing tenants under ORS 90.510.

13 “(46) ‘Surrender’ means an agreement, express or implied, as described in ORS 90.148 between
14 a landlord and tenant to terminate a rental agreement that gave the tenant the right to occupy a
15 dwelling unit.

16 “(47) ‘Tenant’:

17 “(a) Except as provided in paragraph (b) of this subsection:

18 “(A) Means a person, including a roomer, entitled under a rental agreement to occupy a dwell-
19 ing unit to the exclusion of others, including a dwelling unit owned, operated or controlled by a
20 public housing authority.

21 “(B) Means a minor, as defined and provided for in ORS 109.697.

22 “(b) For purposes of ORS 90.505 to 90.850, means only a person who owns and occupies as a
23 residence a manufactured dwelling or a floating home in a facility and persons residing with that
24 tenant under the terms of the rental agreement.

25 “(c) Does not mean a guest or temporary occupant.

26 “(48) ‘Transient lodging’ means a room or a suite of rooms.

27 “(49) ‘Transient occupancy’ means occupancy in transient lodging that has all of the following
28 characteristics:

29 “(a) Occupancy is charged on a daily basis and is not collected more than six days in advance;

30 “(b) The lodging operator provides maid and linen service daily or every two days as part of the
31 regularly charged cost of occupancy; and

32 “(c) The period of occupancy does not exceed 30 days.

33 “(50) ‘Vacation occupancy’ means occupancy in a dwelling unit, not including transient occu-
34 pancy in a hotel or motel, that has all of the following characteristics:

35 “(a) The occupant rents the unit for vacation purposes only, not as a principal residence;

36 “(b) The occupant has a principal residence other than at the unit; and

37 “(c) The period of authorized occupancy does not exceed 45 days.

38 “(51) ‘Victim’ means:

39 “(a) The person against whom an incident related to domestic violence, sexual assault or stalk-

41 “(b) The parent or guardian of a minor household member against whom an incident related to
42 domestic violence, sexual assault or stalking is perpetrated, unless the parent or guardian is the
43 perpetrator.

2 appliance that is subject to inspection under ORS 480.410 to 480.460 unless the person has received
3 an LP gas fitter license from the State Fire Marshal in accordance with ORS 480.410 to 480.460.

4 “(3) A person may not operate any LP gas delivery equipment installed on a motorized vehicle
5 unless the person has received an LP gas truck equipment license from the State Fire Marshal in
6 accordance with ORS 480.410 to 480.460.

7 “(4) Any person under the terms of this section who is required to have an LP gas fitter or LP
8 gas truck equipment license is also required to have an LP gas installation license, unless the per-
9 son is an employee of an employer who has an LP gas installation license as provided by this sec-
10 tion.

11 “(5) A person who holds a valid journeyman plumber license under ORS 693.060 or who is in
12 an approved journeyman plumber apprenticeship established under ORS 660.002 to 660.210 is exempt

33 reported. The State Fire Marshal may require that the notification include the location and de-
34 scription of the installation and the name of the user. All fees due and payable must accompany the
35 notification. The replacement of empty containers or receptacles with other containers constructed
36 in accordance with United States Department of Transportation specifications is not a new instal-
37 lation or change in the original installation that requires notification to the State Fire Marshal or
38 necessitates further inspection of the installation. The State Fire Marshal shall collect from the in-
39 staller an installation fee of \$50 for each tank installed or for all tanks at the installation if the total
40 combined capacity is 200 gallons or less. The State Fire Marshal or deputies of the fire marshal or
41 assistants shall inspect a reasonable number of the installations and maintain a record of the in-
42 spections in the office of the State Fire Marshal.

43 “(2) In addition to any installation or inspection fee, the State Fire Marshal may charge a plan
44 review fee, not to exceed \$100, for any liquefied petroleum gas container and receptacle plan review
45 required under a uniform fire code prescribed by the State Fire Marshal by rule.

1 “(3) After the initial installation, liquefied petroleum gas containers may be inspected once ev-
2 ery 10 years except when changes have been made in the original installation. An installer making
3 changes must notify the State Fire Marshal of the changes in the same manner provided in this
4 section for new installations. The State Fire Marshal shall collect from the owner a fee of \$50 for
5 the inspection of each container. The manner of inspection, requirement of corrections, satisfaction
6 of requirements and collection of fees due and payable must conform with the provisions of ORS
7 480.410 to 480.460 for new installations. Upon request of the State Fire Marshal, LP gas installation
8 licensees shall furnish a list of the locations of 10-year old installations that they service.

9 “(4) If, upon inspection of any tank, the new installation does not comply with the requirements
10 of the State Fire Marshal, the State Fire Marshal shall instruct the installer as to what corrections
11 are necessary for compliance with the State Fire Marshal’s requirements. The installer of the new
12 installation shall, within the time set by the State Fire Marshal, not to exceed 60 days after notifi-

16 the new installation and shall collect from the installer an additional fee of \$125. The user, not the

20 stallation within the time set by the State Fire Marshal, not to exceed 60 days after receipt of the

5 the purchaser with a list of features that may make residential housing more accessible to a person
6 with a disability. The list may include the features identified in the model list of features adopted
7 by the Construction Contractors Board by rule under ORS 701.547.

8 “(3) The inclusion of a feature on the list supplied by the developer under subsection (2) of this
9 section does not obligate the developer to make the feature available to a purchaser. The list sup-
10 plied by the developer may specify for each feature whether the feature is standard, optional,
11 available on a limited basis or unavailable from the developer. If a listed feature is available from
12 the developer as an option or on a limited basis, the list of features may specify the stage of con-
13 struction by which the purchaser must submit to the developer any request that the residential
14 housing be constructed with that feature.

15 “(4) This section, or the inclusion of a feature on the model list developed under ORS 701.547,
16 does not affect the requirement that installation of a feature comply with the state building code
17 or be approved under ORS 455.060.

24 “**SECTION 41.** Notwithstanding section 25 of this 2019 Act and the amendments to ORS
25 **446.003** by section 1 of this 2019 Act, a rule adopted by the Director of the Department of
26 **Consumer and Business Services** under ORS 446.003 prior to the effective date of this 2019
27 **Act** defining a recreational vehicle shall continue in effect and, except as provided in section
28 **42** of this 2019 Act, be treated as a rule adopted by the Director of Transportation under
29 **section 25** of this 2019 Act until repealed or amended by the Director of Transportation.

30 “**SECTION 42.** Section 25 of this 2019 Act and the amendments to ORS 446.003, 446.155,
31 **446.160, 446.170, 446.185, 446.250, 446.253, 446.265, 455.010, 455.312, 455.705** and **455.895** by
32 **sections 1 to 4, 6, 9, 11, 13, 16** and **20 to 22** of this 2019 Act do not divest the Department of
33 **Consumer and Business Services** or a municipality of the authority over a violation of ORS
34 **chapter 446** or **455** committed prior to the effective date of this 2019 Act.
