

## SENATE AMENDMENTS TO SENATE BILL 548

By COMMITTEE ON JUDICIARY

April 18

1 In line 2 of the printed bill, after “towing;” delete the rest of the line and insert “creating new  
2 provisions; amending ORS 646.608 and 822.215; repealing ORS 98.864; and declaring an  
3 emergency.”.

4 Delete lines 4 through 11 and insert:

5 **“SECTION 1. State Board of Towing; membership; term; compensation and expenses. (1)**  
6 **The State Board of Towing is established within the Department of Transportation.**

7 **“(2) The State Board of Towing consists of nine members appointed by the Governor as**  
8 **follows:**

9 **“(a) One tower who holds a towing business certificate issued under ORS 822.205 and who**  
10 **represents a city in Oregon with a population of 100,000 or more;**

11 **“(b) One tower who holds a towing business certificate issued under ORS 822.205 and who**  
12 **represents a city in Oregon with a population of less than 100,000;**

13 **“(c) One tower who holds a towing business certificate issued under ORS 822.205 and who**  
14 **has specialized knowledge in towing equipment and vehicles with a gross vehicle weight rat-**  
15 **ing of more than 44,000 pounds;**

16 **“(d) One tower who holds a towing business certificate issued under ORS 822.205 and who**  
17 **has specialized knowledge in towing vehicles with a gross vehicle weight rating of 26,000**  
18 **pounds or less;**

19 **“(e) One member who represents the insurance industry;**

20 **“(f) One member from a tow program within the Department of State Police;**

21 **“(g) One member who is a chief of police;**

22 **“(h) One member who is a member of the public; and**

23 **“(i) One member who is a consumer advocate.**

24 **“(3) All members of the board must be residents of Oregon.**

25 **“(4) The term of office of each member of the board is four years, but a member serves**  
26 **at the pleasure of the Governor. Before the expiration of the term of a member, the Gover-**  
27 **nor shall appoint a successor whose term begins on July 1 next following. A member is eli-**  
28 **gible for reappointment. If there is a vacancy for any cause, the Governor shall make an**  
29 **appointment to become immediately effective for the unexpired term.**

30 **“(5) A member of the board is entitled to compensation and expenses as provided in ORS**  
31 **292.495.**

32 **“SECTION 2. Initial terms of office. Notwithstanding the term of office specified by sec-**  
33 **tion 1 of this 2019 Act, of the members first appointed to the State Board of Towing:**

34 **“(1) Two shall serve for a term ending July 1, 2020.**

35 **“(2) Two shall serve for a term ending July 1, 2021.**

1       “(3) Two shall serve for a term ending July 1, 2022.

2       “(4) Three shall serve for a term ending July 1, 2023.

3       “SECTION 3. Officers; quorum; meetings. (1) The State Board of Towing shall select one  
4 of its members as chairperson and another as vice chairperson, for terms and with duties  
5 and powers necessary for the performance of the functions of the offices as the board de-  
6 termines.

7       “(2) Except as provided in subsection (3) of this section, a majority of the members of  
8 the board constitutes a quorum for the transaction of business.

9       “(3) When the board is deliberating or voting on a matter before it, four members of the  
10 board constitutes a quorum.

11       “(4) No more than two members who are towers may vote on any matter. The chair-  
12 person shall assign a rotation of voting members who are towers. If an assigned member  
13 who is a tower has an actual or potential conflict of interest in a matter before the board,  
14 the chairperson shall designate a different member who is a tower and who does not have  
15 an actual or potential conflict of interest in the matter before the board to deliberate and  
16 vote on that matter.

17       “(5) The board shall meet at least once a quarter at a time and place determined by the  
18 board. The board shall also meet at such other times and places as are specified by the call  
19 of the chairperson, vice chairperson or administrative officer.

20       “SECTION 4. Administrative officer for board; other employees. (1) The State Board of  
21 Towing shall appoint an administrative officer to serve at the pleasure of the Governor. The  
22 determination of qualifications of the administrative officer and appointment of the admin-  
23 istrative officer shall be made by the board after consulting with the Governor.

24       “(2) The administrative officer may not be a member of the board.

25       “(3) The designation of the administrative officer must be by written order, filed with the  
26 Secretary of State.

27       “(4) The administrative officer is in the unclassified service under ORS chapter 240, and  
28 the board shall fix the salary of the officer in accordance with the applicable provisions of  
29 ORS chapter 240.

30       “(5) Subject to any applicable provisions of ORS chapter 240, the administrative officer  
31 shall appoint all subordinate officers and employees of the board, prescribe their duties and  
32 fix their compensation.

33       “SECTION 5. Rulemaking authority; board seal. (1) In accordance with applicable pro-  
34 visions of ORS chapter 183, the State Board of Towing may adopt rules:

35       “(a) Necessary for the administration of the laws that the board is charged with admin-  
36 istering.

37       “(b) To implement ORS 98.853 to 98.862.

38       “(2) The board may adopt a seal.

39       “SECTION 6. State Board of Towing Account. (1) The State Board of Towing Account is  
40 established in the State Treasury, separate and distinct from the General Fund.

41       “(2) The account consists of the following:

42       “(a) Moneys collected from civil penalties imposed under section 11 of this 2019 Act.

43       “(b) Moneys appropriated to the account by the Legislative Assembly.

44       “(c) Moneys from any other source.

45       “(3) Moneys in the account are continuously appropriated to the State Board of Towing

1 to carry out the provisions of sections 1 to 12 of this 2019 Act.

2 **“SECTION 7. Administration of oaths; obtaining and taking evidence at board pro-**  
3 **ceedings; effect of failure to obey board subpoena.** The State Board of Towing, acting through  
4 its chairperson or vice chairperson, may administer oaths, take depositions and issue  
5 subpoenas to compel the attendance of witnesses and the production of documents or other  
6 written information necessary to carry out the provisions of sections 1 to 12 of this 2019 Act.  
7 If any person fails to comply with a subpoena issued under this section or refuses to testify  
8 on matters on which the person lawfully may be interrogated, the procedure set out in ORS  
9 183.440 shall be followed to compel obedience.

10 **“SECTION 8. Denial, suspension, revocation or refusal of towing business certificate.** (1)  
11 As used in this section:

12 **“(a) ‘Person’ includes individuals, public bodies as defined in ORS 174.109, corporations,**  
13 **firms, associations, partnerships, limited liability companies, joint stock companies or any**  
14 **other business entity created under law.**

15 **“(b) ‘Relative’ means an individual related within the third degree as determined by the**  
16 **common law, a spouse, an individual related to a spouse within the third degree as deter-**  
17 **mined by the common law or an individual in an adoptive relationship within the third degree**  
18 **as determined by the common law.**

19 **“(2) In addition to any other penalty provided under ORS 822.215 and subject to ORS**  
20 **chapter 183, the State Board of Towing may file a written request directing the Department**  
21 **of Transportation to deny, suspend, revoke or refuse to renew a towing business certificate**  
22 **issued under ORS 822.205, if the person holding or applying for the certificate:**

23 **“(a) Fails to comply with any rule adopted by the board;**

24 **“(b) Violates any provision of, or rules or ordinances adopted under, ORS 98.853, 98.854,**  
25 **98.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605;**

26 **“(c) Fails to comply with an order of the board, including but not limited to the failure**  
27 **to pay a civil penalty as ordered by the board;**

28 **“(d) Has performed work as a tow operator without the appropriate certification or letter**  
29 **of appointment or has employed individuals to perform work as a tow operator without ap-**  
30 **propriate certification or letter of appointment;**

31 **“(e) Has advertised or otherwise held themselves out as being a certified towing business**  
32 **without holding the appropriate certificate;**

33 **“(f) As a, or as a relative of a, partner, officer, member or employee of a towing business,**  
34 **advertises or holds themselves out that the towing business is certified if the business does**  
35 **not possess the appropriate certificate;**

36 **“(g) Has engaged in towing or recovering by any means, as part of any business operation**  
37 **of the person, vehicles that are wrecked, damaged, disabled or abandoned or replacement**  
38 **vehicles;**

39 **“(h) Fails to meet any condition or requirement to obtain a certificate or letter of ap-**  
40 **pointment;**

41 **“(i) Acts or has acted in a manner creating a serious danger to the public health or**  
42 **safety; or**

43 **“(j) Has been subject to a revocation, cancellation or suspension order or to other disci-**  
44 **plinary action related to towing or the towing industry by any other public body, as defined**  
45 **in ORS 174.109, or has failed to pay a civil penalty imposed by the body.**

1           “(3) A violation described in subsection (2) of this section for which the board recom-  
2 mends the Department of Transportation deny, suspend, revoke or refuse to renew a certif-  
3 icate to perform work or conduct business may be treated as a failure to be in conformance  
4 with sections 1 to 12 of this 2019 Act.

5           “SECTION 9. Additional powers of the board. (1) In carrying out its investigative and  
6 enforcement duties, functions and powers, and notwithstanding any other provision of law,  
7 the State Board of Towing may procure services and award a contract for the personal ser-  
8 vices of a subject matter expert, on a case-by-case basis, in any manner deemed practical  
9 or convenient. The price of such contracts, including any amendments, may not exceed  
10 \$25,000.

11           “(2) If the board has reason to believe that any person has been engaged or is engaging  
12 in any violation of ORS 98.853, 98.854, 98.856, 98.858, 181A.350, 822.200, 822.215, 822.225, 822.230,  
13 822.235 or 822.605 or sections 1 to 12 of this 2019 Act or any rule adopted under those stat-  
14 utes, or any order issued by the board, the board may, without bond, bring suit in the name  
15 and on behalf of the State of Oregon in the circuit court of any county of this state to enjoin  
16 the acts or practices and to enforce compliance with ORS 98.853, 98.854, 98.856, 98.858,  
17 181A.350, 822.200, 822.215, 822.225, 822.230, 822.235 or 822.605 or sections 1 to 12 of this 2019  
18 Act or any rule adopted under those statutes, or any order issued by the board. Upon a  
19 proper showing, a permanent or temporary injunction, restraining order or writ of  
20 mandamus shall be granted.

21           “SECTION 10. Participation in the Department of State Police tow rotation. (1) As used  
22 in this section:

23           “(a) ‘Person’ includes individuals, public bodies as defined in ORS 174.109, corporations,  
24 firms, associations, partnerships, limited liability companies, joint stock companies or any  
25 other business entity created under law.

26           “(b) ‘Relative’ means an individual related within the third degree as determined by the  
27 common law, a spouse, an individual related to a spouse within the third degree as deter-  
28 mined by the common law or an individual in an adoptive relationship within the third degree  
29 as determined by the common law.

30           “(2) Subject to ORS chapter 183, the State Board of Towing may order the Department  
31 of State Police to deny, suspend, condition or revoke a letter of appointment to participate  
32 on the rotational list of towing businesses established under ORS 181A.350, if the person  
33 holding or applying for the letter of appointment:

34           “(a) Fails to comply with any rule adopted by the board;

35           “(b) Violates any provision of, or rules or ordinances adopted under, ORS 98.853, 98.854,  
36 98.856, 98.858, 181A.350, 822.200, 822.215 822.225, 822.230, 822.235 or 822.605;

37           “(c) Fails to comply with an order of the board, including but not limited to the failure  
38 to pay a civil penalty as ordered by the board;

39           “(d) Has performed work as a tow operator without the appropriate certification or letter  
40 of appointment or has employed individuals to perform work as a tow operator without ap-  
41 propriate certification or letter of appointment;

42           “(e) Has advertised or otherwise held themselves out as being a certified tow operator  
43 without holding the appropriate certificate;

44           “(f) As a, or as a relative of a, partner, officer, member or employee of a towing business,  
45 advertises or holds themselves out that the towing business is certified if the business does

1 not possess the appropriate certificate;

2 “(g) Has engaged in towing or recovering by any means, as part of any business operation  
3 of the person, vehicles that are wrecked, damaged, disabled or abandoned or replacement  
4 vehicles;

5 “(h) Fails to meet any condition or requirement to obtain a certificate or letter of ap-  
6 pointment;

7 “(i) Acts or has acted in a manner creating a serious danger to the public health or  
8 safety; or

9 “(j) Has been subject to a revocation, cancellation or suspension order or to other disci-  
10 plinary action related to towing or the towing industry by any other public body, as defined  
11 in ORS 174.109, or has failed to pay a civil penalty imposed by the body.

12 “(3) A violation described in subsection (2) of this section for which the board orders the  
13 Department of State Police to deny, suspend, condition or revoke a letter of appointment to  
14 participate on the rotational list of towing business established under ORS 181A.350 may be  
15 treated as a failure to be in conformance with sections 1 to 12 of this 2019 Act.

16 “SECTION 11. Civil penalties. (1) In addition to any other penalty provided by law, any  
17 person who violates any provision of ORS 98.853, 98.854, 98.856, 98.858, 181A.350, 822.200,  
18 822.215 822.225, 822.230, 822.235 or 822.605 or any rule adopted by the State Board of Towing  
19 is subject to payment of a civil penalty to the board.

20 “(2) The board may adopt rules establishing a schedule of civil penalties that may be  
21 imposed under this section. Civil penalties imposed under this section may not exceed \$25,000  
22 for each violation.

23 “(3) Civil penalties under this section shall be imposed as provided in ORS 183.745.

24 “(4) Notwithstanding ORS 670.335, civil penalties collected by the board under this section  
25 shall be deposited into the State Board of Towing Account established under section 6 of this  
26 2019 Act.

27 “SECTION 12. In imposing a penalty pursuant to the schedule adopted pursuant to sec-  
28 tion 11 of this 2019 Act, the State Board of Towing shall consider the following factors:

29 “(1) The past history of the person incurring a penalty in taking all feasible steps or  
30 procedures necessary or appropriate to correct any violation.

31 “(2) Any prior violations by the person incurring the penalty of statutes, rules or orders  
32 pertaining to facilities.

33 “(3) The economic and financial conditions of the person incurring the penalty.

34 “(4) The immediacy and extent to which the violation threatens the public health or  
35 safety.

36 “SECTION 13. ORS 646.608 is amended to read:

37 “646.608. (1) A person engages in an unlawful practice if in the course of the person’s business,  
38 vocation or occupation the person does any of the following:

39 “(a) Passes off real estate, goods or services as the real estate, goods or services of another.

40 “(b) Causes likelihood of confusion or of misunderstanding as to the source, sponsorship, ap-  
41 proval, or certification of real estate, goods or services.

42 “(c) Causes likelihood of confusion or of misunderstanding as to affiliation, connection, or asso-  
43 ciation with, or certification by, another.

44 “(d) Uses deceptive representations or designations of geographic origin in connection with real  
45 estate, goods or services.

1 “(e) Represents that real estate, goods or services have sponsorship, approval, characteristics,  
2 ingredients, uses, benefits, quantities or qualities that the real estate, goods or services do not have  
3 or that a person has a sponsorship, approval, status, qualification, affiliation, or connection that the  
4 person does not have.

5 “(f) Represents that real estate or goods are original or new if the real estate or goods are de-  
6 teriorated, altered, reconditioned, reclaimed, used or secondhand.

7 “(g) Represents that real estate, goods or services are of a particular standard, quality, or grade,  
8 or that real estate or goods are of a particular style or model, if the real estate, goods or services  
9 are of another.

10 “(h) Disparages the real estate, goods, services, property or business of a customer or another  
11 by false or misleading representations of fact.

12 “(i) Advertises real estate, goods or services with intent not to provide the real estate, goods  
13 or services as advertised, or with intent not to supply reasonably expectable public demand, unless  
14 the advertisement discloses a limitation of quantity.

15 “(j) Makes false or misleading representations of fact concerning the reasons for, existence of,  
16 or amounts of price reductions.

17 “(k) Makes false or misleading representations concerning credit availability or the nature of  
18 the transaction or obligation incurred.

19 “(L) Makes false or misleading representations relating to commissions or other compensation  
20 to be paid in exchange for permitting real estate, goods or services to be used for model or demon-  
21 stration purposes or in exchange for submitting names of potential customers.

22 “(m) Performs service on or dismantles any goods or real estate if the owner or apparent owner  
23 of the goods or real estate does not authorize the service or dismantling.

24 “(n) Solicits potential customers by telephone or door to door as a seller unless the person  
25 provides the information required under ORS 646.611.

26 “(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give  
27 a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of  
28 the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or  
29 otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,  
30 discount or other value is contingent upon an event occurring after the time the customer enters  
31 into the transaction.

32 “(p) Makes any false or misleading statement about a prize, contest or promotion used to pub-  
33 licize a product, business or service.

34 “(q) Promises to deliver real estate, goods or services within a certain period of time with intent  
35 not to deliver the real estate, goods or services as promised.

36 “(r) Organizes or induces or attempts to induce membership in a pyramid club.

37 “(s) Makes false or misleading representations of fact concerning the offering price of, or the  
38 person’s cost for real estate, goods or services.

39 “(t) Concurrent with tender or delivery of any real estate, goods or services fails to disclose any  
40 known material defect or material nonconformity.

41 “(u) Engages in any other unfair or deceptive conduct in trade or commerce.

42 “(v) Violates any of the provisions relating to auction sales, consignment sales, auctioneers,  
43 consignees or auction marts under ORS 698.640, whether in a commercial or noncommercial situ-  
44 ation.

45 “(w) Manufactures mercury fever thermometers.

1       “(x) Sells or supplies mercury fever thermometers unless the thermometer is required by federal  
2 law, or is:  
3       “(A) Prescribed by a person licensed under ORS chapter 677; and  
4       “(B) Supplied with instructions on the careful handling of the thermometer to avoid breakage  
5 and on the proper cleanup of mercury should breakage occur.  
6       “(y) Sells a thermostat that contains mercury unless the thermostat is labeled in a manner to  
7 inform the purchaser that mercury is present in the thermostat and that the thermostat may not be  
8 disposed of until the mercury is removed, reused, recycled or otherwise managed to ensure that the  
9 mercury does not become part of the solid waste stream or wastewater. For purposes of this para-  
10 graph, ‘thermostat’ means a device commonly used to sense and, through electrical communication  
11 with heating, cooling or ventilation equipment, control room temperature.  
12       “(z) Sells or offers for sale a motor vehicle manufactured after January 1, 2006, that contains  
13 mercury light switches.  
14       “(aa) Violates the provisions of ORS 803.375, 803.385 or 815.410 to 815.430.  
15       “(bb) Violates ORS 646A.070 (1).  
16       “(cc) Violates any requirement of ORS 646A.030 to 646A.040.  
17       “(dd) Violates the provisions of ORS 128.801 to 128.898.  
18       “(ee) Violates ORS 646.883 or 646.885.  
19       “(ff) Violates ORS 646.569.  
20       “(gg) Violates the provisions of ORS 646A.142.  
21       “(hh) Violates ORS 646A.360.  
22       “(ii) Violates ORS 646.553 or 646.557 or any rule adopted pursuant thereto.  
23       “(jj) Violates ORS 646.563.  
24       “(kk) Violates ORS 759.680 or any rule adopted pursuant thereto.  
25       “(LL) Violates the provisions of ORS 759.705, 759.710 and 759.720 or any rule adopted pursuant  
26 thereto.  
27       “(mm) Violates ORS 646A.210 or 646A.214.  
28       “(nn) Violates any provision of ORS 646A.124 to 646A.134.  
29       “(oo) Violates ORS 646A.095.  
30       “(pp) Violates ORS 822.046.  
31       “(qq) Violates ORS 128.001.  
32       “(rr) Violates ORS 646A.800 (2) to (4).  
33       “(ss) Violates ORS 646A.090 (2) to (5).  
34       “(tt) Violates ORS 87.686.  
35       “(uu) Violates ORS 646A.803.

45       “(eee) Sells a gift card in violation of ORS 646A.276.

1 “(fff) Violates ORS 646A.102, 646A.106 or 646A.108.  
2 “(ggg) Violates ORS 646A.430 to 646A.450.  
3 “(hhh) Violates a provision of ORS 744.318 to 744.384.  
4 “(iii) Violates a provision of ORS 646A.702 to 646A.720.  
5 “(jjj) Violates ORS 646A.530 30 or more days after a recall notice, warning or declaration de-  
6 scribed in ORS 646A.530 is issued for the children’s product, as defined in ORS 646A.525, that is the  
7 subject of the violation.  
8 “(kkk) Violates a provision of ORS 697.612, 697.642, 697.652, 697.662, 697.682, 697.692 or 697.707.  
9 “(LLL) Violates the consumer protection provisions of the Servicemembers Civil Relief Act, 50  
10 U.S.C. App. 501 et seq., as in effect on January 1, 2010.  
11 “(mmm) Violates a provision of ORS 646A.480 to 646A.495.  
12 “(nnn) Violates ORS 646A.082.  
13 “(ooo) Violates ORS 646.647.  
14 “(ppp) Violates ORS 646A.115.  
15 “(qqq) Violates a provision of ORS 646A.405.  
16 “(rrr) Violates ORS 646A.092.  
17 “(sss) Violates a provision of ORS 646.644.

27 “(aaaa) Violates ORS 443.376.  
28 “(2) A representation under subsection (1) of this section or ORS 646.607 may be any manifes-  
29 tation of any assertion by words or conduct, including, but not limited to, a failure to disclose a fact.  
30 “(3) In order to prevail in an action or suit under ORS 336.184 and 646.605 to 646.652, a prose-  
31 cuting attorney need not prove competition between the parties or actual confusion or misunder-  
32 standing.  
33 “(4) An action or suit may not be brought under subsection (1)(u) of this section unless the At-  
34 torney General has first established a rule in accordance with the provisions of ORS chapter 183  
35 declaring the conduct to be unfair or deceptive in trade or commerce.  
36 “(5) Notwithstanding any other provision of ORS 336.184 and 646.605 to 646.652, if an action or  
37 suit is brought under subsection (1)(xx) of this section by a person other than a prosecuting attor-  
38 ney, relief is limited to an injunction and the prevailing party may be awarded reasonable attorney  
39 fees.  
40 “**SECTION 14.** ORS 646.608, as amended by section 10, chapter 523, Oregon Laws 2015, section  
41 15, chapter 113, Oregon Laws 2017, section 3, chapter 241, Oregon Laws 2017, section 16, chapter  
42 480, Oregon Laws 2017, and section 6, chapter 656, Oregon Laws 2017, is amended to read:  
43 “646.608. (1) A person engages in an unlawful practice if in the course of the person’s business,

18          “(i) Advertises real estate, goods or services with intent not to provide the real estate, goods  
19          or services as advertised, or with intent not to supply reasonably expectable public demand, unless  
20          the advertisement discloses a limitation of quantity.

21          “(j) Makes false or misleading representations of fact concerning the reasons for, existence of,  
22          or amounts of price reductions.

23          “(k) Makes false or misleading representations concerning credit availability or the nature of  
24          the transaction or obligation incurred.

25          “(L) Makes false or misleading representations relating to commissions or other compensation  
26          to be paid in exchange for permitting real estate, goods or services to be used for model or demon-  
27          stration purposes or in exchange for submitting names of potential customers.

28          “(m) Performs service on or dismantles any goods or real estate if the owner or apparent owner  
29          of the goods or real estate does not authorize the service or dismantling.

30          “(n) Solicits potential customers by telephone or door to door as a seller unless the person  
31          provides the information required under ORS 646.611.

32          “(o) In a sale, rental or other disposition of real estate, goods or services, gives or offers to give  
33          a rebate or discount or otherwise pays or offers to pay value to the customer in consideration of  
34          the customer giving to the person the names of prospective purchasers, lessees, or borrowers, or  
35          otherwise aiding the person in making a sale, lease, or loan to another person, if earning the rebate,  
36          discount or other value is contingent upon an event occurring after the time the customer enters  
37          into the transaction.

40          “(q) Promises to deliver real estate, goods or services within a certain period of time with intent

28 tion of the public peace, health and safety, an emergency is declared to exist, and this 2019  
29 Act takes effect on its passage.”
