SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Appropriates moneys from General Fund to Public Defense Services Commission for certain biennial expenses.

Limits biennial expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by commission.

Appropriates moneys from General Fund to Emergency Board for allocation to commission.

Declares emergency, effective July 1, 2019.

A BILL FOR AN ACT

Relating to the financial administration of the Public Defense Services Commission; and declaring an emergency.

Be It Enacted by the People of the State of Oregon:

SECTION 1. There are appropriated to the Public Defense Services Commission, for the biennium beginning July 1, 2019, out of the General Fund, the following amounts, for the following purposes:

- (1) Appellate Division \$ 22,637,870**
- (2) Professional services..... \$309,304,337**
- (3) Contract and Business Services Division..... \$ 6,982,059**

SECTION 2. Notwithstanding any other law limiting expenditures, the following amounts are established for the biennium beginning July 1, 2019, as the maximum limits for payment of expenses from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by the Public Defense Services Commission, for the following purposes:

- (1) Professional services..... \$ 3,200,000**
- (2) Contract and Business Services Division..... \$ 536,398**

SECTION 3. (1) In addition to and not in lieu of any other appropriation, there is appropriated to the Emergency Board, for the biennium beginning July 1, 2019, out of the General Fund, the amount of \$2,000,000, to be allocated to the Public Defense Services Commission for acquisition of a new financial management system.

(2) If any of the moneys appropriated by subsection (1) of this section are not allocated
