

C-Engrossed Senate Bill 586

Ordered by the House June 19

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Abolishes "Office of Manufactured Dwelling Park Community Relations." Renames "Mobile Home Parks Account" to "Manufactured and Marina Communities Account."

Requires facilities to establish mediation policy for certain disputes. Authorizes grants from Housing and Community Services Department for legal needs of low-income facility tenants. Establishes Manufactured and Marina Communities Dispute Resolution Advisory Committee.

Sunset grants and committee on January 2, 2024.

Extends department's existing duties to manufactured dwellings and manufactured dwelling parks to include marinas and floating home tenants.

Requires floating home owners in marina to pay fees to Manufactured and Marina Communities Account. Requires marina owners to pay fees to account and complete educational requirements. Delays operative date.

Applies provisions for sale of manufactured dwelling park to marina.

Allows tenants of marinas to enter into storage agreements with landlords for 12 months following lease termination.

Requires manufactured dwelling park landlord, before maintaining trees, to provide tenant reasonable notice and opportunity to maintain trees.

Authorizes marina landlord to require tenant to move floating home at landlord's cost. Requires marina landlords to extend for-cause termination notice for 10 months to allow tenant to repair home's float. Authorizes marina landlords to amend rental agreement to charge allowable fees.

Amends process for facility landlords to terminate tenancy for cause.

Amends requirements for siting, billing and notice before converting facility to submeter or pro rata billing. Amends other facility billing and conversion processes.

12 **SECTION 1. (1) The Office of Manufactured Dwelling Park Community Relations of the**
13 **Housing and Community Services Department is abolished, and all the duties, functions, and**
14 **powers of the office are imposed upon, transferred to and vested in the Housing and Com-**
15 **munity Services Department.**

1 (2) Whenever, in any statutory law or resolution of the Legislative Assembly or in any

4 considered to be a reference to the Housing and Community Services Department.

5 (3) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel

7 Relations,” wherever they occur in statutory law, other words designating the “Housing and
8 Community Services Department.”

9 **SECTION 2.** (1) The Mobile Home Parks Account of the Housing and Community Services
10 Department is renamed the Manufactured and Marina Communities Account.

11 (2) Whenever, in any statutory law or resolution of the Legislative Assembly or in any
12 rule, document, record or proceeding authorized by the Legislative Assembly, reference is
13 made to the Mobile Home Parks Account, the reference is considered to be a reference to
14 the Manufactured and Marina Communities Account.

15 (3) For the purpose of harmonizing and clarifying statutory law, the Legislative Counsel

19 **SECTION 3.** ORS 446.533 is amended to read:

20 446.533. There hereby is established separate and distinct from the General Fund the [*Mobile*
21 *Home Parks*] **Manufactured and Marina Communities** Account [*of the Housing and Community*
22 *Services Department*]. [*Except as otherwise provided by law,*] All moneys [*appropriated or credited*
23 *to*] **in** the account are **continuously** appropriated [*continuously for and shall be used by the Director*
24 *of*] **to** the Housing and Community Services Department [*for the purpose of carrying*] **to carry** out
25 the duties and responsibilities [*imposed under ORS 105.138 and 446.515 to 446.547*] **of the depart-**
26 **ment under ORS 90.505 to 90.850 and 446.515 to 446.547.** Interest earned on the account [*shall*
27 *be*] **is** credited to the account.

28 **SECTION 4.** ORS 446.543 is amended to read:

29 446.543. [(1) *An Office of Manufactured Dwelling Park Community Relations is established in the*
30 *Housing and Community Services Department.*]

31 [(2)] The [*Director of the*] Housing and Community Services Department shall [, *through the use*
32 *of office personnel or by other means*]:

33 [(a)] (1) Undertake, participate in or cooperate with persons and agencies in such conferences,
34 inquiries, meetings or studies as might lead to improvements in manufactured dwelling park **and**
35 **marina** landlord and tenant relationships;

36 [(b)] (2) Develop and implement a centralized resource referral program for tenants and land-
37 lords to encourage the voluntary resolution of disputes;

38 [(c)] (3) Maintain a current list of manufactured dwelling parks **and marinas** in the state, indi-

2 **SECTION 5.** ORS 90.732 is amended to read:

3 90.732. (1) Every landlord of a manufactured dwelling park shall register annually in writing
4 with the Housing and Community Services Department. The department shall charge the landlord
5 a registration fee of [\$50] **\$100** for parks with more than 20 spaces and [\$25] **\$50** for parks with 20
6 or fewer spaces. The landlord shall file a registration and pay a registration fee for each park owned
7 or managed by the landlord. The registration shall consist of the following information:

8 (a) The name and business mailing address of the landlord and of any person authorized to
9 manage the premises of the park.

10 (b) The name of the park.

11 (c) The physical address of the park [or] **and**, if different from the physical address, the mailing
12 address.

13 (d) A telephone number of the park.

14 (e) The total number of spaces in the park.

15 (2) The landlord of a new manufactured dwelling park shall register with the department no
16 later than 60 days after the opening of the park.

17 (3) The department shall send a written reminder notice to each landlord that holds a current
18 registration under this section before the due date for the landlord to file a new registration. The
19 department shall confirm receipt of a registration.

20 (4) Notwithstanding subsections (1) to (3) of this section, the department may provide for regis-
21 tration and confirmation of registration to be accomplished by electronic means instead of in writ-
22 ing.

23 (5) Moneys from registration fees described in subsection (1) of this section [shall] **must** be de-
24 posited in the [Mobile Home Parks] **Manufactured and Marina Communities** Account.
25 [Notwithstanding ORS 446.533, moneys deposited in the account under this section are continuously
26 appropriated to the department for the purpose of implementing and administering the duties of the
27 department under this section and ORS 90.734 and 90.738.]

28 **SECTION 6.** ORS 90.736 is amended to read:

29 90.736. (1) The Housing and Community Services Department may assess a civil penalty against
30 a landlord or owner if the department finds that the landlord or owner has not complied with ORS
31 90.732 or 90.734. The civil penalty may not exceed \$1,000. The department shall assess the civil
32 penalty according to the schedule of penalties developed by the department under ORS 90.738. In
33 assessing a civil penalty under this section, the department shall take into consideration any good
34 faith efforts by the landlord or owner to comply with ORS 90.732 or 90.734.

35 (2) **The department shall deposit** a civil penalty assessed under this section [shall be
36 deposited] in the [Mobile Home Parks Account and continuously appropriated to the department for
37 use in carrying out the policies described in ORS 446.515] **Manufactured and Marina Communities**
38 **Account.**

39 (3) If a civil penalty assessed under this section is not paid on or before 90 days after the order
40 assessing the civil penalty becomes final by operation of law, the department may file the order with
41 the county clerk of the county where the manufactured dwelling park of the landlord or owner is
42 located as a lien against the park. In addition to any other available remedy, recording the order
43 in the County Clerk Lien Record has the effect provided for in ORS 205.125 and 205.126 and the
44 order may be enforced as provided in ORS 205.125 and 205.126.

1 **MANUFACTURED DWELLING PARK AND MARINA MEDIATION**

2
3 **SECTION 7.** Section 8 of this 2019 Act is added to and made a part of ORS 90.505 to 90.850.

4 **SECTION 8.** (1) For disputes subject to mediation under this section, if any party initiates
5 mediation under this section, mediation is mandatory. A landlord of a tenancy subject to
6 ORS 90.505 to 90.850 shall establish a mediation policy to resolve disputes related to:

7 (a) Landlord or tenant compliance with the rental agreement or with the provisions of
8 this chapter;

9 (b) Landlord or tenant conduct within the facility; or

10 (c) The modification of a rule or regulation under ORS 90.610.

11 (2) A mediation policy under this section must include:

12 (a) The process and format by which a tenant or landlord may initiate mediation.

13 (b) The names and contact information, including the phone number and website address,
14 for mediation services available through the referral program provided by the Housing and
15 Community Services Department under ORS 446.543 (2) and any other no-cost mediation
16 service acceptable to the landlord.

17 (c) Information substantially explaining requirements for mediation under subsections (3)
18 to (7) of this section.

19 (3) Mediation conducted under this section:

20 (a) In addition to any process authorized under subsection (2)(a) of this section, may be
21 initiated by the landlord or tenant's contact with the Housing and Community Services De-
22 partment in a format required by the department.

23 (b) May not resolve any matters except by the agreement of all parties.

24 (c) Must require that communications from all parties are held strictly confidential and
25 may not be used in any legal proceedings.

26 (d) May be used to resolve:

27 (A) Disputes between the landlord and one or more tenants, initiated by any party; and

28 (B) Disputes between any two or more tenants, initiated only by the landlord.

29 (e) Must allow a party to designate any person, including a nonattorney, to represent the
30 interests of the party provided that the person has the authority to bind that party to any
31 resolution of the dispute.

32 (f) Must comply with any other provisions as the Housing and Community Services De-
33 partment may require by rule.

34 (4) Parties must participate in mediation under this section by making a good faith effort
35 to schedule mediation within 30 days after mediation is initiated, attending and participating
36 in mediation and cooperating with reasonable requests of the mediator.

37 (5) After mediation has been initiated and while it is ongoing under this section:

38 (a) Any statute of limitations related to the dispute is tolled.

39 (b) A party may not file an action related to the dispute, including an action for pos-
40 session under ORS 105.110.

41 (c)(A) A tenant shall continue paying rent to the landlord.

42 (B) A landlord receiving rent under this paragraph has not accepted rent for the pur-
43 poses of ORS 90.412 (2), provided that the landlord refunds the rent within 10 days following
44 the conclusion of mediation.

45 (6) Unless specifically provided for in a mediation policy established under this section,

1 or agreed to by all parties, no party may initiate mediation for:

2 (a) Facility closures consistent with ORS 90.645 or 90.671.

3 (b) Facility sales consistent with ORS 90.842 to 90.850.

4 (c) Rent increases consistent with ORS 90.600.

5 (d) Rent payments or amounts owed.

6 (e) Tenant violations alleged in a termination notice given under ORS 90.394, 90.396 or
7 90.630 (8).

8 (f) Violations of an alleged unauthorized person in possession in a notice given under ORS
9 90.403.

10 (g) Unless initiated by the victim, a dispute involving allegations of domestic violence,
11 sexual assault or stalking or a dispute between the victim and the alleged perpetrator.

12 (h) A dispute arising after the termination of the tenancy, including under ORS 90.425,
13 90.675 or 105.161.

14 (7) This section does not require any party to:

15 (a) Reach an agreement on any or all issues submitted to mediation;

16 (b) Participate in more than one mediation session or participate for an unreasonable
17 length of time in a session; or

18 (c) Waive or forgo any rights or remedies or the use of any other available informal
19 dispute resolution process.

20 (8) A mediator in a mediation under this section shall notify the Housing and Community
21 Services Department as to whether the dispute was resolved through mediation but may not
22 provide the department with the contents of any resolution.

23 (9) A landlord may unilaterally amend a rental agreement or facility rules and regu-
24 lations to comply with this section.

25 (10) If a party refuses to participate in good faith in mediation with another party or uses
26 mediation to harass another party, the other party:

27 (a) Has a defense to a claim related to the subject of the dispute for which mediation
28 was sought; and

29 (b) Is entitled to damages of one month's rent against the party.

30 **SECTION 9.** (1) The Housing and Community Services Department shall award grants to
31 persons to provide legal representation to low-income facility tenants in addressing disputes
32 involving legal matters arising under ORS chapter 90.

33 (2) The department may adopt rules and income level criteria to implement this program.

34 (3) In selecting entities for grants under this section, the department shall consider the
35 experience and qualifications of the entities relating to:

36 (a) Representing tenants in disputes arising under ORS chapter 90;

37 (b) Serving tenants throughout the state, including by telephone or online communi-
38 cations or resources when appropriate; and

39 (c) Ability to network with other attorneys to leverage the available legal assistance.

40 (4) Total grant amounts awarded under this section may only come from the Manufac-
41 tured and Marina Communities account under ORS 446.533 and may not exceed \$200,000 per
42 biennium.

43 **SECTION 10.** (1) There is established the Manufactured and Marina Communities Dispute
44 Resolution Advisory Committee.

45 (2) Members of the committee are appointed by the Director of the Housing and Com-

1 **munity Services Department. The director shall have discretion to determine the number of**
2 **committee members and the duration of membership. The committee membership must be**
3 **geographically representative of all regions of this state and must include an equal number**
4 **of representatives of landlords of facilities or their advocates and representatives of tenants**
5 **of facilities or their advocates and at least one representative of a provider of mediation**
6 **services.**

7 **(3) The committee shall:**

8 **(a) Advise the Housing and Community Services Department regarding the mandatory**
9 **mediation required by section 8 of this 2019 Act and the grants provided under section 9 of**
10 **this 2019 Act.**

11 **(b) No later than September 15 of each even-numbered year, provide a report to the ap-**
12 **propriate interim committees of the Legislative Assembly, in the manner provided under**
13 **ORS 192.245, regarding the effectiveness of the mandatory mediation required by section 8**
14 **of this 2019 Act and the grants provided under section 9 of this 2019 Act and make recom-**
15 **mendations regarding the continuation of mandatory mediation and the renewal of the**
16 **grants.**

17 **SECTION 11. Section 8 of this 2019 Act applies to rental agreements entered into before,**
18 **on or after the effective date of this 2019 Act.**

19 **SECTION 12. Sections 9 and 10 of this 2019 Act are repealed January 2, 2024.**

20 **SECTION 13. ORS 90.610 is amended to read:**

21 90.610. (1) As used in this section, “eligible space” means each space in the facility as long as:

22 (a) The space is rented to a tenant and the tenancy is subject to ORS 90.505 to 90.850; and

23 (b) The tenant who occupies the space has not:

24 (A) Previously agreed to a rental agreement that includes the proposed rule or regulation
25 change; or

26 (B) Become subject to the proposed rule or regulation change as a result of a change in rules
27 or regulations previously adopted in a manner consistent with this section.

28 *[(2) Notwithstanding ORS 90.245 (1), the parties to a rental agreement to which ORS 90.505 to*
29 *90.850 apply shall provide for a process establishing informal dispute resolution of disputes that may*
30 *arise concerning the rental agreement for a manufactured dwelling or floating home space.]*

31 *[(3)] (2) The landlord may propose changes in rules or regulations, including changes that make*
32 *a substantial modification of the landlord’s bargain with a tenant, by giving written notice of the*
33 *proposed rule or regulation change, and unless tenants of at least 51 percent of the eligible spaces*
34 *in the facility object in writing within 30 days of the date the notice was served, the change shall*
35 *become effective for all tenants of those spaces on a date not less than 60 days after the date that*
36 *the notice was served by the landlord.*

37 *[(4)] (3) One tenant of record per eligible space may object to the rule or regulation change*
38 *through either:*

39 (a) A signed and dated written communication to the landlord; or

40 (b) A petition format that is signed and dated by tenants of eligible spaces and that includes a
41 copy of the proposed rule or regulation and a copy of the notice.

42 *[(5)] (4) If a tenant of an eligible space signs both a written communication to the landlord and*
43 *a petition under subsection [(4)] (3) of this section, or signs more than one written communication*
44 *or petition, only the latest signature of the tenant may be counted.*

45 *[(6)] (5) Notwithstanding subsection [(4)] (3) of this section, a proxy may be used only if a tenant*

1 has a disability that prevents the tenant from objecting to the rule or regulation change in writing.

2 [(7)] (6) The landlord’s notice of a proposed change in rules or regulations required by sub-
3 section [(3)] (2) of this section must be given or served as provided in ORS 90.155 and must include:

4 (a) Language of the existing rule or regulation and the language that would be added or deleted
5 by the proposed rule or regulation change; and

6 (b) A statement substantially in the following form, with all blank spaces in the notice to be
7 filled in by the landlord:

10 NOTICE OF PROPOSED RULE
11 OR REGULATION CHANGE

12 The landlord intends to change a rule or regulation in this facility.

13 The change will go into effect unless tenants of at least 51 percent of the eligible spaces object
14 in writing within 30 days. Any objection must be signed and dated by a tenant of an eligible space.

15 The number of eligible spaces as of the date of this notice is: _____. Those eligible spaces are
16 (space or street identification): _____.

17 The last day for a tenant of an eligible space to deliver a written objection to the landlord is
18 _____ (landlord fill in date).

19 Unless tenants in at least 51 percent of the eligible spaces object, the proposed rule or regu-
20 lation will go into effect on _____.

21 The parties may attempt to resolve disagreements regarding the proposed rule or regulation
22 change by using the facility’s **mandatory mediation process or, if available, the facility’s** in-
23 formal dispute resolution process.

26 [(8)] (7) A good faith mistake by the landlord in completing those portions of the notice relating
27 to the number of eligible spaces that have tenants entitled to vote or relating to space or street
28 identification numbers does not invalidate the notice or the proposed rule or regulation change.

29 [(9)] (8) After the effective date of the rule or regulation change, when a tenant continues to
30 engage in an activity affected by the new rule or regulation to which the landlord objects, the
31 landlord may give the tenant a notice of termination of the tenancy pursuant to ORS 90.630. [*The*
32 *notice shall include a statement that the tenant may request a resolution through the facility’s informal*
33 *dispute resolution process by giving the landlord a written request within seven days from the date the*
34 *notice was served. If the tenant requests an informal dispute resolution, the landlord may not file an*
35 *action for possession pursuant to ORS 105.105 to 105.168 until 30 days after the date of the tenant’s*
36 *request for informal dispute resolution or the date the informal dispute resolution is complete, which-*
37 *ever occurs first.*]

38 [(10) *An agreement under this section may not require informal dispute resolution of disputes re-*
39 *lating to:*]

40 [(a) *Facility closure;*]

41 [(b) *Facility sale; or*]

42 [(c) *Rent, including but not limited to amount, increase and nonpayment.*]

43 [(11) *ORS 90.510 (1) to (3), requiring a landlord to provide a statement of policy, do not create a*
44 *basis for a tenant to demand informal dispute resolution of a rent increase.*]

45 **SECTION 14. Sections 9, 10 and 14a of this 2019 Act and ORS 446.380, 446.385, 446.390 and**

1 **446.392 are added to and made a part of ORS 446.515 to 446.547.**

2 **SECTION 14a. As used in ORS 446.515 to 446.547, “facility,” “manufactured dwelling,”**
3 **“manufactured dwelling park” and “marina” have the meanings given those terms in ORS**
4 **90.100.**

5 **SECTION 15.** ORS 446.515 is amended to read:

6 446.515. (1) It is the policy of the State of Oregon:

7 (a) To encourage [*mobile home and*] manufactured dwelling park **and marina** residents and
8 [*mobile home and*] manufactured dwelling park **and marina** owners and managers to settle disputes
9 among themselves without recourse, if possible, to either the court system or intervention by a state
10 agency.

11 (b) To assist [*mobile home and*] manufactured dwelling park **and marina** residents and [*mobile*
12 *home and*] manufactured dwelling park **and marina** owners and managers to develop alternative
13 dispute resolution techniques including, but not limited to, providing technical advice in the area
14 of mediation.

15 (c) To educate [*mobile home and*] manufactured dwelling park **and marina** residents, owners and
16 managers about issues and laws that affect [*mobile home and*] manufactured dwelling park **and**
17 **marina** tenancies for the purpose of assisting those persons in resolving disputes.

18 (2) The Legislative Assembly recognizes that a significant percentage of its citizens are [*mobile*
19 *home and*] manufactured dwelling park **and marina** residents, owners or managers and that a pro-
20 posal which reduces the necessity of court resolution of certain disputes between these residents,
21 owners and managers may help these citizens avoid the expense of going to court.

22 (3) All citizens of this state benefit when the courts are reserved for the resolution of the types
23 of disputes for which no alternative dispute resolution exists.

24 **(4) For some disputes, alternative dispute resolution is not effective and tenants must**
25 **have recourse to legal representation and the courts.**

26 **SECTION 16.** ORS 446.547 is amended to read:

27 446.547. [*Each mobile home and manufactured dwelling park shall*] **In addition to mandatory**
28 **mediation required under section 8 of this 2019 Act, a facility may** establish an informal dispute
29 resolution procedure that [*insures*] **ensures** each issue with merit [*shall be given a fair hearing*] **is**
30 **addressed** within 30 days [*of*] **after** receipt of a formal complaint.

31 **SECTION 17.** ORS 446.525 is amended to read:

32 446.525. (1) Except as provided in ORS 308.250 (2)(b), a special assessment is levied annually
33 upon each manufactured dwelling that is assessed for ad valorem property tax purposes as personal
34 property. The amount of the assessment is \$10.

35 (2) On or before July 15 of each year, the county assessor shall determine and list the manu-
36 factured dwellings in the county that are assessed for the current assessment year as personal
37 property. Upon making a determination and list, the county assessor shall cause the special assess-
38 ment levied under subsection (1) of this section to be entered on the general assessment and tax roll
39 prepared for the current assessment year as a charge against each manufactured dwelling so listed.
40 Upon entry, the special assessment shall become a lien, be assessed and be collected in the same
41 manner and with the same interest, penalty and cost charges as apply to ad valorem property taxes
42 in this state.

43 (3) [*Any amounts of special assessment*] **Moneys** collected pursuant to subsection (2) of this sec-
44 tion [*shall be*] **are** deposited in the county treasury, paid over by the county treasurer to the State
45 Treasury and credited to the [*Mobile Home Parks*] **Manufactured and Marina Communities Ac-**

1 count [to be used exclusively for carrying out ORS 446.380, 446.385, 446.392 and 446.543, implementing
2 the policies described in ORS 446.515 and compensating the county for billing and collecting any spe-
3 cial assessment under subsection (2) of this section].

4 (4) The Housing and Community Services Department shall pay to a county \$1.50 for each spe-
5 cial assessment account that the county bills under subsection (2) of this section.

6 [(4)] (5) In lieu of the procedures under subsection (2) of this section, the [Director of the Hous-
7 ing and Community Services Department] **department** may make a direct billing of the special as-
8 sessment to the owners of manufactured dwellings and receive payment of the special assessment
9 from those owners. [In the event that under the billing procedures] **If** any owner fails to make pay-
10 ment, the unpaid special assessment [shall become] **becomes** a lien against the manufactured dwell-
11 ing and may be collected under contract or other agreement by a collection agency or may be
12 collected under ORS 293.250, or the lien may be foreclosed by suit as provided under ORS chapter

14 subsection[, the amounts of special assessment shall be] **are** deposited in the State Treasury and [shall
15 be] credited to the [Mobile Home Parks] **Manufactured and Marina Communities** Account [to be
16 used exclusively for carrying out ORS 446.380, 446.385, 446.392 and 446.543 and implementing the
17 policies described in ORS 446.515].

18 **DELAYED FEES AND REQUIREMENTS FOR MARINA AND FLOATING HOME OWNERS**

19 **SECTION 18.** ORS 90.732, as amended by section 5 of this 2019 Act, is amended to read:

20
21 90.732. (1) Every landlord of a [manufactured dwelling park] **facility** shall register annually in
22 writing with the Housing and Community Services Department. The department shall charge the
23 landlord a registration fee of \$100 for [parks] **facilities** with more than 20 spaces and \$50 for
24 [parks] **facilities** with 20 or fewer spaces. The landlord shall file a registration and pay a registra-
25 tion fee for each [park] **facility** owned or managed by the landlord. The registration shall consist
26 of the following information:
27

28 (a) The name and business mailing address of the landlord and of any person authorized to
29 manage the premises of the [park] **facility**.

30 (b) The name of the [park] **facility**.

31 (c) The physical address of the [park] **facility** and, if different from the physical address, the
32 mailing address.

33 (d) A telephone number of the [park] **facility**.

34 (e) The total number of spaces in the [park] **facility**.

35 (2) The landlord of a new [manufactured dwelling park] **facility** shall register with the depart-
36 ment no later than 60 days after the opening of the [park] **facility**.

37 (3) The department shall send a written reminder notice to each landlord that holds a current
38 registration under this section before the due date for the landlord to file a new registration. The
39 department shall confirm receipt of a registration.

40 (4) Notwithstanding subsections (1) to (3) of this section, the department may provide for regis-
41 tration and confirmation of registration to be accomplished by electronic means instead of in writ-
42 ing.

43 (5) Moneys from registration fees described in subsection (1) of this section must be deposited
44 in the Manufactured and Marina Communities Account.

45 **SECTION 19.** ORS 90.734 is amended to read:

1 90.734. (1) At least one person for each [*manufactured dwelling park*] **facility** who has authority
 2 to manage the premises of the [*park*] **facility** shall, every two years, complete four hours of contin-
 3 uing education relating to the management of [*manufactured dwelling parks*] **facilities**. The following
 4 apply for a person whose continuing education is required:

5 (a) If there is any manager or owner who lives in the [*park*] **facility**, the person completing the
 6 continuing education must be a manager or owner who lives in the [*park*] **facility**.

7 (b) If no manager or owner lives in the [*park*] **facility**, the person completing the continuing
 8 education must be a manager who lives outside the [*park*] **facility** or, if there is no manager, an
 9 owner of the [*park*] **facility**.

10 (c) A manager or owner may satisfy the continuing education requirement for more than one
 11 [*park*] **facility** that does not have a manager or owner who lives in the [*park*] **facility**.

12 (2) If a person becomes the [*manufactured dwelling park*] **facility** manager or owner who is re-
 13 sponsible for completing continuing education, and the person does not have a current certificate
 14 of completion issued under subsection (3) of this section, the person shall complete the continuing
 15 education requirement by taking the next regularly scheduled continuing education class or by
 16 taking a continuing education class held within 75 days.

17 (3) The Housing and Community Services Department shall ensure that continuing education
 18 classes:

19 (a) Are offered at least once every six months;

20 (b) Are offered by a statewide nonprofit trade association in Oregon representing [*manufactured*
 21 *housing*] **facility** interests and approved by the department;

22 (c) Have at least one-half of the class instruction on one or more provisions of ORS chapter 90,
 23 ORS 105.105 to 105.168, fair housing law or other law relating to landlords and tenants;

24 (d) Provide a certificate of completion to all attendees; and

25 (e) Provide the department with the following information:

26 (A) The name of each person who attends a class;

27 (B) The name of the attendee's [*manufactured dwelling park*] **facility**;

28 (C) The city or county in which the attendee's [*park*] **facility** is located;

29 (D) The date of the class; and

30 (E) The names of the persons who taught the class.

31 (4) The department, a trade association or instructor is not responsible for the conduct of a
 32 landlord, manager, owner or other person attending a continuing education class under this section.
 33 This section does not create a cause of action against the department, a trade association or in-
 34 structor related to the continuing education class.

35 (5) The owner of a [*manufactured dwelling park*] **facility** is responsible for ensuring compliance
 36 with the continuing education requirements in this section.

37 (6) The department shall annually send a written reminder notice regarding continuing educa-
 38 tion requirements under this section to each [*manufactured dwelling park*] **facility** at the address
 39 shown in the [*park*] **facility** registration filed under ORS 90.732.

40 **SECTION 20.** ORS 90.736, as amended by section 6 of this 2019 Act, is amended to read:

41 90.736. (1) The Housing and Community Services Department may assess a civil penalty against
 42 a landlord or owner if the department finds that the landlord or owner has not complied with ORS
 43 90.732 or 90.734. The civil penalty may not exceed \$1,000. The department shall assess the civil
 44 penalty according to the schedule of penalties developed by the department under ORS 90.738. In
 45 assessing a civil penalty under this section, the department shall take into consideration any good

1 faith efforts by the landlord or owner to comply with ORS 90.732 or 90.734.

2 (2) The department shall deposit a civil penalty assessed under this section in the Manufactured
3 and Marina Communities Account.

4 (3) If a civil penalty assessed under this section is not paid on or before 90 days after the order
5 assessing the civil penalty becomes final by operation of law, the department may file the order with
6 the county clerk of the county where the [*manufactured dwelling park of the landlord or owner*] **fa-**
7 **ility** is located as a lien against the [*park*] **facility**. In addition to any other available remedy, re-
8 cording the order in the County Clerk Lien Record has the effect provided for in ORS 205.125 and
9 205.126 and the order may be enforced as provided in ORS 205.125 and 205.126.

10 **SECTION 21. The amendments to ORS 90.732, 90.734 and 90.736 by sections 18 to 20 of this**
11 **2019 Act become operative on January 1, 2022.**

12 **SECTION 22. The Housing and Community Services Department may not assess a fine**
13 **against the owner or landlord of a marina for any violation under ORS 90.736 that occurred**
14 **before January 1, 2022, and is not ongoing on or after January 1, 2022.**

15 **SECTION 23.** ORS 446.525, as amended by section 17 of this 2019 Act, is amended to read:

16 446.525. (1) Except as provided in ORS 308.250 (2)(b), a special assessment is levied annually
17 upon each manufactured dwelling **or floating home** that is assessed for ad valorem property tax
18 purposes as personal property. The amount of the assessment is \$10.

19 (2) On or before July 15 of each year, the county assessor shall determine and list the manu-
20 factured dwellings **and floating homes** in the county that are assessed for the current assessment
21 year as personal property. Upon making a determination and list, the county assessor shall cause
22 the special assessment levied under subsection (1) of this section to be entered on the general as-
23 sessment and tax roll prepared for the current assessment year as a charge against each manufac-
24 tured dwelling **and floating home** so listed. Upon entry, the special assessment shall become a lien,
25 be assessed and be collected in the same manner and with the same interest, penalty and cost

27 (3) Moneys collected pursuant to subsection (2) of this section are deposited in the county

30 (4) The Housing and Community Services Department shall pay to a county \$1.50 for each spe-
31 cial assessment account that the county bills under subsection (2) of this section.

32 (5) In lieu of the procedures under subsection (2) of this section, the department may make a
33 direct billing of the special assessment to the owners of manufactured dwellings **and floating homes**
34 and receive payment of the special assessment from those owners. If any owner fails to make pay-
35 ment, the unpaid special assessment becomes a lien against the manufactured dwelling **or floating**
36 **home** and may be collected under contract or other agreement by a collection agency or may be
37 collected under ORS 293.250, or the lien may be foreclosed by suit as provided under ORS chapter
38 88 or as provided under ORS 87.272 to 87.306. Moneys collected under this subsection are deposited
39 in the State Treasury and credited to the Manufactured and Marina Communities Account.

40 **SECTION 24. The amendments to ORS 446.525 by section 23 of this 2019 Act apply to**
41 **property tax years beginning on or after July 1, 2022.**

45 **SECTION 25. ORS 90.805, 90.810, 90.815, 90.820 and 90.830 are repealed.**

1 **SECTION 26.** ORS 90.842 is amended to read:

2 90.842. (1) An owner of a [*manufactured dwelling park*] **facility** shall give written notice of the
3 owner's interest in selling the [*park*] **facility** before the owner markets the [*park*] **facility** for sale
4 or when the owner receives an offer to purchase that the owner intends to consider, whichever oc-
5 curs first.

6 (2) The owner shall give the notice required by subsection (1) of this section to:

7 (a) All tenants of the [*park*] **facility**; or

8 (b) A tenants committee, if there is an existing committee of tenants formed for purposes in-
9 cluding the purchase of the [*park*] **facility** and with which the owner has met in the 12-month period
10 immediately before delivery of the notice.

11 (3) The owner shall also give the notice required by subsection (1) of this section to the [*Office*
12 *of Manufactured Dwelling Park Community Relations of the*] Housing and Community Services De-
13 partment.

14 (4) The notice must include the following:

15 (a) The owner is considering selling the [*park*] **facility**.

16 (b) The tenants, through a tenants committee, have an opportunity to compete to purchase the
17 [*park*] **facility**.

18 (c) In order to compete to purchase the [*park*] **facility**, within 10 days after delivery of the no-
19 tice, the tenants must form or identify a single tenants committee for the purpose of purchasing the
20 [*park*] **facility** and notify the owner in writing of:

21 (A) The tenants' interest in competing to purchase the [*park*] **facility**; and

22 (B) The name and contact information of the representative of the tenants committee with whom
23 the owner may communicate about the purchase.

24 (d) The representative of the tenants committee may request financial information described in
25 ORS 90.844 (2) from the owner within the 10-day period.

26 (e) Information about purchasing a [*manufactured dwelling park*] **facility** is available from the
27 [*Office of Manufactured Dwelling Park Community Relations of the*] Housing and Community Services
28 Department.

29 **SECTION 27.** ORS 90.844 is amended to read:

30 90.844. (1) Within 10 days after delivery of the notice described in ORS 90.842, if the tenants
31 choose to compete to purchase the [*manufactured dwelling park*] **facility** in which the tenants reside,
32 the tenants must notify the owner in writing of:

33 (a) The tenants' interest in competing to purchase the [*park*] **facility**;

34 (b) The formation or identification of a single tenants committee formed for the purpose of pur-
35 chasing the [*park*] **facility**; and

36 (c) The name and contact information of the representative of the tenants committee with whom
37 the owner may communicate about the purchase.

38 (2) During the 10-day period, in order to perform a due diligence evaluation of the opportunity
39 to compete to purchase the [*park*] **facility**, the representative of the tenants committee may make
40 a written request for the kind of financial information that a seller of a [*park*] **facility** would cus-
41 tomarily provide to a prospective purchaser.

42 (3) Of the financial information described in subsection (2) of this section, the owner shall pro-
43 vide the following information within seven days after delivery of the request by the tenants com-
44 mittee for the information:

45 (a) The asking price, if any, for the [*park*] **facility**;

1 (b) The total income collected from the *[park]* **facility** and related profit centers, including
2 storage and laundry, in the 12-month period immediately before delivery of the notice required by
3 ORS 90.842;

4 (c) The cost of all utilities for the *[park]* **facility** that were paid by the owner in the 12-month
5 period immediately before delivery of the notice required by ORS 90.842;

6 (d) The annual cost of all insurance policies for the *[park]* **facility** that were paid by the owner,
7 as shown by the most recent premium;

8 (e) The number of homes in the *[park]* **facility** owned by the owner; and

9 (f) The number of vacant spaces and homes in the *[park]* **facility**.

10 (4) The owner may:

11 (a) Designate all or part of the financial information provided pursuant to this section as confi-
12 dential.

13 (b) If the owner designates financial information as confidential, establish, in cooperation with
14 the representative of the tenants committee, a list of persons with whom the tenants may share the
15 information, including any of the following persons that are either seeking to purchase the *[park]*
16 **facility** on behalf of the tenants committee or assisting the tenants committee in evaluating or
17 purchasing the *[park]* **facility**:

18 (A) A nonprofit organization or a housing authority.

19 (B) An attorney or other licensed professional or adviser.

20 (C) A financial institution.

21 (c) Require that persons authorized to receive the confidential information:

22 (A) Sign a confidentiality agreement before receiving the information;

23 (B) Refrain from copying any of the information; and

24 (C) Return the information to the owner when the negotiations to purchase the *[park]* **facility**
25 are completed or terminated.

26 (5) Within 15 days after delivery of the financial information described in subsection (3) of this
27 section, or within 15 days after the end of the 10-day period described in subsection (1) of this sec-
28 tion when the representative of the tenants committee does not request financial information under
29 subsection (2) of this section, if the tenants choose to continue competing to purchase the *[park]*
30 **facility**, the tenants committee must:

31 (a) Form a corporate entity under ORS chapter 60, 62 or 65 that is legally capable of purchasing
32 real property or associate with a nonprofit corporation or housing authority that is legally capable
33 of purchasing real property or that is advising the tenants about purchasing the *[park]* **facility** in
34 which the tenants reside.

35 (b) Submit to the owner a written offer to purchase the *[park]* **facility**, in the form of a proposed
36 purchase and sale agreement, and either a copy of the articles of incorporation of the corporate
37 entity or other evidence of the legal capacity of the formed or associated corporate entity to pur-
38 chase real property.

39 (6)(a) The owner may accept the offer to purchase in the tenants committee's purchase and sale
40 agreement, reject the offer or submit a counteroffer.

41 (b) If the parties reach agreement on the purchase, the purchase and sale agreement must
42 specify the price, due diligence duties, schedules, timelines, conditions and any extensions.

43 (c) If the tenants do not act as required within the time periods described in this section and
44 ORS 90.842, if the tenants violate the confidentiality agreement described in this section or if the
45 parties do not reach agreement on a purchase, the owner is not obligated to take additional action

1 under ORS 90.842 to 90.850.

2 **SECTION 28.** ORS 90.846 is amended to read:

3 90.846. (1) During the process described in ORS 90.842 to 90.850, the parties shall act in a
4 commercially reasonable manner.

5 (2) Except as provided in ORS 90.848, before selling a [*manufactured dwelling park*] **facility** to
6 an entity that is not formed by or associated with the tenants, the owner of the [*park*] **facility** must
7 give the notice required by ORS 90.842 and comply with the requirements of ORS 90.844.

8 (3) A minor error in providing the notice required by ORS 90.842 or in providing the financial
9 information required by ORS 90.844 does not prevent the owner from selling the [*park*] **facility** to
10 an entity that is not formed by or associated with the tenants and does not cause the owner to be
11 liable to the tenants for damages or a penalty.

12 (4) During the process described in ORS 90.842 to 90.850, the owner may seek, or negotiate with,
13 potential purchasers other than the tenants or an entity formed by or associated with the tenants.

14 (5) If the owner does not comply with requirements of this section and ORS 90.842 and 90.844,
15 in a substantial way that prevents the tenants from competing to purchase the [*park*] **facility**, the
16 tenants may:

17 (a) Obtain injunctive relief to prevent a sale or transfer to an entity that is not formed by or
18 associated with the tenants when the owner has not caused an affidavit to be recorded before the
19 sale or transfer pursuant to ORS 90.850.

20 (b) Recover actual damages or twice the rent from the owner for each tenant, whichever is
21 greater.

22 (6) If a tenant misuses or discloses, in a substantial way, confidential information in violation
23 of a confidentiality agreement described in ORS 90.844, the owner may recover actual damages from
24 the tenant.

25 (7) The [*Office of Manufactured Dwelling Park Community Relations of the*] Housing and Com-
26 munity Services Department shall prepare and make available information for tenants about pur-
27 chasing a [*manufactured dwelling park*] **facility**.

28 **SECTION 29.** ORS 90.848 is amended to read:

29 90.848. (1) With regard to a sale or transfer of a [*manufactured dwelling park*] **facility**, ORS
30 90.842, 90.844 and 90.846 do not apply to:

31 (a) Any sale or transfer to an individual who would be included within the table of descent and
32 distribution if the owner of the [*manufactured dwelling park*] **facility** were to die intestate.

33 (b) Any transfer by gift, devise or operation of law.

34 (c) Any sale or transfer by a corporation to an affiliate.

35 (d) Any sale or transfer by a partnership to any of its partners.

36 (e) Any sale or transfer of an interest in a limited liability company to any of the limited li-
37 ability company's members.

38 (f) Any conveyance of an interest in a [*park*] **facility** incidental to the financing of the [*park*]
39 **facility**.

40 (g) Any conveyance resulting from the foreclosure of a mortgage, deed of trust or other instru-
41 ment encumbering a [*park*] **facility** or any deed given in lieu of a foreclosure.

42 (h) Any sale or transfer between or among joint tenants or tenants in common owning a [*park*]
43 **facility**.

44 (i) Any sale or transfer in which the [*park*] **facility** satisfies the purchaser's requirement to
45 make a like-kind exchange under section 1031 of the Internal Revenue Code.

1 (j) Any purchase of a *[park]* **facility** by a governmental entity under the entity’s powers of em-
2 inent domain.

3 (k) Any transfer to a charitable trust.

4 (2) As used in this section, “affiliate” means any shareholder of the selling or transferring cor-
5 poration, any corporation or entity owned or controlled, directly or indirectly, by the selling or
6 transferring corporation or any other corporation or entity owned or controlled, directly or indi-
7 rectly, by any shareholder of the selling or transferring corporation.

8 **SECTION 30.** ORS 90.849 is amended to read:

9 90.849. In addition to providing notice as required by ORS 90.842, upon sale of a *[manufactured*
10 *dwelling park]* **facility** under ORS 90.842 to 90.850 or upon any sale, transfer, exchange or other
11 conveyance of a *[manufactured dwelling park]* **facility** described in ORS 90.848, the owner shall give
12 notice of the conveyance to the *[Office of Manufactured Dwelling Park Community Relations]*
13 **Housing and Community Services Department** stating:

- 14 (1) The number of vacant spaces and homes in the *[manufactured dwelling park]* **facility**;
- 15 (2) If applicable, the final sale price of the *[manufactured dwelling park]* **facility**;
- 16 (3) The date the conveyance became final; and
- 17 (4) The name, address and telephone number of the new owner.

18 **SECTION 31.** ORS 90.850 is amended to read:

19 90.850. (1) A *[manufactured dwelling park]* **facility** owner may present for recordation, in the
20 County Clerk Lien Record of the county in which the *[manufactured dwelling park]* **facility** is lo-
21 cated, an affidavit in which the owner certifies that:

- 22 (a) The owner has complied with the requirements of ORS 90.842, 90.844 and 90.846 with refer-
23 ence to an offer by the owner for the sale or transfer of the *[park]* **facility**.
- 24 (b) The owner has complied with the requirements of ORS 90.842, 90.844 and 90.846 with refer-
25 ence to an offer received by the owner for the purchase or transfer of the *[park]* **facility** or to a
26 counteroffer the owner has made or intends to make.
- 27 (c) The owner has not entered into a contract for the sale or transfer of the *[park]* **facility** to
28 an entity formed by or associated with the tenants.
- 29 (d) ORS 90.842, 90.844 and 90.846 do not apply to a particular sale or transfer of the *[park]* **fa-**
30 **ility** pursuant to ORS 90.848.

31 (2) The following parties have an absolute right to rely on the truth and accuracy of all state-
32 ments appearing in the affidavit and are not obligated to inquire further as to any matter or fact
33 relating to the owner’s compliance with ORS 90.842, 90.844 and 90.846:

- 34 (a) A party that acquires an interest in a *[park]* **facility**.
- 35 (b) A title insurance company, or an attorney, that prepares, furnishes or examines evidence of
36 title.

37 (3) The purpose and intention of this section is to preserve the marketability of title to *[parks]*
38 **facilities**. Accordingly, the provisions of this section must be liberally construed in order that all
39 persons may rely on the record title to *[parks]* **facilities**.

41 **MISCELLANEOUS FACILITY PROVISIONS**

42
43 **SECTION 32.** Section 33 of this 2019 Act is added to and made a part of ORS 90.505 to
44 **90.850.**

45 **SECTION 33.** (1) A landlord may require a tenant in a marina to move the tenant’s

1 floating home under this section for reasons allowing for the safety and convenience of the
2 marina and other tenants, including:

- 3 (a) Moving another floating home within the marina;
- 4 (b) Repairing an adjacent floating home; or
- 5 (c) Dredging, repairing an adjacent dock or otherwise repairing or improving the marina.

6 (2) Before requiring the tenant to move, the landlord must give written notice to the
7 tenant specifying the reason for the move, describing the parties' rights and obligations un-
8 der subsections (4) to (6) of this section, the allowable dates for the move and the maximum
9 duration of the move.

10 (3) The notice under subsection (2) of this section must be given:

11 (a) No less than 48 hours before the move if necessary to prevent the risk of serious and
12 imminent harm to persons or property within the marina; or

13 (b) Thirty days before the move in all other cases.

14 (4) The landlord must:

15 (a) Move the floating home to another space in the marina that allows the tenant to
16 continue to occupy the home.

17 (b) Return the floating home to its original space at the end of the relocation period.

18 (5) A landlord must pay:

19 (a) The costs to prepare the floating home for the move;

20 (b) The costs to move the floating home;

21 (c) The costs to prepare the floating home for its temporary location in the marina;

22 (d) If the relocation lasts more than 30 days, unless the floating home cannot be restored
23 to its original space because weather or water conditions are unsafe, actual damages based
24 on a decrease in value or quality of the temporary location;

25 (e) The costs to return the floating home to its original location in the original space;
26 and

27 (f) The costs to repair any damage to the floating home or tenant's personal property
28 caused by the move or to replace the property.

29 (6) A landlord is required to make any payments due to the tenant under subsection (5)
30 of this section within 30 days from the date the cost is incurred.

31 (7) If a tenant prohibits the landlord from moving the floating home under this section,
32 a landlord may give notice to terminate the tenancy under ORS 90.630.

33 (8) If a landlord fails to comply with a provision of this section, a tenant is entitled to
34 damages of one month's rent or twice the tenant's actual damages, whichever is greater.

35 **SECTION 34.** ORS 90.632 is amended to read:

36 90.632. (1) A landlord may terminate a month-to-month or fixed term rental agreement and re-
37 quire the tenant to remove a manufactured dwelling or floating home from a facility, due to the
38 physical condition of the exterior of the manufactured dwelling or floating home, only by complying
39 with this section and ORS 105.105 to 105.168. A termination shall include removal of the dwelling
40 or home.

41 (2) A landlord may not require removal of a manufactured dwelling or floating home, or consider
42 a dwelling or home to be in disrepair or deteriorated, because of the age, size, style or original
43 construction material of the dwelling or home or because the dwelling or home was built prior to
44 adoption of the National Manufactured Housing Construction and Safety Standards Act of 1974 (42
45 U.S.C. 5403), in compliance with the standards of that Act in effect at that time or in compliance

1 with the state building code as defined in ORS 455.010.

2 (3) Except as provided in subsections (4) and (6) of this section, if the exterior of the tenant's
3 dwelling or home is in disrepair or is deteriorated, a landlord may terminate a rental agreement and
4 require the removal of a dwelling or home by giving to the tenant not less than 60 days' written
5 notice before the date designated in the notice for termination.

6 (4) If the disrepair or deterioration of the manufactured dwelling or floating home creates a risk
7 of imminent and serious harm to dwellings, homes or persons within the facility, a landlord may
8 terminate a rental agreement and require the removal of the dwelling or home by giving to the
9 tenant not less than 30 days' written notice before the date designated in the notice for termination.
10 The notice shall describe the risk of harm.

11 (5) The notice required by subsections (3) and (4) of this section must:

12 (a) State facts sufficient to notify the tenant of the specific disrepair or deterioration that is the
13 cause or reason for termination of the tenancy and removal of the dwelling or home;

14 (b) State that the tenant can avoid termination and removal by correcting the cause for termi-
15 nation and removal within the notice period;

16 (c) If reasonably known by the landlord, describe specifically what repairs are required to cor-
17 rect the disrepair or deterioration that is the cause for termination;

18 (d) Describe the tenant's right to give the landlord a written notice of correction, where to give
19 the notice and the deadline for giving the notice in order to ensure a response by the landlord, all
20 as provided by subsection (7) of this section; and

21 (e) Describe the tenant's right to have the termination and correction period extended as pro-
22 vided by subsection (8) of this section.

23 (6) The tenant may avoid termination of the tenancy by correcting the cause within the period
24 specified. However, if substantially the same condition that constituted a prior cause for termination
25 of which notice was given recurs within 12 months after the date of the notice, the landlord may
26 terminate the tenancy and require the removal of the dwelling or home upon at least 30 days'
27 written notice specifying the violation and the date of termination of the tenancy.

28 (7) During the termination notice or extension period, the tenant may give the landlord written
29 notice that the tenant has corrected the cause for termination. Within a reasonable time after the
30 tenant's notice of correction, the landlord shall respond to the tenant in writing, stating whether the
31 landlord agrees that the cause has been corrected. If the tenant's notice of correction is given at
32 least 14 days prior to the end of the termination notice or extension period, failure by the landlord
33 to respond as required by this subsection is a defense to a termination based upon the landlord's
34 notice for termination.

35 (8) Except when the disrepair or deterioration creates a risk of imminent and serious harm to
36 dwellings, homes or persons within the facility, the 60-day period provided for the tenant to correct
37 the cause for termination and removal shall be extended by at least:

38 (a) An additional 60 days if:

39 (A) The necessary correction involves exterior painting, roof repair, concrete pouring or similar
40 work and the weather prevents that work during a substantial portion of the 60-day period; or

41 (B) The nature or extent of the correction work is such that it cannot reasonably be completed
42 within 60 days because of factors such as the amount of work necessary, the type and complexity
43 of the work and the availability of necessary repair persons; *[or]*

44 (b) An additional six months if the disrepair or deterioration has existed for more than the
45 preceding 12 months with the landlord's knowledge or acceptance as described in ORS 90.412[.]; **or**

1 (c) **An additional 10 months if the disrepair or deterioration relates to the float of a**
2 **floating home.**

3 (9) In order to have the period for correction extended as provided in subsection (8) of this
4 section, a tenant must give the landlord written notice describing the necessity for an extension in
5 order to complete the correction work. The notice must be given a reasonable amount of time prior
6 to the end of the notice for termination period.

7 (10) A tenancy terminates on the date designated in the notice and without regard to the expi-
8 ration of the period for which, by the terms of the rental agreement, rents are to be paid. Unless
9 otherwise agreed, rent is uniformly apportionable from day to day.

10 (11) This section does not limit a landlord's right to terminate a tenancy for nonpayment of rent
11 under ORS 90.394 or for other cause under ORS 90.380 (5)(b), 90.396, 90.398 or 90.630 by complying
12 with ORS 105.105 to 105.168.

13 (12) A landlord may give a copy of the notice for termination required by this section to any
14 lienholder of the dwelling or home, by first class mail with certificate of mailing or by any other
15 method allowed by ORS 90.150 (2) and (3). A landlord is not liable to a tenant for any damages in-
16 curred by the tenant as a result of the landlord giving a copy of the notice in good faith to a
17 lienholder.

18 (13) When a tenant has been given a notice for termination pursuant to this section and has
19 subsequently abandoned the dwelling or home as described in ORS 90.675, any lienholder shall have
20 the same rights as provided by ORS 90.675, including the right to correct the cause of the notice,
21 within the 90-day period provided by ORS 90.675 (20) notwithstanding the expiration of the notice
22 period provided by this section for the tenant to correct the cause.

23 **SECTION 35.** ORS 90.727 is amended to read:

24 90.727. (1) As used in this section:

25 (a) "Maintaining a tree" means removing or trimming a tree for the purpose of eliminating fea-
26 tures of the tree that cause the tree to be hazardous, or that may cause the tree to become haz-
27 ardous in the near future.

28 (b) "Removing a tree" includes:

29 (A) Felling and removing the tree; and

30 (B) Grinding or removing the stump of the tree.

31 (2) The landlord or tenant that is responsible for maintaining a tree must engage a landscape
32 construction professional with a valid license issued pursuant to ORS 671.560 to maintain any tree
33 with a DBH of eight inches or more.

34 (3) A landlord:

35 (a) Shall maintain a tree that is a hazard tree, that was not planted by the current tenant, on
36 a rented space in a manufactured dwelling park if the landlord knows or should know that the tree
37 is a hazard tree.

38 (b) May maintain a tree on the rented space to prevent the tree from becoming a hazard tree[,
39 *after providing the tenant with reasonable written notice and a reasonable opportunity to maintain the*
40 *tree*].

41 (c) Has discretion to decide whether the appropriate maintenance is removal or trimming of the
42 hazard tree.

43 (d) Is not responsible for maintaining a tree that is not a hazard tree or for maintaining any tree
44 for aesthetic purposes.

45 (4) [*A landlord shall comply*] **In addition to complying** with ORS 90.725, before entering a

1 tenant's space to inspect or maintain a tree[.], **the landlord must provide the tenant with:**

2 (a) **Reasonable notice to inspect a tree.**

3 (b) **Reasonable written notice to maintain a tree and, except as necessary to avoid an**
4 **imminent and serious harm to persons or property, a reasonable opportunity for the tenant**
5 **to maintain the tree. The notice must specify any tree that the landlord intends to remove.**

6 (5) Except as provided in subsection (3) of this section, a tenant is responsible for maintaining
7 the trees on the tenant's space in a manufactured dwelling park at the tenant's expense. The tenant
8 may retain an arborist licensed as a landscape construction professional pursuant to ORS 671.560
9 and certified by the International Society of Arboriculture to inspect a tree on the tenant's rented
10 space at the tenant's expense and if the arborist determines that the tree is a hazard, the tenant
11 may:

12 (a) Require the landlord to maintain a tree that is the landlord's responsibility under subsection
13 (3) of this section; or

14 (b) Maintain the tree at the tenant's expense, after providing the landlord with reasonable
15 written notice of the proposed maintenance and a copy of the arborist's report.

16 (6) If a manufactured dwelling cannot be removed from a space without first removing or trim-
17 ming a tree on the space, the owner of the manufactured dwelling may remove or trim the tree at
18 the dwelling owner's expense, after giving reasonable written notice to the landlord, for the purpose
19 of removing the manufactured dwelling.

20 **SECTION 36.** ORS 90.675, as amended by section 10, chapter 1, Oregon Laws 2019 (Enrolled
21 Senate Bill 608), is amended to read:

22 90.675. (1) As used in this section:

23 (a) "Current market value" means the amount in cash, as determined by the county assessor,
24 that could reasonably be expected to be paid for personal property by an informed buyer to an in-
25 formed seller, each acting without compulsion in an arm's-length transaction occurring on the as-
26 sessment date for the tax year or on the date of a subsequent reappraisal by the county assessor.

27 (b) "Dispose of the personal property" means that, if reasonably appropriate, the landlord may
28 throw away the property or may give it without consideration to a nonprofit organization or to a
29 person unrelated to the landlord. The landlord may not retain the property for personal use or
30 benefit.

31 (c) "Lienholder" means any lienholder of abandoned personal property, if the lien is of record
32 or the lienholder is actually known to the landlord.

33 (d) "Of record" means:

34 (A) For a manufactured dwelling, that a security interest has been properly recorded in the re-
35 cords of the Department of Consumer and Business Services pursuant to ORS 446.611 or on a cer-
36 tificate of title issued by the Department of Transportation prior to May 1, 2005.

37 (B) For a floating home, that a security interest has been properly recorded with the State
38 Marine Board pursuant to ORS 830.740 to 830.755 for a home registered and titled with the board
39 pursuant to ORS 830.715.

40 (e) "Personal property" means only a manufactured dwelling or floating home located in a fa-
41 cility and subject to ORS 90.505 to 90.850. "Personal property" does not include goods left inside a
42 manufactured dwelling or floating home or left upon a rented space and subject to disposition under
43 ORS 90.425.

44 (2) A landlord is responsible for abandoned personal property and shall store, sell or dispose of
45 abandoned personal property as provided by this section. This section governs the rights and obli-

1 gations of landlords, tenants and any lienholders in any personal property abandoned or left upon
2 the premises by the tenant or any lienholder in the following circumstances:

3 (a) The tenancy has ended by termination or expiration of a rental agreement or by
4 relinquishment or abandonment of the premises and the landlord reasonably believes under all the
5 circumstances that the tenant has left the personal property upon the premises with no intention
6 of asserting any further claim to the premises or to the personal property;

7 (b) The tenant has been absent from the premises continuously for seven days after termination
8 of a tenancy by a court order that has not been executed; or

9 (c) The landlord receives possession of the premises from the sheriff following restitution pur-
10 suant to ORS 105.161.

11 (3) Prior to storing, selling or disposing of the tenant's personal property under this section, the
12 landlord must give a written notice to the tenant that must be:

13 (a) Personally delivered to the tenant; or

14 (b) Sent by first class mail addressed and mailed to the tenant at:

15 (A) The premises;

16 (B) Any post-office box held by the tenant and actually known to the landlord; and

17 (C) The most recent forwarding address if provided by the tenant or actually known to the
18 landlord.

19 (4)(a) A landlord shall also give a copy of the notice described in subsection (3) of this section
20 to:

21 (A) Any lienholder of the personal property;

22 (B) The tax collector of the county where the personal property is located; and

23 (C) The assessor of the county where the personal property is located.

24 (b) The landlord shall give the notice copy required by this subsection by personal delivery or
25 first class mail, except that for any lienholder, mail service must be both by first class mail and by
26 certified mail with return receipt requested.

27 (c) A notice to lienholders under paragraph (a)(A) of this subsection must be sent to each
28 lienholder at each address:

29 (A) Actually known to the landlord;

30 (B) Of record; and

31 (C) Provided to the landlord by the lienholder in a written notice that identifies the personal
32 property subject to the lien and that was sent to the landlord by certified mail with return receipt
33 requested within the preceding five years. The notice must identify the personal property by de-
34 scribing the physical address of the property.

35 (5) The notice required under subsection (3) of this section must state that:

36 (a) The personal property left upon the premises is considered abandoned;

37 (b) The tenant or any lienholder must contact the landlord by a specified date, as provided in
38 subsection (6) of this section, to arrange for the removal of the abandoned personal property;

39 (c) The personal property is stored on the rented space;

40 (d) The tenant or any lienholder, except as provided by subsection (19) of this section, may ar-
41 range for removal of the personal property by contacting the landlord at a described telephone
42 number or address on or before the specified date;

43 (e) The landlord shall make the personal property available for removal by the tenant or any
44 lienholder, except as provided by subsection (19) of this section, by appointment at reasonable times;

45 (f) If the personal property is considered to be abandoned pursuant to subsection (2)(a) or (b)

1 of this section, the landlord may require payment of storage charges, as provided by subsection (7)(b)
2 of this section, prior to releasing the personal property to the tenant or any lienholder;

3 (g) If the personal property is considered to be abandoned pursuant to subsection (2)(c) of this
4 section, the landlord may not require payment of storage charges prior to releasing the personal
5 property;

6 (h) If the tenant or any lienholder fails to contact the landlord by the specified date or fails to
7 remove the personal property within 30 days after that contact, the landlord may sell or dispose of
8 the personal property. If the landlord reasonably believes the county assessor will determine that
9 the current market value of the personal property is \$8,000 or less, and the landlord intends to
10 dispose of the property if the property is not claimed, the notice shall state that belief and intent;
11 and

12 (i) If applicable, there is a lienholder that has a right to claim the personal property, except as
13 provided by subsection (19) of this section.

14 (6) For purposes of subsection (5) of this section, the specified date by which a tenant or
15 lienholder must contact a landlord to arrange for the disposition of abandoned personal property
16 must be not less than 45 days after personal delivery or mailing of the notice.

17 (7) After notifying the tenant as required by subsection (3) of this section, the landlord:

18 (a) Shall store the abandoned personal property of the tenant on the rented space and shall ex-
19 ercise reasonable care for the personal property; and

20 (b) Is entitled to reasonable or actual storage charges and costs incidental to storage or dis-
21 posal. The storage charge may be no greater than the monthly space rent last payable by the tenant.

22 (8) If a tenant or lienholder, upon the receipt of the notice provided by subsection (3) or (4) of
23 this section or otherwise, responds by actual notice to the landlord on or before the specified date
24 in the landlord's notice that the tenant or lienholder intends to remove the personal property from
25 the premises, the landlord must make that personal property available for removal by the tenant or
26 lienholder by appointment at reasonable times during the 30 days following the date of the response,
27 subject to subsection (19) of this section. If the personal property is considered to be abandoned
28 pursuant to subsection (2)(a) or (b) of this section, but not pursuant to subsection (2)(c) of this sec-
29 tion, the landlord may require payment of storage charges, as provided in subsection (7)(b) of this
30 section, prior to allowing the tenant or lienholder to remove the personal property. Acceptance by
31 a landlord of such payment does not operate to create or reinstate a tenancy or create a waiver
32 pursuant to ORS 90.412 or 90.417.

33 (9) Except as provided in subsections (19) to [(21)] **(22)** of this section, if the tenant or lienholder
34 does not respond within the time provided by the landlord's notice, or the tenant or lienholder does
35 not remove the personal property within 30 days after responding to the landlord or by any date
36 agreed to with the landlord, whichever is later, the personal property is conclusively presumed to
37 be abandoned. The tenant and any lienholder that have been given notice pursuant to subsection (3)
38 or (4) of this section shall, except with regard to the distribution of sale proceeds pursuant to sub-
39 section (13) of this section, have no further right, title or interest to the personal property and may
40 not claim or sell the property.

41 (10) If the personal property is presumed to be abandoned under subsection (9) of this section,
42 the landlord then may:

43 (a) Sell the personal property at a public or private sale, provided that prior to the sale:

44 (A) The landlord may seek to transfer ownership of record of the personal property by comply-
45 ing with the requirements of the appropriate state agency; and

- 1 (B) The landlord shall:
- 2 (i) Place a notice in a newspaper of general circulation in the county in which the personal
3 property is located. The notice shall state:
- 4 (I) That the personal property is abandoned;
- 5 (II) The tenant's name;
- 6 (III) The address and any space number where the personal property is located, and any plate,
7 registration or other identification number for a floating home noted on the title, if actually known
8 to the landlord;
- 9 (IV) Whether the sale is by private bidding or public auction;
- 10 (V) Whether the landlord is accepting sealed bids and, if so, the last date on which bids will be
11 accepted; and
- 12 (VI) The name and telephone number of the person to contact to inspect the personal property;
- 13 (ii) At a reasonable time prior to the sale, give a copy of the notice required by sub-
14 subparagraph (i) of this subparagraph to the tenant and to any lienholder, by personal delivery or
15 first class mail, except that for any lienholder, mail service must be by first class mail with certif-
16 icate of mailing;
- 17 (iii) Obtain an affidavit of publication from the newspaper to show that the notice required un-
18 der sub-subparagraph (i) of this subparagraph ran in the newspaper at least one day in each of two
19 consecutive weeks prior to the date scheduled for the sale or the last date bids will be accepted;
20 and
- 21 (iv) Obtain written proof from the county that all property taxes and assessments on the per-
22 sonal property have been paid or, if not paid, that the county has authorized the sale, with the sale
23 proceeds to be distributed pursuant to subsection (13) of this section; or
- 24 (b) Destroy or otherwise dispose of the personal property if the landlord determines from the
25 county assessor that the current market value of the property is \$8,000 or less.
- 26 (11)(a) A public or private sale authorized by this section must be conducted consistent with the
27 terms listed in subsection (10)(a)(B)(i) of this section. Every aspect of the sale including the method,
28 manner, time, place and terms must be commercially reasonable.
- 29 (b) If there is no buyer at a sale described under paragraph (a) of this subsection, the personal
30 property is considered to be worth \$8,000 or less, regardless of current market value, and the land-
31 lord shall destroy or otherwise dispose of the personal property.
- 32 (12) Notwithstanding ORS 446.155 (1) and (2), unless a landlord intentionally misrepresents the
33 condition of personal property, the landlord is not liable for the condition of the personal property
34 to:
- 35 (a) A buyer of the personal property at a sale pursuant to subsection (10)(a) of this section, with
36 or without consideration; or
- 37 (b) A person or nonprofit organization to whom the landlord gives the personal property pursu-
38 ant to subsection (1)(b), (10)(b) or (11)(b) of this section.
- 39 (13)(a) The landlord may deduct from the proceeds of the sale:
- 40 (A) The reasonable or actual cost of notice, storage and sale; and
- 41 (B) Unpaid rent.
- 42 (b) After deducting the amounts listed in paragraph (a) of this subsection, the landlord shall
43 remit the remaining proceeds, if any, to the county tax collector to the extent of any unpaid prop-
44 erty taxes and assessments owed on the dwelling or home.
- 45 (c) After deducting the amounts listed in paragraphs (a) and (b) of this subsection, if applicable,

1 the landlord shall remit the remaining proceeds, if any, to any lienholder to the extent of any unpaid
2 balance owed on the lien on the personal property.

3 (d) After deducting the amounts listed in paragraphs (a), (b) and (c) of this subsection, if appli-
4 cable, the landlord shall remit to the tenant the remaining proceeds, if any, together with an item-
5 ized accounting.

6 (e) If the tenant cannot after due diligence be found, the landlord shall deposit the remaining
7 proceeds with the county treasurer of the county in which the sale occurred. If not claimed within
8 three years, the deposited proceeds revert to the general fund of the county and are available for
9 general purposes.

10 (14) The county tax collector and the Department of Revenue shall cancel all unpaid property
11 taxes and special assessments as provided under ORS 305.155 and 311.790 only under one of the
12 following circumstances:

13 (a) The landlord disposes of the personal property after a determination described in subsection
14 (10)(b) of this section.

15 (b) There is no buyer of the personal property at a sale described under subsection (11) of this
16 section and the landlord disposes of the property.

17 (c)(A) There is a buyer of the personal property at a sale described under subsection (11) of this
18 section;

19 (B) The current market value of the personal property is \$8,000 or less; and

20 (C) The proceeds of the sale are insufficient to satisfy the unpaid property taxes and assessments
21 owed on the personal property after distribution of the proceeds pursuant to subsection (13) of this
22 section.

23 (d) The landlord buys the personal property at a sale described under subsection (11) of this
24 section and sells the property, in compliance with subsection (15) of this section, to a buyer who
25 intends to occupy the property in the facility in which the property is located.

26 (e) The landlord acquires the personal property as a result of an agreement described in sub-
27 section [(23)] **(24)** of this section and sells the property, in compliance with subsection (15) of this
28 section, to a buyer who intends to occupy the property in the facility in which the property is lo-
29 cated.

30 (15)(a) Subsection (14)(d) and (e) of this section apply only if:

31 (A) There exists a lien on the personal property for unpaid property taxes and special assess-
32 ments owed to a county or to the Department of Revenue and the landlord files an affidavit or
33 declaration with the county tax collector or the Department of Revenue, as appropriate, that states:

34 (i) The landlord's intent to sell the property in an arm's-length transaction to an unrelated buyer
35 who intends to occupy the property in the facility in which the property is located; and

36 (ii) That the landlord shall comply with the requirements of this subsection; and

37 (B) Following the sale described in paragraph (a)(A) of this subsection, the landlord files an af-
38 fidavit or declaration with the county tax collector or the Department of Revenue, as appropriate,
39 that states:

40 (i) That the landlord has sold the property in an arm's-length transaction to an unrelated buyer
41 who intends to occupy the property in the facility in which the property is located;

42 (ii) The sale price and a description of the landlord's claims against the property or costs from
43 the sale, as described under subsection (13)(a) of this section, and any costs of improvements to the
44 property for sale; and

45 (iii) The period of time, which may not be more than is reasonably necessary, that is taken by

1 the landlord to complete the sale of the property.

2 (b) After a landlord files the affidavit or declaration under paragraph (a)(A) of this subsection,
3 the county tax collector shall provide to the landlord a title to the property that the landlord may
4 then provide to a buyer at the time of the sale of the property.

5 (c) The affidavit or declaration described in paragraph (a)(B) of this subsection must be accom-
6 panied by:

7 (A) Payment to the county tax collector or the Department of Revenue, as appropriate, of the
8 amount remaining from the sale proceeds after the deduction of the landlord's claims and costs as
9 described in the affidavit or declaration, up to the amount of the unpaid taxes or tax lien. The
10 landlord may retain the amount of the sale proceeds that exceed the amount of the unpaid taxes or
11 tax lien;

12 (B) Payment to the county tax collector of any county warrant fees; and

13 (C) An affidavit or declaration from the buyer that states the buyer's intent to occupy the
14 property in the facility in which the property is located.

15 (d) Upon a showing of compliance with paragraph (c) of this subsection, the county tax collector
16 or the Department of Revenue shall cancel all unpaid taxes or tax liens on the property.

17 (16) The landlord is not responsible for any loss to the tenant or lienholder resulting from
18 storage of personal property in compliance with this section unless the loss was caused by the
19 landlord's deliberate or negligent act. In the event of a deliberate and malicious violation, the
20 landlord is liable for twice the actual damages sustained by the tenant or lienholder.

21 (17) Complete compliance in good faith with this section shall constitute a complete defense in
22 any action brought by a tenant or lienholder against a landlord for loss or damage to such personal
23 property disposed of pursuant to this section.

24 (18) If a landlord does not comply with this section:

25 (a) The tenant is relieved of any liability for damage to the premises caused by conduct that
26 was not deliberate, intentional or grossly negligent and for unpaid rent and may recover from the
27 landlord up to twice the actual damages sustained by the tenant;

28 (b) A lienholder aggrieved by the noncompliance may recover from the landlord the actual
29 damages sustained by the lienholder. ORS 90.255 does not authorize an award of attorney fees to
30 the prevailing party in any action arising under this paragraph; and

31 (c) A county tax collector aggrieved by the noncompliance may recover from the landlord the
32 actual damages sustained by the tax collector, if the noncompliance is part of an effort by the
33 landlord to defraud the tax collector. ORS 90.255 does not authorize an award of attorney fees to
34 the prevailing party in any action arising under this paragraph.

35 (19) The provisions of this section regarding the rights and responsibilities of a tenant to the
36 abandoned personal property also apply to any lienholder, except that the lienholder may not sell
37 or remove the dwelling or home unless:

38 (a) The lienholder has foreclosed the lien on the manufactured dwelling or floating home;

39 (b) The tenant or a personal representative or designated person described in subsection (21)
40 of this section has waived all rights under this section pursuant to subsection [(23)] (24) of this
41 section; or

42 (c) The notice and response periods provided by subsections (6) and (8) of this section have ex-
43 pired.

44 (20)(a) Except as provided by subsection (21)(d) and (e) of this section, if a lienholder makes a
45 timely response to a notice of abandoned personal property pursuant to subsections (6) and (8) of

1 this section and so requests, a landlord shall enter into a written storage agreement with the
2 lienholder providing that the personal property may not be sold or disposed of by the landlord for
3 up to 12 months. A storage agreement entitles the lienholder to store the personal property on the
4 previously rented space during the term of the agreement, but does not entitle anyone to occupy the
5 personal property.

6 (b) The lienholder's right to a storage agreement arises upon the failure of the tenant or, in the
7 case of a deceased tenant, the personal representative, designated person, heir or devisee to remove
8 or sell the dwelling or home within the allotted time.

9 (c) To exercise the right to a storage agreement under this subsection, in addition to contacting
10 the landlord with a timely response as described in paragraph (a) of this subsection, the lienholder
11 must enter into the proposed storage agreement within 60 days after the landlord gives a copy of
12 the agreement to the lienholder. The landlord shall give a copy of the proposed storage agreement
13 to the lienholder in the same manner as provided by subsection (4)(b) of this section. The landlord
14 may include a copy of the proposed storage agreement with the notice of abandoned property re-
15 quired by subsection (4) of this section. A lienholder enters into a storage agreement by signing a
16 copy of the agreement provided by the landlord and personally delivering or mailing the signed copy
17 to the landlord within the 60-day period. **If the tenancy is in a marina, the proposed storage**
18 **agreement is conditioned upon the tenant not electing to enter into a storage agreement**
19 **under subsection (22) of this section.**

20 (d) The storage agreement may require, in addition to other provisions agreed to by the landlord
21 and the lienholder, that:

22 (A) The lienholder make timely periodic payment of all storage charges, as described in sub-
23 section (7)(b) of this section, accruing from the commencement of the 45-day period described in
24 subsection (6) of this section. A storage charge may include a utility or service charge, as described
25 in ORS 90.532, if limited to charges for electricity, water, sewer service and natural gas and if in-
26 cidental to the storage of personal property. A storage charge may not be due more frequently than
27 monthly;

28 (B) The lienholder pay a late charge or fee for failure to pay a storage charge by the date re-
29 quired in the agreement, if the amount of the late charge is no greater than for late charges imposed
30 on facility tenants;

31 (C) The lienholder maintain the personal property and the space on which the personal property
32 is stored in a manner consistent with the rights and obligations described in the rental agreement
33 that the landlord currently provides to tenants as required by ORS 90.510 (4); and

34 (D) The lienholder repair any defects in the physical condition of the personal property that
35 existed prior to the lienholder entering into the storage agreement, if the defects and necessary re-
36 pairs are reasonably described in the storage agreement and, for homes that were first placed on
37 the space within the previous 24 months, the repairs are reasonably consistent with facility stan-
38 dards in effect at the time of placement. The lienholder shall have 90 days after entering into the
39 storage agreement to make the repairs. Failure to make the repairs within the allotted time consti-
40 tutes a violation of the storage agreement and the landlord may terminate the agreement by giving
41 at least 14 days' written notice to the lienholder stating facts sufficient to notify the lienholder of
42 the reason for termination. Unless the lienholder corrects the violation within the notice period, the
43 agreement terminates as provided and the landlord may sell or dispose of the property without fur-
44 ther notice to the lienholder.

45 (e) Notwithstanding subsection (7)(b) of this section, a landlord may increase the storage charge

1 if the increase is part of a facility-wide rent increase for all facility tenants, the increase is no
2 greater than the increase for other tenants and the landlord gives the lienholder written notice
3 consistent with the requirements of ORS 90.600.

4 (f) During the term of an agreement described under this subsection, the lienholder has the right
5 to remove or sell the property, subject to the provisions of the lien. Selling the property includes a
6 sale to a purchaser who wishes to leave the property on the rented space and become a tenant,
7 subject to the provisions of ORS 90.680. The landlord may condition approval for occupancy of any
8 purchaser of the property upon payment of all unpaid storage charges and maintenance costs.

9 (g)(A) Except as provided in paragraph (d)(D) of this subsection, if the lienholder violates the
10 storage agreement, the landlord may terminate the agreement by giving at least 90 days' written
11 notice to the lienholder stating facts sufficient to notify the lienholder of the reason for the termi-
12 nation. Unless the lienholder corrects the violation within the notice period, the agreement termi-
13 nates as provided and the landlord may sell or dispose of the property without further notice to the
14 lienholder.

15 (B) After a landlord gives a termination notice pursuant to subparagraph (A) of this paragraph
16 for failure of the lienholder to pay a storage charge and the lienholder corrects the violation, if the
17 lienholder again violates the storage agreement by failing to pay a subsequent storage charge, the
18 landlord may terminate the agreement by giving at least 30 days' written notice to the lienholder
19 stating facts sufficient to notify the lienholder of the reason for termination. Unless the lienholder
20 corrects the violation within the notice period, the agreement terminates as provided and the land-
21 lord may sell or dispose of the property without further notice to the lienholder.

22 (C) A lienholder may terminate a storage agreement at any time upon at least 14 days' written
23 notice to the landlord and may remove the property from the facility if the lienholder has paid all
24 storage charges and other charges as provided in the agreement.

25 (h) Upon the failure of a lienholder to enter into a storage agreement as provided by this sub-
26 section or upon termination of an agreement, unless the parties otherwise agree or the lienholder
27 has sold or removed the property, the landlord may sell or dispose of the property pursuant to this
28 section without further notice to the lienholder.

29 (21) If the personal property is considered abandoned as a result of the death of a tenant who
30 was the only tenant, this section applies, except as follows:

31 (a) The provisions of this section regarding the rights and responsibilities of a tenant to the
32 abandoned personal property shall apply to any personal representative named in a will or appointed
33 by a court to act for the deceased tenant or any person designated in writing by the tenant to be
34 contacted by the landlord in the event of the tenant's death.

35 (b) The notice required by subsection (3) of this section must be:

36 (A) Sent by first class mail to the deceased tenant at the premises; and

37 (B) Personally delivered or sent by first class mail to any personal representative or designated
38 person if actually known to the landlord.

39 (c) The notice described in subsection (5) of this section must refer to any personal represen-
40 tative or designated person, instead of the deceased tenant, and must incorporate the provisions of
41 this subsection.

42 (d) If a personal representative, designated person or other person entitled to possession of the
43 property, such as an heir or devisee, responds by actual notice to a landlord within the 45-day period
44 provided by subsection (6) of this section and so requests, the landlord shall enter into a written
45 storage agreement with the representative or person providing that the personal property may not

1 be sold or disposed of by the landlord for up to 90 days or until conclusion of any probate pro-
 2 ceedings, whichever is later. A storage agreement entitles the representative or person to store the
 3 personal property on the previously rented space during the term of the agreement, but does not
 4 entitle anyone to occupy the personal property. If such an agreement is entered, the landlord may
 5 not enter a similar agreement with a lienholder pursuant to subsection (20) of this section until the
 6 agreement with the personal representative or designated person ends.

7 (e) If a personal representative or other person requests that a landlord enter into a storage
 8 agreement, subsection (20)(c) to (e) and (g)(C) of this section applies, with the representative or
 9 person having the rights and responsibilities of a lienholder with regard to the storage agreement.

10 (f) During the term of an agreement described under paragraph (d) of this subsection, the rep-
 11 resentative or person has the right to remove or sell the property, including a sale to a purchaser
 12 or a transfer to an heir or devisee where the purchaser, heir or devisee wishes to leave the property
 13 on the rented space and become a tenant, subject to the provisions of ORS 90.680. The landlord also
 14 may condition approval for occupancy of any purchaser, heir or devisee of the property upon pay-
 15 ment of all unpaid storage charges and maintenance costs.

16 (g) If the representative or person violates the storage agreement, the landlord may terminate
 17 the agreement by giving at least 30 days' written notice to the representative or person stating facts
 18 sufficient to notify the representative or person of the reason for the termination. Unless the rep-
 19 resentative or person corrects the violation within the notice period, the agreement terminates as
 20 provided and the landlord may sell or dispose of the property without further notice to the repre-
 21 sentative or person.

22 (h) Upon the failure of a representative or person to enter into a storage agreement as provided
 23 by this subsection or upon termination of an agreement, unless the parties otherwise agree or the
 24 representative or person has sold or removed the property, the landlord may sell or dispose of the
 25 property pursuant to this section without further notice to the representative or person.

26 **(22)(a) If a tenant of a marina makes a timely response to a notice of abandoned personal**
 27 **property pursuant to subsections (6) and (8) of this section and so requests, and has not**
 28 **entered into a storage agreement under ORS 90.545 (7), a landlord shall enter into a written**
 29 **storage agreement with the tenant providing that the personal property may not be sold or**
 30 **disposed of by the landlord for up to 12 months. A storage agreement entitles the tenant to**
 31 **store the personal property on the previously rented space during the term of the agreement**
 32 **but does not entitle anyone to occupy the personal property.**

33 **(b) To exercise the right to a storage agreement under this subsection, in addition to**
 34 **contacting the landlord with a timely response as described in paragraph (a) of this sub-**
 35 **section, the tenant must enter into the proposed storage agreement within 60 days after the**
 36 **landlord gives a copy of the agreement to the tenant. The landlord shall give a copy of the**
 37 **proposed storage agreement to the tenant in the same manner as provided by subsection (3)**
 38 **of this section. The landlord may include a copy of the proposed storage agreement with the**
 39 **notice of abandoned property required by subsection (3) of this section. A tenant enters into**
 40 **a storage agreement by signing a copy of the agreement provided by the landlord and per-**
 41 **sonally delivering or mailing the signed copy to the landlord within the 60-day period.**

42 **(c) The storage agreement may require, in addition to other provisions agreed to by the**
 43 **landlord and the tenant, that:**

44 **(A) The tenant make timely periodic payment of all storage charges, as described in**
 45 **subsection (7)(b) of this section, accruing from the commencement of the 45-day period de-**

1 scribed in subsection (6) of this section. A storage charge may include a utility or service
2 charge, as described in ORS 90.532, if limited to charges for electricity, water, sewer service
3 and natural gas and if incidental to the storage of personal property. A storage charge may
4 not be due more frequently than monthly.

5 (B) The tenant pay a late charge or fee for failure to pay a storage charge by the date
6 required in the agreement, if the amount of the late charge is no greater than for late
7 charges imposed on facility tenants.

8 (C) The tenant maintain the personal property and the space on which the personal
9 property is stored in a manner consistent with the rights and obligations described in the
10 rental agreement that the landlord currently provides to tenants as required by ORS 90.510
11 (4).

12 (D) The tenant repair any defects in the physical condition of the personal property that
13 existed prior to the tenant entering into the storage agreement, except repair the float of
14 the home, if the defects and necessary repairs are reasonably described in the storage
15 agreement and, for homes that were first placed on the space within the previous 24 months,
16 the repairs are reasonably consistent with facility standards in effect at the time of place-
17 ment. The tenant shall have 90 days after entering into the storage agreement to make the
18 repairs. Failure to make the repairs within the allotted time constitutes a violation of the
19 storage agreement and the landlord may terminate the agreement by giving at least 14 days'
20 written notice to the tenant stating facts sufficient to notify the tenant of the reason for
21 termination. Unless the tenant corrects the violation within the notice period, the agree-
22 ment terminates as provided and the landlord may sell or dispose of the property without
23 further notice to the tenant.

24 (d) Notwithstanding subsection (7)(b) of this section, a landlord may increase the storage
25 charge if the increase is part of a facility-wide rent increase for all facility tenants, the in-
26 crease is no greater than the increase for other tenants and the landlord gives the tenant
27 written notice consistent with the requirements of ORS 90.600.

28 (e) During the term of an agreement described under this subsection, the tenant has the
29 right to remove or sell the property. Selling the property includes a sale to a purchaser who
30 wishes to leave the property on the rented space and become a tenant, subject to the pro-
31 visions of ORS 90.680. The landlord may condition approval for occupancy of any purchaser
32 of the property upon payment of all unpaid storage charges and maintenance costs.

33 (f)(A) Except as provided in paragraph (c)(D) of this subsection, if the tenant violates the
34 storage agreement, the landlord may terminate the agreement by giving at least 90 days'
35 written notice to the tenant stating facts sufficient to notify the tenant of the reason for the
36 termination. Unless the tenant corrects the violation within the notice period, the agreement
37 terminates as provided and the landlord may sell or dispose of the property without further
38 notice to the tenant.

39 (B) After a landlord gives a termination notice pursuant to subparagraph (A) of this
40 paragraph for failure of the tenant to pay a storage charge and the tenant corrects the vio-
41 lation, if the tenant again violates the storage agreement by failing to pay a subsequent
42 storage charge, the landlord may terminate the agreement by giving at least 30 days' written
43 notice to the tenant stating facts sufficient to notify the tenant of the reason for termi-
44 nation. Unless the tenant corrects the violation within the notice period, the agreement
45 terminates as provided and the landlord may sell or dispose of the property without further

1 **notice to the tenant.**

2 (C) A tenant may terminate a storage agreement at any time upon at least 14 days'
3 written notice to the landlord and may remove the property from the facility if the tenant
4 has paid all storage charges and other charges as provided in the agreement.

5 (g) Upon the failure of a tenant to enter into a storage agreement as provided by this
6 subsection or upon termination of an agreement, unless the parties otherwise agree, the
7 landlord may sell or dispose of the property pursuant to this section without further notice
8 to the tenant after providing at least 15 days' written notice to any lienholder to enter into
9 a storage agreement under subsection (20) of this section.

10 [(22)] (23) If a governmental agency determines that the condition of personal property aban-
11 doned under this section constitutes an extreme health or safety hazard under state or local law and
12 the agency determines that the hazard endangers others in the facility and requires quick removal
13 of the property, the landlord may sell or dispose of the property pursuant to this subsection. The
14 landlord shall comply with all provisions of this section, except as follows:

15 (a) The date provided in subsection (6) of this section by which a tenant, lienholder, personal
16 representative or designated person must contact a landlord to arrange for the disposition of the
17 property must be not less than 15 days after personal delivery or mailing of the notice required by
18 subsection (3) of this section.

19 (b) The date provided in subsections (8) and (9) of this section by which a tenant, lienholder,
20 personal representative or designated person must remove the property must be not less than seven
21 days after the tenant, lienholder, personal representative or designated person contacts the landlord.

22 (c) The notice required by subsection (3) of this section must be as provided in subsection (5)
23 of this section, except that:

24 (A) The dates and deadlines in the notice for contacting the landlord and removing the property
25 must be consistent with this subsection;

26 (B) The notice must state that a governmental agency has determined that the property consti-
27 tutes an extreme health or safety hazard and must be removed quickly; and

28 (C) The landlord shall attach a copy of the agency's determination to the notice.

29 (d) If the tenant, a lienholder or a personal representative or designated person does not remove
30 the property within the time allowed, the landlord or a buyer at a sale by the landlord under sub-
31 section (11) of this section shall promptly remove the property from the facility.

32 (e) A landlord is not required to enter into a storage agreement with a lienholder, personal
33 representative or designated person pursuant to subsection (20) of this section.

34 [(23)(a)] (24)(a) A landlord may sell or dispose of a tenant's abandoned personal property with-
35 out complying with the provisions of this section if, after termination of the tenancy or no more than
36 seven days prior to the termination of the tenancy, the following parties so agree in a writing en-
37 tered into in good faith:

38 (A) The landlord;

39 (B) The tenant, or for an abandonment as the result of the death of a tenant who was the only
40 tenant, the personal representative, designated person or other person entitled to possession of the
41 personal property, such as an heir or devisee, as described in subsection (21) of this section; and

42 (C) Any lienholder.

43 (b) A landlord may not, as part of a rental agreement, as a condition to approving a sale of
44 property on rented space under ORS 90.680 or in any other manner, require a tenant, a personal
45 representative, a designated person or any lienholder to waive any right provided by this section.

1 [(24)] (25) Until personal property is conclusively presumed to be abandoned under subsection
2 (9) of this section, a landlord does not have a lien pursuant to ORS 87.152 for storing the personal
3 property.

5 **FACILITY REMEDIES FOR RENTAL AGREEMENT VIOLATIONS**
6

7 **SECTION 37.** ORS 90.302 is amended to read:

8 90.302. (1) A landlord may not charge a fee at the beginning of the tenancy for an anticipated
9 landlord expense and may not require the payment of any fee except as provided in this section.
10 A fee must be described in a written rental agreement.

11 (2) A landlord may charge a tenant a fee for each occurrence of the following:

12 (a) A late rent payment, pursuant to ORS 90.260.

13 (b) A dishonored check, pursuant to ORS 30.701 (5). The amount of the fee may not exceed the
14 amount described in ORS 30.701 (5) plus any amount that a bank has charged the landlord for pro-
15 cessing the dishonored check.

16 (c) Removal or tampering with a properly functioning smoke alarm, smoke detector or carbon
17 monoxide alarm, as provided in ORS 90.325 (2). The landlord may charge a fee of up to \$250 unless
18 the State Fire Marshal assesses the tenant a civil penalty for the conduct under ORS 479.990 or
19 under ORS 105.836 to 105.842 and 476.725.

20 (d) The violation of a written pet agreement or of a rule relating to pets in a facility, pursuant
21 to ORS 90.530.

22 (e) The abandonment or relinquishment of a dwelling unit during a fixed term tenancy without
23 cause. The fee may not exceed one and one-half times the monthly rent. A landlord may not assess
24 a fee under this paragraph if the abandonment or relinquishment is pursuant to ORS 90.453 (2),
25 90.472 or 90.475. If the landlord assesses a fee under this paragraph:

26 (A) The landlord may not recover unpaid rent for any period of the fixed term tenancy beyond
27 the date that the landlord knew or reasonably should have known of the abandonment or
28 relinquishment;

29 (B) The landlord may not recover damages related to the cost of renting the dwelling unit to a
30 new tenant; and

31 (C) ORS 90.410 (3) does not apply to the abandonment or relinquishment.

32 (3)(a) A landlord may charge a tenant a fee under this subsection for a second noncompliance
33 or for a subsequent noncompliance with written rules or policies that describe the prohibited con-
34 duct and the fee for a second noncompliance, and for any third or subsequent noncompliance, that
35 occurs within one year after a written warning notice described in subparagraph (A) of this para-
36 graph. Except as provided in paragraph (b)(G) or (H) of this subsection, the fee may not exceed \$50
37 for the second noncompliance within one year after the warning notice for the same or a similar
38 noncompliance or \$50 plus five percent of the rent payment for the current rental period for a third
39 or subsequent noncompliance within one year after the warning notice for the same or a similar
40 noncompliance. The landlord:

41 (A) Shall give a tenant a written warning notice that describes:

42 (i) A specific noncompliance before charging a fee for a second or subsequent noncompliance for
43 the same or similar conduct; and

44 (ii) The amount of the fee for a second noncompliance, and for any subsequent noncompliance,
45 that occurs within one year after the warning notice.

1 (B) Shall give a tenant a written notice describing the noncompliance when assessing a fee for
2 a second or subsequent noncompliance that occurs within one year after the warning notice.

3 (C) Shall give a warning notice for a noncompliance or assess a fee for a second or subsequent
4 noncompliance within 30 days after the act constituting noncompliance.

5 (D) May terminate a tenancy for a noncompliance consistent with this chapter instead of as-
6 ssuming a fee under this subsection, but may not assess a fee and terminate a tenancy for the same
7 noncompliance.

8 (E) May not deduct a fee assessed pursuant to this subsection from a rent payment for the
9 current or a subsequent rental period.

10 (b) A landlord may charge a tenant a fee for occurrences of noncompliance with written rules
11 or policies as provided in paragraph (a) of this subsection for the following types of noncompliance:

12 (A) The late payment of a utility or service charge that the tenant owes the landlord as de-
13 scribed in ORS 90.315.

14 (B) Failure to clean up pet waste from a part of the premises other than the dwelling unit.

15 (C) Failure to clean up the waste of a service animal or a companion animal from a part of the
16 premises other than the dwelling unit.

17 (D) Failure to clean up garbage, rubbish and other waste from a part of the premises other than
18 the dwelling unit.

19 (E) Parking violations.

20 (F) The improper use of vehicles within the premises.

21 (G) Smoking in a clearly designated nonsmoking unit or area of the premises. The fee for a
22 second or any subsequent noncompliance under this subparagraph may not exceed \$250. A landlord
23 may not assess this fee before 24 hours after the required warning notice to the tenant.

24 (H) Keeping on the premises an unauthorized pet capable of causing damage to persons or
25 property, as described in ORS 90.405. The fee for a second or any subsequent noncompliance under
26 this subparagraph may not exceed \$250. A landlord may not assess this fee before 48 hours after the
27 required warning notice to the tenant.

28 (4) A landlord may not be required to account for or return to the tenant any fee.

29 (5) Except as provided in subsection (2)(e) of this section, a landlord may not charge a tenant
30 any form of liquidated damages, however designated.

31 (6) Nonpayment of a fee is not grounds for termination of a rental agreement for nonpayment
32 of rent under ORS 90.394, but is grounds for termination of a rental agreement for cause under ORS
33 90.392 or 90.630 (1).

34 (7) This section does not apply to:

35 (a) Attorney fees awarded pursuant to ORS 90.255;

36 (b) Applicant screening charges paid pursuant to ORS 90.295;

37 (c) Charges for improvements or other actions that are requested by the tenant and are not re-
38 quired of the landlord by the rental agreement or by law, including the cost to replace a key lost
39 by a tenant;

40 (d) Processing fees charged to the landlord by a credit card company and passed through to the
41 tenant for the use of a credit card by the tenant to make a payment when:

42 (A) The credit card company allows processing fees to be passed through to the credit card
43 holder; and

44 (B) The landlord allows the tenant to pay in cash or by check;

45 (e) A requirement by a landlord in a written rental agreement that a tenant obtain and maintain

1 renter's liability insurance pursuant to ORS 90.222; or

2 (f) Assessments, as defined in ORS 94.550 and 100.005, for a dwelling unit that is within a
3 homeowners association organized under ORS 94.625 or an association of unit owners organized
4 under ORS 100.405, respectively, if:

5 (A) The assessments are imposed by the association on a landlord who owns a dwelling unit
6 within the association and the landlord passes the assessments through to a tenant of the unit;

7 (B) The assessments are imposed by the association on any person for expenses related to
8 moving into or out of a unit located within the association;

9 (C) The landlord sets forth the assessment requirement in the written rental agreement at the
10 commencement of the tenancy; and

11 (D) The landlord gives a copy of the assessment the landlord receives from the association to
12 the tenant before or at the time the landlord charges the tenant.

13 (8) If a landlord charges a tenant a fee in violation of this section, the tenant may recover twice
14 the actual damages of the tenant or \$300, whichever is greater. This penalty does not apply to fees
15 described in subsection (2) of this section.

16 **(9) The landlord may unilaterally amend a rental agreement for a facility subject to ORS**
17 **90.505 to 90.850 to impose fees authorized by subsection (3) of this section upon a 90-day**
18 **written notice to the tenant, except that a marina landlord may not impose a noncompliance**
19 **fee for parking under subsection (3)(b)(E) of this section.**

20 **SECTION 38.** ORS 90.630, as amended by section 22, chapter 820, Oregon Laws 2015, is
21 amended to read:

22 90.630. (1) Except as provided in subsection [(4)] (5) of this section, the landlord may terminate
23 a rental agreement [*that is a month-to-month or fixed term tenancy*] for space for a manufactured
24 dwelling or floating home by giving to the tenant not less than 30 days' notice in writing before the
25 **termination** date designated in the notice, [*for termination*] if the tenant:

26 (a) **Materially** violates a law [*or ordinance*] related to the tenant's conduct as a tenant, [*in-*
27 *cluding but not limited to a material noncompliance with ORS 90.740*];

28 (b) **Materially** violates a [*rule or*] rental agreement provision related to the tenant's conduct as
29 a tenant and imposed as a condition of occupancy[, *including but not limited to a material noncom-*
30 *pliance with a rental agreement regarding a program of recovery in drug and alcohol free housing*];

31 (c) Is classified as a level three sex offender under ORS 163A.100 (3); or

32 (d) Fails to pay a:

33 (A) Late charge pursuant to ORS 90.260;

34 (B) Fee pursuant to ORS 90.302; or

35 (C) Utility or service charge pursuant to ORS 90.534 or 90.536.

36 (2) A violation making a tenant subject to termination under subsection (1) of this section in-
37 cludes a tenant's failure to maintain the space as required by law, [*ordinance,*] rental agreement or
38 rule, but does not include the physical condition of the dwelling or home. Termination of a rental
39 agreement based upon the physical condition of a dwelling or home [*shall only be*] **may only occur**
40 as provided in ORS 90.632.

41 (3) The notice required by subsection (1) of this section [*shall*] **must** state:

42 (a) **That the tenancy will terminate on a designated termination date;**

43 (b) Facts sufficient to notify the tenant of the reasons for termination of the tenancy; [*and*
44 *state*]

45 (c) That the tenant may avoid termination by correcting the violation [*as provided in subsection*

1 (4) of this section.] by a designated date that is:

2 (A) At least 30 days after delivery of the notice; or

3 (B) If the violation involves conduct that was a separate and distinct act or omission and
4 is not ongoing, at least three days after delivery of the notice;

5 (d) If a date to correct is given under paragraph (c)(B) of this subsection, that the vio-
6 lation is conduct that is a separate and distinct violation and that the date designated for
7 correcting the violation is different from the termination date; and

8 (e) At least one possible method by which the tenant may correct the violation.

9 (4) For the purposes of subsection (3) of this section, conduct is ongoing if:

10 (a) The conduct is constant or persistent or has been sufficiently repetitive over time
11 that a reasonable person would consider the conduct to be ongoing; and

12 (b) The violation does not involve a pet or assistance animal.

13 [(4)] (5) [The tenant may avoid termination of the tenancy by correcting] The tenancy terminates
14 on the termination date unless the tenant corrects the violation [within the 30-day period spec-
15 ified] by the designated date in subsection [(1)] (3)(c) of this section. If the notice fails to des-
16 ignate a date for correcting the violation, the violation must be corrected by the termination
17 date.

18 (6) [However, if] Notwithstanding subsection (3) of this section, if a tenant avoids termi-
19 nation as described in subsection (5) of this section and substantially the same act or omission
20 that constituted a prior violation of which notice was given recurs within six months after the
21 termination date [of] designated in the original notice, the landlord may terminate the tenancy
22 upon at least 20 days' written notice before the termination date designated in the new notice
23 specifying the violation [and the date of termination of the tenancy] and stating that the tenant
24 has no right to correct the violation and avoid termination.

25 [(5)] (7) Notwithstanding [subsection (3) or (4)] subsections (3) to (5) of this section, a tenant
26 who is given a notice of termination under subsection (1)(c) of this section does not have a right to
27 correct the violation. A notice given to a tenant under subsection (1)(c) of this section must state
28 that the tenant does not have a right to avoid the termination.

29 [(6)] (8) This section does not limit a landlord's right to terminate a tenancy [for nonpayment
30 of rent under ORS 90.394 or] for other cause under [ORS 90.380 (5)(b), 90.396, 90.398 or 90.632 by
31 complying with ORS 105.105 to 105.168] this chapter.

32 [(7)] (9) A tenancy terminates on the termination date designated in the notice and without
33 regard to the expiration of the period for which, by the terms of the rental agreement, rents are to
34 be paid. Unless otherwise agreed, rent is uniformly apportionable from day to day.

35 [(8)] (10) Notwithstanding any other provision of this section [or ORS 90.394, 90.396 or 90.398],

37 home because of repeated late payment of rent by giving the tenant not less than 30 days' notice in
38 writing before the termination date designated in [that] the notice [for termination and may take
39 possession as provided in ORS 105.105 to 105.168] if:

40 (a) The tenant has not paid the monthly rent prior to the eighth day of the rental period as

43 of rent termination notice pursuant to ORS 90.394 (2) during each of those three instances of non-

 18 common area that is already served by that line, unless the installation causes a system upgrade,
 19 a local government may not assess a system development charge as defined in ORS 223.299 as a
 20 result of the installation.

21 **SECTION 47.** ORS 90.538 is amended to read:

22 90.538. **(1) If a landlord bills tenants for water using pro rata billing or submeter billing,**
 23 **the landlord shall post the facility water bills in an area accessible to tenants, including on**
 24 **an Internet location.**

25 *[(1)]* **(2)** A landlord shall, upon written request by the tenant, make available for inspection by
 26 the tenant all utility billing records relating to a utility or service charge billed to the tenant **by**
 27 **the landlord** during the preceding year. The landlord shall make the records available to the tenant
 28 during normal business hours at an on-site manager's office or at a location agreed to by the land-
 29 lord and tenant. A tenant may not abuse the right to inspect utility or service charge records or
 30 use the right to harass the landlord.

31 *[(2)]* **(3)** If a landlord fails to comply with a provision of ORS 90.531 to 90.539, the tenant may

39 **(2) After giving notice under ORS 90.725, a landlord may enter a tenant's space to install**
 40 **or maintain a utility or service line or a submeter that measures the amount of a provided**
 41 **utility or service. The installation of a submeter may be at the connection to the space or**
 42 **anywhere within the space, including under the dwelling or home, if the location does not**
 43 **interfere with the tenant's access to the dwelling or home. The landlord shall ensure that**
 44 **the submeter and the water line to which it is attached are adequately insulated or located**
 45 **to prevent the submeter or water line from damage from freezing or weather.**

19 or service charge for water by [*the*] pro rata billing [*method described in ORS 90.532 (1)(b)(C)(ii)*]

32 *basis,*] with [*only the following factors being considered in the apportionment*], notwithstanding ORS

34 [(i)] **(A)** The number of tenants or occupants in the manufactured dwelling compared with the
35 number of tenants or occupants in the manufactured dwelling park; and

36 [(ii)] **(B)** The size of a tenant's space as a percentage of the total area of the manufactured
37 dwelling park.

38 [(B)] **(b)** [*Base*] **Bases** two-thirds of the charge to the tenants on the factor described in [*sub-*
39 *paragraph (A)(i) of this paragraph*] **paragraph (a)(A) of this subsection** and one-third of the charge
40 on the factor described in [*subparagraph (A)(ii) of this paragraph*] **paragraph (a)(B) of this sub-**
41 **section.**

42 [(C)] **(c)** [*Determine*] **Determines** the number of tenants or occupants in each dwelling unit and

22 unit, the purpose of which is to pay the cost of processing an application for a rental agreement for
23 a residential dwelling unit.

24 (4) "Building and housing codes" includes any law, ordinance or governmental regulation con-
25 cerning fitness for habitation, or the construction, maintenance, operation, occupancy, use or ap-
26 pearance of any premises or dwelling unit.

27 (5) "Carbon monoxide alarm" has the meaning given that term in ORS 105.836.

28 (6) "Carbon monoxide source" has the meaning given that term in ORS 105.836.

29 (7) "Conduct" means the commission of an act or the failure to act.

30 (8) "DBH" means the diameter at breast height, which is measured as the width of a standing
31 tree at four and one-half feet above the ground on the uphill side.

32 (9) "Dealer" means any person in the business of selling, leasing or distributing new or used
33 manufactured dwellings or floating homes to persons who purchase or lease a manufactured dwelling
34 or floating home for use as a residence.

35 (10) "Domestic violence" means:

36 (a) Abuse between family or household members, as those terms are defined in ORS 107.705; or

37 (b) Abuse, as defined in ORS 107.705, between partners in a dating relationship.

38 (11) "Drug and alcohol free housing" means a dwelling unit described in ORS 90.243.

39 (12) "Dwelling unit" means a structure or the part of a structure that is used as a home, resi-
40 dence or sleeping place by one person who maintains a household or by two or more persons who
41 maintain a common household. "Dwelling unit" regarding a person who rents a space for a manu-
42 factured dwelling or recreational vehicle or regarding a person who rents moorage space for a
43 floating home as defined in ORS 830.700, but does not rent the home, means the space rented and
44 not the manufactured dwelling, recreational vehicle or floating home itself.

45 (13) "Essential service" means:

1 (a) For a tenancy not consisting of rental space for a manufactured dwelling, floating home or
2 recreational vehicle owned by the tenant and not otherwise subject to ORS 90.505 to 90.850:

3 (A) Heat, plumbing, hot and cold running water, gas, electricity, light fixtures, locks for exterior
4 doors, latches for windows and any cooking appliance or refrigerator supplied or required to be
5 supplied by the landlord; and

6 (B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.320,
7 the lack or violation of which creates a serious threat to the tenant's health, safety or property or
8 makes the dwelling unit unfit for occupancy.

9 (b) For a tenancy consisting of rental space for a manufactured dwelling, floating home or rec-
10 reational vehicle owned by the tenant or that is otherwise subject to ORS 90.505 to 90.850:

11 (A) Sewage disposal, water supply, electrical supply and, if required by applicable law, any
12 drainage system; and

13 (B) Any other service or habitability obligation imposed by the rental agreement or ORS 90.730,
14 the lack or violation of which creates a serious threat to the tenant's health, safety or property or
15 makes the rented space unfit for occupancy.

16 (14) "Facility" means a manufactured dwelling park or a marina.

17 (15) "Fee" means a nonrefundable payment of money.

18 (16) "First class mail" does not include certified or registered mail, or any other form of mail
19 that may delay or hinder actual delivery of mail to the recipient.

20 (17) "Fixed term tenancy" means a tenancy that has a fixed term of existence, continuing to a
21 specific ending date and terminating on that date without requiring further notice to effect the ter-
22 mination.

23 (18) "Floating home" has the meaning given that term in ORS 830.700. "Floating home" includes
24 an accessory building or structure.

25 (19) "Good faith" means honesty in fact in the conduct of the transaction concerned.

26 (20) "Hazard tree" means a tree that:

27 (a) Is located on a rented space in a manufactured dwelling park;

28 (b) Measures at least eight inches DBH; and

29 (c) Is considered, by an arborist licensed as a landscape construction professional pursuant to
30 ORS 671.560 and certified by the International Society of Arboriculture, to pose an unreasonable
31 risk of causing serious physical harm or damage to individuals or property in the near future.

32 (21) "Hotel or motel" means "hotel" as that term is defined in ORS 699.005.

33 (22) "Informal dispute resolution" includes **voluntary** consultation between the landlord or
34 landlord's agent and one or more tenants[,] or **voluntary** mediation utilizing the services of a third
35 party, **but does not include mandatory mediation or arbitration.**

36 (23) "Landlord" means the owner, lessor or sublessor of the dwelling unit or the building or
37 premises of which it is a part. "Landlord" includes a person who is authorized by the owner, lessor
38 or sublessor to manage the premises or to enter into a rental agreement.

39 (24) "Landlord's agent" means a person who has oral or written authority, either express or
40 implied, to act for or on behalf of a landlord.

41 (25) "Last month's rent deposit" means a type of security deposit, however designated, the pri-
42 mary function of which is to secure the payment of rent for the last month of the tenancy.

43 (26) "Manufactured dwelling" means a residential trailer, a mobile home or a manufactured
44 home as those terms are defined in ORS 446.003. "Manufactured dwelling" includes an accessory
45 building or structure. "Manufactured dwelling" does not include a recreational vehicle.

1 (27) "Manufactured dwelling park" means a place where four or more manufactured dwellings
2 are located, the primary purpose of which is to rent space or keep space for rent to any person for
3 a charge or fee.

4 (28) "Marina" means a moorage of contiguous dwelling units that may be legally transferred as
5 a single unit and are owned by one person where four or more floating homes are secured, the pri-
6 mary purpose of which is to rent space or keep space for rent to any person for a charge or fee.

7 (29) "Marina purchase association" means a group of three or more tenants who reside in a
8 marina and have organized for the purpose of eventual purchase of the marina.

9 (30) "Month-to-month tenancy" means a tenancy that automatically renews and continues for
10 successive monthly periods on the same terms and conditions originally agreed to, or as revised by
11 the parties, until terminated by one or both of the parties.

12 (31) "Organization" includes a corporation, government, governmental subdivision or agency,
13 business trust, estate, trust, partnership or association, two or more persons having a joint or com-
14 mon interest, and any other legal or commercial entity.

15 (32) "Owner" includes a mortgagee in possession and means one or more persons, jointly or se-
16 verally, in whom is vested:

17 (a) All or part of the legal title to property; or

18 (b) All or part of the beneficial ownership and a right to present use and enjoyment of the
19 premises.

20 (33) "Person" includes an individual or organization.

21 (34) "Premises" means:

22 (a) A dwelling unit and the structure of which it is a part and facilities and appurtenances
23 therein;

24 (b) Grounds, areas and facilities held out for the use of tenants generally or the use of which
25 is promised to the tenant; and

26 (c) A facility for manufactured dwellings or floating homes.

27 (35) "Prepaid rent" means any payment of money to the landlord for a rent obligation not yet
28 due. In addition, "prepaid rent" means rent paid for a period extending beyond a termination date.

29 (36) "Recreational vehicle" has the meaning given that term in ORS 446.003.

30 (37) "Rent" means any payment to be made to the landlord under the rental agreement, periodic
31 or otherwise, in exchange for the right of a tenant and any permitted pet to occupy a dwelling unit
32 to the exclusion of others and to use the premises. "Rent" does not include security deposits, fees
33 or utility or service charges as described in ORS 90.315 (4) and 90.532.

34 (38) "Rental agreement" means all agreements, written or oral, and valid rules and regulations
35 adopted under ORS 90.262 or 90.510 (6) embodying the terms and conditions concerning the use and
36 occupancy of a dwelling unit and premises. "Rental agreement" includes a lease. A rental agreement
37 [shall be] is either a week-to-week tenancy, month-to-month tenancy or fixed term tenancy.

38 (39) "Roomer" means a person occupying a dwelling unit that does not include a toilet and ei-
39 ther a bathtub or a shower and a refrigerator, stove and kitchen, all provided by the landlord, and
40 where one or more of these facilities are used in common by occupants in the structure.

41 (40) "Screening or admission criteria" means a written statement of any factors a landlord
42 considers in deciding whether to accept or reject an applicant and any qualifications required for
43 acceptance. "Screening or admission criteria" includes, but is not limited to, the rental history,
44 character references, public records, criminal records, credit reports, credit references and incomes
45 or resources of the applicant.

1 (41) "Security deposit" means a refundable payment or deposit of money, however designated,
2 the primary function of which is to secure the performance of a rental agreement or any part of a
3 rental agreement. "Security deposit" does not include a fee.

4 (42) "Sexual assault" has the meaning given that term in ORS 147.450.

5 (43) "Squatter" means a person occupying a dwelling unit who is not so entitled under a rental
6 agreement or who is not authorized by the tenant to occupy that dwelling unit. "Squatter" does
7 not include a tenant who holds over as described in ORS 90.427 (11).

8 (44) "Stalking" means the behavior described in ORS 163.732.

9 (45) "Statement of policy" means the summary explanation of information and facility policies
10 to be provided to prospective and existing tenants under ORS 90.510.

11 (46) "Surrender" means an agreement, express or implied, as described in ORS 90.148 between
12 a landlord and tenant to terminate a rental agreement that gave the tenant the right to occupy a
13 dwelling unit.

14 (47) "Tenant":

15 (a) Except as provided in paragraph (b) of this subsection:

16 (A) Means a person, including a roomer, entitled under a rental agreement to occupy a dwelling
17 unit to the exclusion of others, including a dwelling unit owned, operated or controlled by a public
18 housing authority.

19 (B) Means a minor, as defined and provided for in ORS 109.697.

20 (b) For purposes of ORS 90.505 to 90.850, means only a person who owns and occupies as a
21 residence a manufactured dwelling or a floating home in a facility and persons residing with that
22 tenant under the terms of the rental agreement.

23 (c) Does not mean a guest or temporary occupant.

24 (48) "Transient lodging" means a room or a suite of rooms.

25 (49) "Transient occupancy" means occupancy in transient lodging that has all of the following
26 characteristics:

27 (a) Occupancy is charged on a daily basis and is not collected more than six days in advance;

28 (b) The lodging operator provides maid and linen service daily or every two days as part of the
29 regularly charged cost of occupancy; and

30 (c) The period of occupancy does not exceed 30 days.

31 (50) "Vacation occupancy" means occupancy in a dwelling unit, not including transient occu-
32 pancy in a hotel or motel, that has all of the following characteristics:

33 (a) The occupant rents the unit for vacation purposes only, not as a principal residence;

34 (b) The occupant has a principal residence other than at the unit; and

35 (c) The period of authorized occupancy does not exceed 45 days.

36 (51) "Victim" means:

37 (a) The person against whom an incident related to domestic violence, sexual assault or stalking
38 is perpetrated; or

39 (b) The parent or guardian of a minor household member against whom an incident related to
40 domestic violence, sexual assault or stalking is perpetrated, unless the parent or guardian is the
41 perpetrator.

42 (52) "Week-to-week tenancy" means a tenancy that has all of the following characteristics:

43 (a) Occupancy is charged on a weekly basis and is payable no less frequently than every seven
44 days;

45 (b) There is a written rental agreement that defines the landlord's and the tenant's rights and

1 responsibilities under this chapter; and

2 (c) There are no fees or security deposits, although the landlord may require the payment of an
3 applicant screening charge, as provided in ORS 90.295.

4 **SECTION 50.** ORS 90.155 is amended to read:

5 90.155. (1) Except as provided in ORS 90.300, 90.315, 90.425 and 90.675, where this chapter re-
6 quires written notice, service or delivery of that written notice shall be executed by one or more
7 of the following methods:

8 (a) Personal delivery to the landlord or tenant;

9 (b) First class mail to the landlord or tenant; or

10 (c) If a written rental agreement so provides, both first class mail and attachment to a desig-
11 nated location. In order for a written rental agreement to provide for mail and attachment service
12 of written notices from the landlord to the tenant, the agreement must also provide for such service

35 (2)(a) Except as otherwise provided in this section, a landlord may require a tenant to pay a
36 security deposit. The landlord shall provide the tenant with a receipt for any security deposit the
37 tenant pays. The landlord shall hold a security deposit or prepaid rent for the tenant who is a party
38 to the rental agreement. A tenant's claim to the security deposit or prepaid rent is prior to the claim
39 of a creditor of the landlord, including a trustee in bankruptcy.

7 agreement to permit a pet or for other cause and the additional deposit relates to the modification.
8 This paragraph does not prevent a landlord from collecting a security deposit that an initial rental
9 agreement provided for but that remained unpaid at the time the tenancy began.

10 (b) If a landlord requires a new or increased security deposit after the first year of the tenancy,
11 the landlord shall allow the tenant at least three months to pay the new or increased deposit.

12 (6) The landlord may claim all or part of the security deposit only if the landlord required the
13 security deposit for any or all of the purposes specified in subsection (7) of this section.

14 (7)(a) The landlord may claim from the security deposit only the amount reasonably necessary:

15 (A) To remedy the tenant's defaults in the performance of the rental agreement including, but
16 not limited to, unpaid rent; and

17 (B) To repair damages to the premises caused by the tenant, not including ordinary wear and
18 tear.

19 (b) A landlord is not required to repair damage caused by the tenant in order for the landlord
20 to claim against the deposit for the cost to make the repair. Any labor costs the landlord assesses
21 under this subsection for cleaning or repairs must be based on a reasonable hourly rate. The land-
22 lord may charge a reasonable hourly rate for the landlord's own performance of cleaning or repair
23 work.

24 (c) Defaults and damages for which a landlord may recover under this subsection include, but
25 are not limited to:

26 (A) Carpet cleaning, other than the use of a common vacuum cleaner, if:

27 (i) The cleaning is performed by use of a machine specifically designed for cleaning or
28 shampooing carpets;

29 (ii) The carpet was cleaned or replaced after the previous tenancy or the most recent significant
30 use of the carpet and before the tenant took possession; and

31 (iii) The written rental agreement provides that the landlord may deduct the cost of carpet
32 cleaning regardless of whether the tenant cleans the carpet before the tenant delivers possession
33 as described in ORS 90.147.

34 (B) Loss of use of the dwelling unit during the performance of necessary cleaning or repairs for
35 which the tenant is responsible under this subsection if the cleaning or repairs are performed in a
36 timely manner.

37 (8) A landlord may not require a tenant to pay or to forfeit a security deposit or prepaid rent
38 to the landlord for the tenant's failure to maintain a tenancy for a minimum number of months in
39 a month-to-month tenancy.

40 (9) The landlord must apply any last month's rent deposit to the rent due for the last month of
41 the tenancy:

42 (a) When either the landlord or the tenant gives to the other a notice of termination, pursuant
43 to this chapter, other than a notice of termination under ORS 90.394;

44 (b) When the landlord and tenant agree to terminate the tenancy; or

45 (c) When the tenancy terminates in accordance with the provisions of a written rental agree-

1 ment for a term tenancy.

2 (10) A landlord shall account for and refund as provided in subsections (12) to (14) of this section
3 any portion of a last month's rent deposit the landlord does not apply as provided under subsection
4 (9) of this section. Unless the tenant and landlord agree otherwise, the tenant may not require the
5 landlord to apply a last month's rent deposit to rent due for any period other than the last month
6 of the tenancy. A last month's rent deposit does not limit the amount of rent charged unless a
7 written rental agreement provides otherwise.

8 (11) When the tenancy terminates, a landlord shall account for and refund to the tenant, in the
9 same manner this section requires for security deposits, the unused balance of any prepaid rent the
10 landlord has not previously refunded to the tenant under ORS 90.380 and 105.120 (5)(b) or any other
11 provision of this chapter. The landlord may claim from the remaining prepaid rent only the amount
12 reasonably necessary to pay the tenant's unpaid rent.

13 (12) In order to claim all or part of any prepaid rent or security deposit, within 31 days after
14 the tenancy terminates and the tenant delivers possession the landlord shall give to the tenant a
15 written accounting that states specifically the basis or bases of the claim. The landlord shall give
16 a separate accounting for security deposits and for prepaid rent.

17 (13) The landlord shall return to the tenant the security deposit or prepaid rent or the portion
18 of the security deposit or prepaid rent that the landlord does not claim in the manner provided by
19 subsections (11) and (12) of this section not later than 31 days after the tenancy terminates and the
20 tenant delivers possession to the landlord.

21 (14) The landlord shall give the written accounting required under subsection (12) of this section
22 or shall return the security deposit or prepaid rent as required by subsection (13) of this section by
23 personal delivery or by first class mail.

24 (15) If a security deposit or prepaid rent secures a tenancy for a space for a manufactured
25 dwelling or floating home the tenant owns and occupies, whether or not in a facility, and the
26 dwelling or home is abandoned as described in ORS 90.425 (2) or 90.675 (2), the 31-day period de-
27 scribed in subsections (12) and (13) of this section commences on the earliest of:

- 28 (a) Waiver of the abandoned property process under ORS 90.425 (26) or 90.675 [(23)] (24);
- 29 (b) Removal of the manufactured dwelling or floating home from the rented space;
- 30 (c) Destruction or other disposition of the manufactured dwelling or floating home under ORS
31 90.425 (10)(b) or 90.675 (10)(b); or
- 32 (d) Sale of the manufactured dwelling or floating home pursuant to ORS 90.425 (10)(a) or 90.675
33 (10)(a).

34 (16) If the landlord fails to comply with subsection (13) of this section or if the landlord in bad
35 faith fails to return all or any portion of any prepaid rent or security deposit due to the tenant
36 under this chapter or the rental agreement, the tenant may recover the money due in an amount
37 equal to twice the amount:

- 38 (a) Withheld without a written accounting under subsection (12) of this section; or
- 39 (b) Withheld in bad faith.

40 (17)(a) A security deposit or prepaid rent in the possession of the landlord is not garnishable
41 property, as provided in ORS 18.618.

42 (b) If a landlord delivers a security deposit or prepaid rent to a garnishor in violation of ORS
43 18.618 (1)(b), the landlord that delivered the security deposit or prepaid rent to the garnishor shall
44 allow the tenant at least 30 days after a copy of the garnishee response required by ORS 18.680 is
45 delivered to the tenant under ORS 18.690 to restore the security deposit or prepaid rent. If the

1 tenant fails to restore a security deposit or prepaid rent under the provisions of this paragraph be-
2 fore the tenancy terminates, and the landlord retains no security deposit or prepaid rent from the
3 tenant after the garnishment, the landlord is not required to refund or account for the security de-
4 posit or prepaid rent under subsection (11) of this section.

5 (18) This section does not preclude the landlord or tenant from recovering other damages under
6 this chapter.

7 **SECTION 52.** ORS 90.545 is amended to read:

8 90.545. (1) Except as provided under subsections (2) to (6) of this section, a fixed term tenancy
9 for space for a manufactured dwelling or floating home, upon reaching its ending date, automatically
10 renews as a month-to-month tenancy having the same terms and conditions, other than duration and
11 rent increases under ORS 90.600, unless the tenancy is terminated under ORS 90.380 (5)(b), 90.394,
12 90.396, 90.398, 90.630 or 90.632.

13 (2) To renew or extend a fixed term tenancy for another term, of any duration that is consistent
14 with ORS 90.550, the landlord shall submit the proposed new rental agreement to the tenant at least
15 60 days prior to the ending date of the term. The landlord shall include with the proposed agreement
16 a written statement that summarizes any new or revised terms, conditions, rules or regulations.

17 (3) Notwithstanding ORS 90.610 [(3)] (2), a landlord's proposed new rental agreement may in-
18 clude new or revised terms, conditions, rules or regulations, if the new or revised terms, conditions,
19 rules or regulations:

20 (a)(A) Fairly implement a statute or ordinance adopted after the creation of the existing agree-
21 ment; or

22 (B) Are the same as those offered to new or prospective tenants in the facility at the time the
23 proposed agreement is submitted to the tenant and for the six-month period preceding the submission
24 of the proposed agreement or, if there have been no new or prospective tenants during the six-month
25 period, are the same as are customary for the rental market;

26 (b) Are consistent with the rights and remedies provided to tenants under this chapter, including
27 the right to keep a pet pursuant to ORS 90.530;

28 (c) Do not relate to the age, size, style, construction material or year of construction of the
29 manufactured dwelling or floating home contrary to ORS 90.632 (2); and

30 (d) Do not require an alteration of the manufactured dwelling or floating home or alteration or
31 new construction of an accessory building or structure.

32 (4) A tenant shall accept or reject a landlord's proposed new rental agreement at least 30 days
33 prior to the ending of the term by giving written notice to the landlord.

34 (5) If a landlord fails to submit a proposed new rental agreement as provided by subsection (2)
35 of this section, the tenancy renews as a month-to-month tenancy as provided by subsection (1) of this
36 section.

37 (6) If a tenant fails to accept or unreasonably rejects a landlord's proposed new rental agree-
38 ment as provided by subsection (4) of this section, the fixed term tenancy terminates on the ending
39 date without further notice and the landlord may take possession by complying with ORS 105.105
40 to 105.168.

41 (7) If a tenancy terminates under conditions described in subsection (6) of this section, and the
42 tenant surrenders or delivers possession of the premises to the landlord prior to the filing of an
43 action pursuant to ORS 105.110, the tenant has the right to enter into a written storage agreement
44 with the landlord, with the tenant having the same rights and responsibilities as a lienholder under
45 ORS 90.675 (20), except that the landlord may limit the term of the storage agreement to not exceed

1 six months. Unless the parties agree otherwise, the storage agreement must commence upon the
2 date of the termination of the tenancy. The rights under ORS 90.675 of any lienholder are delayed
3 until the end of the tenant storage agreement.

4 **SECTION 53.** ORS 90.510 is amended to read:

5 90.510. (1) Every landlord who rents a space for a manufactured dwelling or floating home shall
6 provide a written statement of policy to prospective and existing tenants. The purpose of the state-
7 ment of policy is to provide disclosure of the landlord's policies to prospective tenants and to ex-
8 isting tenants who have not previously received a statement of policy. The statement of policy is
9 not a part of the rental agreement. The statement of policy shall provide all of the following infor-
10 mation in summary form:

11 (a) The location and approximate size of the space to be rented.

12 (b) The federal fair-housing age classification and present zoning that affect the use of the
13 rented space.

14 (c) The facility policy regarding rent adjustment and a rent history for the space to be rented.
15 The rent history must, at a minimum, show the rent amounts on January 1 of each of the five pre-
16 ceding calendar years or during the length of the landlord's ownership, leasing or subleasing of the
17 facility, whichever period is shorter.

18 (d) The personal property, services and facilities that are provided by the landlord.

19 (e) The installation charges that are imposed by the landlord and the installation fees that are
20 imposed by government agencies.

21 (f) The facility policy regarding rental agreement termination including, but not limited to, clo-
22 sure of the facility.

23 (g) The facility policy regarding facility sale.

24 (h) The facility policy regarding **mandatory mediation under section 8 of this 2019 Act and**
25 **informal dispute resolution, if any, under ORS 446.547.**

26 (i) The utilities and services that are available, the name of the person furnishing them and the
27 name of the person responsible for payment.

28 **(j) The facility policy regarding methods of billing for utilities and services as described**
29 **in ORS 90.531 to 90.539.**

30 [(j)] (k) If a tenants' association exists for the facility, a one-page summary about the tenants'
31 association. The tenants' association shall provide the summary to the landlord.

32 [(k)] (L) Any facility policy regarding the removal of a manufactured dwelling, including a
33 statement that removal requirements may impact the market value of a dwelling.

34 [(L)] (m) Any facility policy regarding the planting of trees on the rented space for a manufac-
35 tured dwelling.

36 (2) The rental agreement and the facility rules and regulations [shall] **must** be attached as an
37 exhibit to the statement of policy. If the recipient of the statement of policy is a tenant, the rental
38 agreement attached to the statement of policy must be a copy of the agreement entered by the
39 landlord and tenant.

40 (3) The landlord shall give:

41 (a) Prospective tenants a copy of the statement of policy before the prospective tenants sign
42 rental agreements;

43 (b) Existing tenants who have not previously received a copy of the statement of policy and who
44 are on month-to-month rental agreements a copy of the statement of policy at the time a 90-day
45 notice of a rent increase is issued; and

1 (c) All other existing tenants who have not previously received a copy of the statement of policy
2 a copy of the statement of policy upon the expiration of their rental agreements and before the
3 tenants sign new agreements.

4 (4) Every landlord who rents a space for a manufactured dwelling or floating home shall provide
5 a written rental agreement, except as provided by ORS 90.710 (2)(d). The agreement must be signed
6 by the landlord and tenant and may not be [*unilaterally*] amended by one of the parties to the con-
7 tract except by:

8 (a) Mutual agreement of the parties;

9 (b) [*Actions taken pursuant to ORS*] **The landlord unilaterally under ORS 90.155 (4), 90.302**
10 **(9), 90.530, 90.533, 90.537, 90.543 (3), 90.600, 90.610, 90.643, 90.725 (3)(f) and (7) or 90.727 or section**
11 **8 (9) of this 2019 Act;** or

12 (c) Those provisions required by changes in statute or ordinance.

13 (5) The **rental** agreement required by subsection (4) of this section must specify:

14 (a) The location and approximate size of the rented space[;].

15 (b) The federal fair-housing age classification[;].

16 (c) The rent per month[;].

17 (d) All personal property, services and facilities [*to be*] provided by the landlord[;].

18 (e) All security deposits, fees and installation charges imposed by the landlord[;].

19 (f) Any facility policy regarding the planting of trees on the rented space for a manufactured
20 dwelling[;].

21 (g) Improvements that the tenant may or must make to the rental space, including plant mate-
22 rials and landscaping[;].

23 (h) Provisions for dealing with improvements to the rental space at the termination of the
24 tenancy[;].

25 (i) Any conditions the landlord applies in approving a purchaser of a manufactured dwelling or
26 floating home as a tenant in the event the tenant elects to sell the home. Those conditions must be
27 in conformance with state and federal law and may include, but are not limited to, conditions as to
28 pets, number of occupants and screening or admission criteria[;].

29 (j) That the tenant may not sell the tenant's manufactured dwelling or floating home to a person
30 who intends to leave the manufactured dwelling or floating home on the rental space until the
31 landlord has accepted the person as a tenant[;].

32 (k) The term of the tenancy[;].

33 (L) The process by which the rental agreement or rules and regulations may be changed [, *which*
34 *shall identify that the rules and regulations may be changed with 60 days' notice unless tenants of at*
35 *least 51 percent of the eligible spaces file an objection within 30 days; and*] **that is consistent with**
36 **ORS 90.610.**

37 (m) The process by which the landlord or tenant shall give notices.

38 **(n) That either party may request no-cost mandatory mediation of disputes through the**
39 **Housing and Community Services Department or a dispute resolution program described in**
40 **ORS 36.155 and the process by which mandatory mediation is initiated and conducted that is**
41 **consistent with section 8 of this 2019 Act.**

42 (6) Every landlord who rents a space for a manufactured dwelling or floating home shall provide
43 rules and regulations concerning the tenant's use and occupancy of the premises. A violation of the
44 rules and regulations may be cause for termination of a rental agreement. However, this subsection
45 does not create a presumption that all rules and regulations are identical for all tenants at all times.

1 A rule or regulation [shall be] is enforceable against the tenant only if:

2 (a) The rule or regulation:

3 (A) Promotes the convenience, safety or welfare of the tenants;

4 (B) Preserves the landlord's property from abusive use; or

5 (C) Makes a fair distribution of services and facilities held out for the general use of the ten-
6 ants.

7 (b) The rule or regulation:

8 (A) Is reasonably related to the purpose for which it is adopted and is reasonably applied;

9 (B) Is sufficiently explicit in its prohibition, direction or limitation of the tenant's conduct to
10 fairly inform the tenant of what the tenant shall do or may not do to comply; and

11 (C) Is not for the purpose of evading the obligations of the landlord.

12 (7)(a) A landlord who rents a space for a manufactured dwelling or floating home may adopt a
13 rule or regulation regarding occupancy guidelines. If adopted, an occupancy guideline in a facility
14 must be based on reasonable factors and not be more restrictive than limiting occupancy to two
15 people per bedroom.

16 (b) As used in this subsection:

17 (A) [*Reasonable factors may include but are not limited to*] **Factors to be considered in deter-**
18 **mining reasonableness include:**

19 (i) The size of the dwelling.

20 (ii) The size of the rented space.

21 (iii) Any discriminatory impact [*for reasons identified in*] **as described in ORS 659A.421 and**
22 **659A.425.**

23 (iv) Limitations placed on utility services governed by a permit for water or sewage disposal.

24 (B) "Bedroom" means a room that is intended to be used primarily for sleeping purposes and
25 does not include bathrooms, toilet compartments, closets, halls, storage or utility space and similar
26 areas.

27 (8) Intentional and deliberate failure of the landlord to comply with subsections (1) to (3) of this
28 section is cause for suit or action to remedy the violation or to recover actual damages. The pre-
29 vailing party is entitled to reasonable attorney fees and court costs.

30 (9) A receipt signed by the potential tenant or tenants for documents required to be delivered
31 by the landlord pursuant to subsections (1) to (3) of this section is a defense for the landlord in an
32 action against the landlord for nondelivery of the documents.

33 (10) A suit or action arising under subsection (8) of this section must be commenced within one
34 year after the discovery or identification of the alleged violation.

35 (11) Every landlord who publishes a directory of tenants and tenant services must include a
36 one-page summary regarding any tenants' association. The tenants' association shall provide the
37 summary to the landlord.

38 **SECTION 54.** ORS 90.533 is amended to read:

39 90.533. (1) A landlord may unilaterally amend a rental agreement to convert the method of bill-
40 ing a tenant for garbage collection and disposal from [*a method described in ORS 90.532 (1)(b)*]
41 **rent-included billing or pro rata billing** to a **billing** method in which the service provider:

42 (a) Supplies garbage receptacles;

43 (b) Collects and disposes of garbage; and

44 (c)(A) Bills the tenant directly; or

45 (B) Bills the landlord, who then bills the tenant based upon the number and size of the recep-

1 tacles used by the tenant.

2 (2) A landlord shall give a tenant not less than 180 days' written notice before converting a
3 billing method under subsection (1) of this section.

4 (3) If the cost of garbage service was included in the rent before the conversion of a billing
5 method under subsection (1) of this section, the landlord shall reduce the tenant's rent upon the first
6 billing of the tenant under the new billing method. The rent reduction may not be less than an
7 amount reasonably comparable to the amount of rent previously allocated for garbage collection and
8 disposal costs averaged over at least the preceding year. Before the conversion occurs, the landlord
9 shall provide the tenant with written documentation from the service provider showing the
10 landlord's cost for the garbage collection and disposal service provided to the facility during at least
11 the preceding year.

12 (4) A landlord may not convert a billing method under subsection (1) of this section less than
13 one year after giving notice of a rent increase, unless the rent increase is an automatic increase
14 provided for in a fixed term rental agreement entered into one year or more before the conversion.

15 **SECTION 55.** ORS 90.555 is amended to read:

16 90.555. (1) A facility tenant may not rent the tenant's manufactured dwelling or floating home
17 to another person for a period exceeding three days unless the facility landlord, facility tenant and
18 dwelling or home renter enter into a written subleasing agreement specifying the rights and obli-
19 gations of the landlord, tenant and renter during the renter's occupancy of the dwelling or home.
20 The subleasing agreement shall include, but need not be limited to, provisions that require the
21 dwelling or home renter to timely pay directly to the facility landlord the space rent, any separately
22 assessed fees payable under the rental agreement and any separately billed utility or service charge
23 described in ORS [90.532 (1)(b) or (c)] **90.531 to 90.539**, and provisions that grant the dwelling or
24 home renter the same rights as the facility tenant to cure a violation of the rental agreement for
25 the facility space, to require facility landlord compliance with ORS 90.730 and to be protected from
26 retaliatory conduct under ORS 90.765. This subsection does not authorize a facility tenant to rent
27 a manufactured dwelling or floating home to another person in violation of the rental agreement
28 between the facility tenant and the facility landlord.

29 (2) Notwithstanding ORS 90.100 (47), a facility tenant who enters into a subleasing agreement
30 continues to be the tenant of the facility space and retains all rights and obligations of a facility
31 tenant under the rental agreement and this chapter. The occupancy of a manufactured dwelling or
32 floating home by a renter as provided in a subleasing agreement does not constitute abandonment
33 of the dwelling or home by the facility tenant.

34 (3) The rights and obligations of the dwelling or home renter under a subleasing agreement are
35 in addition to the rights and obligations retained by the facility tenant under subsection (2) of this
36 section. The rights and obligations of the dwelling or home renter under the subleasing agreement
37 are separate from any rights or obligations of the renter under ORS 90.100 to 90.465 applicable to
38 the renter's occupancy of the manufactured dwelling or floating home owned by the facility tenant.

39 (4) Unless otherwise provided in the subleasing agreement, a facility landlord may terminate a
40 subleasing agreement:

41 (a) Without cause by giving the dwelling or home renter written notice not less than 30 days
42 prior to the termination;

43 (b) If a condition described in ORS 90.380 (5)(b) exists for the facility space, by giving the renter
44 the same notice to which the facility tenant is entitled under ORS 90.380 (5)(b); or

45 (c) Subject to the cure right established in subsection (1) of this section and regardless of

1 whether the landlord terminates the rental agreement of the facility tenant:

2 (A) For nonpayment of facility space rent; or

3 (B) For any conduct by the dwelling or home renter that would be a violation of the rental
4 agreement under ORS 90.396 or 90.398 if committed by the facility tenant.

5 (5) Upon termination of a subleasing agreement by the facility landlord, whether with or without
6 cause, the dwelling or home renter and the facility tenant are excused from continued performance
7 under any agreement for the renter's occupancy of the manufactured dwelling or floating home
8 owned by the facility tenant.

9 (6)(a) If, during the term of a subleasing agreement, the facility landlord gives notice to the fa-
10 cility tenant of a rental agreement violation, of a law or ordinance violation or of the facility's
11 closure, conversion or sale, the landlord shall also promptly give a copy of the notice to the dwelling
12 or home renter. The giving of notice to the dwelling or home renter does not constitute notice to
13 the facility tenant unless the tenant has expressly appointed the renter as the tenant's agent for
14 purposes of receiving notice.

15 (b) If the facility landlord gives notice to the dwelling or home renter that the landlord is ter-
16 minating the subleasing agreement, the landlord shall also promptly give a copy of the notice to the
17 facility tenant. The landlord shall give the notice to the facility tenant in the same manner as for
18 giving notice of a rental agreement violation.

19 (c) If, during the term of a subleasing agreement, the facility tenant gives notice to the facility
20 landlord of a rental agreement violation, termination of tenancy or sale of the manufactured dwell-
21 ing or floating home, the tenant shall also promptly give a copy of the notice to the dwelling or
22 home renter.

23 (d) If the dwelling or home renter gives notice to the facility landlord of a violation of ORS
24 90.730, the renter shall also promptly give a copy of the notice to the facility tenant.

25 (7) If the rental agreement permits the facility tenant to sublease the tenant's manufactured
26 dwelling or floating home, the landlord shall apply to the dwelling or home renter credit and con-
27 duct screening criteria that is substantially similar to the credit and conduct screening criteria the
28 landlord applies to applicants for a tenancy of a dwelling or home that is either owned by the
29 landlord or on consignment with the landlord under ORS 90.680.

30 **SECTION 56.** ORS 90.600, as amended by section 3, chapter 1, Oregon Laws 2019 (Enrolled
31 Senate Bill 608), is amended to read:

32 90.600. (1) For purposes of this section, the term "consumer price index" refers to the annual
33 12-month average change in the Consumer Price Index for All Urban Consumers, West Region (All
34 Items), as published by the Bureau of Labor Statistics of the United States Department of Labor in
35 September of the prior calendar year.

36 (2) If a rental agreement is a month-to-month tenancy to which ORS 90.505 to 90.850 apply, the
37 landlord may not increase the rent:

38 (a) Without giving each affected tenant notice in writing at least 90 days prior to the effective
39 date of the rent increase; and

40 (b) During any 12-month period, in an amount greater than seven percent plus the consumer
41 price index above the existing rent.

42 (3) The written notice required by subsection (2)(a) of this section must specify:

43 (a) The amount of the rent increase;

44 (b) The amount of the new rent;

45 (c) Facts supporting the exemption authorized by subsection (4) of this section, if the increase

1 is above the amount allowed in subsection (2)(b) of this section; and

2 (d) The date on which the increase becomes effective.

3 (4) A landlord is not subject to subsection (2)(b) of this section when:

4 (a) The first certificate of occupancy for the dwelling unit was issued less than 15 years from
5 the date of the notice of the rent increase; or

6 (b) The landlord is providing reduced rent to the tenant as part of a federal, state or local pro-
7 gram or subsidy.

8 (5) A landlord that increases rent in violation of subsection (2)(b) of this section shall be liable
9 to the tenant in an amount equal to three months' rent plus actual damages suffered by the tenant.

10 (6) This section does not create a right to increase rent that does not otherwise exist.

6 (b) Lien records shall be accessible through the online electronic medium to any individual or
7 organization by mutual agreement with the city. Users of the online electronic medium shall be au-
8 thorized to access the lien records from equipment maintained at sites of their choosing.

10 ment charge installment payment contract shall be made in the same location as the original re-

19 (a) "Emergency" includes but is not limited to:

20 (A) A repair problem that, unless remedied immediately, is likely to cause serious physical harm
21 or damage to individuals or property.

22 (B) The presence of a hazard tree on a rented space in a manufactured dwelling park.

23 (b) "Unreasonable time" refers to a time of day, day of the week or particular time that conflicts
24 with the tenant's reasonable and specific plans to use the space.

25 (c) "Yard maintenance, equipment servicing or grounds keeping" includes, but is not limited to,
26 servicing individual septic tank systems or water pumps, weeding, mowing grass and pruning trees
27 and shrubs.

28 (2) A landlord or a landlord's agent may enter onto a rented space, not including the tenant's
29 manufactured dwelling or floating home or an accessory building or structure, to:

30 (a) Inspect the space;

31 (b) Make necessary or agreed repairs, decorations, alterations or improvements;

32 (c) Inspect or maintain trees;

33 (d) Supply necessary or agreed services;

34 (e) Perform agreed yard maintenance, equipment servicing or grounds keeping; [or]

35 (f) Exhibit the space to prospective or actual purchasers of the facility, mortgagees, tenants,
36 workers or contractors[.]; **or**

37 **(g) Install or maintain a utility or service line or submeter under ORS 90.531 to 90.539.**

38 (3) The right of access of the landlord or landlord's agent is limited as follows:

39 (a) A landlord or landlord's agent may enter upon the rented space without consent of the ten-
40 ant and without notice to the tenant for the purpose of serving notices required or permitted under
41 this chapter, the rental agreement or any provision of applicable law.

42 (b) In case of an emergency, a landlord or landlord's agent may enter the rented space without
43 consent of the tenant, without notice to the tenant and at any time. If a landlord or landlord's agent
44 makes an emergency entry in the tenant's absence, the landlord shall give the tenant actual notice
45 within 24 hours after the entry, and the notice shall include the fact of the entry, the date and time

1 of the entry, the nature of the emergency and the names of the persons who entered.

2 (c) If the tenant requests repairs or maintenance in writing, the landlord or landlord's agent,
3 without further notice, may enter upon demand, in the tenant's absence or without consent of the
4 tenant, for the purpose of making the requested repairs until the repairs are completed. The tenant's
5 written request may specify allowable times. Otherwise, the entry must be at a reasonable time. The
6 authorization to enter provided by the tenant's written request expires after seven days, unless the
7 repairs are in progress and the landlord or landlord's agent is making a reasonable effort to com-
8 plete the repairs in a timely manner. If the person entering to do the repairs is not the landlord,
9 upon request of the tenant, the person must show the tenant written evidence from the landlord
10 authorizing that person to act for the landlord in making the repairs.

11 (d) If a written agreement requires the landlord to perform yard maintenance, equipment ser-
12 vicing or grounds keeping for the space:

13 (A) A landlord and tenant may agree that the landlord or landlord's agent may enter for that
14 purpose upon the space, without notice to the tenant, at reasonable times and with reasonable fre-
15 quency. The terms of the right of entry must be described in the rental agreement or in a separate
16 written agreement.

17 (B) A tenant may deny consent for a landlord or landlord's agent to enter upon the space pur-
18 suant to this paragraph if the entry is at an unreasonable time or with unreasonable frequency.
19 The tenant must assert the denial by giving actual notice of the denial to the landlord or landlord's
20 agent prior to, or at the time of, the attempted entry.

21 (e) In all other cases, unless there is an agreement between the landlord and the tenant to the
22 contrary regarding a specific entry, the landlord shall give the tenant at least 24 hours' actual no-
23 tice of the intent of the landlord to enter and the landlord or landlord's agent may enter only at
24 reasonable times. The landlord or landlord's agent may not enter if the tenant, after receiving the
25 landlord's notice, denies consent to enter. The tenant must assert this denial of consent by giving
26 actual notice of the denial to the landlord or the landlord's agent prior to, or at the time of, the
27 attempt by the landlord or landlord's agent to enter.

28 (f) Notwithstanding paragraph (e) of this subsection, a landlord or the landlord's agent may en-
29 ter a rented space solely to inspect a tree despite a denial of consent by the tenant if the landlord
30 or the landlord's agent has given at least 24 hours' actual notice of the intent to enter to inspect
31 the tree and the entry occurs at a reasonable time.

32 (4) A landlord shall not abuse the right of access or use it to harass the tenant. A tenant shall
33 not unreasonably withhold consent from the landlord to enter.

34 (5) A landlord has no other right of access except:

35 (a) Pursuant to court order;

36 (b) As permitted by ORS 90.410 (2);

37 (c) As permitted under ORS 90.539; or

38 (d) When the tenant has abandoned or relinquished the premises.

39 (6) If a landlord is required by a governmental agency to enter a rented space, but the landlord
40 fails to gain entry after a good faith effort in compliance with this section, the landlord shall not
41 be found in violation of any state statute or local ordinance due to the failure.

42 (7) If a landlord has a report from an arborist licensed as a landscape construction professional
43 pursuant to ORS 671.560 and certified by the International Society of Arboriculture that a tree on
44 the rented space is a hazard tree that must be maintained by the landlord as described in ORS
45 90.727, the landlord is not liable for any damage or injury as a result of the hazard tree if the

landlord is unable to gain entry after a good faith effort in compliance with this section.

(8) If the tenant refuses to allow lawful access, the landlord may obtain injunctive relief to compel access or may terminate the rental agreement pursuant to ORS 90.630 (1) and take possession in the manner provided in ORS 105.105 to 105.168. In addition, the landlord may recover actual damages.

(9) If the landlord makes an unlawful entry or a lawful entry in an unreasonable manner or makes repeated demands for entry otherwise lawful but that have the effect of unreasonably harassing the tenant, the tenant may obtain injunctive relief to prevent the reoccurrence of the conduct or may terminate the rental agreement pursuant to ORS 90.620 (1). In addition, the tenant may recover actual damages not less than an amount equal to one month's rent.
