Senate Bill 854

Sponsored by Senator DEMBROW, Representative HERNANDEZ; Senator MANNING JR, Representatives FAHEY, PILUSO

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs professional licensing boards, in certain circumstances, to accept individual taxpayer identification number or other federally-issued identification number in lieu of Social Security number on applications for issuance or renewal of authorization to practice occupation or profession. Takes effect on 91st day following adjournment sine die.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> (1) As used in this section:

6 (a) "Occupational or professional service" means a service:

7 (A) That an individual must possess a license, certificate or other form of authorization

8 to provide under the laws of this state; and

9 (B) Over which a professional licensing board has regulatory oversight.

(b) "Professional licensing board" means a state agency or board that licenses, certifies
 or otherwise authorizes individuals to provide an occupational or professional service.

(2)(a) Except as provided in paragraph (b) of this subsection, a professional licensing board that regulates an occupational or professional service and that requires a person to provide the person's Social Security number on an application for issuance or renewal of a licensure, certification or other authorization to provide the occupational or professional service shall accept in lieu of the Social Security number a person's federal individual taxpayer identification number or other federally-issued identification number.

(b) If so required by applicable federal law, a professional licensing board shall accept
 only a person's Social Security number on the materials described in paragraph (a) of this
 subsection.

(3) A professional licensing board may adopt rules to carry out the provisions of this
 section.

23 <u>SECTION 2.</u> Section 1 of this 2019 Act applies to applications for issuance or renewal of 24 a certificate, license or other authorization received by a professional licensing board on and 25 after the operative date specified in section 3 of this 2019 Act.

26 SECTION 3. (1) Section 1 of this 2019 Act becomes operative on January 1, 2020.

(2) A professional licensing board may take any action before the operative date specified
in subsection (1) of this section that is necessary to enable the board to exercise, on and
after the operative date specified in subsection (1) of this section, all of the duties, functions
and powers conferred on the board by section 1 of this 2019 Act.
