year.

4 "329.007. As used in this chapter, unless the context requires otherwise:

"(1) 'Academic content standards' means expectations of student knowledge and skills adopted by the State Board of Education under ORS 329.045.
"(2) 'Administrator' includes all persons whose duties require an admin-

8 istrative license.

9 "(3) 'Board' or 'state board' means the State Board of Education.

"(4) 'Community learning center' means a school-based or school-linked program providing informal meeting places and coordination for community activities, adult education, child care, information and referral and other services as described in ORS 329.157. 'Community learning center' includes, but is not limited to, a community school program as defined in ORS 336.505, family resource centers as described in ORS 417.725, full service schools, lighted schools and 21st century community learning centers.

17 "(5) 'Department' means the Department of Education.

18 "(6) 'English' includes, but is not limited to, reading and writing.

"(7) 'Holocaust and genocide studies' means studies on the
 Holocaust, genocide and other acts of mass violence that comply with

"[(7)] (8) 'History, geography, economics and civics' includes, but is not
limited to, Holocaust and genocide studies and Oregon Studies.

"[(8)] (9) 'Oregon Studies' means history, geography, economics and civics specific to the State of Oregon. Oregon Studies instruction in Oregon government shall include municipal, county, tribal and state government, as well as the electoral and legislative processes.

"[(9)] (10) 'Parents' means parents or guardians of students who are covered by this chapter.

"[(11)] (12) 'School district' means a school district as defined in ORS
332.002, a state-operated school or any legally constituted combination of

5 "[(12)] (13) 'Teacher' means any licensed employee of a school district who 6 has direct responsibility for instruction, coordination of educational pro-7 grams or supervision of students and who is compensated for such services 8 from public funds. 'Teacher' does not include a school nurse, as defined in 9 ORS 342.455, or a person whose duties require an administrative license.

"[(13)] (14) 'The arts' includes, but is not limited to, literary arts, performing arts and visual arts.

"[(14)] (15) 'World languages' means American Sign Language and lan guages other than English.

"[(15)] (16) '21st Century Schools Council' means a council established
 pursuant to ORS 329.704.

"SECTION 7. The amendments to ORS 329.007 by section 6 of this
 2019 Act become operative on September 1, 2025.".
