## PROPOSED AMENDMENTS TO HOUSE BILL 2027

1 On <u>page 1</u> of the printed bill, line 2, after "329A.030," insert "329A.120, 2 329A.250,".

On page 6, line 38, delete "described in ORS 329A.250 (5)(d)" and insert "operated by a school district as defined in ORS 332.002, a political subdivision of this state or a governmental agency".

6 On page 12, after line 31, insert:

7 **"SECTION 11.** ORS 329A.120 is amended to read:

8 "329A.120. (1) The Office of Child Care shall implement the resource and
9 referral system.

10 "(2) Resource and referral entities must provide services including, but 11 not limited to:

"(a) Training and technical assistance for existing and potential child
 care providers that includes, but is not limited to, coaching, mentoring,
 consulting and advising on professional development;

"(b) Referrals for parents or guardians seeking child care providers;
[and] or

"(c) Recruitment of qualified individuals to meet the child care needs ofa community.

"SECTION 12. ORS 329A.250, as amended by section 2, chapter 115,
 Oregon Laws 2018, is amended to read:

1 context requires otherwise:

"(1) 'Babysitter' means a person who goes into the home of a child to give
care during the temporary absence of the parent or legal guardian or custodian.

5 "(2) 'Certification' means the certification that is issued under ORS 6 329A.280 by the Office of Child Care to a family child care home, child care 7 center or other child care facility.

8 "(3) 'Child' means a child under 13 years of age or a child under 18 years 9 of age who has special needs or disabilities and requires a level of care that 10 is above normal for the child's age.

"(4) Subject to ORS 329A.440, 'child care' means the care, supervision and guidance on a regular basis of a child, unaccompanied by a parent, guardian or custodian, provided to a child during a part of the 24 hours of the day, in a place other than the child's home, with or without compensation. 'Child care' does not include care provided:

16 "(a) In the home of the child;

17 "(b) By the child's parent, guardian, or person acting in loco parentis;

18 "(c) By a person related to the child by blood or marriage within the 19 fourth degree as determined by civil law;

20 "(d) On an occasional basis by a person not ordinarily engaged in pro-21 viding child care;

22 "(e) By providers of medical services;

23 "(f) By a babysitter;

"(g) By a person who cares for children from only one family other than
the person's own family;

"(h) By a person who cares for no more than three children other thanthe person's own children; or

"(i) By a person who is a member of the child's extended family, as determined by the office on a case-by-case basis.

30 "(5) 'Child care facility' means any facility that provides child care to

children, including a day nursery, nursery school, child care center, certified
or registered family child care home or similar unit operating under any
name, but not including any:

4 "(a) Preschool recorded program.

5 "(b) Facility providing care for school-age children that is primarily a 6 single enrichment activity, for eight hours or less a week.

"(c) Facility providing care that is primarily group athletic or social activities sponsored by or under the supervision of an organized club or hobby
group.

10 "[(d) Facility operated by:]

11 "[(A) A school district as defined in ORS 332.002;]

12 "[(B) A political subdivision of this state; or]

- 13 "[(C) A governmental agency.]
- 14 "((e)) (d) Residential facility licensed under ORS 443.400 to 443.455.

15 "[(f)] (e) Babysitters.

"[(g)] (f) Facility operated as a parent cooperative for no more than fourhours a day.

"[(h)] (g) Facility providing care while the child's parent remains on the
 premises and is engaged in an activity offered by the facility or in other
 nonwork activity.

[(i)] (h) Facility operated as a school-age recorded program.

"(6) 'Family' has the meaning given that term in ORS 329.145.

"(7) 'Occasional' means that care is provided for no more than 70 days in
any calendar year.

<sup>25</sup> "(8) 'Parent cooperative' means a child care program in which:

<sup>26</sup> "(a) Care is provided by parents on a rotating basis;

27 "(b) Membership in the cooperative includes parents;

<sup>28</sup> "(c) There are written policies and procedures; and

"(d) A board of directors that includes parents of the children cared for
by the cooperative controls the policies and procedures of the program.

"(9) 'Preschool recorded program' means a facility providing care for preschool children that is primarily educational for four hours or less per day and where no child is present at the facility for more than four hours per day.

"(10) 'Record' means the record that is issued under ORS 329A.255 to a
preschool recorded program or under ORS 329A.257 to a school-age recorded
program.

8 "(11) 'Registration' means the registration that is issued under ORS 9 329A.330 by the Office of Child Care to a family child care home where care 10 is provided in the family living quarters of the provider's home.

"(12) 'School age' means of an age eligible to be enrolled in kindergarten
or above on or before the first day of the current school year.

"(13) 'School-age recorded program' means a program for school-age chil-dren:

<sup>15</sup> "(a) That is not operated by a school district as defined in ORS 332.002;

"(b) That is not required to be certified under ORS 329A.280 or registered
under ORS 329A.330; and

"(c) In which youth development activities are provided to children during
 hours that school is not in session and does not take the place of a parent's
 care.

"(14) 'Youth development activities' means care, supervision or guidance that is intended for enrichment, including but not limited to teaching skills or proficiency in physical, social or educational activities such as tutoring, music lessons, social activities, sports and recreational activities.".
