³ **"SECTION 1.** ORS 163.095 is amended to read:

"163.095. As used in ORS 163.105 and this section, 'aggravated murder'
means [*murder as defined in ORS 163.115 which*]:

6 "(1) Criminal homicide of two or more persons that is premeditated 7 and committed intentionally [under, or accompanied by, any of the following 8 circumstances] and with the intent to:

9 "(a) Intimidate, injure or coerce a civilian population;

"(b) Influence the policy of a government by intimidation or
 coercion; or

"(c) Affect the conduct of a government through destruction of
 property, murder, kidnapping or aircraft piracy; or

"(2) Murder in the second degree, as defined in ORS 163.115, that is
 premeditated and committed intentionally against a person under 14
 years of age.

"[(1)(a) The defendant committed the murder pursuant to an agreement that the defendant receive money or other thing of value for committing the murder.]

20 "[(b) The defendant solicited another to commit the murder and paid or 21 agreed to pay the person money or other thing of value for committing the 1 *murder*.]

² "[(c) The defendant committed murder after having been convicted previously in any jurisdiction of any homicide, the elements of which constitute the crime of murder as defined in ORS 163.115 or manslaughter in the first degree as defined in ORS 163.118.]

6 "[(d) There was more than one murder victim in the same criminal episode 7 as defined in ORS 131.505.]

8 "[(e) The homicide occurred in the course of or as a result of intentional
9 maiming or torture of the victim.]

10 "[(f) The victim of the intentional homicide was a person under the age of 11 14 years.]

"[(2)(a) The victim was one of the following and the murder was related to
 the performance of the victim's official duties in the justice system:]

14 "[(A) A police officer as defined in ORS 181A.355;]

"[(B) A correctional, parole and probation officer or other person charged
with the duty of custody, control or supervision of convicted persons;]

17 "[(C) A member of the Oregon State Police;]

18 "[(D) A judicial officer as defined in ORS 1.210;]

19 "[(E) A juror or witness in a criminal proceeding;]

20 "[(F) An employee or officer of a court of justice;]

21 "[(G) A member of the State Board of Parole and Post-Prison Supervision; 22 or]

23 "[(H) A regulatory specialist.]

²⁴ "[(b) The defendant was confined in a state, county or municipal penal or ²⁵ correctional facility or was otherwise in custody when the murder occurred.]

²⁶ "[(c) The defendant committed murder by means of an explosive as defined ²⁷ in ORS 164.055.]

"[(d) Notwithstanding ORS 163.115 (1)(b), the defendant personally and
intentionally committed the homicide under the circumstances set forth in ORS
163.115 (1)(b).]
