**PROPOSED AMENDMENTS TO  
SENATE BILL 978**

1 In line 2 of the printed bill, after “firearms” insert “; creating new pro-  
2 visions; amending ORS 166.210, 166.250, 166.262, 166.274, 166.291, 166.360,  
3 166.370, 166.412, 166.435, 166.470 and 659A.403; and prescribing an effective  
4 date”.

5 Delete lines 4 through 9 and insert:  
6

7 **“MINIMUM AGE FOR FIREARM SALES**  
8

9 **“SECTION 1. (1) The following may establish a minimum age of 18,**  
10 **19, 20 or 21 years for the purchase of firearms, firearm accessories,**  
11 **firearm components, ammunition or ammunition components, or for**  
12 **the repair or service of a firearm:**

13 **“(a) A person transferring a firearm, a firearm accessory, a firearm**  
14 **component, ammunition or an ammunition component at a gun show;**

15 **“(b) A gun dealer; or**

16 **“(c) A business engaged in repairing or servicing a firearm.**

17 **“(2) As used in this section and ORS 659A.403:**

18 **“(a) ‘Antique firearm’ has the meaning given that term in ORS**  
19 **166.210.**

20 **“(b) ‘Ammunition component’ includes primers, powder and acces-**  
21 **sories that are used to create, modify or reload ammunition.**

1       “(c) ‘Firearm’ has the meaning given that term in ORS 166.210 but  
2 does not include an antique firearm.

3       “(d) ‘Firearm accessory’ means any device that attaches to a  
4 firearm, or that is used in or facilitates the operation of a firearm,  
5 including but not limited to stocks, grips, detachable magazines and  
6 speedloaders.

7       “(e) ‘Firearm component’ means any part of a firearm that is ma-  
8 terial to the function of the firearm.

9       “(f) ‘Gun dealer’ has the meaning given that term in ORS 166.412.

10       “(g) ‘Gun show’ has the meaning given that term in ORS 166.432.

11       “SECTION 2. ORS 659A.403 is amended to read:

12       “659A.403. (1) Except as provided in subsection (2) of this section, all  
13 persons within the jurisdiction of this state are entitled to the full and equal  
14 accommodations, advantages, facilities and privileges of any place of public  
15 accommodation, without any distinction, discrimination or restriction on  
16 account of race, color, religion, sex, sexual orientation, national origin,  
17 marital status or age if the individual is of age, as described in this section,  
18 or older.

19       “(2) Subsection (1) of this section does not prohibit:

20       “(a) The enforcement of laws governing the consumption of alcoholic  
21 beverages by minors and the frequenting by minors of places of public ac-  
22 commodation where alcoholic beverages are served;

23       “(b) The enforcement of laws governing the use of marijuana items, as  
24 defined in ORS 475B.015, by persons under 21 years of age and the frequen-  
25 ting by persons under 21 years of age of places of public accommodation  
26 where marijuana items are sold; [or]

27       “(c) The offering of special rates or services to persons 50 years of age  
28 or older[.];

29       “(d) **The following from enforcing minimum age restrictions, pur-**  
30 **suant to section 1 of this 2019 Act, on the purchase of firearms,**

1 **firearm accessories, firearm components, ammunition or ammunition**  
2 **components:**

3 **“(A) A person transferring a firearm, a firearm accessory, a firearm**  
4 **component, ammunition or an ammunition component at a gun show;**  
5 **or**

6 **“(B) A gun dealer; or**

7 **“(e) A business engaged in the repairing and servicing of firearms**  
8 **from enforcing minimum age restrictions, pursuant to section 1 of this**  
9 **2019 Act, for the repair or service of a firearm.**

10 **“(3) It is an unlawful practice for any person to deny full and equal ac-**  
11 **commodations, advantages, facilities and privileges of any place of public**  
12 **accommodation in violation of this section.**

13 **“(4) The definitions in section 1 of this 2019 Act apply to this sec-**  
14 **tion.**

15 **“SECTION 3. (1) Except as provided in subsection (2) of this section,**  
16 **the amendments to ORS 659A.403 by section 2 of this 2019 Act apply**  
17 **to all causes of action under ORS 659A.403, whether arising before, on**  
18 **or after the effective date of this 2019 Act.**

19 **“(2)(a) The amendments to ORS 659A.403 by section 2 of this 2019**  
20 **Act do not apply to any action under ORS 659A.403 for which a final**  
21 **judgment has been entered into before the effective date of this 2019**  
22 **Act.**

23 **“(b) As used in this subsection, ‘final judgment’ means a judgment**  
24 **for which the time to appeal has expired without any party filing an**  
25 **appeal or that is not subject to further appeal or review.**

26

27 **“FIREARM STORAGE, LOSS OR THEFT REPORTING AND ACCESS**  
28 **BY MINORS**

29

30 **“SECTION 4. Sections 5 to 10 of this 2019 Act shall be known and**

1 may be cited as the Cindy Yuille and Steve Forsyth Act.

2 **“SECTION 5. As used in sections 5 to 10 of this 2019 Act:**

3 **“(1) ‘Authorized person’ means a person authorized by the owner**  
4 **or possessor of a firearm to carry or control the firearm.**

5 **“(2)(a) ‘Container’ means a box, case, chest, locker, safe or other**  
6 **similar receptacle.**

7 **“(b) ‘Container’ does not include a building, room or vehicle or a**  
8 **space within a vehicle.**

9 **“(3) ‘Control’ means, in relation to a firearm, that a person is in**  
10 **sufficiently close proximity to the firearm to prevent another person**  
11 **from obtaining the firearm.**

12 **“(4) ‘Firearm’ has the meaning given that term in ORS 166.210, ex-**  
13 **cept that it does not include a firearm that has been rendered perma-**  
14 **nently inoperable.**

15 **“(5) ‘Gun dealer’ has the meaning given that term in ORS 166.412.**

16 **“(6) ‘Gun room’ means an area within a building enclosed by walls,**  
17 **a floor and a ceiling, including a closet, that has all entrances secured**  
18 **by a tamper-resistant lock, that is kept locked at all times when un-**  
19 **occupied and that is used for:**

20 **“(a) The storage of firearms, ammunition, components of firearms**  
21 **or ammunition, or equipment for firearm-related activities including**  
22 **but not limited to reloading ammunition, gunsmithing and firearm**  
23 **cleaning and maintenance; or**

24 **“(b) Conducting firearm-related activities, including but not limited**  
25 **to reloading ammunition, gunsmithing and firearm cleaning and**  
26 **maintenance.**

27 **“(7) ‘Law enforcement agency’ has the meaning given that term in**  
28 **ORS 166.525.**

29 **“(8) ‘Minor’ means a person under 18 years of age.**

30 **“(9)(a) ‘Transfer’ means the delivery of a firearm from a person to**

1 a recipient, neither of whom is a gun dealer or is licensed as a man-  
2 ufacturer or importer under 18 U.S.C. 923, including, but not limited  
3 to, the sale, gift, loan or lease of the firearm.

4 “(b) ‘Transfer’ does not include:

5 “(A) The temporary provision of a firearm by a person to a recipient  
6 other than a minor if the person has no reason to believe the recipient  
7 is prohibited from possessing a firearm or intends to use the firearm  
8 in the commission of a crime, and the provision occurs:

9 “(i) At a shooting range, shooting gallery or other area designed for  
10 the purpose of target shooting, for use during target practice, a  
11 firearms safety or training course or class or a similar lawful activity;

12 “(ii) For the purpose of hunting, trapping or target shooting, during  
13 the time in which the recipient is engaged in activities related to  
14 hunting, trapping or target shooting;

15 “(iii) Under circumstances in which the recipient and the firearm  
16 are in the presence of the person;

17 “(iv) To a recipient who is in the business of repairing firearms, for  
18 the time during which the firearm is being repaired;

19 “(v) To a recipient who is in the business of making or repairing  
20 custom accessories for firearms, for the time during which the acces-  
21 sories are being made or repaired; or

22 “(vi) For the purpose of preventing imminent death or serious  
23 physical injury, and the provision lasts only as long as is necessary to  
24 prevent the death or serious physical injury; or

25 “(B) A delivery of a firearm made inoperable for the specific pur-  
26 pose of being used as a prop in the making a motion picture, tele-  
27 vision, digital or similar production.

28 **“SECTION 6. (1)(a) A person who owns or possesses a firearm shall,**  
29 **at all times that the firearm is not carried by or under the control of**  
30 **the person or an authorized person, secure the firearm:**

1       **“(A) With an engaged trigger lock or cable lock that meets or ex-**  
2 **ceeds the minimum specifications established by the Oregon Health**  
3 **Authority under section 10 of this 2019 Act;**

4       **“(B) In a locked container, equipped with a tamper-resistant lock,**  
5 **that meets or exceeds the minimum specifications established by the**  
6 **Oregon Health Authority under section 10 of this 2019 Act; or**

7       **“(C) In a gun room.**

8       **“(b) For purposes of paragraph (a) of this subsection, a firearm is**  
9 **not secured if a key, combination or other means of opening a lock**  
10 **or container is readily available to a person the owner or possessor**  
11 **has not authorized to carry or control the firearm.**

12       **“(2)(a) A violation of subsection (1) of this section is a Class C vio-**  
13 **lation.**

14       **“(b) Each firearm owned or possessed in violation of subsection (1)**  
15 **of this section constitutes a separate violation.**

16       **“(3) If a person obtains an unsecured firearm as a result of the**  
17 **owner or possessor of a firearm violating subsection (1) of this section**  
18 **and the firearm is used to injure a person or property within two years**  
19 **of the violation, the owner or possessor of the firearm who violated**  
20 **subsection (1) of this section is strictly liable for the injury.**

21       **“(4) The liability imposed by subsection (3) of this section does not**  
22 **apply if:**

23       **“(a) The injury results from a lawful act of self-defense or defense**  
24 **of another person; or**

25       **“(b) The unsecured firearm was obtained:**

26       **“(A) At a shooting range, shooting gallery or other area designed**  
27 **for the purpose of target shooting, for use during target practice, a**  
28 **firearms safety or training course or class or a similar lawful activity;**

29       **“(B) For the purpose of hunting, trapping or target shooting, during**  
30 **the time in which the person is engaged in activities related to hunt-**

1 **ing, trapping or target shooting;**

2 **“(C) Under circumstances in which the person and the firearm are**  
3 **in the presence of the owner or possessor of the firearm;**

4 **“(D) By a person who is in the business of repairing firearms, for**  
5 **the purpose of repairing the firearm;**

6 **“(E) By a person who is in the business of making or repairing**  
7 **custom accessories for firearms, for the purpose of making or repair-**  
8 **ing the accessories; or**

9 **“(F) From a person who is a gun dealer or is licensed as a man-**  
10 **ufacturer or importer under 18 U.S.C. 923, in accordance with federal**  
11 **law.**

12 **“SECTION 7. (1) A person transferring a firearm shall transfer the**  
13 **firearm:**

14 **“(a) With an engaged trigger lock or cable lock that meets or ex-**  
15 **ceeds the minimum specifications established by the Oregon Health**  
16 **Authority under section 10 of this 2019 Act; or**

17 **“(b) In a locked container, equipped with a tamper-resistant lock,**  
18 **that meets or exceeds the minimum specifications established by the**  
19 **Oregon Health Authority under section 10 of this 2019 Act.**

20 **“(2)(a) A violation of subsection (1) of this section is a Class C vio-**  
21 **lation.**

22 **“(b) Each firearm transferred in violation of subsection (1) of this**  
23 **section constitutes a separate violation.**

24 **“(3) If a firearm transferred in a manner that violates subsection**  
25 **(1) of this section is used to injure a person or property within two**  
26 **years of the violation, the owner or possessor of the firearm who**  
27 **transferred the firearm in violation of subsection (1) of this section is**  
28 **strictly liable for the injury.**

29 **“(4) The liability imposed by subsection (3) of this section does not**  
30 **apply if the injury results from a lawful act of self-defense or defense**

1 of another person.

2 **“SECTION 8. (1)(a) A person who owns, possesses or controls a**  
3 **firearm shall report the loss or theft of the firearm to a law enforce-**  
4 **ment agency in the jurisdiction in which the loss or theft occurred as**  
5 **soon as practicable but not later than 72 hours of the time the person**  
6 **knew or reasonably should have known of the loss or theft.**

7 **“(b) If a means of reporting a loss or theft of a firearm within 72**  
8 **hours is not reasonably available, the person who owned, possessed or**  
9 **controlled the firearm that was lost or stolen must report the loss or**  
10 **theft within 24 hours of the means of reporting becoming available.**

11 **“(2)(a) A violation of subsection (1) of this section is a Class B vio-**  
12 **lation.**

13 **“(b) Each firearm for which a person does not make the report**  
14 **within the time required by subsection (1) of this section constitutes**  
15 **a separate violation.**

16 **“(3) If a lost or stolen firearm is used to injure a person or property**  
17 **and the person who owned, possessed or controlled the firearm at the**  
18 **time of the loss or theft did not report the loss or theft within the time**  
19 **period required by subsection (1) of this section, the person who**  
20 **owned, possessed or controlled the firearm at the time of the loss or**  
21 **theft is strictly liable for the injury for two years from the expiration**  
22 **of the time limit for reporting or until the loss or theft report is made,**  
23 **whichever occurs sooner.**

24 **“(4) The liability imposed by subsection (3) of this section does not**  
25 **apply if the injury results from a lawful act of self-defense or defense**  
26 **of another person.**

27 **“(5)(a) Within 24 hours of receiving a report under subsection (1)**  
28 **of this section, a law enforcement agency shall provide the informa-**  
29 **tion concerning the lost or stolen firearm to the Department of State**  
30 **Police.**



1       “(b) The department shall enter the information concerning the lost  
2 or stolen firearm into the Law Enforcement Data System or another  
3 electronic database as determined by the department.

4       “(c) The department may adopt rules to carry out the provisions  
5 of this subsection.

6       “SECTION 9. (1)(a) A person who transfers a firearm to a minor  
7 shall directly supervise the minor’s use of the firearm.

8       “(b) Notwithstanding ORS 166.250, except in the case of a lawful act  
9 of self-defense or defense of another person, a minor may possess a  
10 firearm only under the direct supervision of an adult.

11       “(2)(a) A person who transfers a firearm to a minor, and who fails  
12 to directly supervise the minor’s use of the firearm, is strictly liable  
13 for injury to person or property caused by the minor’s use of the  
14 firearm until the person regains possession of the firearm.

15       “(b) The liability imposed by paragraph (a) of this subsection does  
16 not apply if the injury results from a lawful act of self-defense or de-  
17 fense of another person.

18       “(3) This section does not apply to the transfer of a firearm:

19       “(a) That is owned by the minor; or

20       “(b) To a minor by a person who is the minor’s parent or guardian  
21 or who has obtained the permission of the minor’s parent or guardian:

22       “(A) For the purpose of hunting in accordance with ORS 497.360,  
23 trapping or target shooting, during the time in which the minor is  
24 engaged in activities related to hunting, trapping or target shooting;  
25 and

26       “(B) Who holds a valid youth license under ORS 497.127 for the  
27 purposes of hunting.

28       “SECTION 10. No later than January 1, 2020, the Oregon Health  
29 Authority, in consultation with the Department of State Police and  
30 after considering any relevant standards in the Consumer Product

1 Safety Act (15 U.S.C. 2051 et seq.), shall adopt rules establishing the  
2 minimum specifications for trigger locks, cable locks and containers  
3 equipped with tamper-resistant locks required by sections 6 and 7 of  
4 this 2019 Act.

5 **“SECTION 11. Sections 5 to 9 of this 2019 Act become operative on**  
6 **January 1, 2020.**

7 **“SECTION 12. (1) A person commits the offense of unlawful storage**  
8 **of a firearm if:**

9 **“(a) The person stores or leaves a firearm in a location where the**  
10 **person knows, or reasonably should know, that a minor under 18 years**  
11 **of age is likely to gain access to the firearm; and**

12 **“(b) A minor under 18 years of age obtains possession of the**  
13 **firearm.**

14 **“(2)(a) Except as otherwise provided in paragraph (b) or (c) of this**  
15 **subsection, unlawful storage of a firearm is a Class C violation.**

16 **“(b) Unlawful storage of a firearm is a Class A violation if the mi-**  
17 **nor who obtains possession of the firearm intentionally, by word or**  
18 **conduct, attempts to place another person in fear of imminent serious**  
19 **physical injury.**

20 **“(c) Unlawful storage of a firearm is a Class A misdemeanor if the**  
21 **minor who obtains possession of the firearm injures or kills a person**  
22 **by means of the firearm.**

23 **“(3) Subsection (1) of this section does not apply if:**

24 **“(a) The minor obtains possession of the firearm while under the**  
25 **direct supervision of the minor’s parent or guardian;**

26 **“(b) The minor obtains possession of the firearm:**

27 **“(A) In a lawful act of self-defense or defense of another person;**  
28 **or**

29 **“(B) Through the illegal act of any person other than the person**  
30 **described in subsection (1)(a) of this section;**

1       “(c) The firearm is equipped with a trigger lock or other safe stor-  
2 age device;

3       “(d) The firearm is stored in a securely locked container or in a  
4 location that a reasonable person would believe to be secure;

5       “(e) The firearm is rendered inoperable by the removal of an es-  
6 sential component of the firing mechanism; or

7       “(f) The person is a peace officer or member of the military forces  
8 of this state or the United States and the minor obtained the firearm  
9 during, or incidental to, the performance of the person’s duties.

10       “(4) As used in this section, ‘firearm’ has the meaning given that  
11 term in ORS 166.210.

12       “SECTION 13. A gun dealer shall post in a prominent location in  
13 the gun dealer’s place of business a notice, in block letters not less  
14 than one inch in height, that states: ‘The purchaser of a firearm has  
15 an obligation to store firearms in a safe manner and to prevent un-  
16 supervised access to a firearm by a minor. If a minor obtains access  
17 to a firearm and the owner failed to store the firearm in a safe man-  
18 ner, the owner may be guilty of a crime.’

20                               **“UNDETECTABLE AND UNTRACEABLE FIREARMS**

21

22       “SECTION 14. ORS 166.412, as amended by section 4, chapter 5, Oregon  
23 Laws 2018, and section 15, chapter 120, Oregon Laws 2018, is amended to  
24 read:

25       “166.412. (1) As used in this section:

26       “(a) ‘Antique firearm’ has the meaning given that term in 18 U.S.C. 921;

27       “(b) ‘Department’ means the Department of State Police;

28       “(c) ‘Firearm’ has the meaning given that term in ORS 166.210, except  
29 that it does not include an antique firearm;

30       “(d) ‘Firearms transaction record’ means the firearms transaction record

1 required by 18 U.S.C. 921 to 929;

2 “(e) ‘Firearms transaction thumbprint form’ means a form provided by the  
3 department under subsection (11) of this section;

4 “(f) ‘Gun dealer’ means a person engaged in the business, as defined in  
5 18 U.S.C. 921, of selling, leasing or otherwise transferring a firearm, whether  
6 the person is a retail dealer, pawnbroker or otherwise; [*and*]

7 “(g) ‘Purchaser’ means a person who buys, leases or otherwise receives a  
8 firearm **or unfinished frame or receiver** from a gun dealer[.]; **and**

9 **“(h) ‘Unfinished frame or receiver’ has the meaning given that term**  
10 **in ORS 166.210.**

11 “(2) Except as provided in subsections (3)(c) and (12) of this section, a gun  
12 dealer shall comply with the following before a firearm **or unfinished frame**  
13 **or receiver** is delivered to a purchaser:

14 “(a) The purchaser shall present to the gun dealer current identification  
15 meeting the requirements of subsection (4) of this section.

16 “(b) The gun dealer shall complete the firearms transaction record and  
17 obtain the signature of the purchaser on the record.

18 “(c) The gun dealer shall obtain the thumbprints of the purchaser on the  
19 firearms transaction thumbprint form and attach the form to the gun dealer’s  
20 copy of the firearms transaction record to be filed with that copy.

21 “(d) The gun dealer shall request by telephone that the department con-  
22 duct a criminal history record check on the purchaser and shall provide the  
23 following information to the department:

24 “(A) The federal firearms license number of the gun dealer;

25 “(B) The business name of the gun dealer;

26 “(C) The place of transfer;

27 “(D) The name of the person making the transfer;

28 “(E) The make, model, caliber and manufacturer’s number of the firearm  
29 being transferred **or a description of the unfinished frame or receiver**  
30 **being transferred;**

1 “(F) The name and date of birth of the purchaser;

2 “(G) The Social Security number of the purchaser if the purchaser vol-  
3 untarily provides this number to the gun dealer; and

4 “(H) The type, issuer and identification number of the identification pre-  
5 sented by the purchaser.

6 “(e) The gun dealer shall receive a unique approval number for the  
7 transfer from the department and record the approval number on the firearms  
8 transaction record and on the firearms transaction thumbprint form.

9 “(f) The gun dealer may destroy the firearms transaction thumbprint form  
10 five years after the completion of the firearms transaction thumbprint form.

11 “(3)(a) Upon receipt of a request of the gun dealer for a criminal history  
12 record check, the department shall immediately, during the gun dealer’s  
13 telephone call or by return call:

14 “(A) Determine, from criminal records and other information available to  
15 it, whether the purchaser is disqualified under ORS 166.470 from completing  
16 the purchase; and

17 “(B) Notify the gun dealer when a purchaser is disqualified from com-  
18 pleting the transfer or provide the gun dealer with a unique approval number  
19 indicating that the purchaser is qualified to complete the transfer.

20 “(b) If the department is unable to determine if the purchaser is qualified  
21 or disqualified from completing the transfer within 30 minutes, the depart-  
22 ment shall notify the gun dealer and provide the gun dealer with an estimate  
23 of the time when the department will provide the requested information.

24 “(c) If the department fails to provide a unique approval number to a gun  
25 dealer or to notify the gun dealer that the purchaser is disqualified under  
26 paragraph (a) of this subsection before the close of the gun dealer’s next  
27 business day following the request by the gun dealer for a criminal history  
28 record check, the gun dealer may deliver the firearm **or unfinished frame**  
29 **or receiver** to the purchaser.

30 “(4)(a) Identification required of the purchaser under subsection (2) of this

1 section shall include one piece of current identification bearing a photograph  
2 and the date of birth of the purchaser that:

3 “(A) Is issued under the authority of the United States Government, a  
4 state, a political subdivision of a state, a foreign government, a political  
5 subdivision of a foreign government, an international governmental organ-  
6 ization or an international quasi-governmental organization; and

7 “(B) Is intended to be used for identification of an individual or is com-  
8 monly accepted for the purpose of identification of an individual.

9 “(b) If the identification presented by the purchaser under paragraph (a)  
10 of this subsection does not include the current address of the purchaser, the  
11 purchaser shall present a second piece of current identification that contains  
12 the current address of the purchaser. The Superintendent of State Police may  
13 specify by rule the type of identification that may be presented under this  
14 paragraph.

15 “(c) The department may require that the gun dealer verify the identifi-  
16 cation of the purchaser if that identity is in question by sending the  
17 thumbprints of the purchaser to the department.

18 “(5) The department shall establish a telephone number that shall be op-  
19 erational seven days a week between the hours of 8 a.m. and 10 p.m. for the  
20 purpose of responding to inquiries from gun dealers for a criminal history  
21 record check under this section.

22 “(6) No public employee, official or agency shall be held criminally or  
23 civilly liable for performing the investigations required by this section pro-  
24 vided the employee, official or agency acts in good faith and without malice.

25 “(7)(a) The department may retain a record of the information obtained  
26 during a request for a criminal history record check for no more than five  
27 years.

28 “(b) The record of the information obtained during a request for a crimi-  
29 nal history record check by a gun dealer is exempt from disclosure under  
30 public records law.

1       “(c) If the department determines that a purchaser is prohibited from  
2 possessing a firearm under ORS 166.250 (1)(c), the department shall report  
3 the attempted transfer, the purchaser’s name and any other personally iden-  
4 tifiable information to all federal, state and local law enforcement agencies  
5 and district attorneys that have jurisdiction over the location or locations  
6 where the attempted transfer was made and where the purchaser resides.

7       “(d) If the department determines that, based on the judgment of con-  
8 viction, the purchaser is prohibited from possessing a firearm as a condition  
9 of probation or that the purchaser is currently on post-prison supervision or  
10 parole, the department shall report the attempted transfer to the purchaser’s  
11 supervising officer and the district attorney of the county in which the con-  
12 viction occurred.

13       “(e) If the department determines that the purchaser is prohibited from  
14 possessing a firearm due to a court order described in ORS 166.255 (1)(a), the  
15 department shall report the attempted transfer to the court that issued the  
16 order.

17       “(f) If the department determines that the purchaser is under the juris-  
18 diction of the Psychiatric Security Review Board, the department shall re-  
19 port the attempted transfer to the board.

20       “(g) Reports required by paragraphs (c) to (f) of this subsection shall be  
21 made within 24 hours after the determination is made, unless a report would  
22 compromise an ongoing investigation, in which case the report may be de-  
23 layed as long as necessary to avoid compromising the investigation.

24       “(h) On or before January 31 of each year, a law enforcement agency or  
25 a prosecuting attorney’s office that received a report pursuant to paragraph  
26 (c) of this subsection during the previous calendar year shall inform the de-  
27 partment of any action that was taken concerning the report and the out-  
28 come of the action.

29       “(i) The department shall annually publish a written report, based on any  
30 information received under paragraph (h) of this subsection, detailing the

1 following information for the previous year:

2 “(A) The number of purchasers whom the department determined were  
3 prohibited from possessing a firearm under ORS 166.250 (1)(c), arranged by  
4 category of prohibition;

5 “(B) The number of reports made pursuant to paragraph (c) of this sub-

7 “(C) The number of investigations arising from the reports made pursuant

10 category of prohibition; and

14 “(8) A law enforcement agency may inspect the records of a gun dealer  
15 relating to transfers of firearms **and unfinished frames or receivers** with  
16 the consent of a gun dealer in the course of a reasonable inquiry during a  
17 criminal investigation or under the authority of a properly authorized  
18 subpoena or search warrant.

19 “(9) When a firearm is delivered, it shall be unloaded.

20 “(10) In accordance with applicable provisions of ORS chapter 183, the

8 subsection is immune from civil liability for any use of the firearm **or un-**  
9 **finished frame or receiver** by the recipient or transferee, provided that the

29 **factured within this state, imports into this state, or offers for sale,**  
30 **sells or transfers, an undetectable firearm commits a Class B felony.**

1       **“(3) A person who knowingly possesses an undetectable firearm**  
2 **commits a Class A misdemeanor.**

3       **“SECTION 17. (1) As used in this section:**

4       **“(a) ‘Antique firearm’ and ‘unfinished frame or receiver’ have the**  
5 **meanings given those terms in ORS 166.210.**

6       **“(b) ‘Untraceable firearm’ means a firearm other than an antique**  
7 **firearm for which the sale or distribution chain, from a licensed**  
8 **retailer to the point of first retail sale, cannot be traced by a law**  
9 **enforcement agency by means of a serial number affixed to the**  
10 **firearm by a federally licensed manufacturer or importer in accord-**  
11 **ance with 18 U.S.C. 923(i) and all regulations issued under the au-**  
12 **thority of 18 U.S.C. 923(i), including but not limited to 27 C.F.R. 478.92.**

13       **“(2) A person who knowingly possesses, manufactures, assembles,**  
14 **causes to be manufactured or assembled, imports into this state, offers**  
15 **for sale, sells or transfers an untraceable firearm commits a Class B**  
16 **felony.**

17       **“(3) A person who knowingly imports into this state, offers for sale,**  
18 **sells or transfers an unfinished frame or receiver commits a Class B**  
19 **felony unless:**

20       **“(a) The person is a federally licensed gun dealer;**

21       **“(b) The name of the manufacturer and an individual serial number**  
22 **is conspicuously placed on the unfinished frame or receiver in ac-**  
23 **cordance with the procedures for the serialization of a firearm in 18**  
24 **U.S.C. 923(i) and all regulations under the authority of 18 U.S.C. 923(i),**  
25 **including but not limited to 27 C.F.R. 478.92; and**

26       **“(c) The person maintains records relating to the unfinished frame**  
27 **or receiver in accordance with the procedures for record keeping re-**  
28 **lated to firearms in 18 U.S.C. 923(g) and all regulations issued under**  
29 **the authority of 18 U.S.C. 923(g), including but not limited to 27 C.F.R.**  
30 **478.121 to 478.134.**

1       **“(4) A person who knowingly possesses an unfinished frame or re-**  
2 **ceiver that is not serialized as provided in subsection (3)(b) of this**  
3 **section commits a Class C felony, unless:**

4       **“(a) The person is a federally licensed gun manufacturer; and**

5       **“(b) The unfinished frame or receiver is an unfinished part within**  
6 **a manufacturing process that includes serialization.**

7  
8                   **“PROHIBITED POSSESSION AND TRANSFER**

9  
10       **“SECTION 18.** ORS 166.210 is amended to read:

11       **“166.210. As used in ORS 166.250 to 166.270, 166.291 to 166.295 and 166.410**  
12 **to 166.470:**

13       **“(1) ‘Antique firearm’ means:**

14       **“(a) Any firearm, including any firearm with a matchlock, flintlock, per-**  
15 **cussion cap or similar type of ignition system, manufactured in or before**  
16 **1898; and**

17       **“(b) Any replica of any firearm described in paragraph (a) of this sub-**  
18 **section if the replica:**

19       **“(A) Is not designed or redesigned for using rimfire or conventional**  
20 **centerfire fixed ammunition; or**

21       **“(B) Uses rimfire or conventional centerfire fixed ammunition that is no**  
22 **longer manufactured in the United States and that is not readily available**  
23 **in the ordinary channels of commercial trade.**

24       **“(2) ‘Corrections officer’ has the meaning given that term in ORS**  
25 **181A.355.**

26       **“(3) ‘Firearm’ means a weapon, by whatever name known, which is de-**  
27 **signed to expel a projectile by the action of powder.**

28       **“(4) ‘Firearms silencer’ means any device for silencing, muffling or di-**  
29 **minishing the report of a firearm.**

30       **“(5) ‘Frame or receiver’ means the part of a firearm that provides**

1 **housing for the hammer, bolt or breechlock and firing mechanism and**  
2 **that is usually threaded at its forward portion to receive the barrel.**

3 “[5] (6) ‘Handgun’ means any pistol or revolver using a fixed cartridge  
4 containing a propellant charge, primer and projectile, and designed to be  
5 aimed or fired otherwise than from the shoulder.

6 “[6] (7) ‘Machine gun’ means a weapon of any description by whatever  
7 name known, loaded or unloaded, which is designed or modified to allow two  
8 or more shots to be fired by a single pressure on the trigger device.

10 “[8] (9) ‘Offense’ has the meaning given that term in ORS 161.505.

15 “[11] (12) ‘Short-barreled rifle’ means a rifle having one or more barrels  
16 less than 16 inches in length and any weapon made from a rifle if the weapon

19 barrels less than 18 inches in length and any weapon made from a shotgun  
20 if the weapon has an overall length of less than 26 inches.

22 **frame or receiver consisting of a blank, casting or machined body that:**

23 **“(A) Requires further machining or molding to be used as part of**

10 “(5) Unlawful possession of a firearm is a Class A misdemeanor.

12 “166.470. (1) Unless relief has been granted under ORS 166.273 or 166.274  
13 or 18 U.S.C. 925(c) or the expunction laws of this state or an equivalent law  
14 of another jurisdiction, a person may not intentionally sell, deliver or oth-  
15 erwise transfer any firearm when the transferor knows or reasonably should

7 “(2) A person may not sell, deliver or otherwise transfer any firearm that  
8 the person knows or reasonably should know is stolen.

10 “(a) The parent or guardian, or another person with the consent of the  
11 parent or guardian, of a minor from transferring to the minor a firearm,  
12 other than a handgun; or

1       **“(3) The authority shall notify any entity submitting data under**  
2 **this section of any changes to the data sets that must be submitted,**  
3 **no later than July 1 of the calendar year preceding the year in which**  
4 **the changes become effective.**

5       **“(4) The authority may contract with a third party to receive and**  
6 **process the records submitted under this section.**

7       **“(5) The authority shall transfer the patient encounter data ele-**  
8 **ments obtained under this section to the Oregon Trauma Registry.**

9       **“(6) Patient outcome data required to be submitted under this sec-**  
10 **tion includes:**

11       **“(a) Discharge status;**

12       **“(b) The diagnosis the patient received in the emergency depart-**  
13 **ment and any procedures performed on the patient; and**

14       **“(c) Demographic or standard health care information and other**  
15 **information as required by the authority by rule.**

27       **“SECTION 23. ORS 166.291 is amended to read:**

28       **“166.291. (1) The sheriff of a county, upon a person’s application for an**  
29 **Oregon concealed handgun license, upon receipt of the appropriate fees and**  
30 **after compliance with the procedures set out in this section, shall issue the**

1 person a concealed handgun license if the person:

2 “(a)(A) Is a citizen of the United States; or

3 “(B) Is a legal resident alien who can document continuous residency in  
4 the county for at least six months and has declared in writing to the United  
5 States Citizenship and Immigration Services the intent to acquire citizenship  
6 status and can present proof of the written declaration to the sheriff at the  
7 time of application for the license;

8 “(b) Is at least 21 years of age;

9 “(c) Is a resident of the county;

10 “(d) Has no outstanding warrants for arrest;

11 “(e) Is not free on any form of pretrial release;

12 “(f) Demonstrates competence with a handgun by any one of the follow-  
13 ing:

14 “(A) Completion of any hunter education or hunter safety course approved  
15 by the State Department of Fish and Wildlife or a similar agency of another  
16 state if handgun safety was a component of the course;

17 “(B) Completion of any National Rifle Association firearms safety or  
18 training course if handgun safety was a component of the course;

19 “(C) Completion of any firearms safety or training course or class avail-  
20 able to the general public offered by law enforcement, community college,  
21 or private or public institution or organization or firearms training school  
22 utilizing instructors certified by the National Rifle Association or a law  
23 enforcement agency if handgun safety was a component of the course;

24 “(D) Completion of any law enforcement firearms safety or training  
25 course or class offered for security guards, investigators, reserve law  
26 enforcement officers or any other law enforcement officers if handgun safety  
27 was a component of the course;

28 “(E) Presents evidence of equivalent experience with a handgun through  
29 participation in organized shooting competition or military service;

30 “(F) Is licensed or has been licensed to carry a firearm in this state, un-

1 less the license has been revoked; or

2 “(G) Completion of any firearms training or safety course or class con-  
3 ducted by a firearms instructor certified by a law enforcement agency or the  
4 National Rifle Association if handgun safety was a component of the course;

5 “(g) Has never been convicted of a felony or found guilty, except for in-  
6 sanity under ORS 161.295, of a felony;

7 “(h) Has not been convicted of a misdemeanor or found guilty, except for  
8 insanity under ORS 161.295, of a misdemeanor within the four years prior to  
9 the application, including a misdemeanor conviction for the possession of  
10 marijuana as described in paragraph (L) of this subsection;

11 “(i) Has not been committed to the Oregon Health Authority under ORS  
12 426.130;

13 “(j) Has not been found to be a person with mental illness and is not  
14 subject to an order under ORS 426.130 that the person be prohibited from  
15 purchasing or possessing a firearm as a result of that mental illness;

16 “(k) Has been discharged from the jurisdiction of the juvenile court for  
17 more than four years if, while a minor, the person was found to be within  
18 the jurisdiction of the juvenile court for having committed an act that, if  
19 committed by an adult, would constitute a felony or a misdemeanor involving  
20 violence, as defined in ORS 166.470;

21 “(L) Has not been convicted of an offense involving controlled substances  
22 or participated in a court-supervised drug diversion program, except this  
23 disability does not operate to exclude a person if:

24 “(A) The person can demonstrate that the person has been convicted only

2 “(A) \$15 to the Department of State Police for conducting the fingerprint  
3 check of the applicant.

4 “(B) [~~\$50~~] **\$65** to the sheriff for the issuance or renewal of a concealed

6 “(C) [~~\$15~~] **\$20** to the sheriff for the duplication of a license because of

9 “(C) A public or private school, as defined in ORS 339.315[.];

11 “(E) A city hall; [or]

12 “(F) The residence of any state official elected by the state at large, [*and*  
13 *the grounds adjacent to each such building.*] **if the residence is owned by**  
14 **the state; or**

15 “(G) The [*term also includes that*] portion of any other building **owned,**  
16 **occupied or controlled** by an agency of the state or a municipal corporation,  
17 as defined in ORS 297.405, other than a court facility[.];

27 instrument or a knife, other than an ordinary pocketknife with a blade less  
28 than four inches in length, the use of which could inflict injury upon a  
29 person or property;

30 “(c) Mace, tear gas, pepper mace or any similar deleterious agent as de-

1 fined in ORS 163.211;

2 “(d) An electrical stun gun or any similar instrument;

3 “(e) A tear gas weapon as defined in ORS 163.211;

4 “(f) A club, bat, baton, billy club, bludgeon, knobkerrie, nunchaku,  
5 nightstick, truncheon or any similar instrument, the use of which could in-  
6 flict injury upon a person or property; or

7 “(g) A dangerous or deadly weapon as those terms are defined in ORS

9 **“SECTION 27.** ORS 166.370 is amended to read:

10 “166.370. (1) Any person who intentionally possesses a loaded or unloaded  
11 firearm or any other instrument used as a dangerous weapon, while in or on  
12 a public building, shall upon conviction be guilty of a Class C felony.

13 “(2)(a) Except as otherwise provided in paragraph (b) of this subsection,  
14 a person who intentionally possesses:

15 “(A) A firearm in a court facility is guilty, upon conviction, of a Class  
16 C felony. A person who intentionally possesses a firearm in a court facility  
17 shall surrender the firearm to a law enforcement officer.

18 “(B) A weapon, other than a firearm, in a court facility may be required  
19 to surrender the weapon to a law enforcement officer or to immediately re-

18 **BACKGROUND CHECKS**

20 **“SECTION 29.** ORS 166.435 is amended to read:

21 “166.435. (1) As used in this section:

22 “(a) ‘Transfer’ means the delivery of a firearm from a transferor to a  
23 transferee, including, but not limited to, the sale, gift, loan or lease of the  
24 firearm. ‘Transfer’ does not include the temporary provision of a firearm to  
25 a transferee if the transferor has no reason to believe the transferee is pro-  
26 hibited from possessing a firearm or intends to use the firearm in the com-  
27 mission of a crime, and the provision occurs:

28 “(A) At a shooting range, shooting gallery or other area designed for the  
29 purpose of target shooting, for use during target practice, a firearms safety  
30 or training course or class or a similar lawful activity;

1 “(B) For the purpose of hunting, trapping or target shooting, during the  
2 time in which the transferee is engaged in activities related to hunting,  
3 trapping or target shooting;

4 “(C) Under circumstances in which the transferee and the firearm are in  
5 the presence of the transferor;

6 “(D) To a transferee who is in the business of repairing firearms, for the  
7 time during which the firearm is being repaired;

8 “(E) To a transferee who is in the business of making or repairing custom  
9 accessories for firearms, for the time during which the accessories are being  
10 made or repaired; or

11 “(F) For the purpose of preventing imminent death or serious physical  
12 injury, and the provision lasts only as long as is necessary to prevent the  
13 death or serious physical injury.

14 “(b) ‘Transferee’ means a person who is not a gun dealer or licensed as  
15 a manufacturer or importer under 18 U.S.C. 923 and who intends to receive  
16 a firearm from a transferor.

17 “(c) ‘Transferor’ means a person who is not a gun dealer or licensed as  
18 a manufacturer or importer under 18 U.S.C. 923 and who intends to deliver  
19 a firearm to a transferee.

20 “(2) Except as provided in ORS 166.436 and 166.438 and subsection (4) of  
21 this section, a transferor may not transfer a firearm to a transferee unless  
22 the transfer is completed through a gun dealer as described in subsection (3)  
23 of this section.

24 “(3)(a) A transferor may transfer a firearm to a transferee only as pro-  
25 vided in this section. Except as provided in paragraph (b) of this subsection,  
26 prior to the transfer both the transferor and the transferee must appear in  
27 person before a gun dealer, with the firearm, and request that the gun dealer  
28 perform a criminal background check on the transferee.

29 “(b) If the transferor and the transferee reside over 40 miles from each  
30 other, the transferor may ship or deliver the firearm to a gun dealer located

1 near the transferee or a gun dealer designated by the transferee, and the  
2 transferor need not appear before the gun dealer in person.

3 “(c) A gun dealer who agrees to complete a transfer of a firearm under  
4 this section shall request a criminal history record check on the transferee  
5 as described in ORS 166.412 and shall comply with all requirements of federal  
6 law.

7 “(d) If, upon completion of a criminal background check, the gun dealer:

8 “(A) Receives a unique approval number from the Department of State  
9 Police indicating that the transferee is qualified to complete the transfer, the  
10 gun dealer shall notify the transferor, enter the firearm into the gun dealer’s  
11 inventory and transfer the firearm to the transferee.

12 “(B) Receives notification that the transferee is prohibited by state or  
13 federal law from possessing or receiving the firearm, the gun dealer shall  
14 notify the transferor and neither the transferor nor the gun dealer shall  
15 transfer the firearm to the transferee. If the transferor shipped or delivered  
16 the firearm to the gun dealer pursuant to paragraph (b) of this subsection,  
17 the gun dealer shall comply with federal law when returning the firearm to  
18 the transferor.

19 “(e) A gun dealer may charge a reasonable fee for facilitating a firearm  
20 transfer pursuant to this section.

21 “(4) The requirements of subsections (2) and (3) of this section do not  
22 apply to:

23 “(a) The transfer of a firearm by or to a law enforcement agency, or by  
24 or to a law enforcement officer, private security professional or member of  
25 the Armed Forces of the United States, while that person is acting within  
26 the scope of official duties.

27 “(b) The transfer of a firearm as part of a firearm turn-in or buyback  
28 event, in which a law enforcement agency receives or purchases firearms  
29 from members of the public.

30 “(c) The transfer of a firearm to:

1 “(A) A transferor’s spouse or domestic partner;  
2 “(B) A transferor’s parent or stepparent;  
3 “(C) A transferor’s child or stepchild;  
4 “(D) A transferor’s sibling;  
5 “(E) A transferor’s grandparent;  
6 “(F) A transferor’s grandchild;  
7 “(G) A transferor’s aunt or uncle;  
8 “(H) A transferor’s first cousin;  
9 “(I) A transferor’s niece or nephew; or  
10 “(J) The spouse or domestic partner of a person specified in subpara-  
11 graphs (B) to (I) of this paragraph.

12 “(d) The transfer of a firearm that occurs because of the death of the  
13 firearm owner, provided that:

14 “(A) The transfer is conducted or facilitated by a personal representative,  
15 as defined in ORS 111.005, or a trustee of a trust created in a will; and

16 “(B) The transferee is related to the deceased firearm owner in a manner  
17 specified in paragraph (c) of this subsection.

18 “(e) **The transfer of a firearm to a museum as defined in ORS**  
19 **358.415.**

20 “(5)(a) A transferor who fails to comply with the requirements of this  
21 section commits a Class A misdemeanor.

22 “(b) Notwithstanding paragraph (a) of this subsection, a transferor who  
23 fails to comply with the requirements of this section commits a Class B fel-  
24 ony if the transferor has a previous conviction under this section at the time  
25 of the offense.

29 “**SECTION 30. The unit captions used in this 2019 Act are provided**  
30 **only for the convenience of the reader and do not become part of the**

1 **statutory law of this state or express any legislative intent in the**
