**PROPOSED AMENDMENTS TO  
HOUSE BILL 2015**

- 1 On page 1 of the printed bill, line 15, delete the boldfaced material.
- 2 In line 16, delete “not been assigned a Social Security number”.
- 3 On page 2, lines 11 and 12, delete the boldfaced material.
- 4 In line 22, delete the boldfaced material.
- 5 In line 23, delete “person has not been assigned a Social Security
- 6 number”.
- 7 In line 45, delete the boldfaced material.
- 8 On page 3, line 1, delete “section”.
- 9 In line 45, restore “and”.
- 10 On page 4, lines 4 through 7, restore the bracketed material and delete
- 11 the boldfaced material.
- 12 On page 5, line 8, restore “and”.
- 13 In lines 12 through 15, restore the bracketed material and delete the
- 14 boldfaced material.
- 15 On page 6, line 9, delete “, as required under”.
- 16 In line 10, delete “ORS 807.021”.
- 17 On page 8, line 19, delete “, as required under ORS 807.021”.
- 18 On page 10, delete lines 20 through 45.
- 19 On page 11, delete lines 1 through 16 and insert:
- 20 **“SECTION 7. ORS 807.730, as amended by section 19, chapter 568, Oregon**
- 21 **Laws 2017, is amended to read:**

1 “807.730. (1) The Department of Transportation may issue or replace a  
2 **Real ID** limited term driver license, **Real ID** limited term commercial driver  
3 license, **Real ID** limited term driver permit, limited term commercial learner  
4 driver permit, **limited term commercial driver license that is not a Real**  
5 **ID** or **Real ID** limited term identification card only for a person who pro-  
6 vides proof, as determined by the department by rule, that the person [*is le-*  
7 *gally present*] **has lawful status** in the United States on a temporary basis.

8 “(2) A **Real ID** limited term driver license, **Real ID** limited term com-  
9 mercial driver license, **limited term commercial driver license that is**  
10 **not a Real ID** or **Real ID** limited term identification card is valid:

11 “(a) During the applicant’s authorized stay in the United States, but no  
12 longer than eight years from the date of issuance; or

13 “(b) If there is no definite end to the authorized stay, for a period of one  
14 year.

15 “(3) A **Real ID** limited term driver permit or a limited term commercial  
16 learner driver permit is valid:

17 “(a) During the applicant’s authorized stay in the United States, but no  
18 longer than the period of time for which a driver permit of the same type is  
19 issued by the department.

20 “(b) If there is no definite end to the authorized stay, for a period of one  
21 year but no longer than the period of time for which a driver permit of the  
22 same type is issued by the department.

23 “(4) A **Real ID** limited term driver license, **Real ID** limited term com-  
24 mercial driver license, **limited term commercial driver license that is**  
25 **not a Real ID, Real ID** limited term driver permit[, *limited term commercial*  
26 *learner driver permit*] or **Real ID** limited term identification card may be  
27 renewed only upon presentation of valid documentation, as determined by the  
28 department by rule, that the status by which the applicant qualified for the  
29 **Real ID** limited term driver license, **Real ID** limited term commercial driver  
30 license, **limited term commercial driver license that is not a Real ID,**

1 **Real ID** limited term driver permit[, *limited term commercial learner driver*  
2 *permit*] or **Real ID** limited term identification card has been extended or is  
3 still in effect.

4 “(5) A **Real ID** limited term driver license or **Real ID** limited term driver  
5 permit grants the same **driving** privileges as a driver license or driver per-  
6 mit.

7 “(6) A **Real ID** limited term identification card shall bear a statement to  
8 the effect that the **Real ID** limited term identification card is not a license  
9 or any other grant of driving privileges to operate a motor vehicle and is to  
10 be used for identification purposes only.

11 “(7) A limited term commercial driver license, a **Real ID limited term**  
12 **commercial driver license** or limited term commercial learner driver per-  
13 mit grants the same privileges as a commercial driver license or commercial  
14 learner driver permit.

15 “(8) The department may issue a **Real ID limited term commercial**  
16 **driver license**, limited term commercial driver license **that is not a Real**  
17 **ID** or limited term commercial learner driver permit if the applicant is oth-  
18 erwise eligible for commercial driving privileges. The department may adopt  
19 rules describing eligibility requirements for **Real ID** limited term commercial  
20 driver licenses, **limited term commercial driver licenses that are not**  
21 **Real ID** and limited term commercial learner driver permits.

22 “(9) A **Real ID** limited term driver license, **Real ID** limited term com-  
23 mercial driver license, **limited term commercial driver license that is**  
24 **not a Real ID, Real ID limited term driver permit, limited term com-**  
25 **mercial learner driver permit** or **Real ID** limited term identification card  
26 shall clearly indicate **on the face of the card and in the machine read-**  
27 **able zone** that it is a **Real ID** limited term driver license, **Real ID** limited  
28 term commercial driver license, **limited term commercial driver license**  
29 **that is not a Real ID, Real ID limited term driver permit, limited term**  
30 **commercial learner driver permit** or **Real ID** limited term identification

1 card and indicate the date on which it expires.”.

2 On page 25, after line 39, insert:

**“OUTREACH**

6 **“SECTION 23a. (1) The Department of Transportation shall conduct**  
7 **an outreach program to educate driver license and driver permit ap-**  
8 **plicants and the general public about sections 9 and 11 of this 2019 Act,**  
9 **the amendments to ORS 97.953, 659A.885, 802.195, 802.200, 807.021,**  
10 **807.040, 807.130, 807.173, 807.285, 807.310, 807.400, 807.405 and 807.730 by**  
11 **sections 1 to 7 and 12 to 22 of this 2019 Act and the repeal of ORS**  
12 **807.735 by section 24 of this 2019 Act on and after January 1, 2021. The**  
13 **program must:**

14 **“(a) In collaboration with impacted communities, develop a com-**  
15 **munication strategy for dissemination of information using a variety**  
16 **of media sources, state agencies, associations and organizations.**

17 **“(b) Effectively communicate with specific populations in a manner**  
18 **that is culturally and linguistically appropriate.**

19 **“(c) Provide communications, including educational materials, in**  
20 **English and in languages other than English that are most commonly**  
21 **spoken by the residents of this state.**

22 **“(2) To carry out the provisions of this section, the department may**  
23 **enter into a contract with a business or an organization.**

24 **“SECTION 23b. Section 23a of this 2019 Act is repealed on January**  
25 **2, 2023.”.**
