**PROPOSED AMENDMENTS TO  
HOUSE BILL 3377**

1 In line 2 of the printed bill, after “branch” insert “; creating new pro-  
2 visions; amending ORS 40.252, 171.415, 171.740, 171.745 and 244.050; and de-  
3 claring an emergency”.

4 Delete lines 4 and 5 and insert:

5 **“SECTION 1. (1) The Joint Committee on Conduct is established as**  
6 **a joint committee of the Legislative Assembly.**

7 **“(2) The Legislative Conduct Office is established as a nonpartisan**  
8 **office of the Legislative Assembly that is independent of any other**  
9 **nonpartisan office.**

10 **“(3) By concurrent resolution, the Legislative Assembly shall select**  
11 **a Legislative Conduct Officer, to serve as the executive officer of the**  
12 **Legislative Conduct Office. The officer shall receive compensation in**  
13 **accordance with ORS 652.220.**

14 **“(4) The committee may recruit, conduct interviews and make rec-**  
15 **ommendations for the appointment of the Legislative Conduct Officer**  
16 **by the Legislative Assembly. The committee shall consult with the**  
17 **Capitol Leadership Team established under section 13 of this 2019 Act**  
18 **in the performance of the committee’s duties under this section.**

19 **“(5) Subject to the limitations otherwise provided by law for ex-**  
20 **penses of state officers, the Legislative Conduct Officer shall be reim-**  
21 **bursed for actual and necessary expenses incurred or paid by the**

1 **officer in the performance of duties of the officer.**

2 **“(6) The Legislative Conduct Officer serves for a four-year term and**  
3 **is eligible for reappointment to succeeding terms. An officer may be**  
4 **removed for cause by the committee upon a finding by the committee**  
5 **that supports a for-cause removal of the officer.**

6 **“(7) The committee shall:**

7 **“(a) Receive from the Legislative Conduct Officer annual reports**  
8 **described in section 5 of this 2019 Act and any other reports the com-**  
9 **mittee or officer determines are warranted;**

10 **“(b) Provide office facilities for the officer that are sufficiently in-**  
11 **dependent to ensure that the officer operates independently of any**  
12 **other legislative branch organization, including but not limited to au-**  
13 **thorizing the officer to maintain facilities that are located near but**  
14 **outside of the State Capitol;**

15 **“(c) Ensure that the officer possesses all possible indicia of inde-**  
16 **pendence from the other parts of the legislative branch;**

17 **“(d) Provide ongoing direction and oversight for continual updating**  
18 **of the training described in section 7 of this 2019 Act;**

19 **“(e) Develop and maintain a respectful workplace policy to be ad-**  
20 **ministered by the Legislative Administrator and that is designed to**  
21 **address conduct that is inconsistent with a respectful workplace in the**  
22 **State Capitol and that does not rise to the level of creating a hostile**  
23 **work environment or violating public accommodation law;**

24 **“(f) Provide policy direction and oversight to the officer; and**

25 **“(g) Perform other duties as assigned by joint rules of the Legisla-**  
26 **tive Assembly.**

27 **“(8) The Joint Committee on Conduct shall be composed of those**  
28 **members of the Senate Committee on Conduct formed to perform de-**  
29 **legated and assigned functions described in Article IV, section 15, of**  
30 **the Oregon Constitution, for the Senate and the House Committee on**

1 Conduct formed to perform delegated and assigned functions described  
2 in Article IV, section 15, of the Oregon Constitution, for the House of  
3 Representatives.

4 “(9) In any hearing to perform a function described in Article IV,  
5 section 15, of the Oregon Constitution, Joint Committee on Conduct  
6 members of the other legislative chamber may attend and be seated  
7 at the dais as nonvoting observers.

8 “(10) Notwithstanding subsection (8) of this section, a member of  
9 the Joint Committee on Conduct shall be recused from service on a  
10 committee on conduct performing functions under Article IV, section  
11 15, of the Oregon Constitution, if the facts and circumstances at issue  
12 could impair the member’s ability to act impartially and without bias.  
13 In the event of a recusal, the appointing authority shall appoint an  
14 acting member until the functions performed under Article IV, section  
15 15, of the Oregon Constitution, have been resolved.

16 “SECTION 2. (1) The Joint Committee on Conduct has a continuing  
17 existence and may meet, act and conduct its business during the ses-  
18 sions of the Legislative Assembly or any recess thereof, and in the  
19 interim period between sessions, but the committee has no authority  
20 to affect the rules of either legislative chamber.

21 “(2) The committee may not transact business unless a quorum is  
22 present. A quorum consists of a majority of committee members from  
23 the House of Representatives and a majority of committee members  
24 from the Senate.

25 “(3) Action by the committee requires the affirmative vote of a  
26 majority of committee members from the House of Representatives  
27 and a majority of committee members from the Senate.

28 “SECTION 3. Notwithstanding sections 1 and 2 of this 2019 Act, if  
29 a vacancy occurs in the position of the Legislative Conduct Officer  
30 before the expiration of the term of the officer, the Joint Committee

1 on Conduct may select an acting replacement for the vacated officer.  
2 The acting conduct officer selected by the committee serves at the  
3 committee's pleasure until a Legislative Conduct Officer is appointed  
4 under section 1 of this 2019 Act. The acting conduct officer shall re-  
5 ceive compensation in accordance with ORS 652.220.

6 **SECTION 4.** Notwithstanding sections 1 and 2 of this 2019 Act, if  
7 the 2019 regular session of the Eightieth Legislative Assembly adjourns  
8 sine die before the Legislative Conduct Officer has been appointed by  
9 the Legislative Assembly, the Joint Committee on Conduct may select  
10 an acting conduct officer for the vacant position. The acting conduct  
11 officer selected by the committee serves at the committee's pleasure  
12 until a Legislative Conduct Officer is appointed under section 1 of this  
13 2019 Act. The acting conduct officer shall receive compensation in ac-  
14 cordance with ORS 652.220.

15 **SECTION 5.** (1) The Legislative Conduct Officer shall:

16 **“(a) Prepare and present an annual report to the Joint Committee**  
17 **on Conduct. The annual report shall include:**

18 **“(A) A description of the activities of the officer since the last re-**  
19 **port;**

20 **“(B) A detailed description of the training curricula and subjects**  
21 **addressed in the training described in section 7 of this 2019 Act;**

22 **“(C) Statistics that list the number of confidential disclosures,**  
23 **conduct reports and conduct complaints made under any applicable**  
24 **rule, policy or law addressing harassment, discrimination and retali-**  
25 **ation in the legislative branch and the number of investigations con-**  
26 **ducted, except that statistics reported under this subparagraph may**  
27 **not disclose any characteristics that would permit confidential identi-**  
28 **ties to be determined or inferred;**

29 **“(D) The results, or a summary of the results, of the most recent**  
30 **culture and climate survey undertaken by the officer under section 11**

1 of this 2019 Act; and

2 “(E) Any other information required by the committee.

3 “(b) Establish and maintain a Capitol Leadership Team to perform  
4 the duties described in section 13 of this 2019 Act.

5 “(2) The Legislative Conduct Officer may employ and fix the com-  
6 pensation of such professional assistants and other employees as the  
7 officer deems necessary for the work under the officer’s charge. Em-  
8 ployee compensation shall be determined in accordance with ORS  
9 652.220.

10 “(3) The Legislative Conduct Officer may enter into contracts to  
11 carry out the functions of the Legislative Conduct Office.

12 **“SECTION 6. (1) Under the direction of the Joint Committee on**  
13 **Conduct, the Legislative Conduct Officer shall contract with one or**  
14 **more individuals who are unaffiliated with the legislative branch and**  
15 **who meet the standards and criteria established by the committee for**  
16 **performing services for the legislative branch as an independent in-**  
17 **vestigator. An independent investigator shall:**

18 “(a) Receive complaints and reports alleging harassment or other  
19 conduct that is asserted to violate standards of harassment, discrimi-  
20 nation or retaliation prescribed by legislative branch personnel rules;

21 “(b) Conduct investigations, determine facts, write investigative  
22 reports and report outcomes of investigations to appointing authorities  
23 or other persons or entities identified in legislative branch personnel  
24 rules or chamber rules as recipients of independent investigator re-  
25 ports; and

26 “(c) Make recommendations regarding interim safety measures to  
27 appointing authorities or other persons or entities identified in legis-  
28 lative branch personnel rules or chamber rules as recipients of inde-  
29 pendent investigator recommendations on interim safety measures.

30 “(2) An independent investigator may not have access to confiden-

1 tial files and records of the Legislative Conduct Officer.

2 **“SECTION 7. (1) The Legislative Conduct Officer shall at least once**  
3 **each calendar quarter conduct a minimum of two hours of respectful**  
4 **workplace training, including training on:**

5 **“(a) Legislative branch workplace harassment avoidance policies**  
6 **and rules;**

7 **“(b) Legislative branch procedures and rules for reporting or filing**  
8 **complaints to address instances of harassment; and**

9 **“(c) Free speech and free expression rights guaranteed under the**  
10 **Oregon and United States Constitutions.**

11 **“(2) The training described in subsection (1) of this section must**  
12 **be attended annually by all legislators, legislative staff and legislative**  
13 **interns and volunteers. Employees of contractors who reasonably ex-**  
14 **pect to be regularly present in the State Capitol must also attend the**  
15 **training described in subsection (1) of this section. Lobbyists and**  
16 **executive branch and judicial branch personnel who are regularly**  
17 **present in the State Capitol may be invited to attend the training. The**  
18 **Legislative Conduct Officer shall record attendance at the trainings**  
19 **and shall make attendance records publicly available.**

20 **“(3)(a) The Legislative Conduct Officer shall make the training de-**  
21 **scribed in subsection (1) of this section available online. The officer**  
22 **shall maintain records of all persons who have taken online training.**

23 **“(b) The online training described in this subsection is intended to**  
24 **be a last-resort alternative to the in-person training described in sub-**  
25 **section (1) of this section. An individual required to attend training**  
26 **under this section may substitute online training for in-person at-**  
27 **tendance only once in any two-year period.**

28 **“(4)(a) The Legislative Conduct Officer shall strive to present the**  
29 **training in small group settings and employ best practices to maximize**  
30 **attendance at in-person trainings.**

1       **“(b) Of the trainings described in subsection (1) of this section, at**  
2 **least one training session annually shall be on basic requirements**  
3 **under legislative branch personnel rules and at least one training**  
4 **session annually shall be an in-depth focus on one of the following**  
5 **topics:**

6       **“(A) Conduct that constitutes harassment under legislative branch**  
7 **personnel rules or other law;**

8       **“(B) Specific guidance addressing subtle forms of discrimination**  
9 **and harassment that become unlawful because of the pervasiveness**  
10 **of the conduct;**

11       **“(C) Available methods of reporting harassment;**

12       **“(D) Supervisor obligations to report harassment;**

13       **“(E) The authority every individual has to withdraw consent to in-**  
14 **timate conduct and the challenges associated with consensual re-**  
15 **lationships in the workplace;**

16       **“(F) Examples of positive workplace behaviors and constructive**  
17 **working relationships;**

18       **“(G) Skills necessary for individuals to become active bystanders**  
19 **who promote culture change and oppose harassing behavior they ob-**  
20 **serve in the workplace;**

21       **“(H) Methods for discouraging behavior that does not promote a**  
22 **productive and inclusive work environment;**

23       **“(I) The human impact and harm to the work environment that**  
24 **harassment causes; or**

25       **“(J) Free speech and free expression rights guaranteed under the**  
26 **Oregon and United States Constitutions.**

27       **“(5) The Legislative Conduct Officer may contract with other per-**  
28 **sons or entities with experience performing harassment avoidance and**  
29 **respectful workplace training for the performance of the training de-**  
30 **scribed in this section.**

1       **“(6) The Legislative Conduct Officer shall employ best practices in:**

2       **“(a) Developing training content described in this section and de-**  
3 **livery methodologies for the training content; and**

4       **“(b) Writing and publishing written guidance on Legislative Branch**  
5 **Rules and policies relating to:**

6       **“(A) Promoting a respectful and inclusive workplace;**

7       **“(B) Reporting or filing complaints about harassing, discriminatory**  
8 **or retaliatory behavior, or other behavior prohibited by branch rules**  
9 **or policies; and**

10       **“(C) Understanding options available to those who are experiencing**  
11 **behavior prohibited by branch rules or policies.**

12       **“(7) The Legislative Conduct Officer shall consult with the Legisla-**  
13 **tive Administrator and the committee described in section 11 (2) of**  
14 **this 2019 Act in the development of respectful workplace training.**

15       **“SECTION 8. The Legislative Conduct Officer shall begin under-**  
16 **taking training described in section 7 of this 2019 Act as soon as is**  
17 **practicable after the effective date of this 2019 Act.**

18       **“SECTION 9. Section 7 of this 2019 Act is amended to read:**

19       **“Sec. 7. (1) The Legislative Conduct Officer shall at least once each cal-**  
20 **endar quarter conduct a minimum of two hours of respectful workplace**  
21 **training, including training on:**

22       **“(a) Legislative branch workplace harassment avoidance policies and**  
23 **rules;**

24       **“(b) Legislative branch procedures and rules for reporting or filing com-**  
25 **plaints to address instances of harassment; and**

26       **“(c) Free speech and free expression rights guaranteed under the Oregon**  
27 **and United States Constitutions.**

28       **“(2) The training described in subsection (1) of this section must be at-**  
29 **tended annually by all legislators, legislative staff, [and] legislative**  
30 **interns, [and] legislative volunteers and lobbyists who are required to**



1 **register with the Oregon Government Ethics Commission.** Employees  
2 of contractors who reasonably expect to be regularly present in the State  
3 Capitol must also attend the training described in subsection (1) of this  
4 section. [*Lobbyists and*] Executive branch and judicial branch personnel who  
5 are regularly present in the State Capitol may be invited to attend the  
6 training. The Legislative Conduct Officer shall record attendance at the  
7 trainings and shall make attendance records publicly available.

8 “(3)(a) The Legislative Conduct Officer shall make the training described  
9 in subsection (1) of this section available online. The officer shall maintain  
10 records of all persons who have taken online training.

11 “(b) The online training described in this subsection is intended to be a  
12 last-resort alternative to the in-person training described in subsection (1)  
13 of this section. **Except for a registered lobbyist whose principal office**  
14 **is outside of this state,** an individual required to attend training under this  
15 section may substitute online training for in-person attendance only once in  
16 any two-year period.

17 “(4)(a) The Legislative Conduct Officer shall strive to present the training  
18 in small group settings and employ best practices to maximize attendance  
19 at in-person trainings.

20 “(b) Of the trainings described in subsection (1) of this section, at least  
21 one training session annually shall be on basic requirements under legisla-  
22 tive branch personnel rules and at least one training session annually shall  
23 be an in-depth focus on one of the following topics:

24 “(A) Conduct that constitutes harassment under legislative branch per-  
25 sonnel rules or other law;

26 “(B) Specific guidance addressing subtle forms of discrimination and  
27 harassment that become unlawful because of the pervasiveness of the con-  
28 duct;

29 “(C) Available methods of reporting harassment;

30 “(D) Supervisor obligations to report harassment;

1 “(E) The authority every individual has to withdraw consent to intimate  
2 conduct and the challenges associated with consensual relationships in the  
3 workplace;

4 “(F) Examples of positive workplace behaviors and constructive working  
5 relationships;

6 “(G) Skills necessary for individuals to become active bystanders who  
7 promote culture change and oppose harassing behavior they observe in the  
8 workplace;

9 “(H) Methods for discouraging behavior that does not promote a produc-  
10 tive and inclusive work environment;

11 “(I) The human impact and harm to the work environment that  
12 harassment causes; or

13 “(J) Free speech and free expression rights guaranteed under the Oregon  
14 and United States Constitutions.

15 “(5) The Legislative Conduct Officer may contract with other persons or  
16 entities with experience performing harassment avoidance and respectful  
17 workplace training for the performance of the training described in this  
18 section.

19 “(6) The Legislative Conduct Officer shall employ best practices in:

20 “(a) Developing training content described in this section and delivery  
21 methodologies for the training content; and

22 “(b) Writing and publishing written guidance on Legislative Branch Rules  
23 and policies relating to:

24 “(A) Promoting a respectful and inclusive workplace;

25 “(B) Reporting or filing complaints about harassing, discriminatory or  
26 retaliatory behavior, or other behavior prohibited by branch rules or policies;  
27 and

28 “(C) Understanding options available to those who are experiencing be-  
29 havior prohibited by branch rules or policies.

30 “(7) The Legislative Conduct Officer shall consult with the Legislative

1 Administrator and the committee described in section 11 (2) of this 2019 Act  
2 in the development of respectful workplace training.

3 **“SECTION 10. The amendments to section 7 of this 2019 Act by**  
4 **section 9 of this 2019 Act become operative on January 1, 2021.**

5 **“SECTION 11. (1) The Legislative Conduct Officer shall regularly**  
6 **conduct culture and climate surveys of legislators, legislative staff,**  
7 **lobbyists and others who regularly interact with the legislative branch**  
8 **to ascertain the alignment between stated legislative branch policies**  
9 **and goals relating to workplace culture and standards of behavior, and**  
10 **actual beliefs and experiences of those who work in the legislative**  
11 **branch or regularly interact with the legislative branch. The officer**  
12 **shall make the results of culture and climate surveys publicly avail-**  
13 **able.**

14 **“(2) If a diversity, equity and inclusion committee composed of**  
15 **members of the Legislative Assembly and partisan and nonpartisan**  
16 **staff of the legislative branch exists at the time of consultation, the**  
17 **Legislative Conduct Officer shall consult with the committee on cul-**  
18 **ture and climate surveys, training, building policies and practices that**  
19 **may affect legislative branch employees.**

20 **“(3) The Legislative Conduct Officer may contract with other per-**  
21 **sons or entities with experience conducting culture and climate sur-**  
22 **veys to conduct the surveys described in subsection (1) of this section.**

23 **“(4) The Legislative Conduct Officer may collaborate with the Leg-**  
24 **islative Administrator to provide training, coaching and the pro-**  
25 **duction of materials intended to improve State Capitol culture and on**  
26 **matters other than workplace harassment.**

27 **“SECTION 12. (1) The Legislative Conduct Officer shall be available**  
28 **to receive information from any individual about harassing behavior**  
29 **occurring in the State Capitol or involving legislators, legislative staff,**  
30 **lobbyists or others who are present in the State Capitol or who engage**

1 with legislators, legislative staff or lobbyists, whether in the State  
2 Capitol or elsewhere.

3 “(2) The Legislative Conduct Officer shall provide confidential pro-  
4 cess counseling to individuals who believe they have experienced or  
5 observed harassment, including but not limited to:

6 “(a) Providing information on legislative branch personnel rules,  
7 policies and reporting processes; and

8 “(b) Providing information on the extent to which information may  
9 be kept confidential or may be subject to disclosure.

10 “(3) The Legislative Conduct Officer may not engage in any inves-  
11 tigation following a report or complaint alleging harassment or fol-  
12 lowing any consultation described in subsection (1) or (2) of this  
13 section.

14 “(4) The Legislative Conduct Officer may not share any information  
15 acquired during a disclosure or consultation made confidential by leg-  
16 islative rule with an independent investigator performing services un-  
17 der section 6 of this 2019 Act, except that nonpersonally identifiable  
18 information may be disclosed to facilitate the taking of any action that  
19 is consistent with legislative rules and with the principles of the Due  
20 Process Clause of the United States Constitution.

21 **“SECTION 13. (1) The Legislative Conduct Officer shall establish**  
22 **and maintain a Capitol Leadership Team, consisting of legislators,**  
23 **legislative staff, lobbyists, executive and judicial branch staff who**  
24 **regularly interact with the legislative branch, employees of contrac-**  
25 **tors who regularly interact with the legislative branch, and interested**  
26 **members of the public, who have an interest in promoting a productive**  
27 **and inclusive environment in the State Capitol and at functions and**  
28 **events outside of the State Capitol at which legislators, staff, lobbyists**  
29 **and others interact. The officer shall give preference to interested in-**  
30 **dividuals who wish to serve on the team and who also have had expe-**

1 rience working on issues related to diversity, equity and inclusion.  
2 Capitol Leadership Team members who are legislators or partisan  
3 legislative staff shall be composed equally of those affiliated with the  
4 majority party and those affiliated with the minority party, so that  
5 there are equal numbers of legislators from the majority party and  
6 from the minority party and equal numbers of partisan staff team  
7 members from the majority party and from the minority party.

8 “(2) The Legislative Administrator shall provide members of the  
9 Capitol Leadership Team with advanced respectful workplace training,  
10 with an emphasis on implementing cultural change in the workplace.

11 “(3) Capitol Leadership Team members shall serve as mentors and  
12 informal resources of information for others who are interested in  
13 promoting a more respectful workplace or who are facing challenges  
14 in the workplace.

15 “(4) The Capitol Leadership Team shall identify additional services  
16 or additional training needs and shall report those identified additional  
17 services or training needs to the Legislative Conduct Officer and to the  
18 Joint Committee on Conduct.

19 “SECTION 14. (1) At the direction of the Joint Committee on Con-  
20 duct, the Legislative Conduct Officer shall contract with one or more  
21 offsite process counselors to perform the duties described in section  
22 15 of this 2019 Act or such other duties as are assigned by legislative  
23 rule or by the committee.

24 “(2) The committee shall establish minimum qualifications for an  
25 offsite process counselor and may establish other criteria for the se-  
26 lection of an offsite process counselor, including criteria by which a  
27 request for proposals may be evaluated or by which external experts  
28 may be invited to advise the committee on the selection of an offsite  
29 process counselor.

30 “SECTION 15. (1) An offsite process counselor under contract with

1 the Legislative Conduct Officer under section 14 of this 2019 Act shall  
2 be available to receive information from any individual about harass-  
3 ing behavior occurring in the State Capitol or involving legislators,  
4 legislative staff, lobbyists or others who are present in the State Cap-  
5 itol or who engage with legislators, legislative staff or lobbyists,  
6 whether in the State Capitol or elsewhere.

7 “(2) The offsite process counselor shall provide confidential process  
8 counseling to individuals who believe they have experienced or ob-  
9 served harassment, including but not limited to:

10 “(a) Providing information on legislative branch personnel rules,  
11 policies and reporting processes; and

12 “(b) Providing information on the extent to which information may  
13 be kept confidential or may be subject to disclosure.

14 “(3) The offsite process counselor may not engage in any investi-  
15 gation following a report or complaint alleging harassment or follow-  
16 ing any consultation described in subsection (1) or (2) of this section.

17 “(4) The offsite process counselor may not share any information  
18 acquired during a consultation described in subsection (1) or (2) of this  
19 section with the independent investigator performing services under  
20 section 6 of this 2019 Act and legislative branch personnel rules, except  
21 that nonpersonally identifiable information may be disclosed to facili-  
22 tate the taking of any action that is consistent with legislative rules  
23 and with the principles of the Due Process Clause of the United States  
24 Constitution.

25 “(5) Upon request of a person making a disclosure, report or com-  
26 plaint to the Legislative Conduct Officer, the offsite process counselor  
27 may be present when the disclosure, report or complaint is made.

28 “SECTION 16. Section 17 of this 2019 Act is added to and made a  
29 part of ORS 40.225 to 40.295.

30 “SECTION 17. (1) As used in this section:

1       “(a) ‘Confidential communication’ means a communication between  
2 an offsite process counselor and an individual reporting information  
3 or seeking consultative services from the offsite process counselor.

4       “(b) ‘Harassment’ has the meaning given that term in legislative  
5 branch personnel rules that establish a standard of conduct that ap-  
6 plies to legislators, legislative staff or executive or judicial branch  
7 staff that regularly are present in the State Capitol or regularly  
8 interact with the legislative branch, lobbyists who are required to be  
9 registered under ORS 171.740, or contractors, including employees of  
10 contractors, who regularly perform services in the State Capitol.  
11 ‘Harassment’ includes conduct that constitutes sexual harassment or  
12 retaliation as those terms are used in the legislative branch personnel  
13 rules that address harassment. ‘Harassment’ includes discrimination  
14 in a place of public accommodation.

15       “(c) ‘Legislative branch’ means the legislative department, as de-  
16 fined in ORS 174.114.

17       “(d) ‘Offsite process counselor’ means an offsite process counselor  
18 who meets the qualifications established under section 14 (2) of this  
19 2019 Act, who performs services under section 15 of this 2019 Act and  
20 who has completed at least 40 hours of training in advocacy for victims  
21 of domestic violence, sexual assault, stalking or workplace  
22 harassment, including harassment based on race, gender or disability,  
23 that has been approved by the Attorney General by rule.

24       “(2) A person who reports information to an offsite process coun-  
25 selor that concerns harassment that the person has experienced or  
26 witnessed has a privilege to refuse to disclose and to prevent any other  
27 person from disclosing:

10 **counselor in the course of providing counsel or services to the person.**

11 **“(4) This section does not prohibit the disclosure of:**

12 **“(a) Any information if the offsite process counselor reasonably**  
13 **believes that the disclosure is necessary to prevent immediate physical**  
14 **harm or other harm described in ORS 40.252; or**

15 **“(b) Nonpersonally identifying data.**

16 **“(5) This section applies to civil, criminal and administrative pro-**  
17 **ceedings and to legislative branch disciplinary proceedings.**

18 **“SECTION 18. ORS 40.252 is amended to read:**

19 **“40.252. (1) In addition to any other limitations on privilege that may be**  
20 **imposed by law, there is no privilege under ORS 40.225, 40.230, 40.250 or**  
21 **40.264 or section 17 of this 2019 Act for communications if:**

22 **“(a) In the professional judgment of the person receiving the communi-**  
23 **cations, the communications reveal that the declarant has a clear and seri-**  
24 **ous intent at the time the communications are made to subsequently commit**

24 “(2) By April 15 next after the date an appointment takes effect, every

29 “(3) By April 15 next after the filing deadline for the primary election,

28 ance, and maintenance expenses.

29 “(3) If the amount of any expenditure required to be included in a state-  
30 ment is not accurately known at the time the statement is required to be

1 filed, an estimate of the expenditure shall be submitted in the statement and  
2 designated as an estimate. The exact amount expended for which a previous  
3 estimate was made shall be submitted in a subsequent report when the in-  
4 formation is available.

5 “(4) A statement required by this section shall include a copy of any no-  
6 tice provided to a public official or candidate under ORS 244.100.
