## PROPOSED AMENDMENTS TO HOUSE BILL 2112

In line 2 of the printed bill, after "transportation" insert "; creating new provisions; amending ORS 801.041; and prescribing an effective date".

3 Delete lines 4 through 11 and insert:

"SECTION 1. ORS 801.041, as amended by section 1, chapter 24, Oregon
Laws 2018, and section 24, chapter 93, Oregon Laws 2018, is amended to read:
"801.041. The following apply to the authority granted to counties by ORS
801.040 to establish registration fees for vehicles:

"(1) An ordinance establishing registration fees under this section must 8 be enacted by the county imposing the registration fee and filed with the 9 Department of Transportation. Notwithstanding ORS 203.055 or any pro-10 vision of a county charter, the governing body of a county with a population 11 12of 350,000 or more may enact an ordinance establishing registration fees. The governing body of a county with a population of less than 350,000 may enact 13 an ordinance establishing registration fees after submitting the ordinance to 14 the electors of the county for their approval. The governing body of the 15 county imposing the registration fee shall enter into an intergovernmental 16 agreement under ORS 190.010 with the department by which the department 17 shall collect the registration fees, pay them over to the county and, if nec-18 essary, allow the credit or credits described in ORS 803.445 (5). The inter-19 governmental agreement must state the date on which the department shall 20begin collecting registration fees for the county. 21

"(2) The authority granted by this section allows the establishment of registration fees in addition to those described in ORS 803.420 and 803.422. There is no authority under this section to affect registration periods, qualifications, cards, plates, requirements or any other provision relating to vehicle registration under the vehicle code.

"(3) Except as otherwise provided for in this subsection, when registration
fees are imposed under this section, they must be imposed on all vehicle
classes. Registration fees as provided under this section may not be imposed
on the following:

10 "(a) Snowmobiles and Class I all-terrain vehicles.

11 "(b) Fixed load vehicles.

12 "(c) Vehicles registered under ORS 805.100 to disabled veterans.

13 "(d) Vehicles registered as antique vehicles under ORS 805.010.

<sup>14</sup> "(e) Vehicles registered as vehicles of special interest under ORS 805.020.

"(f) Government-owned or operated vehicles registered under ORS 805.040
or 805.045.

17 "(g) School buses or school activity vehicles registered under ORS 805.050.

18 "(h) Law enforcement undercover vehicles registered under ORS 805.060.

<sup>19</sup> "(i) Vehicles registered on a proportional basis for interstate operation.

"(j) Vehicles with a registration weight of 26,001 pounds or more described in ORS 803.420 (14)(a) or (b).

"(k) Vehicles registered as farm vehicles under the provisions of ORS
805.300.

<sup>24</sup> "(L) Travel trailers, campers and motor homes.

"(m) Vehicles registered to an employment address as provided in ORS 802.250 when the eligible public employee or household member's residence address is not within the county of the employment address. The department may adopt rules it considers necessary for the administration of this paragraph.

30 "(n) Vehicles registered under ORS 805.110 to former prisoners of war.

"(4) Any registration fee imposed by a county must be a fixed amount not to exceed, with respect to any vehicle class, the sum of the registration fee established under ORS 803.420 (6)(a) and the fee applicable to the registered vehicle under ORS 803.422. For vehicles on which a flat fee is imposed under ORS 803.420, the fee must be a whole dollar amount.

6 "(5) Moneys from registration fees established under this section must be 7 paid to the county establishing the registration fees as provided in ORS 8 802.110.

9 "[(6) The county ordinance shall provide for payment of at least 40 percent 10 of the moneys to cities within the county unless a different distribution is 11 agreed upon by the county and the cities within the jurisdiction of the 12 county.]

13 "(6) Except as provided in section 3 of this 2019 Act, or unless a 14 different distribution is agreed upon by the county and the cities 15 within the jurisdiction of the county, the county ordinance shall pro-16 vide for payment of at least 40 percent of the moneys from registration 17 fees established under this section to cities within the county.

"(7) The moneys for the cities and the county shall be used for any purpose for which moneys from registration fees may be used, including the payment of debt service and costs related to bonds or other obligations issued for such purposes.

"(8) Two or more counties may act jointly to impose a registration fee under this section. The ordinance of each county acting jointly with another under this subsection must provide for the distribution of moneys collected through a joint registration fee.

"<u>SECTION 2.</u> Section 3 of this 2019 Act is added to and made a part
 of the Oregon Vehicle Code.

28 "<u>SECTION 3.</u> (1) A county ordinance that imposes a vehicle regis-29 tration fee under ORS 801.041 is not required to provide for payment 30 of at least 40 percent of moneys from the registration fee to cities 1 within the county if the county:

2 "(a) Has a population of 650,000 or more; and

"(b) Uses the moneys from the registration fee to pay for maintaining, planning, designing, replacing, acquiring necessary property for, engineering, constructing or repairing a bridge that crosses the Willamette River in the City of Portland, or the approaches to the bridge, including the payment of debt service and costs related to bonds or other obligations issued for such purposes.

9 "(2) This section applies to county vehicle registration fees that are 10 imposed for the purpose of maintaining, planning, designing, replac-11 ing, acquiring necessary property for, engineering, constructing or 12 repairing a bridge that crosses the Willamette River in the City of 13 Portland, or the approaches to the bridge, including the payment of 14 debt service and costs related to bonds or other obligations issued for 15 such purposes.

"<u>SECTION 4.</u> This 2019 Act takes effect on the 91st day after the
 date on which the 2019 regular session of the Eightieth Legislative
 Assembly adjourns sine die.".
