**PROPOSED AMENDMENTS TO
A-ENGROSSED HOUSE BILL 2098**

1 On page 1 of the printed A-engrossed bill, line 4, after “475B.705” delete
2 the rest of the line and insert “, 475B.710 and 475B.760; and declaring an
3 emergency.”.

4 Delete lines 6 through 15 and insert:

5 **“SECTION 1. (1) The State Department of Agriculture, in consul-**
6 **tation with the Oregon Health Authority and the Oregon Liquor Con-**
7 **trol Commission, shall establish the State Cannabis Reference Lab**
8 **within the department. The lab shall establish and use standards and**
9 **practices for testing marijuana and hemp, including all products**
10 **produced from marijuana or hemp and any paraphernalia used in the**
11 **consumption or use of marijuana or hemp. The standards and prac-**
12 **tices must include testing for at least the following:**

13 **“(a) Potency;**

14 **“(b) Water content;**

15 **“(c) Molds;**

16 **“(d) Pesticides;**

17 **“(e) Metals; and**

18 **“(f) Residual solvents.**

19 **“(2) The department may adopt rules as necessary to carry out this**
20 **section.”.**

21 On page 5, line 18, after “duration” insert “and in compliance with sec-

1 tion 3b of this 2019 Act”.

2 After line 22, insert:

3 **“SECTION 3a. Section 3b of this 2019 Act is added to and made a**
4 **part of ORS 475B.010 to 475B.545.**

5 **“SECTION 3b. (1) The Oregon Liquor Control Commission may es-**
6 **tablish a pilot program described in ORS 475B.025 if:**

7 **“(a) The Oregon Liquor Control Commission first submits to the**
8 **Oregon Cannabis Commission a plan for the establishment of the pilot**
9 **program; and**

10 **“(b) The Oregon Cannabis Commission approves the plan.**

11 **“(2) The Oregon Liquor Control Commission and the Oregon**
12 **Cannabis Commission may each adopt rules to carry out this**
13 **section.”.**

14 On page 11, after line 7, insert:

15 **“SECTION 16a. ORS 475B.760 is amended to read:**

16 **“475B.760. (1) All moneys received by the Department of Revenue under**
17 **ORS 475B.700 to 475B.760 shall be deposited in the State Treasury and cred-**
18 **ited to a suspense account established under ORS 293.445. The department**
19 **may pay expenses for the administration and enforcement of ORS 475B.700**
20 **to 475B.760 out of moneys received from the tax imposed under ORS 475B.705.**
21 **Amounts necessary to pay administrative and enforcement expenses are**
22 **continuously appropriated to the department from the suspense account.**

23 **“(2) The Department of Revenue may reimburse, from moneys de-**
24 **scribed in subsection (1) of this section, the State Department of Ag-**
25 **riculture for any expenses incurred by the State Department of**
26 **Agriculture in the administration of section 1 of this 2019 Act.**

27 **“[(2)] (3) After the payment or reimbursement of administrative and**
28 **enforcement expenses and refunds or credits arising from erroneous over-**
29 **payments, the Department of Revenue shall credit the balance of the moneys**
30 **received by the Department of Revenue under this section to the Oregon**

1 Marijuana Account established under ORS 475B.759.”.

2 Delete lines 14 through 25 and insert:

3 **“SECTION 20. (1) Sections 1 and 3b of this 2019 Act and the**
4 **amendments to ORS 475B.015, 475B.025, 475B.045, 475B.074, 475B.096,**
5 **475B.186, 475B.199, 475B.206, 475B.211, 475B.216, 475B.256, 475B.416,**
6 **475B.577, 475B.705, 475B.710 and 475B.760 by sections 2 to 16a of this 2019**
7 **Act become operative on January 1, 2020.**

8 **“(2) The Department of Revenue, the Oregon Cannabis Commission,**
9 **the Oregon Health Authority, the Oregon Liquor Control Commission**
10 **and the State Department of Agriculture may take any action before**
11 **the operative date specified in subsection (1) of this section that is**
12 **necessary to enable the authority, the commissions and the depart-**
13 **ments to exercise, on and after the operative date specified in sub-**
14 **section (1) of this section, all of the duties, functions and powers**
15 **conferred on the authority, the commissions and the departments by**
16 **sections 1 and 3b of this 2019 Act and the amendments to ORS 475B.015,**
17 **475B.025, 475B.045, 475B.074, 475B.096, 475B.186, 475B.199, 475B.206,**
18 **475B.211, 475B.216, 475B.256, 475B.416, 475B.577, 475B.705, 475B.710 and**
19 **475B.760 by sections 2 to 16a of this 2019 Act.”.**
