PROPOSED AMENDMENTS TO HOUSE BILL 2018

1 Delete lines 4 through 12 of the printed bill and insert:

<u>SECTION 1.</u> (1) The Task Force on Educational Accountability and
 Transparency is established.

support to the task force.

"(13) Members of the Legislative Assembly appointed to the task
 force are nonvoting members of the task force and may act in an ad visory capacity only.

"(14) Members of the task force who are not members of the Leg islative Assembly are not entitled to compensation or reimbursement
 for expenses and serve as volunteers on the task force.

HB 2018-3 5/14/19 Proposed Amendments to HB 2018 "(16) The Department of Education may use moneys from the Statewide Education Initiatives Account for the task force as authorized under section 25 (1)(i), chapter __, Oregon Laws 2019 (Enrolled House Bill 3427). Moneys used by the department under this subsection may be used only to enter into a contract with a national organization that:

7 "(a) Has experience in assisting states to improve their account8 ability systems; and

9 "(b) Will advise and assist the task force in its work.

"SECTION 3. Section 1 of this 2019 Act is repealed on December 31,
2020.

"<u>SECTION 4.</u> This 2019 Act being necessary for the immediate
 preservation of the public peace, health and safety, an emergency is
 declared to exist, and this 2019 Act takes effect on its passage.".
