PROPOSED AMENDMENTS TO HOUSE BILL 2015

"807.730. (1) The Department of Transportation may issue or replace a 13 Real ID limited term driver license, Real ID limited term commercial driver 14 15 license, **Real ID** limited term driver permit, limited term commercial learner driver permit, limited term commercial driver license that is not a Real 16 ID or Real ID limited term identification card only for a person who pro-17 vides proof, as determined by the department by rule, that the person *is le-*18 gally present] has lawful status in the United States on a temporary basis. 19 "(2) A Real ID limited term driver license, Real ID limited term com-20mercial driver license, limited term commercial driver license that is 21

1 not a Real ID or Real ID limited term identification card is valid:

"(a) During the applicant's authorized stay in the United States, but no
longer than eight years from the date of issuance; or

"(b) If there is no definite end to the authorized stay, for a period of oneyear.

6 "(3) A **Real ID** limited term driver permit or a limited term commercial 7 learner driver permit is valid:

8 "(a) During the applicant's authorized stay in the United States, but no 9 longer than the period of time for which a driver permit of the same type is 10 issued by the department.

"(b) If there is no definite end to the authorized stay, for a period of one year but no longer than the period of time for which a driver permit of the same type is issued by the department.

"(4) A Real ID limited term driver license, Real ID limited term com-14 mercial driver license, limited term commercial driver license that is 15 not a Real ID, Real ID limited term driver permit[, limited term commercial 16 *learner driver permit*] or **Real ID** limited term identification card may be 17 renewed only upon presentation of valid documentation, as determined by the 18 department by rule, that the status by which the applicant qualified for the 19 **Real ID** limited term driver license, **Real ID** limited term commercial driver 20license, limited term commercial driver license that is not a Real ID, 21**Real ID** limited term driver permit[, limited term commercial learner driver 22*permit*] or **Real ID** limited term identification card has been extended or is 23still in effect. 24

"(5) A Real ID limited term driver license or Real ID limited term driver
permit grants the same driving privileges as a driver license or driver permit.

(6) A **Real ID** limited term identification card shall bear a statement to the effect that the **Real ID** limited term identification card is not a license or any other grant of driving privileges to operate a motor vehicle and is to 1 be used for identification purposes only.

"(7) A limited term commercial driver license, a Real ID limited term
commercial driver license or limited term commercial learner driver permit grants the same privileges as a commercial driver license or commercial
learner driver permit.

6 "(8) The department may issue a **Real ID limited term commercial** 7 **driver license,** limited term commercial driver license **that is not a Real** 8 **ID** or limited term commercial learner driver permit if the applicant is oth-9 erwise eligible for commercial driving privileges. The department may adopt 10 rules describing eligibility requirements for **Real ID** limited term commercial 11 driver licenses, **limited term commercial driver licenses that are not** 12 **Real ID** and limited term commercial learner driver permits.

"(9) A **Real ID** limited term driver license, **Real ID** limited term com-13 mercial driver license, limited term commercial driver license that is 14 not a Real ID, Real ID limited term driver permit, limited term com-15mercial learner driver permit or Real ID limited term identification card 16 shall clearly indicate on the face of the card and in the machine read-17 able zone that it is a Real ID limited term driver license, Real ID limited 18 term commercial driver license, limited term commercial driver license 19 that is not a Real ID, Real ID limited term driver permit, limited term 20commercial learner driver permit or Real ID limited term identification 21card and indicate the date on which it expires.". 22

(1) The Secretary of State shall by rule establish a schedule by ²² which the Department of Transportation shall provide to the secretary elec-²³ tronic records containing the legal name, age, residence and citizenship in-²⁴ formation for, and the electronic signature of, each person who meets ²⁵ qualifications identified by the secretary by rule.

"(2) Upon receiving the electronic record for, and electronic signature of, a person described in subsection (1) of this section, the Secretary of State shall provide the information to the county clerk of the county in which the person may be registered as an elector. The secretary or county clerk shall notify each person of the process to:

- 1 "(a) Decline being registered as an elector.
- 2 "(b) Adopt a political party affiliation.

"(3) If a person notified under subsection (2) of this section does not de-3 cline to be registered as an elector within 21 calendar days after the Secre-4 tary of State or county clerk issues the notification, the person's electronic $\mathbf{5}$ record and electronic signature submitted under subsection (1) of this section 6 will constitute a completed registration card for the person for purposes of 7 this chapter. The person shall be registered to vote if the county clerk de-8 termines that the person is qualified to vote under Article II, section 2, of 9 the Oregon Constitution, and the person is not already registered to vote. 10

"(4) A county clerk may not send a ballot to, or add to an elector registration list, a person who meets eligibility requirements until at least 21 calendar days after the Secretary of State or county clerk provided notification to the person as described in subsection (2) of this section.
