**PROPOSED AMENDMENTS TO
A-ENGROSSED SENATE BILL 107**

1 On page 1 of the printed A-engrossed bill, line 3, after “ORS” insert
2 “811.550 and”.

3 On page 2, delete lines 13 and 14 and insert:

4 “(12)(a) When applicable, this subsection exempts vehicles owned or op-
5 erated by an electric utility when stopping, standing or parking is necessary
6 to respond to an emergency if the vehicle is identified as an electric utility
7 vehicle and:

8 “(A) There is also an emergency vehicle at the location; or

9 “(B) The electric utility is investigating a downed or arcing utility line.

10 “(b) As used in this subsection, ‘electric utility’ means an electric com-
11 pany or consumer-owned utility that is engaged in the business of distribut-
12 ing electricity to retail electricity consumers in this state.

13 **“SECTION 2.** ORS 811.550 is amended to read:

14 “811.550. This section establishes places where stopping, standing and
15 parking a vehicle are prohibited for purposes of the penalties under ORS
16 811.555. Except as provided under an exemption in ORS 811.560, a person is
17 in violation of ORS 811.555 if a person parks, stops or leaves standing a ve-
18 hicle in any of the following places:

19 “(1) Upon a roadway outside a business district or residence district,
20 whether attended or unattended, when it is practicable to stop, park or leave
21 the vehicle standing off the roadway. Exemptions under ORS 811.560 (1),

1 (7), [and] (9), **(11) and (12)** are applicable to this subsection.

2 “(2) On a shoulder, whether attended or unattended, unless a clear and
3 unobstructed width of the roadway opposite the standing vehicle is left for
4 the passage of other vehicles and the standing vehicle is visible from a dis-
5 tance of 200 feet in each direction upon the roadway or the person, at least
6 200 feet in each direction upon the roadway, warns approaching motorists
7 of the standing vehicle by use of flaggers, flags, signs or other signals. Ex-
8 emptions under ORS 811.560 (9), **(11) and (12)** are applicable to this sub-
9 section.

10 “(3) On the roadway side of a vehicle stopped or parked at the edge or
11 curb of a highway. Exemptions under ORS 811.560 (7), **(11) and (12)** are ap-
12 plicable to this subsection.

13 “(4) On a sidewalk. Exemptions under ORS 811.560 (4) to (7), **(11) and (12)**
14 are applicable to this subsection.

15 “(5) Within an intersection. Exemptions under ORS 811.560 (4) to (7), **(11)**
16 **and (12)** are applicable to this subsection.

17 “(6) On a crosswalk. Exemptions under ORS 811.560 (4) to (7), **(11) and**
18 **(12)** are applicable to this subsection.

19 “(7) Between a safety zone and the adjacent curb or within 30 feet of
20 points on the curb immediately opposite the ends of a safety zone, unless a
21 different length is indicated by signs and markings. For purposes of this
22 subsection the safety zone must be an area or space officially set apart
23 within a roadway for the exclusive use of pedestrians and which is protected
24 or is so marked or indicated by adequate signs as to be plainly visible at all
25 times while set apart as a safety zone. Exemptions under ORS 811.560 (4) to
26 (7), **(11) and (12)** are applicable to this subsection.

27 “(8) Alongside or opposite a street excavation or obstruction when stop-
28 ping, standing or parking would obstruct traffic. Exemptions under ORS
29 811.560 (4) to (7), **(11) and (12)** are applicable to this subsection.

30 “(9) Upon a bridge or other elevated structure upon a highway. Ex-

1 exemptions under ORS 811.560 (4) to (8), **(11) and (12)** are applicable to this
2 subsection.

3 “(10) Within a highway tunnel. Exemptions under ORS 811.560 (4) to (7),
4 **(11) and (12)** are applicable to this subsection.

5 “(11) On any railroad or rail fixed guideway public transportation system
6 tracks or within seven and one-half feet of the nearest rail at a time when
7 the parking of vehicles would conflict with operations or repair of the
8 tracks. Exemptions under ORS 811.560 (4) to (7), **(11) and (12)** are applicable
9 to this subsection.

10 “(12) On a throughway. Exemptions under ORS 811.560 (4) to (7), **(11) and**
11 **(12)** are applicable to this subsection.

12 “(13) In the area between roadways of a divided highway, including
13 crossovers. Exemptions under ORS 811.560 (4) to (7), **(11) and (12)** are ap-
14 plicable to this subsection.

15 “(14) At any place where traffic control devices prohibit stopping. Ex-
16 emptions under ORS 811.560 (4) to (7), **(11) and (12)** are applicable to this
17 subsection.

18 “(15) In front of a public or private driveway. Exemptions under ORS
19 811.560 (2), [*and*] (4) to (7), **(11) and (12)** are applicable to this subsection.

20 “(16) Within 10 feet of a fire hydrant. Exemptions under ORS 811.560
21 (2), [*and*] (4) to (7), **(11) and (12)** are applicable to this subsection.

22 “(17) Within 20 feet of a crosswalk at an intersection. Exemptions under
23 ORS 811.560 (2), [*and*] (4) to (7), **(11) and (12)** are applicable to this sub-
24 section.

25 “(18) Within 50 feet upon the approach to an official flashing signal, stop
26 sign, yield sign or traffic control device located at the side of the roadway
27 if the standing or parking of a vehicle will obstruct the view of any traffic
28 control device located at the side of the roadway. Exemptions under ORS
29 811.560 (2), [*and*] (4) to (7), **(11) and (12)** are applicable to this subsection.

30 “(19) Within 15 feet of the driveway entrance to a fire station and on the

1 side of a street opposite the entrance to a fire station, within 75 feet of the
2 entrance. Exemptions under ORS 811.560 (2), [and] (4) to (7), **(11) and (12)**
3 are applicable to this subsection.

4 “(20) At any place where traffic control devices prohibit standing. Ex-
5 emptions under ORS 811.560 (2), [and] (4) to (7), **(11) and (12)** are applicable
6 to this subsection.

7 “(21) Within 50 feet of the nearest rail of a railroad or rail fixed guideway
8 public transportation system crossing. Exemptions under ORS 811.560 (3) to
9 (7), **(11) and (12)** are applicable to this subsection.

10 “(22) At any place where traffic control devices prohibit parking. Ex-
11 emptions under ORS 811.560 (3) to (7), **(11) and (12)** are applicable to this
12 subsection.

13 “(23) On a bicycle lane. Exemptions under ORS 811.560 are applicable to
14 this subsection.

15 “(24) On a bicycle path. Exemptions under ORS 811.560 are applicable to
16 this subsection.

17 **“SECTION 3. The amendments to ORS 811.550 and 811.560 by**
18 **sections 1 and 2 of this 2019 Act apply to conduct occurring on or after**
19 **the effective date of this 2019 Act.”.**
