**PROPOSED AMENDMENTS TO
SENATE BILL 5513**

1 On page 1 of the printed bill, delete lines 6 through 13 and insert:

- 2 “(1) Judicial compensation..... \$ 87,141,293
3 (2) Operations..... \$ 340,873,732
4 (3) Mandated payments..... \$ 16,606,161
5 (4) State court technology
6 systems \$ 3,432,622
7 (5) Debt service \$ 30,968,960
8 (6) Third-party debt
9 collection..... \$15,312,377”.

10 Delete lines 20 through 27.

11 On page 2, delete line 1 and insert:

- 12 “(1) Operations..... \$ 16,339,627
13 (2) Mandated payments..... \$ 689,109
14 (3) State Court Facilities and
15 Security Account..... \$ 6,716,018
16 (4) State Court Technology Fund..... \$19,410,111”.

17 In line 8, delete “\$567,057” and insert “\$320,442”.

18 In line 11, delete “\$77,324” and insert “\$51,710”.

19 In line 14, delete “\$9,006,499” and insert “\$7,183,170”.

20 In line 22, delete “\$7,406,500” and insert “\$7,183,170”.

21 In line 26, delete “2019-2021” and insert “2017-2019”.

1 Delete lines 28 through 30 and insert:

2 **“SECTION 8. (1) In addition to and not in lieu of any other appro-**
3 **priation, there is appropriated to the Judicial Department, for the**
4 **biennium beginning July 1, 2019, out of the General Fund, the amount**
5 **of \$12,257,000 for the purpose of funding the Legal Services Program**
6 **described in ORS 9.572.**

7 **“(2) The Chief Justice of the Supreme Court shall distribute all**
8 **moneys appropriated under this section to the Oregon State Bar in**
9 **eight quarterly installments of equal amount.**

10 **“SECTION 9. (1) Notwithstanding any other provision of law, the**
11 **General Fund appropriation made to the Judicial Department by sec-**
12 **tion 1 (1), chapter 575, Oregon Laws 2017, for the biennium ending June**
13 **30, 2019, for judicial compensation, is decreased by \$950,000.**

14 **“(2) Notwithstanding any other provision of law, the General Fund**
15 **appropriation made to the Judicial Department by section 1 (2), chap-**
16 **ter 575, Oregon Laws 2017, for the biennium ending June 30, 2019, for**
17 **operations, is decreased by \$800,000.**

18 **“(3) Notwithstanding any other provision of law, the General Fund**
19 **appropriation made to the Judicial Department by section 16, chapter**
20 **650, Oregon Laws 2017, for the biennium ending June 30, 2019, is de-**
21 **creased by \$600,000.**

22 **“(4) Notwithstanding any other provision of law, the General Fund**
23 **appropriation made to the Judicial Department by section 141 (1),**
24 **chapter 702, Oregon Laws 2017, for the biennium ending June 30, 2019,**
25 **is decreased by \$500,000.**

26 **“(5) Notwithstanding any other provision of law, the General Fund**
27 **appropriation made to the Judicial Department by section 1 (3), chap-**
28 **ter 575, Oregon Laws 2017, for the biennium ending June 30, 2019, for**
29 **mandated payments, is increased by \$950,000.**

30 **“(6) Notwithstanding any other provision of law, the General Fund**

1 appropriation made to the Judicial Department by section 1 (6), chap-
2 ter 575, Oregon Laws 2017, for the biennium ending June 30, 2019, for
3 third-party debt collection, is increased by \$1,900,000.

4 SECTION 10. This 2019 Act being necessary for the immediate
5 preservation of the public peace, health and safety, an emergency is
6 declared to exist, and this 2019 Act takes effect on its passage.”.
