Notwithstanding any other law limiting expendi-7 tures, the limitation on expenditures established by section 3 (1), 8 chapter ___, Oregon Laws 2019 (Enrolled House Bill 5026), for the 9 biennium beginning July 1, 2019, as the maximum limit for payment 10 of expenses from federal funds, excluding federal funds described in 11 section 2, chapter ___, Oregon Laws 2019 (Enrolled House Bill 5026), 12collected or received by the Department of Human Services, for cen-13 tral services and state assessments and enterprise-wide costs, is in-14 creased by \$392,329 for the purpose of complying with the requirements 15of this 2019 Act.". 16

"SECTION 30. Notwithstanding any other law limiting expenditures, 18 the limitation on expenditures established by section 1, chapter ____, 19 Oregon Laws 2019 (Enrolled Senate Bill 5537), for the biennium begin-20ning July 1, 2019, as the maximum limit for payment of expenses from 21fees, moneys or other revenues, including Miscellaneous Receipts, but 22excluding lottery funds and federal funds, collected or received by the 23Teacher Standards and Practices Commission, is increased by \$525,000 24for the purpose of complying with the requirements of section 23 of 25this 2019 Act.". 26
