HB 4005

Requires owner or possessor of firearm to secure firearm with trigger or cable lock, in locked container or in gun room except in specified circumstances.

HB 4040 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 02/10/2020 AGENDA: Directs Judicial Department to establish Family Treatment Court Program in certain counties to improve outcomes in child welfare cases resulting from parent's or caregiver's alleged substance use disorder.

HB 4065

Repeals driving privilege suspension and eliminates imposition of driving privilege restrictions for failure to pay fine.

HB 4097

Prohibits police officer from conducting or participating in activities intended to determine whether person has paid certain user charges, fees or tolls imposed by mass transit district.

HB 4107

CARRIED OVER FROM THE 02/10/2020 AGENDA: Makes unlawful practice for place of public accommodation to refuse to accept United States coins or currency as payment for goods and services.

HB 4126 **

**Subsequent Referral(s) to Ways and Means

CARRIED OVER FROM THE 02/10/2020 AGENDA: Increases penalties for crime of riot if, during commission of riot, person conceals person's face with intent to facilitate commission of riot.

HB 4131 **

**Subsequent Referral(s) to Ways and Means

Directs Oregon Criminal Justice Commission to establish, in collaboration with Department of Corrections, Family Preservation Project pilot program at Coffee Creek Correctional Facility.

HB 4142

Eliminates minimum amount of fee added to judgment that includes monetary obligation that court or judicial branch is charged with collecting.

HB 4145

CARRIED OVER FROM THE 02/10/2020 AGENDA: Creates crime of unlawfully threatening a school or place of worship.
