To State of Oregon Legislators:

This letter is in support of legislative funding for Community Family Court (CFC) and the Oregon Department of Justice for continued administration of treatment courts. CFC has provided a practical response to parents who struggle with substance abuse and/or child neglect by applying a method of support and accountability provided by relevant community partners and Community Family Court Judges. Working with parent/s in this manner helps them find healing and success, diverting them from incarceration and diverting children from foster care by keeping families together. The healthy outcomes to families because of the treatment court system are immeasurable, but the cost savings to foster care and the corrections systems are also more than significant.

The following are two examples I want to share with you.

A CASA Volunteer commented: *CFC* is so important for the family. It provides the wrap-around services and monitoring the families need as they get their kids back and are so new in recovery. I appreciate it as a CASA because everyone is at the table and talking about everything affecting the family's stability in great detail. The families are supported 360 degrees. Susie Wahl (CFC Coordinator) and our Judges do a fantastic job motivating the family and building their healthy support network alongside them. Every case should be in Community Family Court.

A family's personal story at graduation from CFC:

"Thanks for everything you do. Here is the story of two heroin addicts and the unbelievable story of survival is a true miracle because of people like you. I had zero chance of survival and I survived  $\textcircled$ our son's prognosis of cerebral palsy. I had 14 years of heroin addiction, overdoses, infections, facing prison...because of people like you, this (success) was possible. No judgment from the start and believing in something that could never happen...but you did. Thank you!!! We love our baby and love life and know how precious it is and the second chance we have been given. We will work to do more good in our sober life and pay it forward."

The success stories are abundant, thanks to the special dedication and effort of our Judges and so many others. The success stories give us all renewed hope and remind us why we enlisted in this work to begin with. I hope you will support this request that will provide for the continued success of treatment courts in Oregon.
