

No One can OPT-OUT of a Declared Emergency.

There wouldn't be a purposed bill if permission were not being requested to violate the rights of its citizens.

This Bill is a Red-Flag of Abuse of Power being administered within the Educational District, by means of the Medical Institutions. And it should be carefully scrutinized.

There are already strategies being formed to apply pressure to the students whom wish to not be involved in a Conflict of Interest with cross-agency collaboration of Education and Medical Departments. Barriers will inevitably include blame placed on parents and students for standing up for appropriate boundaries, and make them feel like a social outcast among peers and administrators that their truths are unacceptable which fall more in line with Liberty and appropriateness than the Proposed Law. Our children, students, minors and US Citizens should not have to sacrifice these American morals, ethics, and values when they enter into the public school system in order to receive an education.

When I was in High School, we were surveyed in these exact areas already without this Proposed Law being in effect, therefore this Declared Emergency Agenda is completely unnecessary being disguised as an optional survey. There is already the ability to survey students in the areas described. Additionally, there is already plenty of data for adults to access when addressing the needs of the disparities all Citizens suffer from.

And what exactly is the Emergency? On what grounds is there an emergency and this bill does not decipher what the results of this Declared Emergency would change or benefit the people abiding by it, or would be forced to follow. This bill needs to be rewritten to distinguish clarity of the purposes being implemented, or completely vacated.

There are other ways to solve the issues at hand in the form of medical needs of minors; such as creating equality in accessing our chosen doctor provider whom do not violate our personal beliefs and religion. Please pursue the appropriate avenues that do not violate the rights of all citizens and the rule of other laws that are constitutional rights.

Additionally, it is pointless to add an opt-in, opt-out amendment to a bill that is a civil rights nightmare. The Bill itself is in violation of the Constitution.

It is my opinion, as a United States Citizen, that House Bill 4132 is Unconstitutional and a Conflict of Interest. There is a breach of medical privacy between appropriate relationships such as the patient and their chosen provider. This Bill is a short-cut to addressing problems which violates the rights of its citizens. It is never an emergency to violate human and personal rights of any citizen adult and adolescent. There is a functional rule of law procedure for the purpose of correcting humans in violation of safe and ethical behavior which should be followed accordingly. This is a back-door bill, declaring a medical emergency, against all of its own citizens. This House Bill, if passed, would add unethical regulations for all people to strip our children of their anonymity and force them to participate in scientific studies. Never should there be medical providers or scientific studies embedding themselves into the curriculum, and seat-time removed away from, during the education of Minors. Citizens are already being Doctored-to-death. I ask that you please leave our children out of this political fight against releasing our rights to more regulations; and please make-sure that minors are not responsible for being the tipping point of holding adults accountable. If appropriate and interested educational curriculum were being administered in schools via the Dept of Education, the Medical Field would not feel the need to breach the boundaries of the Liberty and Rights of US Citizens. All problems can be solved by adjusting school curriculum without the overreach of doctors. Even Doctors experience human-error. We need to uphold these values and pave the way by being appropriate role models for American Minors including in our rules of law, no exceptions. There are no short-cuts to doing things the right way for the appropriate results making way for prosperity and longevity, unless we violate our own Truth and Justice system. That is what will result if this Bill is passed.
