Demand Letter / Cease and Desist

Let it be known this day Wednesday February 12<sup>th</sup>, 2020, that Zachary Davis is requesting an immediate Appeal of this Exclusion Notice (see copy). Furthermore Zachary has testified as a member to a (SHAC) Sheltered and Homeless Advocacy Coalition that he was in no way engaged in ANY illegal activity that would cause warrant of this exclusion. He has stated that the "Charging Box was already damaged when he approached it and there were NO signs that indicated the Charging Box wasn't available for public use.

Zachary is an Activist with the Homeless Citizen's Movement and is helping us Discover Charging stations in Public or Publicly funded Buildings available to Homeless Citizens.






agreement under Federal Disability Law

**\*\*\* NOTICE \*\*\***

1. If the disposition on the reverse includes an exclusion, you are excluded under the provisions of Salem Area Mass Transit District Ordinance #2000-01, #2000-03, and/or #2004-01. During the period of the exclusion, you are prohibited from entering or remaining at either: all locations of Salem Area Mass Transit District facilities, buildings, and vehicles – including all transit centers, all buildings, all shelters, and all buses on any route, or as specified in the disposition section on the front of the form.
2. If you enter or remain upon any part of the Salem Area Mass Transit District premises or vehicles from which you are excluded, you may be arrested and prosecuted for the crime of Criminal Trespass in the Second Degree (ORS 164.245).
3. No police officer or Salem Area Mass Transit District employee has the authority to grant you permission to be in or on Salem Area Mass Transit District property or vehicles in violation of this exclusion notice.

**\*\*\* APPEAL RIGHTS \*\*\***

To contest your exclusion, you must mail or have delivered a written appeal to:

The written appeal must be received no later than ten (10) days after the date of your written Notice of Exclusion. The written appeal must contain a statement setting forth the reason the exclusion should be rescinded, altered, or reduced. The written appeal must also contain a copy of your Notice of Exclusion form. The Hearings Officer has the authority to rescind the exclusion, alter the places of exclusion, reduce the duration of the exclusion, or allow the exclusion to stand as issued.

If the written appeal does not include a statement requesting a hearing in person, your appeal will be decided based upon the information in your written appeal and a decision will be made in writing within ten (10) days after receipt of the appeal. If the written appeal includes a statement requesting a hearing in person, a hearing will be conducted by the Hearings Officer within ten (10) days after the receipt of the appeal, and a decision will be made within fifteen (15) days after the hearing.

You may also petition to the Hearings Officer for an emergency temporary waiver of the exclusion. This waiver may be granted at the discretion of the Hearings Officer.

**Subject:** Motion to Acquit/Cease and Desist/Reasonable Request

Dear State of Oregon, Portland/Gresham Multnomah County CoC, Trimet, and any/all relevant parties connected by agreements, contracts, or partnerships to said agencies,

After significant research, the undersigned has determined that the DOJ, FBI, and all other members of the Portland Police Bureau's Criminal Investigations Unit and all members of the **Oregon Department of Justice - Criminal Justice Division's Oregon TITAN Fusion Center** are directly involved in the Targeted Individual Program, attacking civilians with psychological torture techniques, including stalking, gangstalking, harassment, and intimidation.

Furthermore, all members of the Portland/Gresham Multnomah County CoC Trimet, and Homes for Everyone Executive Committee and Coordinating Board and any and all parties involved in the alleged attempted murder, and conspiracy to cover up the attempted murder of Daniel J. Hoffman as well as any suppression of his constitutional rights including the right to due process and cease any actions that violate





the Freedom Of information Act. As indicated by Mr.Hoffman's evidence and Testimony stored on the online publication and connected web pages of [portlandaltdelete.yolasite.com](http://portlandaltdelete.yolasite.com), [shacattack.yolasite.com](http://shacattack.yolasite.com), [portlandhousinglast.yolasite.com](http://portlandhousinglast.yolasite.com) and [homelessaltdelete.yolasite.com](http://homelessaltdelete.yolasite.com)

Let this notice also inform any press our journalist enterprises that have also complied with these illegal activities to henceforth cease any and all censorship of this information and resume reporting on all issues that effect the common welfare of the citizens of Oregon.

I, Daniel J. Hoffman, demand an explanation for these activities and compensation for pain, suffering, and illegal torture.

Also, Pursuant to ORS 136.445, unless any of the herein mentioned agencies or agents of said agencies can immediately produce any evidence of the crimes for which I have been targeted, I am asking the honorable judges to grant this Motion For Acquittal and immediately award a ruling in the favor of the defendant, Daniel J. Hoffman, as may be indicated by suspicion on any subpoenas or warrants signed by any Oregon Judge.

As you are leaders in Law Enforcement and Public Service, I demand that you immediately CEASE AND DESIST your illegal activities, including the use of government personnel and any external groups, which may also be participating. Such operations are in violation of Article 32 of the Geneva Conventions (psychological torture) and numerous Federal & State laws.

This CEASE AND DESIST ORDER is to inform you that your conspiracy to commit torture, harassing, stalking, and intimidation actions are illegal and will not be tolerated. I demand that you immediately CEASE AND DESIST. Should you continue to pursue these activities in violation of this CEASE AND DESIST ORDER, we will not hesitate to pursue further legal action against you.

Furthermore, as publicly funded agencies I would like you to also consider this a reasonable request by an individual with disabilities, to halt all of the above behavior and any future planned behavior that is connected to your current actions, as your actions are and have been exasperating my symptoms and are causing me great physical/mental harm, physical/mental stress, and physical/mental fatigue.

You may have already violated numerous Federal laws, including:

- 18 U.S. Code § 2381; Treason.
- 18 U.S. Code § 2340; (c) Conspiracy to commit torture.
- 18 U.S. Code § 2382; Misprision of Treason.
- 18 U.S. Code § 2384; Seditious Conspiracy.
- 18 U.S. Code § 2389; Recruiting for service against the United States.
- 18 U.S. Code § 241; Conspiracy to Deprive Constitutional Rights.
- 18 U.S. Code § 242; Deprivation of Constitutional Rights.
- 18 USC § 2261A; Interstate Stalking.
- 18 USC § 875(c); Interstate Communications.



Dear Senator and Representative,

Today, once more, I have walked into your offices, as a Voter in your respective Districts, to request that Justice be enforced on the criminals who have suppressed my constitutional rights, made an alleged attempt on my life and/or psychological torture, violated disability laws both State and Federal, Misappropriated Public Funds and tax-payer money, violated their own city and county ordinances, and have been both negligent and intentionally intimidating as well as threatening and coercive in their treatment of the citizens who receive public assistance from them. They have abused their authority (not that they have authority other than what the citizens have faithfully entrusted them in their administering of provisions to the poor and the needy citizens of Oregon) and have violated their own agreements in the operations and governance of the provisions that are meant for the poor.

I still have not spoken directly to either of my State Representatives nor has my evidence and Testimony been allowed to be submitted.

As YOU, Senator Burdick are the Senate Majority Leader and YOU, Representative Lawrence Spence are a member of the Public Safety Ways and Means Committee that oversees the Oregon Criminal Justice Commission, are both in positions to demand from Law enforcement that investigations into these crimes happen I am, as a voter in your Districts requesting, as a reasonable request, and as someone who suffers from multiple disabilities in the State of Oregon, including PTSD, Heart Disease, Kidney Disease, Anxiety and Panic attack Disorder, that you encourage a State congressional Task Force to investigate this level of corruption and use my testimony and evidence to illustrate the oppression that is happening to the poor and homeless community of Oregon and offer this evidence and testimony to support Homeless Citizens as a protected class?

To summarize this evidence:

In early October I filed grievances with Transition Projects Inc., for a policy that we participants felt violated disability rights and was counter to the stated policies and rhetoric that drew us into the River District Navigation Center Shelter.

I began, while staying in the shelter to educate my fellow participants in regards to their rights and organize us into an organization called SHAC- Sheltered and Homeless Advocacy Coalition and the Homeless Citizens Movement in order to strengthen our voice by unity and make known the ineffective policies in place in Portland as well as the truth behind the funding of the River District Navigation Center.

During this period, as was being followed and stalked by an unknown entity, had an attack on my life in the middle of the night by what I believe was shelter staff and shelter participants who may have been incentivised in some way to participate. What really happened is unclear to me because I went

- 1) Emergency
- 2) Are the shelters, governance, and policies actually in the self-interest of the homeless citizens,
- 3) Poverty is a step down from homelessness NOT a step up.
- 4) The current PIT is not an undercount; it is an overcount.  
The current federal barriers in place prevent the largest population of homeless citizens from meeting the requirements of Public Housing.



In any action in which a party alleges that an act, policy or practice of a public body, as defined in ORS 174.109 (“Public body” defined), or of any officer, employee or agent of a public body as defined in ORS 174.109 (“Public body” defined), is unconstitutional or is otherwise contrary to law, the party may continue to prosecute the action and the court may issue a judgment on the validity of the challenged act, policy or practice even though the specific act, policy or practice giving rise to the action no longer has a practical effect on the party if the court determines that:

- (1) The party had standing to commence the action;
- (2) The act challenged by the party is capable of repetition, or the policy or practice challenged by the party continues in effect; **and**
- (3) The challenged policy or practice, or similar acts, are likely to evade judicial review in the future. [2007 c.770 §1]
