





This CEASE AND DESIST ORDER is to inform you that your conspiracy to commit torture, harassing, stalking, and intimidation actions are illegal and will not be tolerated. I demand that you immediately CEASE AND DESIST. Should you continue to pursue these activities in violation of this CEASE AND DESIST ORDER, we will not hesitate to pursue further legal action against you.

Furthermore, as publicly funded agencies I would like you to also consider this a reasonable request by an individual with disabilities, to halt all of the above behavior and any future planned behavior that is connected to your current actions, as your actions are and have been exasperating my symptoms and are causing me great physical/mental harm, physical/mental stress, and physical/mental fatigue.

You may have already violated numerous Federal laws, including:

- 47 USC § 223(a)(1)(c); Harassing Telephone Calls.
- 18 U.S. Code § 1961; Organized Crime Control Act of 1980. (RICO)

Should you choose to continue your current activities, I will not hesitate to exercise my constitutional rights of free speech and publicly expose your ongoing criminal activity.
