Senator Boquist,

The most likely price imposed on a gallon of gas in the year 2021, at the time of implementation of HB 2020, would be about 22 cents.

In the other estimates you mention, they seem to refer to the price in 2016 or 2018 dollars. Some also reference the "floor price" as the lowest likely price "at Least" price.

As far as we are concerned, The state does not receive revenue in 2016 or 2018 dollars, We get the revenue in current year dollars, so no inflation adjustment is relevant in this case. Moreover, the "at least" price is a hard floor price and not the most likely to transpire.

Each dollar of the emission allowance price translates to about 0.985 cents for gallon of gas.
