The following employees of Tri-County Metropolitan Transportation District of Oregon (TriMet), which are members of the Amalgamated Transit Union (ATU), strongly oppose the State of Oregon removing authority given to Oregon law enforcement officers to enforce public transportation fare violation codes. HB-4097 negatively impacts mass transit districts' ability to maintain peace and order under the authority given to Oregon Peace Officers.

TriMet serves a diverse population, encompassing 533 square miles of the Portland Metro area, providing mobility services to approximately 310,000 riders per weekday.

We believe law enforcement is needed to assist in fare enforcement for the following concerns. Police presence is needed to:

- Immediately enforce and identify any uncooperative violator in a fair and equitable manner
- Immediately address harassing and threatening behavior toward TriMet employees and the public
- Immediately enforce interdiction commands, behavioral exclusions, and individuals who are interfering with public transportation
- Investigate time-sensitive safety and security issues that are above and beyond the scope of TriMet employees
- Encourage voluntary compliance with all TriMet code and reduce overall criminal activity

TriMet has enacted several codes to protect riders from unfair and/or biased treatment (TriMet Code Chapter 29) to create a cost saving, self-service, barrier-free fare collection system available to all community members, regardless of socioeconomic status. To ensure safety and security to riders, Oregon Revised Statutes (ORS) 267.140 mandates TriMet's General Manager shall enforce all ordinances adopted by the Board of Directors, which includes giving Oregon Peace Officers authority to enforce TriMet Codes under Chapter 28 & 29.
