"The CASA's report is always at least as important to me as the DHS caseworker's report, and sometimes more so. Often, this is because the CASA has the time to provide me with more details about the child(ren) than does the caseworker, especially in families where there are multiple children with varying strengths, needs, interests, and activities. I used to 'ration' my CASA appointments very carefully because there were nowhere near enough CASA volunteers to go around, but now I appoint a CASA in each case where I feel one could be beneficial to the family. the expansion of this essential resource."

Douglas County

"Here in Douglas County we have had an astounding rise in children entering the child welfare system...a near 300 percent increase over the last 5 years. No one does more to protect these children than CASA. Currently, only about half of the cases in my judicial district have CASAs assigned. I firmly believe that cases where a CASA is assigned have more successful outcomes and lower rates of child abuse. Ideally, every child in foster care would have a CASA assigned to them."

And a judge without a CASA is at a real disadvantage in her pursuit of true justice for the children who most need it."

"I appoint a CASA for every child placed in foster care, although there are not enough volunteers to be assigned to each child or family of siblings, because a CASA reminds me to focus on the needs of the child. I rely on the thorough reports from CASA...to remember why we are doing this important work to prevent further abuse or neglect or risk of harm to this child. I can't imagine a juvenile system without them."
