**Measure Description:**

Modifies statewide greenhouse gas emissions reduction goals.

**Analysis:**

This fiscal impact statement is for the purpose of transmitting the measure from the House Committee on Energy and Environment to the House Committee on Rules.

The measure modifies state greenhouse gas emissions reduction goals, to at least 45 percent below 1990 emissions levels by 2035; and to at least 80 percent below 1990 emissions levels by 2050. Emissions reductions programs are part of the newly-created Oregon Climate Action Program.

The measure is anticipated to have an impact on the Bureau of Labor and Industries, Cities, Construction Contractors Board, Counties, Department of Administrative Services, Department of Consumer and Business Services, Department of Energy, Department of Environmental Quality, Department of Forestry, Department of Justice, Department of Revenue, Department of State Lands, Employment Department, Higher Education Coordinating Commission, Housing and Community Services Department, Legislative Assembly, Legislative Fiscal Office, Legislative Revenue Office, Office of the Governor, Oregon Business Development Department, Oregon Department of Agriculture, Oregon Department of Transportation, Oregon Health Authority, Oregon Health Sciences University, Oregon Judicial Department, Oregon State Police, Oregon State Treasurer, Oregon Watershed Enhancement Board, Public Utility Commission, Special Districts, Water Resources Department, and Public Universities.

A more complete fiscal analysis on the measure will be prepared as the measure is considered in the House Committee on Rules.
