Summary of Revenue Changes

House Bill 4031 appropriates \$606,246 General Fund to produce the assessment required by this bill.

Summary of Human Services Subcommittee Action

House Bill 4031 directs the Oregon Health Authority (OHA) to prepare an analysis of the supply and demand for behavioral health professionals in Oregon over the next 10 years and submit the report by December 1, 2020. The Human Services Subcommittee recommended \$606,246 General Fund be added to OHA’s 2019-21 budget on a one-time basis. This includes one limited duration Operations and Policy Analyst 3 position (0.42 FTE) to coordinate the contract and produce the report, as well as \$500,000 to contract with a consultant to complete the assessment. The consultant will work with the Oregon Department of Education, the Higher Education Coordination Commission, and relevant professional licensing boards in producing the report.
