#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Provides that student who legally entered United States under Compact of Free Association treaty between United States and Republic of Palau, Republic of the Marshall Islands or Federated States of Micronesia and who has not previously established residence in any state or territory of United States other than Oregon qualifies for exemption from nonresident tuition and fees at public universities and is eligible to receive state and university scholarships or other financial aid.

Provides that student who is refugee or special immigrant visa holder and who has not previously established residence in any state or territory of United States other than Oregon qualifies for exemption from nonresident tuition and fees at public universities and is eligible to receive state and university scholarships or other financial aid. **Directs Higher Education Coordinating Commission to provide mission differentiation** 

Directs Higher Education Coordinating Commission to provide mission differentiation funding if specified enrollment threshold is met.

Declares emergency, effective on passage.

### A BILL FOR AN ACT

2 Relating to higher education tuition; creating new provisions; amending ORS 350.240, 352.287 and

3 353.123; and declaring an emergency.

#### 4 Be It Enacted by the People of the State of Oregon:

**SECTION 1.** ORS 352.287 is amended to read:

6 352.287. (1) The governing board of a public university listed in ORS 352.002 shall exempt a 7 student who is not a citizen or a lawful permanent resident of the United States from paying non-8 resident tuition and fees for enrollment as an undergraduate student and as a graduate student in 9 a degree program at a public university listed in ORS 352.002 if the student:

(a) During each of the three years immediately prior to receiving a high school diploma or a
 modified diploma or leaving school before receiving a high school diploma or a modified diploma,
 attended an elementary or a secondary school in this state;

(b) During each of the five years immediately prior to receiving a high school diploma or a
modified diploma or leaving school before receiving a high school diploma or a modified diploma,
attended an elementary or a secondary school in any state or territory of the United States, the
District of Columbia or the Commonwealth of Puerto Rico;

(c) Received a high school diploma or a modified diploma from a secondary school in this stateor received the equivalent of a high school diploma; and

1 submitting to the public university the student attends or plans to attend an official copy of the 2 student's application to register with a federal immigration program or federal deportation deferral

program or a statement of intent that the student will seek to obtain citizenship as permitted underfederal law.

5 (2) The governing board shall exempt a student who is financially dependent upon a person who 6 is not a citizen or a lawful permanent resident of the United States from paying nonresident tuition 7 and fees for enrollment as an undergraduate student and as a graduate student in a degree program 8 at a public university listed in ORS 352.002 if the student:

9 (a) During each of the three years immediately prior to receiving a high school diploma or a 10 modified diploma or leaving school before receiving a high school diploma or a modified diploma, 11 attended an elementary or a secondary school in this state and resided in this state with the person 12 upon whom the student is dependent;

(b) During each of the five years immediately prior to receiving a high school diploma or a
modified diploma or leaving school before receiving a high school diploma or a modified diploma,
attended an elementary or a secondary school in any state or territory of the United States, the
District of Columbia or the Commonwealth of Puerto Rico and resided with the person upon whom
the student is dependent;

(c) Received a high school diploma or a modified diploma from a secondary school in this stateor received the equivalent of a high school diploma; and

(d) For a student who is not already a citizen or lawful permanent resident of the United States,
shows intention to become a citizen or a lawful permanent resident of the United States by submitting to the public university the student attends or plans to attend an official copy of the student's
application to register with a federal immigration program or federal deportation deferral program
or a statement of intent that the student will seek to obtain citizenship as permitted under federal
law.

(3) A student who is a citizen or a lawful permanent resident of the United States and who has
resided outside of Oregon for more than three years while serving in the Armed Forces of the
United States, but who otherwise meets the requirements of subsection (1) or (2) of this section, shall
qualify for exemption from nonresident tuition and fees for enrollment as an undergraduate student
and a graduate student in a degree program at a public university listed in ORS 352.002 without
having to reestablish residency in Oregon.

(4) A student who is a COFA islander and who has not previously established residence
in any state or territory of the United States or the District of Columbia other than Oregon
shall qualify for exemption from nonresident tuition and fees for enrollment as an undergraduate student and a graduate student in a degree program at a public university listed in
ORS 352.002.

(5) A student who is a refugee or special immigrant visa holder and who has not previously established residence in any state or territory of the United States or the District of
Columbia other than Oregon shall qualify for exemption from nonresident tuition and fees
for enrollment as an undergraduate student and a graduate student in a degree program at
a public university listed in ORS 352.002.

43 [(5)] (7) Not later than July 1 of each year, the Higher Education Coordinating Commission shall

3 **SECTION 5.** The Higher Education Coordinating Commission shall provide that any public

4 university listed in ORS 352.002 that enrolls \_\_\_\_\_ or more COFA islanders who qualify for

5 exemption from nonresident tuition and fees under ORS 352.287 shall receive mission differ-

6 entiation funding in the public university support fund distribution formula.

7 <u>SECTION 6.</u> This 2020 Act being necessary for the immediate preservation of the public 8 peace, health and safety, an emergency is declared to exist, and this 2020 Act takes effect 9 on its passage.
