

## HOUSE AMENDMENTS TO HOUSE BILL 4107

- 1 On page 1 of the printed bill, line 2, after “provisions;” insert “and”.
- 2 Delete lines 8 through 23.
- 3 On page 2, delete lines 1 through 24 and insert:
- 4 **“SECTION 1. (1) Except as provided in subsection (2) of this section, it is an unlawful**
- 5 **practice for a place of public accommodation, as defined in ORS 659A.400, offering goods or**
- 6 **services, or any person acting on behalf of such place, to:**
- 7 **“(a) Refuse to accept from a customer or patron United States coins and currency, in-**
- 8 **cluding federal reserve bank notes and circulating notes of federal reserve banks and na-**
- 9 **tional banks, as payment for goods and services.**
- 10 **“(b) Make any distinction, discrimination or restriction because a customer or patron**
- 11 **offers United States coins and currency, including federal reserve bank notes and circulating**
- 12 **notes of federal reserve banks and national banks, as payment for goods and services.**
- 13 **“(2) Notwithstanding subsection (1) of this section, a place of public accommodation, or**
- 14 **any person acting on behalf of such place, may refuse to accept as payment for goods and**
- 15 **services:**
- 16 **“(a) United States coins, in any combination, in an amount equal to or greater than \$100;**
- 17 **or**
- 18 **“(b) United States currency in denominations of \$50 or \$100.**
- 19 **“(3) This section does not apply to:**
- 20 **“(a) A place of public accommodation that is owned or maintained by a public body, as**
- 21 **defined in ORS 174.109;**
- 22 **“(b) Any service to the public, other than public transportation services, that is provided**
- 23 **by a public body, as defined in ORS 174.109;**
- 24 **“(c) Farmers’ markets or roadside stands;**
- 25 **“(d) Transactions occurring on aircraft;**
- 26 **“(e) Transactions for goods or services involving a place or service offering goods, ser-**
- 27 **vices, transient lodging or transportation, when the transaction or a portion of the trans-**
- 28 **action requires a customer or patron to deposit moneys or sign an agreement to rent or**
- 29 **lease consumer goods;**
- 30 **“(f) Any establishment that is owned by or operated under the control of the United**
- 31 **States Government or an agency of the United States;**
- 32 **“(g) Retail transactions that occur entirely over the telephone or by mail;**
- 33 **“(h) Internet-based transactions;**
- 34 **“(i) The purchase of Class 1 flammable liquids, as defined in ORS 480.310, at a filling**
- 35 **station, service station, garage or other dispensary where Class 1 flammable liquids are dis-**

1 **pensed;**

2 **“(j) Electric vehicle charging stations;**

3 **“(k) Transactions that occur in a micro market, including purchases from a vending**

4 **machine;**

5 **“(L) Purchases from a vending machine unless the vending machine is located within a**

6 **concentration or cluster of more than eight vending machines that do not accept coins or**

7 **currency as payment for purchases;**

8 **“(m) Transactions involving the sale of products for which a license is required by ORS**

9 **744.053; or**

10 **“(n) A place of public accommodation that provides hospital or medical services and that**

11 **bills or invoices a person after such services are rendered, provided that the place of public**

12 **accommodation accepts coins and currency as payment for the bill or invoice by mail or at**

13 **a designated location other than the location where the services are rendered.**

14 **“(4) Nothing in this section may be construed to prohibit, restrict, or otherwise interfere**

15 **with the ability of a place of public accommodation to:**

16 **“(a) Accept, in addition to the forms of payment described under subsection (1) of this**

17 **section, as payment for goods or services, any other form of payment provided that such**

18 **payment is not prohibited under federal or state law;**

19 **“(b) After services are rendered, invoice or bill a customer or patron, or submit a claim**

20 **to a third party to receive payment for the services; or**

21 **“(c) Offer a customer or patron an incentive for paying for goods or services in coin or**

22 **currency.**

23 **“(5) A person who alleges a violation of subsection (1) of this section may file a complaint**

24 **with the Commissioner of the Bureau of Labor and Industries in the manner provided by**

25 **ORS 659A.820.**

26 **“(6) As used in this section:**

27 **“(a) ‘Consumer goods’ has the meaning given that term in ORS 79.0102.**

28 **“(b)(A) ‘Internet-based transaction’ means a transaction that occurs over the Internet**

29 **and that involves a sale, purchase or reservation of or deposit for goods or services to be**

30 **picked up by, delivered to or consumed by a customer or patron.**

31 **“(B) ‘Internet-based transaction’ does not mean an in-person transaction.**

32 **“(c) ‘Micro market’ means an unattended retail establishment to which access by the**

33 **general public is restricted that offers whole or fresh-cut fruit and vegetables, packaged**

34 **foods or beverages for purchase through an automated payment processing system.**

35 **“(d) ‘Transient lodging’ has the meaning given that term in ORS 699.005.**

36 **“(e) ‘Vending machine’ has the meaning given that term in ORS 624.310.**

37 **“SECTION 1a. Section 1 of this 2020 Act is amended to read:**

38 **“Sec. 1. (1) Except as provided in subsection (2) of this section, it is an unlawful practice for**

39 **a place of public accommodation, as defined in ORS 659A.400, offering goods or services, or any**

40 **person acting on behalf of such place, to:**

41 **“(a) Refuse to accept from a customer or patron United States coins and currency, including**

42 **federal reserve bank notes and circulating notes of federal reserve banks and national banks, as**

43 **payment for goods and services.**

44 **“(b) Make any distinction, discrimination or restriction because a customer or patron offers**

45 **United States coins and currency, including federal reserve bank notes and circulating notes of**

1 federal reserve banks and national banks, as payment for goods and services.

2 “(2) Notwithstanding subsection (1) of this section, a place of public accommodation, or any  
3 person acting on behalf of such place, may refuse to accept as payment for goods and services:

4 “(a) United States coins, in any combination, in an amount equal to or greater than \$100; or

5 “(b) United States currency in denominations of \$50 or \$100.

6 “(3) This section does not apply to:

7 “(a) A place of public accommodation that is owned or maintained by a public body, as defined  
8 in ORS 174.109;

9 “(b) Any service to the public, other than public transportation services, that is provided by a  
10 public body, as defined in ORS 174.109;

11 “(c) Farmers’ markets or roadside stands;

12 “(d) Transactions occurring on aircraft;

13 “(e) Transactions for goods or services involving a place or service offering goods, services,  
14 transient lodging or transportation, when the transaction or a portion of the transaction requires  
15 a customer or patron to deposit moneys or sign an agreement to rent or lease consumer goods;

16 “(f) Any establishment that is owned by or operated under the control of the United States  
17 Government or an agency of the United States;

18 “(g) Retail transactions that occur entirely over the telephone or by mail;

19 “(h) Internet-based transactions;

20 “(i) The purchase of Class 1 flammable liquids, as defined in ORS 480.310, at a filling station,  
21 service station, garage or other dispensary where Class 1 flammable liquids are dispensed;

22 “(j) Electric vehicle charging stations;

23 “(k) Transactions that occur in a micro market, including purchases from a vending machine;

24 “(L) Purchases from a vending machine unless the vending machine is located within a concen-  
25 tration or cluster of more than eight vending machines that do not accept coins or currency as  
26 payment for purchases;

27 “(m) Transactions involving the sale of products for which a license is required by ORS 744.053;  
28 or

29 “(n) A place of public accommodation that provides hospital or medical services and that bills  
30 or invoices a person after such services are rendered, provided that the place of public accommo-  
31 dation accepts coins and currency as payment for the bill or invoice by mail or at a designated lo-  
32 cation other than the location where the services are rendered.

33 “(4) Nothing in this section may be construed to prohibit, restrict, or otherwise interfere with  
34 the ability of a place of public accommodation to:

35 “(a) Accept, in addition to the forms of payment described under subsection (1) of this section,  
36 as payment for goods or services, any other form of payment provided that such payment is not  
37 prohibited under federal or state law;

38 “(b) After services are rendered, invoice or bill a customer or patron, or submit a claim to a  
39 third party to receive payment for the services; or

40 “(c) Offer a customer or patron an incentive for paying for goods or services in coin or cur-  
41 rency.

42 “(5) A person who alleges a violation of subsection (1) of this section **may bring a civil action**  
43 **under ORS 659A.885 or** may file a complaint with the Commissioner of the Bureau of Labor and  
44 Industries in the manner provided by ORS 659A.820.

45 “(6) As used in this section:

1           “(a) ‘Consumer goods’ has the meaning given that term in ORS 79.0102.  
2           “(b)(A) ‘Internet-based transaction’ means a transaction that occurs over the Internet and that  
3 involves a sale, purchase or reservation of or deposit for goods or services to be picked up by, de-  
4 livered to or consumed by a customer or patron.  
5           “(B) ‘Internet-based transaction’ does not mean an in-person transaction.  
6           “(c) ‘Micro market’ means an unattended retail establishment to which access by the general  
7 public is restricted that offers whole or fresh-cut fruit and vegetables, packaged foods or beverages  
8 for purchase through an automated payment processing system.  
9           “(d) ‘Transient lodging’ has the meaning given that term in ORS 699.005.  
10          “(e) ‘Vending machine’ has the meaning given that term in ORS 624.310.”.  
11          On page 4, line 7, after “class” insert a period and delete the rest of the line and line 8.  
12          On page 17, after line 37, insert:  
13          “**SECTION 11. (1) Section 1 of this 2020 Act becomes operative on July 1, 2021.**  
14          **“(2) The amendments to section 1 of this 2020 Act and ORS 659A.885 by sections 1a and**  
15 **6 to 10 of this 2020 Act become operative on January 1, 2022.**  
16          **“(3) The Commissioner of the Bureau of Labor and Industries may adopt rules and take**  
17 **any action before the operative dates specified in subsections (1) and (2) of this section that**  
18 **is necessary for the commissioner to exercise, on or after the operative dates specified in**  
19 **subsection (1) of this section, all the duties, functions and powers conferred on the commis-**  
20 **sioner by sections 1 and 1a of this 2020 Act and the amendments to ORS 659A.885 by sections**  
21 **6 to 10 of this 2020 Act.”.**  
22          In line 38, delete “11” and insert “12”.
