SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Declares Oregon policy regarding Indian children. Modifies Oregon child welfare laws regarding Indian children to [conform] reconcile with provisions of federal Indian Child Welfare Act.

7	Whereas current research shows that family, culture and community promote resiliency and	
8	health development in Indian children; and	
9	Whereas Congress, working with tribal nations, tribal leadership and advocates for Indian chil-	
10	dren, passed the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) in 1978 to stop the removal of	
11	Indian children from their homes, families and communities; and	
12	Whereas at the time Congress passed the Indian Child Welfare Act, Indian children were being	
13	removed by public and private agencies at rates as high as 25 percent to 35 percent; and	
14	Whereas Indian children continue to be removed from their homes at rates higher than other	
15	non-Indian children; and	
16	Whereas despite requirements under the Indian Child Welfare Act, application of the Indian	
17	Child Welfare Act in Oregon courts is inconsistent; and	
18	Whereas clearly addressing in state law the coordination between and respective roles of the	
19	state and tribes regarding the provision of child welfare services to Indian children will provide	
20	uniform and consistent direction to state courts, tribes and practitioners to prevent unlawful re-	
21	movals of Indian children from their families and promote the stable placement of Indian children	
22	in loving, permanent homes that are connected to family and culture; now, therefore,

25	OREGON INDIAN CHILD WELFARE	
26	(Policy Regarding Indian Children)	
27		
28	SECTION 1. The Legislative Assembly finds that the United States Congress recognizes	

the special legal status of Indian tribes and their members. It is the policy of the State of 1 Oregon to protect the health and safety of Indian children and the stability and security of 2 Indian tribes and families by promoting practices designed to prevent the removal of Indian 3 children from their families and, if removal is necessary and lawful, to prioritize the place-4 ment of an Indian child with the Indian child's extended family and tribal community. The 5 state recognizes the inherent jurisdiction of Indian tribes to make decisions regarding the 6 custody of Indian children. The state also recognizes the importance of ensuring that Indian 7 children and Indian families receive appropriate services to obviate the need to remove an 8 9 Indian child from the Indian child's home and, if removal is necessary and lawful, to effect the child's safe return home. Sections 1 to 22 of this 2020 Act create additional safeguards 10 for Indian children to address disproportionate rates of removal, to improve the treatment 11 12 of and services provided to Indian children and Indian families in the child welfare system and to ensure that Indian children who must be removed are placed with Indian families, 13 communities and cultures. 14 15 16(Definitions; Custody; Parentage; Best Interests of Indian Child; Domicile; 17 18 Indian Child's Tribe) 19 SECTION 2. Definitions. As used in sections 1 to 22 of this 2020 Act, unless the context 20provides otherwise: 2122(1) "Emergency proceeding" means any court action that involves the emergency removal or emergency placement of an Indian child, including removal under ORS 419B.150, 23with or without a protective custody order, or a shelter care proceeding under ORS 419B.185. 2425(2)(a) "Extended family member" has the meaning given that term by the law or custom of an Indian child's tribe. 2627(b) If the meaning of "extended family member" cannot be determined under paragraph (a) of this subsection, "extended family member" means a person who has attained 18 years 28of age and who is the Indian child's grandparent, aunt, uncle, brother, sister, sister-in-law, 2930 brother-in-law, niece, nephew, first cousin, second cousin, stepparent or, as determined by 31 the Indian child's tribe, clan or band member. (3) "Indian" means a person who is a member of an Indian tribe or who is an Alaska 32Native and a member of a regional corporation as defined in section 7 of the Alaska Native 33 34 Claims Settlement Act (43 U.S.C. 1606). 35 (4) "Indian child" means any unmarried person who has not attained 18 years of age and: (a) Is a member or citizen of an Indian tribe; or 36 37 (b) Is eligible for membership or citizenship in an Indian tribe and is the biological child 38 of a member of an Indian tribe. (5) "Indian custodian" means an Indian, other than the Indian child's parent, who has 39 custody, as described in section 3 (1) of this 2020 Act, of the Indian child, or to whom tem-40 porary physical care, custody and control has been transferred by the Indian child's parent. 41 (6) "Indian tribe" or "tribe" means any Indian tribe, band, nation or other organized 42 group or community of Indians federally recognized as eligible for the services provided to 43 Indians by the United States Secretary of the Interior because of their status as Indians, 44 including any Alaska Native village as defined in 43 U.S.C. 1602(c). 45

(7) "Juvenile court" has the meaning given that term in ORS 419A.004. 1 2 (8) "Member" or "membership" means a determination by an Indian tribe that a person is a member or citizen in that Indian tribe. 3 (9) "Parent" means: 4 5 (a) A biological parent of an Indian child; (b) An Indian who has lawfully adopted an Indian child, including adoptions made under 6 7 tribal law or custom; or (c) A father whose parentage has been acknowledged or established under section 4 of 8 9 this 2020 Act. (10) "Party" or "parties" means parties to a proceeding, as described in ORS 419B.875. 10 (11) "Reservation" means Indian country as defined in 18 U.S.C. 1151 and any lands not 11 12 covered under that section, title to which is held by the United States in trust for the benefit of an Indian tribe or individual or held by an Indian tribe or individual subject to a restriction 13 by the United States against alienation. 14 15 (12) "Tribal court" means a court with jurisdiction over child custody proceedings and that is either a Court of Indian Offenses, a court established and operated under the code 16 or custom of an Indian tribe or any other administrative body of a tribe that is vested with 17 18 authority over child custody proceedings. SECTION 3. Custody of Indian child. (1) An individual has custody of an Indian child 19 under sections 1 to 22 of this 2020 Act if the individual has physical custody or legal custody 20of the Indian child under any applicable tribal law, tribal custom or state law. 2122(2) An Indian child's parent has continued custody of the Indian child if the parent currently has, or previously had, custody of the Indian child. 23(3) For purposes of sections 1 to 22 of this 2020 Act, the following individuals are pre-2425sumed to have continued custody of an Indian child: (a) The Indian child's biological mother. 2627(b) A man who is married to the Indian child's biological mother. (c) A man whose parentage has been acknowledged or established as described in section 284 of this 2020 Act. 2930 SECTION 4. Parentage. In addition to the methods for establishing parentage under ORS 31 109.065, a man's parentage of an Indian child is acknowledged or established for purposes of sections 1 to 22 of this 2020 Act and ORS chapter 419B if the man's parentage has been: 32(1) Established under tribal law; 33 34 (2) Recognized in accordance with tribal custom; or 35 (3) Openly proclaimed by the man to the court, to the Indian child's family, to the De-36 partment of Human Services or to an Oregon licensed adoption agency. 37 SECTION 5. Best interests of Indian child. When making a determination regarding the 38 best interests of an Indian child under sections 1 to 22 of this 2020 Act, ORS chapter 419B, the Indian Child Welfare Act (25 U.S.C. 1901 et seq.) or any regulations or rules regarding 39 sections 1 to 22 of this 2020 Act or the Indian Child Welfare Act, the juvenile court shall, in 40 consultation with the Indian child's tribe, consider the following relevant factors: 41 (1) The protection of the safety, well-being, development and stability of the Indian child; 42 (2) The prevention of unnecessary out-of-home placement of the Indian child; 43

44 (3) The prioritization of placement of the Indian child in accordance with the placement
 45 preferences under section 22 of this 2020 Act;

(4) The value to the Indian child of establishing, developing or maintaining a political, 1 cultural, social and spiritual relationship with the Indian child's tribe and tribal community; 2 and 3 (5) The importance to the Indian child of the Indian tribe's ability to maintain the tribe's 4 existence and integrity in promotion of the stability and security of Indian children and 5 families. 6 SECTION 6. Domicile. For purposes of sections 1 to 22 of this 2020 Act: 7 (1) A person's domicile is the place the person regards as home, where the person intends 8 9 to remain or to which, if absent, the person intends to return. (2) An Indian child's domicile is, in order of priority, the domicile of: 10 (a) The Indian child's parents or, if the Indian child's parents do not have the same 11 12 domicile, the Indian child's parent who has physical custody of the Indian child; (b) The Indian child's Indian custodian; or 13 (c) The Indian child's guardian. 14 SECTION 7. Enrollment. (1) Unless an Indian child's parent objects, the Department of 15 Human Services shall provide assistance with enrolling an Indian child within the juvenile 16 court's jurisdiction under ORS 419B.100 in a tribe with which the child is eligible for enroll-17 18 ment. (2) In any proceeding under ORS chapter 419B where there is reason to know the child 19 is an Indian child and the department reasonably believes that the Indian child is eligible for 20enrollment in a tribe, the department shall notify the Indian child's parent of the parent's 2122right to object to the department's assistance under subsection (1) of this section. 23SECTION 8. Determination of Indian child's tribe. (1) In a proceeding under ORS chapter 419B when there is reason to know that the child is an Indian child, the Indian child's tribe 2425is: (a) If the Indian child is a member of or is eligible for membership in only one tribe, the 2627tribe of which the Indian child is a member or eligible for membership. (b) If the Indian child is a member of one tribe but is eligible for membership in one or 28more different tribes, the tribe of which the Indian child is a member. 2930 (c) If the Indian child is a member of more than one tribe or if the Indian child is not a 31 member of any tribe but is eligible for membership with more than one tribe: (A) The tribe designated by agreement between the tribes of which the Indian child is a 32member or in which the Indian child is eligible for membership; or 33 34 (B) If the tribes are unable to agree on the designation of the Indian child's tribe, the 35 tribe designated by the court. (2) When designating an Indian child's tribe under subsection (1)(c)(B) of this section, the 36 37 court shall, after hearing, designate the tribe with which the Indian child has the more sig-38 nificant contacts, taking into consideration the following: (a) The preference of the Indian child's parent; 39 (b) The duration of the Indian child's current or prior domicile or residence on or near 40 the reservation of each tribe; 41 (c) The tribal membership of the Indian child's custodial parent or Indian custodian; 42 (d) The interests asserted by each tribe; 43 (e) Whether a tribe has previously adjudicated a case involving the Indian child; and 44 (f) If the court determines that the Indian child is of sufficient age and capacity to 45

1 meaningfully self-identify, the self-identification of the Indian child.

(3) If an Indian child is a member of or is eligible for membership in more than one tribe,
the court may, in its discretion, permit the tribes, other than the Indian child's tribe determined under subsection (1) of this section, to participate in a proceeding under ORS chapter
419B involving the Indian child in an advisory capacity or as a party.

(Jurisdiction; Transfer)

9 <u>SECTION 9.</u> Determination of domicile and residence. In any proceeding under ORS 10 chapter 419B involving an Indian child, the juvenile court must determine the residence and 11 domicile of the Indian child and whether the Indian child is a ward of tribal court. The ju-12 venile court shall communicate with any tribal courts to the extent necessary to make a 13 determination under this section.

14 <u>SECTION 9a.</u> <u>Tribal-state agreements.</u> (1)(a) The Department of Human Services shall 15 make a good faith effort to enter into a tribal-state agreement with any Indian tribe within 16 the borders of this state.

(b) The department may enter into a tribal-state agreement with any Indian tribe outside
 of this state having significant numbers of member children or membership-eligible children
 residing in this state.

(2) The purposes of a tribal-state agreement are to promote the continued existence and
 integrity of the Indian tribe as a political entity and to protect the vital interests of Indian
 children in securing and maintaining political, cultural and social relationships with their
 tribe.

(3) A tribal-state agreement may include, but is not limited to, agreements regarding default jurisdiction over cases in which the state courts and tribal courts have concurrent jurisdiction, the transfer of cases between state courts and tribal courts, the assessment, removal, placement and custody of Indian children and any other child welfare services provided to Indian children.

(4) A tribal-state agreement must:

(a) Provide for the cooperative delivery of child welfare services to Indian children in this
 state, including the utilization, to the extent available, of services provided by the tribe or
 an organization whose mission is to serve the American Indian or Alaska Native population
 to implement the terms of the tribal-state agreement; and

(b) If services provided by the tribe or an organization whose mission is to serve the
American Indian or Alaska Native population are unavailable, provide for the department's
use of community services and resources developed specifically for Indian families and that
have the demonstrated experience and capacity to provide culturally relevant and effective
services to Indian children.

39 <u>SECTION 9b. Saving clause.</u> Section 9a of this 2020 Act applies to tribal-state agreements
 40 entered into or renewed on or after the effective date of this 2020 Act.

41 <u>SECTION 10.</u> Jurisdiction. (1) Except as otherwise provided in this section, the juvenile 42 court's jurisdiction under ORS 419B.100 (1) in a case involving an Indian child is concurrent 43 with the Indian child's tribe.

(2) If a tribe is not subject to Public Law 83-280, the tribe has exclusive jurisdiction in a
 case described in ORS 419B.100 (1) involving an Indian child if:

(a) The Indian child is a ward of a tribal court of the Indian child's tribe; or 1 (b) The Indian child resides or is domiciled within the reservation of the tribe. 2 (3)(a) An Indian tribe subject to Public Law 83-280 may limit the juvenile court's exercise 3 of jurisdiction under ORS 419B.100 (1) over an Indian child by entering into a tribal-state 4 agreement described in section 9a of this 2020 Act. 5 (b) The juvenile court shall decline to exercise its jurisdiction under ORS 419B.100 (1) 6 over an Indian child who is a ward of a tribal court of the Indian child's tribe, or who resides 7 or is domiciled within the reservation of the tribe, if: 8 9 (A) The tribe has entered into a tribal-state agreement in which the state has agreed to 10 decline jurisdiction; and (B) The tribal-state agreement provides that the tribe has default jurisdiction over those 11 12cases. 13 (c)(A) If the juvenile court declines to exercise its jurisdiction under paragraph (b) of this subsection, the court shall coordinate with the tribal court to facilitate the tribal court's 14 15 assumption of jurisdiction. 16(B) The juvenile court shall: (i) Allow the Indian child's parent, Indian custodian or tribe to participate in any com-17munications under this subsection with a tribal court or, if the person is unable to partic-18 ipate in a communication, provide the person with an opportunity to represent facts and 19 legal arguments supporting the person's position before the juvenile court makes a decision 20regarding jurisdiction; 2122(ii) Create records of any communications under this subsection; 23(iii) Notify the Indian child's parent, Indian custodian or tribe in advance of each com-24munication; and (iv) Provide the Indian child's parent, Indian custodian or tribe with access to the record 2526of the communication. 27(C) Communications between the juvenile court and a tribal court regarding calendars, court records and similar matters may occur without informing the parties or creating a 2829record of the communications. 30 (D) As used in this paragraph, "record" means information that is inscribed on a tangible 31 medium or that is stored in an electronic or other medium and is retrievable in perceivable 32form. (4) Notwithstanding subsections (2) and (3) of this section, the juvenile court has tempo-3334 rary exclusive jurisdiction over an Indian child who is taken into protective custody under ORS 419B.150 or 419B.152. 35 SECTION 11. Motion to transfer to tribal court; objection. (1) Except as provided in 36 37 subsection (5) of this section, the juvenile court shall transfer a proceeding under ORS chapter 419B involving an Indian child if, at any time during the proceeding, the Indian 38 child's parent, Indian custodian or tribe petitions the court to transfer the proceeding to the 39 tribal court. 40 (2) Upon receipt of a transfer motion, the juvenile court shall contact the Indian child's 41 tribe and request a timely response regarding whether the tribe intends to decline the 42 transfer. 43

44 (3) A party may object to the transfer motion on the basis of one of the following:

45 (a) That the Indian child's tribe has declined the transfer;

(b) That one or both of the Indian child's parents object to the transfer; or 1 (c) That good cause exists to deny the transfer. 2 (4)(a) If a party objects to the transfer motion for good cause, the court shall fix the time 3 for hearing on objections to the motion. 4 5 (b) At the hearing, the objecting party has the burden of proof of establishing by clear and convincing evidence that good cause exists to deny the transfer. 6 (c) If the Indian child's tribe contests the assertion that good cause exists to deny the 7 transfer, the court shall give the tribe's argument substantial weight. 8 9 (d) When making a determination whether good cause exists to deny the transfer motion, the juvenile court may not consider: 10 (A) Whether the proceeding is at an advanced stage; 11 12(B) Whether there has been a prior proceeding involving the Indian child in which a 13 transfer motion was not filed; (C) Whether the transfer could affect the placement of the Indian child; 14 15 (D) The Indian child's cultural connections with the tribe or the tribe's reservation; (E) The socioeconomic conditions of the Indian child's tribe or any negative perception 16 of tribal or United States Bureau of Indian Affairs' social services or judicial systems; or 17 18 (F) Whether the transfer serves the best interests of the Indian child. (5)(a) The court shall deny the transfer motion if: 19 (A) The tribe declines the transfer orally on the record or in writing; 20(B) The Indian child's parent objects to the transfer; or 2122(C) The court finds by clear and convincing evidence, after hearing, that good cause exists to deny the transfer. 23(b) Notwithstanding paragraph (a)(B) of this subsection, the objection of the Indian 24child's parent does not preclude the transfer if: 25(A) The objecting parent dies or the objecting parent's parental rights are terminated and 2627have not been reinstated under ORS 419B.532; and (B) The Indian child's remaining parent, Indian custodian or tribe files a new transfer 28motion subsequent to the death of the objecting parent or the termination of the parental 2930 rights of the objecting parent. 31 (6) If the juvenile court denies a transfer under this section, the court shall document the basis for the denial in a written order. 32SECTION 12. Transfer. Upon granting a transfer motion under section 11 of this 2020 33 34 Act, the juvenile court shall expeditiously: (1) Notify the tribal court of the pending dismissal of the proceeding; 35 (2) Transfer all information regarding the proceeding, including but not limited to 36 37 pleadings and court records, to the tribal court; 38 (3) Dismiss the proceeding upon confirmation from the tribal court that the tribal court received the transferred information; and 39 (4) Following dismissal, direct the Department of Human Services to: 40 (a) Coordinate with the tribal court and the Indian child's tribe to ensure that the 41 transfer of the proceeding and the transfer of custody of the Indian child is accomplished 42 with minimal disruption of services to the Indian child and the Indian child's family. 43 (b) Provide the Indian child's tribe with documentation related to the Indian child's el-44 igibility for state and federal assistance and information related to the Indian child's social 45

5	SECTION 13. Emergency inquiry; inquiry; reason to know child is Indian child. (1) In an
6	emergency proceeding, the person taking the child into protective custody shall make a good
7	faith effort to determine whether there is reason to know that the child is an Indian child
8	and to contact by telephone, electronic mail, facsimile or other means of immediate com-
9	munication any tribe of which the child is or may be a member to determine the child's af-
10	filiation.
11	(2) Except as provided in subsection (1) of this section, whenever a person is required
12 12	under ORS chapter 419B to determine whether there is reason to know that a child is an Indian shild if the person has not already determined that the shild is an Indian shild the
13 14	Indian child, if the person has not already determined that the child is an Indian child, the person shall make a good faith effort to determine whether there is reason to know the child
14 15	is an Indian child, including by consulting with:
16	(a) The child;
10	(a) The child's parent or parents;
18	(c) Any person having custody of the child or with whom the child resides;
19	(d) Extended family members of the child;
20	(e) Any other person who may reasonably be expected to have information regarding the
21	child's membership or eligibility for membership in an Indian tribe; and

24	(3)(a) At the commencement of any hearing in which the court is required to inquire
25	whether a child is an Indian child, the court shall ask, on the record, each individual present

28	(b) If no individual in the proceeding knows or has reason to know that the child is an
29	Indian child, the court shall instruct each party to inform the court immediately if the party
30	later receives information that provides reason to know the child is an Indian child.
31	(4) A court has reason to know that a child is an Indian child if:
32	(a) Any individual present in the proceeding, officer of the court involved in the pro-
33	ceeding, Indian tribe, Indian organization or agency informs the court that the child is an
34	Indian child;
35	(b) Any individual present in the proceeding, officer of the court involved in the pro-
36	ceeding, Indian tribe, Indian organization or agency informs the court that information has
37	been discovered indicating that the child is an Indian child;
38	(c) The child indicates to the court that the child is an Indian child;
39	(d) The court is informed that the domicile or residence of the child, the child's parent
40	or the child's Indian custodian is on a reservation or in an Alaska Native village;
41	(e) The court is informed that the child is or has been a ward of a tribal court;
42	(f) The court is informed that the child or the child's parent possesses an identification
43	card or other record indicating membership in an Indian tribe;
44	(g) Testimony or documents presented to the court indicate in any way that the child
45	may be an Indian child; or

(h) Any other indicia provided to the court, or within the court's knowledge, indicates 1 2 that the child is an Indian child. (5) If the court has reason to know the child is an Indian child but the court does not 3 have sufficient evidence to determine whether the child meets the definition of Indian child, 4 the court must: 5 (a) Treat the child as an Indian child until the court determines, on the record, that the 6 child does not meet the definition of an Indian child; and 7 (b) Require the Department of Human Services or another party to submit a report, 8 9 declaration or testimony on the record that the department or other party used due diligence to identify and work with all of the tribes of which there is reason to know the child may 10 be a member or be eligible for membership to verify whether: 11 12(A) The child is a member; or 13 (B) The child is eligible for membership and is the biological child of a member. SECTION 14. Emergency notification; formal notice. (1)(a) In an emergency proceeding, 14 15 if there is reason to know that a child is an Indian child and the nature of the emergency allows, the Department of Human Services must notify by telephone, electronic mail, fac-16 simile or other means of immediate communication any tribe of which the child is or may 17 be a member. 18 (b) Notification under this subsection must include the basis for the child's removal, the 19 time, date and place of the initial hearing and a statement that the tribe, as a party to the 20proceeding under ORS 419B.875, has the right to participate in the proceeding. 2122(2) Except as provided in subsection (1) of this section, if there is reason to know a child in a proceeding under ORS chapter 419B is an Indian child and notice is required, the party 2324providing notice must: (a) Promptly send notice of the proceeding as described in subsection (3) of this section; 25and 2627(b) File an original or a copy of each notice sent under this section with the court, together with any return receipts or other proof of service. 28(3) Notice under subsection (2) of this section must: 2930 (a) Be sent to: 31 (A) Each tribe of which the child may be a member or of which the Indian child may be eligible for membership; 32(B) The child's parents; 33 34 (C) The child's Indian custodian, if applicable; and 35 (D) The appropriate United States Bureau of Indian Affairs Regional Director listed in 25 C.F.R. 23.11(b), if the identity or location of the child's parents, Indian custodian or tribe 36 37 cannot be ascertained. 38 (b) Be sent by registered or certified mail, return receipt requested. 7 (9) The number of cases that were transferred to tribal court under section 12 of this
8 2020 Act.

9 (10) The number of times the court found good cause to decline to transfer jurisdiction 10 of a case to tribal court upon request and the most common reasons the court found good 11 cause to decline a transfer petition.

(11) The efforts the Department of Human Services and the Judicial Department have
 taken to ensure compliance with the provisions of sections 1 to 22 of this 2020 Act and the
 amendments to statutes by sections 23 to 58 of this 2020 Act.

15 <u>SECTION 60.</u> First report due. The report under section 59 of this 2020 Act is first due
 16 no later than September 15, 2022.

17 <u>SECTION 61.</u> Full faith and credit. The juvenile court shall give full faith and credit to 18 the public acts, records and judicial proceedings of an Indian tribe applicable to an Indian 19 child custody proceeding.

20 <u>SECTION 62. Conflict of laws.</u> If any provision of sections 1 to 22 of this 2020 Act or the 21 amendments to statutes by sections 23 to 58 of this 2020 Act is found to contravene the In-22 dian Child Welfare Act (25 U.S.C. 1901 et seq.), it shall not serve to render inoperative any 23 remaining provisions of sections 1 to 22 of this 2020 Act or the amendments to statutes by 24 sections 23 to 58 of this 2020 Act that may be held not to conflict with the Indian Child 25 Welfare Act.

26 <u>SECTION 63.</u> <u>Rules.</u> The Department of Human Services and the Judicial Department 27 may adopt rules to implement sections 1 to 22 of this 2020 Act.

28 <u>SECTION 64.</u> Captions. The unit and section captions used in this 2020 Act are provided 29 only for the convenience of the reader and do not become part of the statutory law of this 30 state or express any legislative intent in the enactment of this 2020 Act.
