marijuana tax receipts, provider taxes, Medicare receipts and federal funds for indirect cost 1 recovery, Supplemental Security Income recoveries, Women, Infants and Children Program $\mathbf{2}$ 3 food rebates, the Coordinated School Health Program, the Edward Byrne Memorial State and Local Law Enforcement Assistance Grant Program and emergency preparedness and re-4 sponse services, but excluding lottery funds and federal funds not described in section 2, 5 chapter 695, Oregon Laws 2019, collected or received by the Oregon Health Authority, for 6 Health Systems, Health Policy and Analytics, and Public Health, is increased by \$624,266.". 7 In line 20, delete "21" and insert "23". 8 In line 31, delete "22" and insert "24". 9 In line 34, delete "23" and insert "25". 10
