**PROPOSED AMENDMENTS TO
HOUSE BILL 4057**

1 In line 2 of the printed bill, after “athletics” delete the rest of the line
2 and insert a period.

3 Delete lines 4 through 15 and insert:

4 **“SECTION 1. (1) The Oregon State Lottery may not offer college**
5 **sports betting games except for games based on Division I sporting**
6 **events.**

7 **“(2) The Oregon State Lottery may not offer any college sports**
8 **betting game in which the outcome is based on the performance or**
9 **nonperformance of any individual athlete.**

10 **“(3) The Oregon State Lottery shall prohibit the following individ-**
11 **uals from participating in college sports betting games through digital**
12 **player accounts:**

13 **“(a) Employees of Oregon Division I universities;**

14 **“(b) Student athletes on Oregon Division I athletic teams;**

15 **“(c) Immediate family members of student athletes on Oregon Di-**
16 **vision I athletic teams; and**

17 **“(d) Athlete agents.**

18 **“(4) Not less than twice per year, Oregon Division I universities and**
19 **the Oregon Department of Education shall provide to the Oregon State**
20 **Lottery any information that is necessary for the Oregon State Lot-**
21 **tery to enforce the prohibition on college sports betting established**

1 by subsection (3) of this section.

2 “(5) Oregon Division I universities shall notify employees and stu-
3 dent athletes of the prohibition on college sports betting established
4 by subsection (3) of this section:

5 “(a) At the time of hiring or enrollment; and

6 “(b) At least once per year thereafter.

7 “(6) The Oregon State Lottery shall provide training and educa-
8 tional materials regarding college sports betting for student athletes
9 at Oregon Division I universities.

10 “(7) The Oregon State Lottery shall regularly share data on college
11 sports betting games, including abnormal betting patterns, with
12 Oregon Division I universities.

13 “(8) As used in this section:

14 “(a) ‘Athlete agent’ has the meaning given that term in ORS
15 702.005.

16 “(b) ‘College sports betting game’ means a game in which the dis-
17 tribution of prizes is based on the outcome of a sporting event that is
18 organized by, sponsored by or played in connection with a post-
19 secondary institution of education.

20 “(c) ‘Division I’ means Division I of the National Collegiate Athletic
21 Association.

22 “SECTION 2. (1) The Oregon State Lottery Commission shall sepa-
23 rately record and account for the costs and net proceeds of college
24 sports betting games.

25 “(2) When the commission transfers net lottery proceeds to the
26 Administrative Services Economic Development Fund established un-
27 der ORS 461.540, the commission shall certify to the Oregon Depart-
28 ment of Administrative Services the amount of such transfer that
29 represents the net proceeds of college sports betting games.

30 “(3) The department shall transfer an amount equal to 50 percent

1 of the net proceeds of college sports betting games to the Opportunity
2 Grant Fund established under ORS 348.266.

3 “(4) As used in this section, ‘college sports betting game’ has the
4 meaning given that term in section 1 of this 2020 Act.”.
