- Serve relatively high concentrations of students from historically underrepresented backgrounds
- Higher Education Act of 1965
  - Discretionary and mandatory funding via Title III and Title V
  - Historical and statutory designation
  - Enrollment criteria
- Programs administered by U.S. Department of Education
