Public Hearing and Possible Work Session

- HB 2661 ** **Subsequent Referral(s) to Ways and Means
(3:20 pm) Appropriates moneys to State Department of Fish and Wildlife for purpose of funding programs that award \$5 for each take of pikeminnow, if take complies with wildlife laws.
- HB 2795 ** **Subsequent Referral(s) to Ways and Means
(3:40 pm) Appropriates moneys to State Forestry Department for purpose of facilitating projects pursued under Good Neighbor Authority Agreement that reduce wildfire risks.

- HB 3075 ** **Subsequent Referral(s) to Revenue
(3:50 pm) Repeals sunset of predator damage control district program.
- HB 3249 ** **Subsequent Referral(s) to Ways and Means
(4:10 pm) Directs State Department of Agriculture, in consultation with Minor Crops Advisory Committee, to establish grant program to study alternatives to chlorpyrifos.
- HB 2724
(4:20 pm) Requires State Department of Agriculture to establish advisory committee to advise department on policies related to Oregon crops.

Work Session

- HB 2691
Directs State Department of Energy to conduct study to identify techniques to increase visibility to birds of rotor blades on wind energy facilities and evaluate suitability of techniques for use in Oregon.
- HB 2611
Prevents application of state structural specialty code to agricultural building used primarily for specified activities.
- HJM 3
Urges Congress to pass and President to sign Emergency Wildfire and Public Safety Act of 2020.
- HB 3191
Directs State Fish and Wildlife Commission to adopt certain requirements related to carcasses of returning hatchery fish.

Note change: HB 2724 has been added from the 4/8/2021 meeting. HB 2572 has been rescheduled to the 4/8/2021 meeting.
