#### HB 3075 \*\*

(3:50 pm) Repeals sunset of predator damage control district program.

HB 3249 \*\*

\*\*Subsequent Referral(s) to Ways and Means (4:20 pm) Directs State Department of Agriculture, in consultation with Minor Crops Advisory Committee, to establish grant program to study alternatives to chlorpyrifos.

#### **Work Session**

HB 2691

Directs State Department of Energy to conduct study to identify techniques to increase visibility to birds of rotor blades on wind energy facilities and evaluate suitability of techniques for use in Oregon.

#### HB 2611

Prevents application of state structural specialty code to agricultural building used primarily for specified activities.

#### HJM 3

Urges Congress to pass and President to sign Emergency Wildfire and Public Safety Act of 2020. HB 2572

Provides that spread of fire in forestland across ownership boundary does not constitute prima facie evidence of fire burning uncontrolled if owners or operators of forestland on both sides of ownership boundary agree in advance to conduct prescribed fire.

#### HB 3191

Directs State Fish and Wildlife Commission to adopt certain requirements related to carcasses of returning hatchery fish.
