HB 2009

Establishes temporary limitations on lenders' remedies for borrowers' failures to make payments on obligations secured by mortgages, trust deeds or land sale contracts for certain real property.

HB 2043

Directs insurer to consider only specified information in determining rates for motor vehicle liability insurance policy.

HB 2938 **

**Subsequent Referral(s) to Ways and Means

Establishes Task Force on Age Discrimination.

HB 2946

Requires parties to franchise agreement to deal in good faith and commercially reasonable manner, and specifies required disclosures in franchise sale transaction.

HB 2420

CARRIED OVER FROM THE 3/22/2021 AGENDA: Extends timeline for filing complaint with Commissioner of Bureau of Labor and Industries alleging retaliation or discrimination for

reporting unlawful practices or exercising certain rights relating to safety and health in workplace.

HB 3080

CARRIED OVER FROM THE 3/22/2021 AGENDA: Allows financial institution to swipe identification card or driver license to collect information about individual for purpose of processing application for deposit account or loan for individual.

Public Hearing

HB 2026

(3: 20 PM) Requires public employers to give preferences to residents of Eastern Oregon Border Economic Development Region for civil service positions if majority of work of position will be performed within region.

HB 2875

(3: 35 PM) Directs Public Employees Retirement Board to study public employee retirement and report to appropriate committee or interim committee of Legislative Assembly no later than September 15, 2022.

HB 3361

(3: 50 PM) Requires third-party food platform to enter into agreement with food place before arranging delivery of orders from food place or listing food place on application or website.

: **Note change: HB 2420 and HB 3080 have been carried over from the 3/22/2021 agenda.**

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
