Public Hearing

SB 209

(3:20 PM) Allows owner of interest held in financial institution or holder of traveler's check or money order to demonstrate lack of abandonment by electronic communication or other records by institution or issuer.

SB 210

(3:35 PM) Provides that certain banking institutions may pay dividend in amount greater than previous statutory maximum amount if such payment is approved by Director of Department of Consumer and Business Services.

SB 425 A

(3:50 PM) Provides that Legislative Assembly finds and declares that telecommunicators are first responders.

SB 184

(4:05 PM) Modifies laws relating to preference given to veterans in public employment.

SB 94 A

Changes design requirement for practical skills tests offered by State Landscape Contractors Board.

SB 111 A

Modifies provisions relating to public employee retirement.

SB 112

Provides that common law employees are employees for purposes of Public Employees Retirement System.

SB 113

Provides that Public Employees Retirement Board may charge participating public employer accrued earnings for late payment of employee and employer contributions to individual account program.

SB 180 A

Requires insurer to notify claimant upon paying \$5,000 or more to settle third-party liability claim if claimant is natural person and if insurer or insurer's agent or other representative, including insurer's attorney, delivers payment to claimant or to claimant's attorney, agent or other representative by draft, check or other form of payment.

You will see a confirmation screen and be sent an email with information on how to join the meeting. If you do not, contact the committee assistant.
- **Register by phone:** 833-588-4500 (U.S. toll free). You will be given a phone number to call into the meeting.
- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Note change: SB 94 A, SB 111 A, SB 112, SB 113, SB 180 A have been carried over from the 5/10/2021 agenda.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
