#### Public Hearing

HB 2166

(1:00 pm) Directs Superintendent of Public Instruction to convene advisory group to review equity in education system of state and to report results of review to interim committee of Legislative Assembly related to education.

HB 2697

(2:00 pm) Requires education provider to prohibit use or display of any symbols of hate on school property or in education program.

HB 2631

(2:20 pm) Prescribes notification requirements for school district upon receipt of report of act of harassment, intimidation, bullying or cyberbullying.

#### **Oral Testimony (Live Remotely)**
