CARRIED OVER FROM THE 03/25/2021 AGENDA: Excludes from criminal records checks conducted by Department of Education certain persons who have submitted to criminal records checks conducted by Teacher Standards and Practices Commission.

### HB 2919

CARRIED OVER FROM THE 03/25/2021 AGENDA: Requires each public university and community college to prominently display total costs of all required course materials and fees for no less than 75 percent of total courses offered by public university or community college. 3254 \*\* HB

CARRIED OVER FROM THE 03/25/2021 AGENDA: Directs Department of Education to provide moneys for payment of costs of education of students in qualified treatment programs.

# AGENDA (cont.) March 30, 2021

#### HB 3354

Directs Teacher Standards and Practices Commission to adopt standards for educator preparation programs relating to evaluations of teacher candidates.

HB 2136

Clarifies terminology of persons who may be investigated or disciplined by Teacher Standards and Practices Commission.

HB 2962

> Requires each school district to evaluate instructional needs of students of school district as result of school closures due to COVID-19 and to report summaries of evaluations to Department of Education.

#### HB 3183

Requires school district to provide information about certain services and placements available for children who are deaf or deafblind or who are hard of hearing and to ensure that representative of Oregon School for the Deaf is present for certain meetings related to individualized education programs or 504 Plans.

HB 2631

Prescribes notification requirements for school district upon receipt of report of act of harassment, intimidation, bullying or cyberbullying.

HB 2330 \*\*

Makes permanent school district funding for foreign exchange students and small school district grants.

HB 2414 \*\*

\*\*Subsequent Referral(s) to Ways and Means

\*\*Subsequent Referral(s) to Revenue

Directs Department of Education to coordinate with Oregon career and technical student organizations in support of organizations for purposes of increasing student achievement and leadership and improving graduation rates, college preparation and career placement for students enrolled in career and technical student organization courses.

#### HB 2412 \*\*

\*\*Subsequent Referral(s) to Ways and Means

\*\*Subsequent Referral(s) to Ways and Means

Appropriates \$500,000 to Higher Education Coordinating Commission to award grant to College Possible organization.

HB 2536 \*\*

\*\*Subsequent Referral(s) to Ways and Means Requires school or school district to offer lunches and breakfasts at no charge to student if school or school district meets requirements of special provisions of federal meal program or if student is from household with income that does not exceed 300 percent of federal poverty guidelines.

#### 2368 \*\* HB

Establishes pilot program to improve educational outcomes by using trauma-informed approaches to education, health services and intervention strategies.

#### **Public Hearing and Possible Work Session**

#### HB 2989

Establishes state policy that career and technical education is provided through seamless system that begins at secondary school level and progresses to post-secondary career and technical education institutions, community colleges and apprenticeship programs.

HB 2954

Allows public charter school to implement weighted lottery that favors historically underserved students when number of applications for enrollment exceeds capacity of program, class, grade level or building.

#### HB 2942 A

Removes certain nonviolent crimes from list of crimes that automatically make person ineligible to hold license or registration issued by Teacher Standards and Practices Commission if person has been convicted of crime.

HB 2135

Prohibits Teacher Standards and Practices Commission from issuing license or registration to person convicted of crime constituting domestic violence.

HB 3169 \*\* \*\*Subsequent Referral(s) to Ways and Means Allows certain schools to qualify as remote school elementary school or small high school and to receive additional distributions from State School Fund if school qualified as remote small elementary school or small high school for 2019-2020 school year.
