- HB 2093 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 04/06/2021 AGENDA: Alters eligibility requirements and formula for establishing amount of award for Oregon Opportunity Grant and renewal of grant.
- HB 2441 \*\* \*\*Subsequent Referral(s) to Revenue  
CARRIED OVER FROM THE 04/06/2021 AGENDA: Extends sunset for tax credit for university venture development fund contributions.
- HB 3363 \*\* \*\*Subsequent Referral(s) to Ways and Means  
CARRIED OVER FROM THE 04/06/2021 AGENDA: Establishes Racial Equity and Justice Student Council.
- HB 3354  
Directs Teacher Standards and Practices Commission to adopt standards for educator preparation programs relating to evaluations of teacher candidates.

**AGENDA (cont.)**  
**April 8, 2021**

HB 2408

Directs Department of Education to conduct study on meeting students' behavioral health needs and to report results of study to interim committee of Legislative Assembly related to education by September 1, 2021.

HB 3294

Requires every public education provider to provide certain feminine hygiene products at no cost to students.

HB 2001

Requires school district that is making reductions in educator staff positions to retain teacher with less seniority if teacher has more merit and if retention of teacher is necessary to maintain school district's diversity ratio.

**Public Hearing and Possible Work Session**

HB 2969

CARRIED OVER FROM THE 04/06/2021 AGENDA: Directs school districts to provide age-appropriate instruction in oral health as part of health education curriculum.

HB 3234

CARRIED OVER FROM THE 04/06/2021 AGENDA: Requires school districts to provide instruction on organ and tissue donation and education.

HB 3350

Prescribes requirements for providing education to student with disability during COVID-19 emergency.

HB 2802 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Allows school district with remote small high school to use moneys received under High School Graduation and College and Career Readiness Act on existing career and technical education programs.

HB 2793 \*\*

\*\*Subsequent Referral(s) to Ways and Means

Appropriates moneys to Department of Education for distribution to certain school districts for certain career and technical education programs.

HB 3338

Directs Department of Education to develop accountability measures related to indicators of school quality and student success.

*Note change: HB 2093, HB 2441, HB 2969, HB 3234, and HB 3363 have been carried over from the 04/06/2021 agenda.*
