SB 602

Removes sunset on requirement that students must receive certain information related to statewide summative assessments.

SB 702 B

Directs State Board of Education to review social studies standards.

SB 232 A

Modifies requirements of report on Educators Equity Act that is prepared by state agencies.

SB 54

Updates terminology for Youth Development Council to match changes in federal law.

SB 732 A

Requires school districts to establish educational equity advisory committee.

SB 667 A

Requires school district to adopt and implement policy concerning ownership rights to teacher-created intellectual property.

SB 744 A

Directs Department of Education to review state requirements for high school diploma and to make recommendations related to requirements.

SB 594 A

Directs Legislative Policy and Research Office to conduct study on software that can be used to monitor student's usage related to district-owned computers and similar devices and district Internet services and to produce summary of study.

- Registration closes at the time the meeting is scheduled to begin.
- A public access kiosk is located outside of the State Capitol Building for anyone without access to a phone or computer to join a meeting by video.

Neither registration nor use of the public access kiosk is a guarantee that you will be able to testify during the meeting. Committee chairs may determine that public testimony must be limited. For this reason, written testimony is encouraged even if you plan to speak.

Unless otherwise noted on the agenda, testimony is only accepted by committees for bills or topics scheduled for a public hearing. See the Oregon Legislature's website for information on contacting individual legislators directly on bills or topics not scheduled for a public hearing.
